AN ACT to amend the tax law, in relation to exemption of new and used ambulance vehicles under the sales and compensating use taxes

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 12 GOVERNMENTAL AGENCIES.
- 13 S 2. This act shall take effect September 1, 2011.
