AN ACT to amend the penal law, in relation to protecting employees of local social services districts from assault

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 120.05 of the penal law is amended by adding two
2 new subdivisions 3-a and 11-a to read as follows:

3 3-A. WITH INTENT TO PREVENT AN EMPLOYEE OF A LOCAL SOCIAL SERVICES
4 DISTRICT DIRECTLY INVOLVED IN INVESTIGATION OF OR RESPONSE TO ALLEGED
5 ABUSE OR NEGLECT OF A CHILD, A VULNERABLE ELDERLY PERSON OR AN INCOMPE-
6 TENT OR PHYSICALLY DISABLED PERSON, FROM PERFORMING SUCH INVESTIGATION
7 OR RESPONSE, THE ACTOR, NOT BEING SUCH CHILD, VULNERABLE ELDERLY PERSON
8 OR INCOMPETENT OR PHYSICALLY DISABLED PERSON, OR WITH INTENT TO PREVENT
9 AN EMPLOYEE OF A LOCAL SOCIAL SERVICES DISTRICT DIRECTLY INVOLVED IN
