AN ACT to amend the tax law and the state finance law, in relation to the rescued animals spay and neuter fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The tax law is amended by adding a new section 209-H to 1 2 read as follows: 3 S 209-H. GIFT FOR RESCUED ANIMALS PROTECTION. EFFECTIVE FOR ANY TAX 4 YEAR COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND TWELVE, A 5 TAXPAYER IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE RESCUED б ANIMALS SPAY AND NEUTER FUND. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE 7 DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY SUCH 8 THE COMMISSIONER SHALL INCLUDE SPACE ON THE CORPORATE INCOME TAXPAYER. TAX RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIBUTION. 9 NOTWITH-10 STANDING ANY OTHER PROVISION OF LAW, ALL REVENUES COLLECTED PURSUANT TO THIS SECTION SHALL BE CREDITED TO THE RESCUED ANIMALS 11 SPAY AND NEUTER 12 FUND AND SHALL BE USED ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION NINETY-FIVE-H OF THE STATE FINANCE LAW. 13 S 2. Part 2 of article 22 of the tax law is amended by adding 14 а new 15 section 630-c to read as follows: GIFT FOR RESCUED ANIMALS PROTECTION. EFFECTIVE FOR ANY TAX 16 S 630-C. 17 YEAR COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND TWELVE, AN INDI-18 VIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE RESCUED AND NEUTER FUND. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE 19 ANIMALS SPAY DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY 20 SUCH 21 INDIVIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE PERSONAL INCOME 22 TAX RETURN TO ENABLE AN INDIVIDUAL TO MAKE SUCH CONTRIBUTION. NOTWITH-23 ANY OTHER PROVISION OF LAW, ALL REVENUES COLLECTED PURSUANT TO STANDING THIS SECTION SHALL BE CREDITED TO THE RESCUED ANIMALS 24 SPAY AND NEUTER

FUND AND SHALL BE USED ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION 1 2 NINETY-FIVE-H OF THE STATE FINANCE LAW. 3 S 3. The state finance law is amended by adding a new section 95-h to 4 read as follows: 5 S 95-H. RESCUED ANIMALS SPAY AND NEUTER FUND. 1. THERE IS HEREBY 6 ESTABLISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF AGRICULTURE AND 7 MARKETS AND THE COMPTROLLER A SPECIAL FUND TO BE KNOWN AS THE "RESCUED ANIMALS SPAY AND NEUTER FUND". THE COMMISSIONER OF AGRICULTURE AND 8 MARKETS SHALL PROMULGATE ANY RULES AND REGULATIONS 9 THE COMMISSIONER 10 DEEMS NECESSARY TO IMPLEMENT AND REGULATE SUCH FUND. 2. SUCH FUND SHALL CONSIST OF: 11 12 A. ALL REVENUES RECEIVED BY THE DEPARTMENT OF TAXATION AND FINANCE PURSUANT TO THE PROVISIONS OF SECTIONS TWO HUNDRED NINE-H AND SIX 13 14 HUNDRED THIRTY-C OF THE TAX LAW; 15 B. ALL REVENUES RECEIVED PURSUANT TO APPROPRIATION BY THE LEGISLATURE; 16 AND 17 C. ALL OTHER MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT TO LAW. 18 19 THE COMMISSIONER OF TAXATION AND FINANCE SHALL REPORT ANNUALLY TO THE STATE COMPTROLLER THE AMOUNTS DESIGNATED FOR THE FUND PURSUANT TO 20 21 SECTIONS TWO HUNDRED NINE-H AND SIX HUNDRED THIRTY-C OF THE TAX LAW, WHO 22 SHALL TRANSFER THAT AMOUNT TO THE FUND. NOTHING CONTAINED IN THIS SECTION SHALL PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS, OR 23 24 BEQUESTS FOR THE PURPOSES OF THE FUND AS DEFINED IN THIS SECTION AND 25 DEPOSITING THEM INTO THE FUND. 26 3. MONEYS OF THE FUND SHALL BE EXPENDED FOR THE PURPOSES OF CARRYING OUT THE PROVISIONS OF SECTION ONE HUNDRED SEVENTEEN-A OF THE AGRICULTURE 27 AND MARKETS LAW. MONEYS SHALL BE PAID OUT OF THE FUND ON THE 28 AUDIT AND WARRANT OF THE STATE COMPTROLLER ON VOUCHERS APPROVED BY THE COMMISSION-29 ER OF AGRICULTURE AND MARKETS. ANY INTEREST RECEIVED BY THE COMPTROLLER 30 ON MONEYS ON DEPOSIT IN THE ANIMAL POPULATION CONTROL FUND SHALL BE 31 32 RETAINED IN AND BECOME PART OF SUCH FUND. 33 S 4. This act shall take effect immediately.
