AN ACT to amend the executive law, in relation to expanding the duties of the women veterans coordinator

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 361-b of the executive law, as amended by chapter 358 of the laws of 1999, is amended to read as follows:

S 361-b. Women veterans coordinator. 1. Definitions. (a) "Veteran" shall have the same meaning as provided in subdivision one of section three hundred sixty-four of this article.

(b) "Division" shall mean the state division of veterans' affairs.

(c) "Women veterans coordinator" shall be a veteran[, provided that a preference shall be given to a qualified woman veteran.

9 (d) "State veterans nursing homes" shall be defined herein as all New 10 York state veterans nursing homes, including but not limited to, the New 11 York state veterans home, located in Oxford; the Long Island state 12 veterans home, located on the campus of the state university of New York 13 at Stony Brook; the New York state veterans home at St. Albans, located 14 in Jamaica; the state veterans home at Batavia, located in Batavia, New 15 York and any future veterans nursing homes located in New York state].

16 2. Such women veterans coordinator shall be appointed by the director. 3. Establishment of women veterans coordinator. There is hereby estab-18 lished within the division, a "women veterans coordinator" who shall 19 work under the direction of the director and whose duties shall include, 20 but not be limited to, the:

(a) identification, development, planning, organization and coordination of all statewide programs and services to meet the needs of women veterans[. This initiative shall include but not be limited to all services in state veterans nursing homes];

1 (b) recommendation to the director to ensure compliance with all 2 existing division policies and regulations pertaining to the needs of 3 women veterans on the state and federal level AND MAKE RECOMMENDATIONS 4 REGARDING THE IMPROVEMENT OF BENEFITS AND SERVICES TO WOMEN VETERANS;

5 (c) liaison between the division, THE UNITED STATES DEPARTMENT OF 6 VETERANS AFFAIRS CENTER FOR WOMEN VETERANS, the United States department 7 of veterans affairs advisory committee on women veterans, state veterans 8 nursing homes, state agencies, community groups, advocates and other 9 veterans AND MILITARY organizations and interested parties;

10 (d) [dissemination of information on available programs and services 11 to state veterans nursing homes;

12 (e) provision of ombudsman services on issues pertaining to women in 13 state veterans nursing homes, with a primary emphasis on health care and 14 services unique to women;

15 (f) provision of consultation services with health care teams within 16 state veterans nursing homes to provide the division with a better 17 understanding of the special needs and concerns of women veterans;

(g) monitoring and tracking availability of adequate hospital rooms; appropriate maintenance of privacy, clothing and personal needs, and canteen projects specific to the needs of women patients; evaluation of satisfaction level of women patients with care received; and maintenance of relevant statistics pertaining to the provision of services and benefits to women at state veterans nursing homes;

24 (h)] development and maintenance of a clearinghouse for information 25 and resources for women VETERANS; [and]

26 (E) PROMOTE EVENTS AND ACTIVITIES THAT RECOGNIZE, EDUCATE AND HONOR

32 4. Reports. The women veterans coordinator shall submit a report to 33 the director each year after the effective date of [the chapter of the laws of nineteen hundred ninety-nine which added this provision] THIS SECTION. Such report shall include, but not be limited to, [the number 34 35 of women veterans served by the program. The director shall include such 36 37 report or synopsis of such report to the governor as provided in section 38 three hundred fifty-three of this article] A DESCRIPTION OF THE WOMEN VETERANS COORDINATOR'S ACTIVITIES FOR THE CALENDAR YEAR AND THE PROGRAMS 39 40 DEVELOPED PURSUANT TO THE PROVISIONS OF THIS SECTION. THE DIRECTOR SHALL SUBMIT THE REPORT OR A SYNOPSIS OF THE REPORT TO THE GOVERNOR IN ACCORD-41 THE PROVISIONS OF SECTION THREE HUNDRED FIFTY-THREE OF THIS 42 ANCE WITH 43 ARTICLE.
