AN ACT to amend the insurance law, in relation to requiring coverage for hospitalization and anesthesia services related to the provision of dental services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The insurance law is amended by adding a new section 3240 2 to read as follows:

3 3240. PAYMENT FOR ANESTHESIA AND HOSPITALIZATION RELATED TO DENTAL S SERVICES. ANY HEALTH INSURANCE AUTHORIZED PURSUANT TO PARAGRAPH THREE OF 4 5 SUBSECTION (A) OF SECTION ONE THOUSAND ONE HUNDRED THIRTEEN OF THIS 6 CHAPTER SHALL COVER ANESTHESIA AND HOSPITAL CHARGES FOR DENTAL CARE 7 PROVIDED TO A COVERED PERSON WHO: (A) IS UNDER EIGHTEEN YEARS OF AGE; OR 8 (B) IS SEVERELY DISABLED; OR (C) HAS A MEDICAL CONDITION THAT REOUIRES 9 GENERAL ANESTHESIA OR HOSPITALIZATION FOR THE PROVISION OF DENTAL SERVICES. THE COVERAGE REQUIRED BY THIS SECTION MAY BE MADE 10 SUBJECT TO PROVISIONS THAT APPLY TO OTHER BENEFITS, INCLUDING BUT NOT LIMITED TO 11 DEDUCTIBLES AND COINSURANCE. A HEALTH INSURER MAY REOUIRE PRIOR AUTHORI-12 13 ZATION FOR HOSPITALIZATION FOR DENTAL CARE IN THE SAME MANNER AS WOULD REOUIRED FOR OTHER COVERED MEDICAL CONDITIONS. WHEN SERVICES DEFINED 14 BE IN THIS SECTION ARE PROVIDED BY A DENTIST ACTING WITHIN THE LAWFUL SCOPE 15 16 OF HIS OR HER LICENSE, BENEFITS SHALL BE PROVIDED AT THE SAME LEVELS AND 17 UNDER THE SAME TERMS WHETHER PROVIDED BY A PHYSICIAN OR DENTIST. 18 S 2. This act shall take effect immediately.
