AN ACT to amend the civil practice law and rules, in relation to establishing the uniform mediation act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (k) of subdivision 1 of section 16-m of section 1
2 of chapter 174 of the laws of 1968, constituting the New York state
3 urban development corporation act, as added by section 4 of part FF of
4 chapter 59 of the laws of 2006, is amended and two new paragraphs (1)
5 and (m) are added to read as follows:
6 (k) Assistance for regional partnership proposals, as provided in
7 subdivision 12 of section 3154 of the public authorities law[.];
8 (1) ASSISTANCE TO BIOSCIENCES RESEARCH INSTITUTIONS AND ORGANIZATIONS
9 ON A COMPETITIVE BASIS TO DEVELOP CURRICULUM AND ADMINISTER BIOSCIENCE
10 SPECIFIC TRAINING PROGRAMS FOR CURRENT AND PROSPECTIVE INDUSTRY EMPLOY-
11 EES, IN CONSULTATION WITH THE DIVISION OF SCIENCE, TECHNOLOGY AND INNO-
12 VATION ESTABLISHED PURSUANT TO ARTICLE 18 OF THE ECONOMIC DEVELOPMENT
13 LAW. FOR THE PURPOSES OF THIS PARAGRAPH, THE TERM BIOSCIENCES RESEARCH
14 SHALL INCLUDE, BUT NOT BE LIMITED TO, THE BASIC, APPLIED, OR TRANSLA-
15 TIONAL RESEARCH THAT LEADS TO THE DEVELOPMENT OF THERAPEUTICS, DIAGNOS-
16 TICS, OR DEVICES, TO IMPROVE HUMAN HEALTH OR AGRICULTURE AND THAT
17 REQUIRE FEDERAL DRUG ADMINISTRATION APPROVAL;
18 (M) ASSISTANCE TO BUSINESSES THAT CONDUCT BASIC, APPLIED OR TRANSLA-
19 TIONAL RESEARCH THAT LEADS TO THE DEVELOPMENT OF PRODUCTS THAT IMPROVE
20 HUMAN HEALTH OR AGRICULTURE AND THAT REQUIRE APPROVAL BY THE FEDERAL
21 FOOD AND DRUG ADMINISTRATION, IN ORDER TO CREATE OR EXPAND FACILITIES,

1 IN ACCORDANCE WITH GOOD MANUFACTURING PRACTICE REGULATIONS, THAT WILL
