AN ACT to amend the elder law, in relation to establishing small flexible funds accounts at the local level

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 203 of the elder law is amended by adding a new
2 subdivision 11 to read as follows:
3 11. THE DIRECTOR IS HEREBY AUTHORIZED TO AND SHALL ESTABLISH THE
4 REGRANT PROGRAM WITHIN THE OFFICE WITHIN AMOUNTS SPECIFICALLY AVAILABLE
5 BY APPROPRIATION THEREFOR, AND IN IMPLEMENTING SUCH PROGRAM MAY CONTRACT
6 WITH DESIGNATED AGENCIES, AS SUCH TERM IS DEFINED IN SECTION TWO HUNDRED
7 FOURTEEN OF THIS TITLE, TO ADMINISTER FUNDING AND TECHNICAL ASSISTANCE
8 FOR PROGRAMS AND ACTIVITIES NOT OTHERWISE DIRECTLY FUNDED BY PROGRAMS
9 ADMINISTERED BY THE OFFICE, OR WHICH CONSTITUTE ONE-TIME EVENTS OR SHORT
10 TERM NEEDS. ONLY DESIGNATED AGENCIES MAY APPLY FOR FUNDING THROUGH THE
11 REGRANT PROGRAM. APPLICATIONS SHALL PROVIDE OR DEMONSTRATE THE FOLLOWING
12 IN A FORM AND AT A LEVEL OF DETAIL SATISFACTORY TO THE DIRECTOR:
13 (A) PROGRAM SUMMARY, DESCRIBING THE REGRANT PROGRAM AND THOSE INTENDED
14 TO BE SERVED, AND HOW THE PROPOSED PROGRAM RELATES TO, COMPLEMENTS, OR
15 STRENGTHENS OTHER PROGRAMS FOR THE ELDERLY IN THE COMMUNITY.
16 (B) SCOPE OF ACTIVITY, DESCRIBING THE ANTICIPATED NUMBER OF REQUESTS
17 TO BE RECEIVED, AND THE AVERAGE REQUEST AMOUNT AND GRANT AMOUNT.
18 (C) STAFFING AND BUDGET, DESCRIBING THE INDIVIDUALS IN THE ORGANIZA-
19 TION RESPONSIBLE FOR ADMINISTRATION OF THIS PROJECT, THE WORK PLAN, AND
20 ASSURANCES THAT ADMINISTRATIVE COSTS BY THE AGENCY SHALL NOT EXCEED
21 FIFTEEN PERCENT OF PROJECT COSTS.
22 (D) MARKETING/OUTREACH, DESCRIBING STRATEGIES FOR OUTREACH AND MARKET-
23 ING TO COMMUNITY GROUPS.
24 (E) SELECTION PROCESS, DESCRIBING THE LOCAL APPLICATION AND SELECTION
25 PROCESS, INCLUDING APPLICANT REQUIREMENTS, RESTRICTIONS, AND WHETHER
26 SELECTION INCLUDES REVIEW BY AN OUTSIDE PANEL.
27 (F) EVALUATION, DESCRIBING HOW THE APPLICANT WILL EVALUATE AND ASSESS
28 THE EFFECTIVENESS OF THE PROGRAM.
29 S 2. This act shall take effect immediately.
