AN ACT to amend the county law, in relation to permitting Onondaga county to collaborate with other counties with respect to operating and maintaining a foreign trade zone

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 23 of section 224 of the county law, as
2 amended by chapter 2 of the laws of 1985, is amended to read as follows:
3 23. The county of Onondaga may make application to the Foreign Trade
4 Zones Board established by the act of Congress, approved June eighth,
5 nineteenth, nineteen hundred thirty-four, entitled "An act to provide the
6 establishment, operation and maintenance of foreign trade zones in ports
7 of entry of the United States, to expedite and encourage foreign
8 commerce, and for other purposes," for a grant to Onondaga county of the
9 privilege to have established, operated and maintained, a foreign trade
10 zone or zones within such county AND ITS DESIGNATED SERVICE AREA,
11 INCLUDING THE ADJACENT COUNTIES OF CAYUGA, OSWEGO AND MADISON, pursuant
12 to the provisions of such act, and if such application be granted, to
13 have established, operated and maintained such zone in accordance with
14 law including [a sub-zone to be located in Cortland county which has the
15 authority to create said sub-zone pursuant to subdivision twenty-three-a
16 of this section] SITES IN ONONDAGA COUNTY AND THE COUNTIES OF CAYUGA,
17 OSWEGO, AND MADISON, WHICH ARE COUNTIES LOCATED ADJACENT TO THE SYRACUSE
18 HANCOCK INTERNATIONAL AIRPORT; FOR PURPOSES OF THIS SECTION, THE TERM
19 "ADJACENT" MEANS THOSE AREAS LOCATED WITHIN SIXTY MILES OR NINETY
20 MINUTES DRIVING TIME OF A UNITED STATES CUSTOMS AND BORDER PROTECTION
21 PORT OF ENTRY. [Said sub-zone may only be created with the approval of
22 the governing body of Cortland county.] The county of Onondaga may enter
23 into such contracts and may appropriate such sums of money and may take
24 such further actions as it may deem appropriate, subject to the
25 provisions of this article, towards the promotion, establishment and
26 maintenance of such zone or zones.
27 S 2. This act shall take effect immediately.
