AN ACT to amend the vehicle and traffic law, in relation to forms of identification cards and licenses of veterans

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph (i) of paragraph (a) and paragraph (b) of 2 subdivision 3 of section 490 of the vehicle and traffic law, subpara-3 graph (i) of paragraph (a) as amended by chapter 235 of the laws of 4 2002, and paragraph (b) as amended by chapter 600 of the laws of 1989, 5 are amended to read as follows:

(i) The commissioner shall upon submission of an appropriate applica-on, upon payment of the prescribed fee, and upon being satisfied that 6 7 tion, 8 the person described is the applicant and that such applicant meets the 9 requirements set forth in subdivision two of this section, issue to such applicant a nontransferable identification card. 10 In addition, the 11 commissioner also shall require that an applicant for an identification or renewal thereof provide his or her social security number. THE 12 card 13 COMMISSIONER SHALL PROVIDE SPACE SO THAT AN APPLICANT MAY REOUEST A NOTATION UPON SUCH IDENTIFICATION CARD THAT HE OR SHE IS A VETERAN OF 14 15 THE UNITED STATES ARMED FORCES.

16 (b) The identification card shall contain a distinguishing number or 17 mark and adequate space upon which an anatomical gift, pursuant to arti-18 cle forty-three of the public health law, by the holder may be recorded 19 and shall contain such other information and shall be issued in such form as the commissioner shall determine; provided, however, every iden-20 tification card or renewal thereof issued to a person under the age of 21 22 twenty-one years shall have prominently imprinted thereon the statement 23 "UNDER 21 YEARS OF AGE" in notably distinctive print or format. 24 PROVIDED, FURTHER, HOWEVER, THAT EVERY IDENTIFICATION CARD ISSUED TO AN WHO WAS A MEMBER OF THE ARMED FORCES OF THE UNITED STATES AND 25 APPLICANT

RECEIVED ON HONORABLE DISCHARGE OR WAS RELEASED THEREFROM UNDER HONOR-1 2 CONDITIONS SHALL, UPON HIS OR HER REQUEST AND SUBMISSION OF PROOF ABLE 3 AS SET FORTH HEREIN, CONTAIN A DISTINGUISHING MARK, IN SUCH FORM AS THE 4 COMMISSIONER SHALL DETERMINE, INDICATING THAT HE OR SHE IS A VETERAN. 5 SUCH PROOF SHALL CONSIST OF A CERTIFICATE OF RELEASE OR DISCHARGE FROM 6 INCLUDING BUT NOT LIMITED TO A DD FORM 214 OR OTHER PROOF ACTIVE DUTY 7 SATISFACTORY TO THE COMMISSIONER. The commissioner shall not require 8 fees for the issuance of such identification cards or renewals thereof 9 to persons under twenty-one years of age which are different from the 10 fees required for the issuance of identification cards or renewals ther-11 to persons twenty-one years of age or over, NOR FEES TO PERSONS eof REQUESTING A VETERAN NOTATION WHICH ARE DIFFERENT FROM FEES 12 THAT WOULD 13 OTHERWISE BE REOUIRED.

14 S 2. Subdivision 1 of section 502 of the vehicle and traffic law, as 15 amended by section 2 of part CC of chapter 58 of the laws of 2011, is 16 amended to read as follows:

17 Application for license. Application for a driver's license shall 1. be made to the commissioner. The fee prescribed by law may be submitted 18 19 with such application. The applicant shall furnish such proof of identi-20 ty, age, and fitness as may be required by the commissioner. The commis-21 sioner may also provide that the application procedure shall include the 22 taking of a photo image or images of the applicant in accordance with 23 rules and regulations prescribed by the commissioner. In addition, the commissioner also shall require that the applicant provide his or her 24 25 social security number and provide space on the application so that the 26 applicant may register in the New York state organ and tissue donor 27 registry under section forty-three hundred ten of the public health law, AND SPACE SO THAT THE APPLICANT MAY REQUEST A NOTATION UPON SUCH LICENSE 28 29 THAT HE OR SHE IS A VETERAN OF THE UNITED STATES ARMED FORCES. In addition, an applicant for a commercial driver's license who will operate a 30 commercial motor vehicle in interstate commerce shall certify that such 31 32 applicant meets the requirements to operate a commercial motor vehicle, 33 set forth in public law 99-570, title XII, and title 49 of the code as 34 of federal regulations, and all regulations promulgated by the United 35 States secretary of transportation under the hazardous materials trans-36 portation act. In addition, an applicant for a commercial driver's 37 license shall submit a medical certificate at such intervals as required 38 the federal motor carrier safety improvement act of 1999 and Part by 383.71(h) of title 49 of the code of federal regulations relating to 39 40 medical certification and in a manner prescribed by the commissioner. For purposes of this section and sections five hundred three and five 41 hundred ten-a of this title, the term "medical certificate" shall mean a 42 43 form substantially in compliance with the form set forth in Part 391.43(h) of title 49 of the code of federal regulations. Upon a deter-44 45 mination that the holder of a commercial driver's license has made any false statement, with respect to the application for such license, 46 the 47 commissioner shall revoke such license.

48 S 3. Subdivision 1 of section 504 of the vehicle and traffic law is 49 amended by adding a new paragraph (a-1) to read as follows:

50 (A-1) EVERY LICENSE OR RENEWAL THEREOF ISSUED TO AN APPLICANT WHO WAS 51 A MEMBER OF THE ARMED FORCES OF THE UNITED STATES AND RECEIVED AN HONOR-52 ABLE DISCHARGE OR WAS RELEASED THEREFROM UNDER HONORABLE CONDITIONS SHALL, UPON HIS OR HER REQUEST AND SUBMISSION OF 53 PROOF AS SET FORTH 54 HEREIN, CONTAIN A DISTINGUISHING MARK, IN SUCH FORM AS THE COMMISSIONER 55 SHALL DETERMINE, INDICATING THAT HE OR SHE IS A VETERAN. SUCH PROOF 56 SHALL CONSIST OF A CERTIFICATE OF RELEASE OR DISCHARGE FROM ACTIVE DUTY

INCLUDING BUT NOT LIMITED TO A DD FORM 214 OR OTHER PROOF SATISFACTORY
 TO THE COMMISSIONER. THE COMMISSIONER SHALL NOT REQUIRE FEES FOR THE
