AN ACT to amend the education law, in relation to establishment of a
facilitator center for private and parochial schools

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The education law is amended by adding a new section 115 to

3 S 115. FACILITATOR CENTER FOR PRIVATE AND PAROCHIAL SCHOOLS. 1. THERE
4 IS HEREBY ESTABLISHED THE FACILITATOR CENTER FOR PRIVATE AND PAROCHIAL
5 SCHOOLS TO SUPPORT THE ACTIVITIES OF INDEPENDENT AND RELIGIOUS SCHOOLS
6 IN THE STATE; TO PROMOTE, FOSTER, AND ENCOURAGE ACADEMIC EXCELLENCE AND
7 SCHOLASTIC ACHIEVEMENT IN SUCH SCHOOLS; TO RECEIVE ALLOCATIONS OF AID
8 FROM THE FEDERAL, STATE AND LOCAL GOVERNMENTS AND SUBDIVISIONS THEREOF;
9 TO ADMINISTER AND EXPEND SUCH ALLOCATIONS ON BEHALF OF SUCH SCHOOLS IN
10 ACCORDANCE WITH THE LAWS, RULES AND/OR REGULATIONS GOVERNING SUCH ALLO-
11 CATIONS.
12 2. THE COMMISSIONER SHALL, UPON THE REQUEST OF ONE OR MORE PRIVATE AND
13 PAROCHIAL SCHOOLS, REALLOCATE TO THE FACILITATOR CENTER SUCH FEDERAL,
14 STATE OR LOCAL EDUCATION FUNDS AS HAVE BEEN IDENTIFIED BY SUCH SCHOOL OR
15 SCHOOLS IN ORDER THAT SUCH FUNDS BE ADMINISTERED BY THE FACILITATOR
16 CENTER. THE ADMINISTRATIVE CHARGES OF THE FACILITATOR CENTER, WHICH
17 SHALL BE DEDUCTED FROM SUCH FEDERAL, STATE AND/OR LOCAL EDUCATION FUNDS,
18 SHALL BE ESTABLISHED AND ADJUSTED ACCORDING TO A MEMORANDUM OF AGREEMENT
19 BETWEEN THE COMMISSIONER, THE CHIEF EXECUTIVE OFFICER OF THE FACILITATOR
20 CENTER AND A REPRESENTATIVE OF SUCH SCHOOL OR SCHOOLS.
21 3. THE COMMISSIONER SHALL PROMULGATE ANY RULE OR REGULATION NECESSARY
22 TO CARRY OUT THE PROVISIONS OF THIS SECTION.
23 S 2. This act shall take effect immediately.
