- AN ACT to amend the environmental conservation law, in relation to waiving certain fishing and hunting fees for members of the United States armed forces in active service

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 11-0715 of the environmental 2 conservation law, as amended by section 3 of part KK of chapter 59 of 3 the laws of 2009, is amended to read as follows:

4 2. A member of the Shinnecock tribe or the Poospatuck tribe or a 5 member of the six nations, residing on any reservation wholly or partly 6 within the state, is entitled to receive free of charge a fishing license, a small and big game license, a sportsman license, [a muzzle-7 8 loading stamp, a trapping license, and a bow hunting stamp; a resident 9 of the state who is] a member of the United States armed forces in active service [who is not stationed within the state and has not been 10 herein longer than thirty days on leave or furlough,] is entitled to 11 receive free of charge a fishing license, a small and big game license, 12 13 and a trapping license; [a resident of the state who is] an active 14 member of the organized militia of the state of New York as defined by 15 section one of the military law, or the reserve components of the armed the United States, and excluding members of the inactive 16 forces of national guard and individual ready reserve, is entitled to receive free 17 of charge a fishing license, a small and big game license, and a trap-18 19 ping license; and a resident who is blind is entitled to receive a fishing license free of charge. For the purposes of this subdivision a 20 person is blind only if either: (a) his or her central visual acuity 21 does not exceed 20/200 in the better eye with correcting lenses, or (b) 22

A resident in the state for a period of thirty days immediately prior to the date of application who has attained the age of seventy is entitled to receive a sportsman license at the cost of ten dollars as a license fee.

8 A resident in the state for a period of thirty days immediately prior 9 to the date of application who has attained the age of seventy is enti-10 tled to receive a fishing license, and a trapping license, at a cost of 11 five dollars for each license.

12 A resident in the state for a period of thirty days immediately prior 13 to the date of application who has attained the age of seventy is enti-14 tled to receive free of charge a bowhunting stamp and a muzzle-loading 15 stamp.

16 S 2. This act shall take effect immediately.
