AN ACT to amend the administrative code of the city of New York, in relation to suspending certain licenses for failure to answer appearance tickets or pay fines to the New York city taxi and limousine commission

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision b of section 19-528 of the administrative code  
2 of the city of New York is amended by adding a new paragraph 4 to read  
3 as follows:

4 4. TO NOTIFY THE COMMISSIONER OF MOTOR VEHICLES WHEN THE COMMISSION OR  
5 ADMINISTRATIVE TRIBUNAL THEREOF FINDS A PERSON HAS FAILED TO APPEAR  
6 WITHIN ONE HUNDRED AND TWENTY DAYS OF THE RETURN DATE OR A NEW SUBSE-  
7 QUENT AND ADJOURNED DATE, PURSUANT TO AN APPEARANCE TICKET CHARGING SUCH  
8 PERSON WITH A VIOLATION OF THIS TITLE, OR ANY RULE OR REGULATION PROMUL-  
9 GATED UNDER THIS TITLE, PROHIBITING THE OPERATION OF A TAXICAB OR LIVERY  
10 WITHOUT A LICENSE ISSUED BY THE COMMISSION OR WITH A LICENSE ISSUED BY  
11 THE COMMISSION WHICH HAS BEEN SUSPENDED OR REVOKED, OR THE FAILURE TO  
12 PAY A FINE IMPOSED BY THE COMMISSION. THE COMMISSIONER OF MOTOR VEHICLES  
13 OR HIS OR HER AGENT MAY SUSPEND THE DRIVER'S LICENSE OR PRIVILEGES OF  
14 SUCH PERSON AND REGISTRATION OF SUCH VEHICLE PENDING RECEIPT OF NOTICE  
15 FROM THE COMMISSION OR ADMINISTRATIVE TRIBUNAL THEREOF THAT SUCH PERSON  
16 HAS APPEARED IN RESPONSE TO SUCH APPEARANCE TICKET OR HAS PAID SUCH  
17 FINE. SUCH SUSPENSION SHALL TAKE EFFECT NO LESS THAN THIRTY DAYS FROM  
18 THE DAY UPON WHICH NOTICE THEREOF IS SENT BY SUCH COMMISSIONER TO THE  
19 PERSON WHOSE DRIVER'S LICENSE OR PRIVILEGES, OR WHOSE VEHICLE REGISTRA-  
20 TION ARE TO BE SUSPENDED.

21 S 2. This act shall take effect immediately.
