AN ACT to amend the vehicle and traffic law, in relation to authorizing distinctive license plates for recipients of the conspicuous service cross

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The vehicle and traffic law is amended by adding a new section 404-x to read as follows:

- S 404-X. DISTINCTIVE PLATES FOR CONSPICUOUS SERVICE CROSS RECIPIENTS. 1. ANY CONSPICUOUS SERVICE CROSS RECIPIENT RESIDING IN THIS STATE OR THE SUCH RECIPIENT SHALL, UPON REQUEST, BE ISSUED A LICENSE SPOUSE OF ANY PLATE BEARING THE WORDS "CONSPICUOUS SERVICE CROSS RECIPIENT". IS ISSUED TO A CONSPICUOUS SERVICE CROSS RECIPIENT DISTINCTIVE PLATE PURSUANT TO THIS SECTION, SUCH A DISTINCTIVE PLATE SHALL NOT THE SPOUSE OF SUCH CONSPICUOUS SERVICE CROSS RECIPIENT. APPLICATION FOR SAID LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.
- 2. THE DISTINCTIVE PLATE AUTHORIZED BY THIS SECTION SHALL BE UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE APPLICANT OR THE SPOUSE OF THE APPLICANT IS A CONSPICUOUS SERVICE CROSS RECIPIENT.
- 3. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THEREGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE; THAT AN ADDITIONAL, ONE-TIME SERVICE CHARGE OF TEN PROVIDED, HOWEVER, DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH ANNUAL SERVICE DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION FOUR HUNDRED 21 FOUR-OO OF THIS ARTICLE TO THE CREDIT OF THE DEPARTMENT OF MOTOR DISTINCTIVE DEVELOPMENT 22 CLES PLATE FUND ESTABLISHED BY SECTION 23 NINETY-FIVE-G OF THE STATE FINANCE LAW AND SHALL BEUSED FOR THE
