AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for hunting in Wyoming county; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907
2 of the environmental conservation law, as amended by section 11 of chap-
3 ter 483 of the laws of 2010, is amended to read as follows:

12 deemed repealed one year after such effective date; provided that the
13 amendments to item (i) of paragraph a of subdivision 2 of section
14 11-0907 of the environmental conservation law made by section one of
15 this act shall be subject to the expiration and reversion of such item
16 pursuant to section 13 of chapter 600 of the laws of 1993, as amended,
17 when upon such date the provisions of section two of this act shall take
18 effect.
