- AN ACT to amend the executive law, in relation to the fair treatment standards for crime victims

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The executive law is amended by adding a new section 645-a 2 to read as follows:
- 3 S 645-A. INFORMATION RELATIVE TO ORDERS OF PROTECTION. EVERY COURT 4 SHALL BE RESPONSIBLE FOR PROVIDING INFORMATION TO INDIVIDUALS CLERK 5 PETITIONING FOR EX PARTE ORDERS OF PROTECTION REGARDING NOTIFICATION OF ORDERS OF PROTECTION. SUCH NOTIFICATION TO THE PETIб SERVICE OF THESE 7 TIONER IS REQUIRED IF THE PETITIONER HAS REGISTERED A TELEPHONE NUMBER 8 THE STATE'S VICTIM NOTIFICATION SYSTEM, ESTABLISHED UNDER SUBDIVI-WITH 9 SION TWO OF SECTION TWO HUNDRED FIFTY-NINE-I OF THIS CHAPTER. THE PETI-TIONER SHALL BE INFORMED OF HIS OR HER OPTION TO RECEIVE NOTIFICATION OF 10 SERVICE OF AN EX PARTE ORDER OF PROTECTION OR SUMMONS ON THE RESPONDENT 11 BY THE COURT CLERK AND SHALL BE PROVIDED INFORMATION ON HOW 12 ТО RECEIVE 13 NOTIFICATION OF SERVICE OF EX PARTE ORDERS OF PROTECTION OR SUMMONS TO COURT. THE LOCAL LAW ENFORCEMENT AGENCY OR ANY OTHER GOVERNMENT 14 AGENCY FOR SERVING EX PARTE ORDERS OF PROTECTION OR SUMMONS TO 15 RESPONSIBLE 16 COURT SHALL RECORD THE SERVICE OF THESE ORDERS OF PROTECTION INTO A LAW 17 DATABASE, OR SIMILAR ELECTRONIC RECORD KEEPING SYSTEM, AT ENFORCEMENT 18 THE TIME WHEN SERVICE OCCURS. THE PROVISION OF THIS SECTION SHALL ONLY TO THOSE COURT CLERKS ABLE TO ACCESS A STATEWIDE VICTIM NOTIFICA-19 APPLY TION SYSTEM DESIGNED TO PROVIDE NOTIFICATION OF SERVICE 20 OF ORDERS OF 21 PROTECTION.
- 22 S 2. Subdivision 2 of section 646-a of the executive law is amended by 23 adding a new paragraph (h) to read as follows:

1 (H) THE RIGHTS OF CRIME VICTIMS TO BE PROVIDED WITH INFORMATION 2 REGARDING SERVICE OF EX PARTE ORDERS OF PROTECTION OR SUMMONS TO COURT 3 AS PROVIDED BY SECTION SIX HUNDRED FORTY-FIVE-A OF THIS ARTICLE.

4 S 3. This act shall take effect on the ninetieth day after it shall 5 have become a law. Effective immediately, the addition, amendment and/or 6 repeal of any rule or regulation necessary for the implementation of 7 this act on its effective date are authorized and directed to be made 8 and completed on or before such effective date.
