AN ACT to amend the public health law, in relation to the sharing of
information related to environmentally-related diseases

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (t) of subdivision 5 of section 225 of the public
2 health law, as added by chapter 351 of the laws of 1980, is amended to
3 read as follows:
4 (t) facilitate epidemiological research into the prevention of envi-
5 ronmental diseases, [when such research is conducted pursuant to para-
6 graph (j) of subdivision one of section two hundred six of this chap-
7 ter,] by establishing regulations designating as environmentally related
8 diseases those pathological conditions of the body or mind resulting
9 from contact with toxins, mutagens or teratogens in solid, liquid or
10 gaseous form, or in the form of ionizing radiation or nonionizing elec-
11 tromagnetic radiation, and by requiring the reporting of such diseases
12 or suspected cases of such diseases to the department by physicians,
13 medical facilities and clinical laboratories. Any information provided
14 to the department pursuant to such regulations shall be in the form
15 required by the department, and shall be kept confidential and used by
16 the commissioner pursuant to the provisions of paragraph (j) of subdivi-
17 sion one of section two hundred six of this chapter, and other applica-
18 ble laws relating to the confidential treatment of patient and medical
19 data, EXCEPT THAT THE DEPARTMENT MAY SHARE IDENTIFYING OR OTHER INFORMA-
20 TION WITH A LOCAL HEALTH DEPARTMENT WHEN, AND ONLY TO THE EXTENT THAT,
21 THE DEPARTMENT DETERMINES THIS INFORMATION IS NECESSARY TO PROTECT
22 PUBLIC HEALTH AGAINST THE HAZARDS ASSOCIATED WITH EXPOSURE TO THE MATE-
23 RIAL. DATA SHARED WITH THE LOCAL HEALTH DEPARTMENT SHALL NOT BE FURTHER
24 DISCLOSED AND SHALL BE OTHERWISE SUBJECT TO THE CONFIDENTIALITY REQUIRE-
