AN ACT to amend the public authorities law, in relation to creating the Albany county renewable energy authority

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Article 5 of the public authorities law is amended by
2 adding a new title 10-E to read as follows:

S 1233. SHORT TITLE. THIS TITLE MAY BE CITED AS THE "ALBANY COUNTY RENEWABLE ENERGY AUTHORITY ACT".

S 1234. DEFINITIONS. AS USED OR REFERRED TO IN THIS TITLE, UNLESS A DIFFERENT MEANING CLEARLY APPEARS FROM THE CONTEXT:

1. THE TERM "AUTHORITY" SHALL MEAN THE ALBANY COUNTY RENEWABLE ENERGY AUTHORITY CREATED BY SECTION TWELVE HUNDRED THIRTY-SIX OF THIS TITLE.

2. THE TERM "BONDS" SHALL MEAN BONDS, NOTES OR OTHER EVIDENCES OF INDEBTEDNESS ISSUED BY THE AUTHORITY PURSUANT TO THIS TITLE.

3. THE TERM "COMPTROLLER" SHALL MEAN THE COMPTROLLER OF THE STATE.

4. THE TERM "CIVIL SERVICE COMMISSION" SHALL MEAN THE CIVIL SERVICE COMMISSION OF THE COUNTY OF ALBANY.

5. THE TERM "COUNTY" SHALL MEAN THE COUNTY OF ALBANY.

6. THE TERM "DISTRICT" SHALL MEAN THE ALBANY COUNTY RENEWABLE ENERGY DISTRICT CREATED BY SECTION TWELVE HUNDRED THIRTY-FIVE OF THIS TITLE.

7. THE TERM "COUNTY LEGISLATURE" SHALL MEAN THE COUNTY LEGISLATURE OF THE COUNTY OF ALBANY.

8. THE TERM "COUNTY EXECUTIVE" SHALL MEAN THE COUNTY EXECUTIVE OF THE COUNTY OF ALBANY.

9. THE TERM "PROPERTIES" SHALL MEAN THE POWER DISTRIBUTION SYSTEM OR SYSTEMS OF THE AUTHORITY, WHETHER SITUATED WITHIN OR WITHOUT THE TERRITORIAL LIMITS OF THE DISTRICT, INCLUDING THE PRODUCTION FACILITIES, PLANTS, WORKS, STRUCTURES, POLES, LINES, CONDUITS, MAINS, SYSTEMS, INSTRUMENTALITIES OR PART THEREOF AND APPURTENANCES THERETO, LANDS, EASEMENTS, RIGHTS IN LAND AND WATER RIGHTS, RIGHTS-OF-WAY, CONTRACT RIGHTS, FRANCHISES, TRANSMISSION FACILITIES AND DISTRIBUTION FACILITIES, OR ANY OTHER PROPERTY INCIDENTAL TO AND INCLUDED IN SUCH SYSTEM OR PART THEREOF, AND ANY IMPROVEMENTS, EXTENSIONS OR BETTERMENTS.

10. THE TERM "MUNICIPALITIES" SHALL MEAN ANY COUNTY, CITY, TOWN, VILLAGE, SCHOOL DISTRICT, AND ANY OTHER POLITICAL SUBDIVISION OF THE STATE.

11. THE TERM "RENEWABLE ENERGY" SHALL MEAN ENERGY GENERATED BY SOLAR, WIND, HYDRO, GEOTHERMAL OR TIDAL.

12. THE TERM "REVENUES" SHALL MEAN ALL RATES, RENTS, FEES, CHARGES, PAYMENTS AND OTHER INCOME AND RECEIPTS DERIVED FROM THE OPERATION OF THE PROPERTIES OF THE AUTHORITY INCLUDING, BUT NOT LIMITED TO, INVESTMENT PROCEEDS AND PROCEEDS OF INSURANCE, CONDEMNATION, AND SALES OR OTHER DISPOSITION OF ASSETS, TOGETHER WITH ALL FEDERAL, STATE OR MUNICIPAL AID.

13. THE TERM "STATE" SHALL MEAN THE STATE OF NEW YORK.

S 1235. ALBANY COUNTY RENEWABLE ENERGY DISTRICT. THERE IS HEREBY DEFINED AND ESTABLISHED AN AREA TO BE KNOWN AS THE "ALBANY COUNTY RENEWABLE ENERGY DISTRICT," WHICH SHALL EMBRACE ALL THE TERRITORY LOCATED WITHIN THE COUNTY.

S 1236. ALBANY COUNTY RENEWABLE ENERGY AUTHORITY. 1. THERE IS HEREBY CREATED AND ESTABLISHED A PUBLIC CORPORATION, TO BE KNOWN AS THE "ALBANY COUNTY RENEWABLE ENERGY AUTHORITY". THE AUTHORITY SHALL BE A BODY CORPORATE AND POLITIC CONSTITUTING A PUBLIC BENEFIT CORPORATION, THE

1 OBJECTS OF WHICH IN THE JUDGMENT OF THE LEGISLATURE CANNOT BE ATTAINED
2 UNDER GENERAL LAWS.

3 2. THE AUTHORITY SHALL HAVE THE POWER TO ACQUIRE SUCH REAL ESTATE AND
4 OTHER PROPERTY AS MAY BE NECESSARY FOR ITS CORPORATE PURPOSES, TO SUE
5 AND BE SUED, TO INCUR DEBTS, LIABILITIES AND OBLIGATIONS, TO ISSUE BONDS
6 AND OTHER EVIDENCES OF INDEBTEDNESS, TO HAVE A SEAL, AND TO EXERCISE ALL
7 POWERS AUTHORIZED BY THIS TITLE AND REASONABLY NECESSARY FOR ACCOMPLISH-
8 ING ITS PURPOSES, OR PROPERLY INCIDENTAL THERETO, SUBJECT TO THE
9 PROVISIONS HEREIN CONTAINED AND TO THE CONSTITUTION AND LAWS OF THE
10 UNITED STATES AND OF THE STATE.

11 3. THE AUTHORITY AND ITS EXISTENCE SHALL CONTINUE FOR A PERIOD OF
12 TWELVE YEARS AND THEREAFTER UNTIL ALL ITS LIABILITIES HAVE BEEN MET AND
13 ITS BONDS HAVE BEEN PAID IN FULL OR SUCH LIABILITIES AND BONDS HAVE
14 OTHERWISE BEEN DISCHARGED AND THEREUPON ALL RIGHTS AND PROPERTIES OF THE
15 AUTHORITY THEN REMAINING SHALL PASS TO AND BE VESTED IN THE COUNTY.

16 4. THE AUTHORITY SHALL CONSIST OF FIVE MEMBERS, TO BE RESIDENTS OF THE
17 COUNTY AND BE APPOINTED BY THE COUNTY EXECUTIVE WITH THE ADVICE AND
18 CONSENT OF THE COUNTY LEGISLATURE. THE TERM OF OFFICE OF A MEMBER SHALL
19 BE FIVE YEARS, BUT IN THE FIRST INSTANCE SUCH MEMBERS SHALL BE APPOINTED
20 TO HOLD OFFICE, ONE FOR ONE YEAR, ONE FOR TWO YEARS, ONE FOR THREE
21 YEARS, ONE FOR FOUR YEARS AND ONE FOR FIVE YEARS, THE TERM OF EACH TO BE
22 FIXED BY THE RESOLUTION MAKING THE APPOINTMENT. UPON RESIGNATION OF A
23 MEMBER, OR A VACANCY OCCURRING IN ANY OTHER MANNER, IT SHALL BE FILLED
24 BY APPOINTMENT FOR THE UNEXPIRED TERM. IN OTHER RESPECTS, ALL VACANCIES
25 SHALL BE FILLED IN THE MANNER CORRESPONDING TO THE ORIGINAL APPOINTMENT.

26 5. THE MEMBERS OF THE AUTHORITY MAY APPOINT AN EXECUTIVE COMMITTEE OF
27 NOT LESS THAN THREE MEMBERS AND MAY DELEGATE FULL POWERS TO SUCH COMMIT-
28 TEE. THEY MAY APPOINT SUCH OTHER COMMITTEES OF NOT LESS THAN THREE
29 MEMBERS EACH WITH SUCH POWERS AS THEY MAY PROVIDE. THEY MAY ELECT ONE OF
30 THE MEMBERS AS A CHAIRPERSON AND MAY ELECT OR APPOINT OTHER OFFICERS AND
31 DETERMINE THEIR POWERS. THEY MAY BY A VOTE OF A MAJORITY OF MEMBERS
32 ADOPT BY-LAWS AND PROVIDE FOR THEIR ANNUAL AND REGULAR MEETINGS AND FOR
33 THE CALLING OF SPECIAL MEETINGS. THE TREASURER OF THE COUNTY SHALL BE
34 EX-OFFICIO TREASURER OF THE AUTHORITY. EACH MEMBER BEFORE ENTERING UPON
35 THE DUTIES OF HIS OR HER OFFICE SHALL TAKE THE CONSTITUTIONAL OATH OF
36 OFFICE, WHICH SHALL BE FILED IN THE OFFICE OF THE SECRETARY OF STATE.
37 THREE MEMBERS SHALL CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS
38 AND THE CONCURRENCE OF THREE MEMBERS AT A MEETING SHALL BE NECESSARY TO
39 THE VALIDITY OF ANY RESOLUTION, ORDER OR DETERMINATION. ANY MEMBER MAY
40 BE REMOVED BY THE COUNTY EXECUTIVE FOR INEFFICIENCY, NEGLECT OF DUTY OR
41 MISCONDUCT IN OFFICE, AFTER A HEARING UPON CHARGES AND AN OPPORTUNITY TO
42 BE HEARD IN PERSON OR BY COUNSEL UPON NOT LESS THAN TEN DAYS' NOTICE.
43 THE MEMBERS SHALL SERVE WITHOUT COMPENSATION.

44 6. NO PUBLIC OFFICER OR EMPLOYEE SHALL BE INELIGIBLE FOR APPOINTMENT
45 AS A MEMBER OR OFFICER OF THE AUTHORITY AND ANY PUBLIC OFFICER OR
46 EMPLOYEE MAY ACCEPT SUCH APPOINTMENT AND SERVE AS A MEMBER OR OFFICER
47 WITHOUT FORFEITURE OF ANY OTHER PUBLIC OFFICE OR POSITION OF PUBLIC
48 EMPLOYMENT BY REASON THEREOF. ANY ONE OR MORE MEMBERS OR OFFICERS OF THE
49 AUTHORITY MAY BE AN OFFICER OR EMPLOYEE OF THE COUNTY. IN THE EVENT THAT
50 AN OFFICER OR EMPLOYEE OF THE COUNTY SHALL BE APPOINTED AS A MEMBER OR
51 OFFICER OF THE AUTHORITY, ACCEPTANCE OR RETENTION OF SUCH APPOINTMENT
52 SHALL NOT BE DEEMED A FORFEITURE OF HIS OR HER COUNTY OFFICE OR EMPLOY-
53 MENT, OR INCOMPATIBLE THERewith OR AFFECT HIS OR HER TENURE OR COMPEN-
54 SATION IN ANY WAY.

55 7. IT IS HEREBY DETERMINED AND DECLARED THAT THE AUTHORITY AND THE
56 CARRYING OUT OF ITS POWERS, PURPOSES AND DUTIES ARE IN ALL RESPECTS FOR

1 THE BENEFIT OF THE PEOPLE OF THE COUNTY AND THE STATE OF NEW YORK, AND
2 THAT SAID PURPOSES ARE PUBLIC PURPOSES AND THAT THE AUTHORITY IS AND
3 WILL BE PERFORMING AN ESSENTIAL GOVERNMENTAL FUNCTION IN THE EXERCISE OF
4 THE POWERS CONFERRED UPON IT BY THIS TITLE.

5 8. NEITHER THE PUBLIC SERVICE COMMISSION NOR ANY OTHER BOARD OR
6 COMMISSION OF LIKE CHARACTER, SHALL HAVE JURISDICTION OVER THE AUTHORITY
7 IN THE MANAGEMENT AND CONTROL OF ITS PROPERTIES OR OPERATIONS OR ANY
8 POWER OVER THE REGULATION OF RATES FIXED OR CHARGES COLLECTED BY THE
9 AUTHORITY EXCEPT AS OTHERWISE PROVIDED IN THIS SUBDIVISION.

10 (A) THE AUTHORITY'S RATES, SERVICES AND PRACTICES WITH RESPECT TO
11 POWER AND ENERGY PURCHASED FROM THE POWER AUTHORITY OF THE STATE OF NEW
12 YORK SHALL BE SUBJECT TO REGULATION BY SUCH POWER AUTHORITY PURSUANT TO
13 THE PROVISIONS OF THE POWER AUTHORITY ACT AND ANY CONTRACT BETWEEN THE
14 TWO AUTHORITIES.

15 (B) THE AUTHORITY'S RATES, SERVICES AND PRACTICES WITH RESPECT TO
16 POWER AND ENERGY THAT IS EITHER (I) GENERATED OR PRODUCED BY A FACILITY
17 OWNED, OPERATED OR MANAGED BY THE AUTHORITY, OR (II) PURCHASED BY THE
18 AUTHORITY FROM SOURCES OTHER THAN THE POWER AUTHORITY OF THE STATE OF
19 NEW YORK SHALL BE SUBJECT TO REGULATIONS OF THE PUBLIC SERVICE COMMIS-
20 SION UNDER THE PROVISIONS OF THE PUBLIC SERVICE LAW.

21 S 1237. POWERS OF THE AUTHORITY. THE POWER CONFERRED BY THIS TITLE
22 SHALL BE EXERCISED BY THE MEMBERS OF THE AUTHORITY, SUBJECT TO THE TERMS
23 OF THIS TITLE. IN THE EXERCISE OF THOSE POWERS, EITHER DIRECTLY OR
24 THROUGH ITS OFFICERS AND EMPLOYEES, THE MEMBERS MAY DO THE FOLLOWING
25 THINGS, AMONG OTHERS, AND THE FOLLOWING LIST OF POWERS SHALL NOT BE
26 DEEMED COMPLETE OR EXCLUSIVE, OR TO DENY THE EXISTENCE OF OTHER POWERS,
27 WHETHER SIMILAR OR DIFFERENT, SO LONG AS THEY ARE REASONABLY NECESSARY
28 FOR ACCOMPLISHING THE PURPOSES DECLARED AND INDICATED IN THIS TITLE:

29 1. TO DETERMINE THE LOCATION, TYPE, SIZE, CONSTRUCTION, LEASE,
30 PURCHASE, OWNERSHIP, ACQUISITION, USE AND OPERATION OF ANY GENERATION,
31 TRANSMISSION OR DISTRIBUTION FACILITIES OR OTHER STRUCTURES OR PROPER-
32 TIES, WITHIN OR WITHOUT THE TERRITORIAL LIMITS OF THE DISTRICT;

33 2. TO ACQUIRE ON BEHALF AND IN THE NAME OF THE AUTHORITY, WHETHER BY
34 AGREEMENT WITH AND PURCHASE FROM THE OWNER OR OWNERS, OR WITHIN THE
35 DISTRICT BY EMINENT DOMAIN, OR BY LEASE, THE WHOLE OR ANY PART OF ANY
36 EXISTING FACILITIES OR OF ANY OTHER PROPERTY WHICH IT IS AUTHORIZED TO
37 ACQUIRE UNDER THIS TITLE; PROVIDED, HOWEVER, THAT THE AUTHORITY MAY NOT
38 ACQUIRE REAL PROPERTY OF A MUNICIPALITY OR A POLITICAL SUBDIVISION OF
39 THE STATE UNLESS SUCH MUNICIPALITY OR POLITICAL SUBDIVISION SHALL
40 CONSENT THERETO; AND IN CONNECTION WITH THE PURCHASE OF SUCH PROPERTIES
41 THE AUTHORITY MAY ASSUME ANY OBLIGATIONS OF THE OWNER OF SUCH PROPERTIES
42 AND, TO THE EXTENT REQUIRED BY THE TERMS OF ANY INDENTURES OR OTHER
43 INSTRUMENTS UNDER WHICH SUCH OBLIGATIONS WERE ISSUED, THE AUTHORITY MAY
44 ASSUME AND AGREE TO PERFORM COVENANTS AND OBSERVE RESTRICTIONS CONTAINED
45 IN SUCH INSTRUMENTS; AND FURTHERMORE THE OWNER OF ANY PROPERTIES, WHICH
46 THE AUTHORITY IS AUTHORIZED TO ACQUIRE, IS HEREBY AUTHORIZED TO SELL OR
47 OTHERWISE TRANSFER THE SAME TO THE AUTHORITY. IN THE EXERCISE OF THE
48 POWER OF EMINENT DOMAIN, AS HEREIN PROVIDED, THE PROPERTY BEING ACQUIRED
49 SHALL BE DEEMED, WHEN SO DETERMINED BY THE AUTHORITY, TO BE FOR A PUBLIC
50 USE;

51 3. TO DEVELOP, ACQUIRE, CONSTRUCT, RECONSTRUCT, REHABILITATE AND
52 IMPROVE FACILITIES FOR THE PRODUCTION, TRANSMISSION OR DISTRIBUTION OF
53 LIGHT, HEAT, POWER OR ANY CONNECTED SERVICE;

54 4. TO MAINTAIN, OPERATE AND MANAGE, AND CONTRACT FOR THE MAINTENANCE,
55 OPERATION AND MANAGEMENT OF PROPERTIES OF THE AUTHORITY;

1 5. TO APPLY TO THE APPROPRIATE AGENCIES AND OFFICIALS OF THE FEDERAL,
2 STATE AND LOCAL GOVERNMENTS FOR SUCH LICENSES, PERMITS OR APPROVALS FOR
3 ITS PLANS AND PROJECTS AS IT MAY DEEM NECESSARY OR ADVISABLE, AND UPON
4 SUCH TERMS AND CONDITIONS AS IT MAY DEEM APPROPRIATE TO ACCEPT, IN ITS
5 DISCRETION, SUCH LICENSES, PERMITS OR APPROVALS AS MAY BE TENDERED TO IT
6 BY SUCH AGENCIES AND OFFICIALS;

7 6. TO ENTER UPON SUCH LANDS, WATERS OR PREMISES AS IN THE JUDGMENT OF
8 THE AUTHORITY SHALL BE NECESSARY FOR THE PURPOSE OF MAKING SURVEYS,
9 SOUNDINGS, BORINGS AND EXAMINATIONS TO ACCOMPLISH ANY PURPOSE AUTHORIZED
10 BY THIS TITLE, THE AUTHORITY BEING LIABLE ONLY FOR ACTUAL DAMAGES DONE;

11 7. SUBJECT TO ITS AGREEMENT WITH THE COUNTY, TO GENERATE, SUPPLY AND
12 SELL LIGHT, HEAT AND POWER AND ANY CONNECTED SERVICES WITHIN THE
13 DISTRICT, TO FIX RATES AND CHARGES FOR THE FURNISHING OR RENDITION OF
14 LIGHT, HEAT OR POWER OR OF ANY CONNECTED SERVICE, AND TO COLLECT THROUGH
15 BILLS THEREFOR THE REVENUES DERIVED THEREFROM, SO AS TO PROVIDE REVENUES
16 TO THE AUTHORITY SUFFICIENT AT ALL TIMES TO PAY, AS THE SAME SHALL
17 BECOME DUE, THE PRINCIPAL OF AND INTEREST ON THE BONDS OF THE AUTHORITY
18 TOGETHER WITH THE MAINTENANCE OF PROPER RESERVES THEREFOR, IN ADDITION
19 TO PAYING AS THE SAME SHALL BECOME DUE THE EXPENSE OF OPERATING AND
20 MAINTAINING THE PROPERTIES OF THE AUTHORITY TOGETHER WITH PROPER
21 RESERVES FOR MAINTENANCE, CONTINGENCIES AND ALL OTHER OBLIGATIONS AND
22 INDEBTEDNESS OF THE AUTHORITY;

23 8. TO ADOPT, REVISE AND AMEND BYLAWS FOR THE MANAGEMENT OF ITS AFFAIRS
24 AND, SUBJECT TO AGREEMENTS WITH BONDHOLDERS, RULES FOR THE SALE OF
25 LIGHT, HEAT OR POWER OR OF ANY CONNECTED SERVICE, AND THE COLLECTION OF
26 RATES AND CHARGES THEREFOR. A COPY OF SUCH RULES AND BYLAWS, AND ALL
27 AMENDMENTS THERETO, DULY CERTIFIED BY THE SECRETARY OF THE AUTHORITY,
28 SHALL BE FILED IN THE OFFICE OF THE COUNTY CLERK;

29 9. TO ENTER INTO COOPERATIVE AGREEMENTS WITH OTHER AUTHORITIES, MUNI-
30 CIPALITIES, UTILITY COMPANIES, INDIVIDUALS, FIRMS, COOPERATIVES OR
31 CORPORATIONS FOR THE INTERCONNECTION OF FACILITIES AND THE EXCHANGE OR
32 INTERCHANGE OF SERVICES AND COMMODITIES, UPON SUCH TERMS AND CONDITIONS
33 AS SHALL BE DETERMINED TO BE REASONABLE;

34 10. TO EXECUTE CONTRACTS, BORROW MONEY, ISSUE BONDS AND SELL OR
35 DISPOSE OF THE SAME IN SUCH AMOUNTS AND AT SUCH RATES OF INTEREST AS MAY
36 BE ADVISABLE;

37 11. TO APPOINT AND REMOVE A SECRETARY AND SUCH CLERICAL, ENGINEERING,
38 LEGAL AND OTHER PROFESSIONAL ASSISTANTS AS IT MAY DEEM NECESSARY FOR THE
39 PURPOSES OF THIS TITLE AND TO FIX THEIR COMPENSATION, SUBJECT TO THE
40 PROVISIONS OF THE CIVIL SERVICE LAW;

41 12. TO APPOINT AND REMOVE ALL EMPLOYEES, TO TRANSFER EMPLOYEES FROM
42 THEIR POSITIONS TO OTHER POSITIONS AND TO CONSOLIDATE OR ABOLISH SUCH
43 POSITIONS, SUBJECT TO THE PROVISIONS OF THE CIVIL SERVICE LAW;

44 13. TO MAKE ANY PLANS, STUDIES OR INVESTIGATION WHICH IT MAY DEEM
45 NECESSARY, CONVENIENT OR DESIRABLE TO ENABLE IT EFFECTUALLY TO CARRY OUT
46 THE PROVISIONS OF THIS TITLE;

48 ANY CONNECTED SERVICE, TO PROMULGATE REGULATIONS GRANTING TO RESIDENTIAL
49 CUSTOMERS, THE PROTECTIONS AFFORDED BY ARTICLE TWO OF THE PUBLIC SERVICE
50 LAW AND SECTION ONE HUNDRED THIRTY-ONE-S OF THE SOCIAL SERVICES LAW; AND

51 15. TO DO WHATEVER MAY BE NECESSARY TO GIVE EFFECT TO THE PURPOSES OF
52 THIS TITLE, AND IN GENERAL TO HAVE AND EXERCISE ALL OTHER POWERS NECES-
53 SARY OR INCIDENTAL TO THE PURPOSES OF THIS TITLE.

54 S 1238. POWER TO FURNISH SERVICE WITHIN DISTRICT. THE AUTHORITY SHALL
55 HAVE POWER TO CONSTRUCT OR ACQUIRE, AND TO EQUIP, OWN AND OPERATE, WITH-
56 IN OR WITHOUT THE TERRITORIAL LIMITS OF THE DISTRICT, ANY PROPERTIES AND

1 ANY AND ALL OTHER REAL AND PERSONAL PROPERTY, USED, CONNECTED WITH OR
2 APPERTAINING TO THE GENERATION, FURNISHING AND TRANSMISSION OF ELECTRIC

7 OR FROM ANY MUNICIPALITY OR COOPERATIVE, OR FROM ANY PRIVATE OR PUBLIC
8 CORPORATION.

9 S 1239. SALE OF SURPLUS. WHENEVER ANY ELECTRICAL ENERGY WHICH THE
10 AUTHORITY MAY GENERATE OR ACQUIRE CREATES A SURPLUS OVER THE AMOUNT OF
11 LIGHT, HEAT AND POWER, IN ANY OF SUCH SERVICES, REQUIRED BY THE RESI-
12 DENTS OF THE DISTRICT TO WHICH SUCH SERVICE IS CONTRACTED, THE AUTHORITY
13 MAY SELL SUCH SURPLUS IN TERRITORY OUTSIDE THE DISTRICT TO PERSONS OR
14 PUBLIC OR PRIVATE CORPORATIONS. IN ACQUIRING ANY FACILITY OR PROPERTY
15 WHICH ALSO SERVES ANY MUNICIPALITY OR TERRITORY OUTSIDE THE DISTRICT,
16 THE AUTHORITY, IF IT DEEMS IT ADVANTAGEOUS AND ECONOMICAL SO TO DO, MAY,
17 WITH THE CONSENT OF THE MEMBERS OF THE AUTHORITY, SERVE ANY SUCH MUNICI-
18 PALITY OR TERRITORY OR SELL HEAT, POWER OR ELECTRICAL ENERGY TO PERSONS,
19 PUBLIC OR PRIVATE CORPORATIONS IN SUCH TERRITORY OR TO SUCH MUNICI-
20 PALITY.

21 S 1240. BONDS AND NOTES OF THE AUTHORITY. 1. THE AUTHORITY SHALL HAVE
22 THE POWER AND IS HEREBY AUTHORIZED FROM TIME TO TIME TO ISSUE BONDS IN
23 CONFORMITY WITH APPLICABLE PROVISIONS OF THE UNIFORM COMMERCIAL CODE FOR
24 ANY OF ITS CORPORATE PURPOSES, INCLUDING INCIDENTAL EXPENSES IN
25 CONNECTION THEREWITH, AND TO SECURE THE PAYMENT OF THE SAME BY THE
26 PLEDGE OF THE REVENUES OF THE AUTHORITY OR BY LIEN ON THE PROPERTY OF
27 THE AUTHORITY. THE AUTHORITY SHALL HAVE POWER FROM TIME TO TIME WHENEVER
28 IT DEEMS REFUNDING EXPEDIENT, TO REFUND ANY BONDS BY THE ISSUANCE OF NEW
29 BONDS, WHETHER THE BONDS TO BE REFUNDED HAVE OR HAVE NOT MATURED, AND
30 MAY ISSUE BONDS PARTLY TO REFUND BONDS THEN OUTSTANDING AND PARTLY FOR
31 ANY OF ITS CORPORATE PURPOSES. BONDS ISSUED BY THE AUTHORITY MAY BE
32 GENERAL OBLIGATIONS SECURED BY THE FAITH AND CREDIT OF THE AUTHORITY OR
33 MAY BE SPECIAL OBLIGATIONS PAYABLE OUT OF PARTICULAR REVENUES OR OTHER
34 MONEYS OF THE AUTHORITY AS MAY BE DESIGNATED IN THE PROCEEDINGS OF THE
35 AUTHORITY UNDER WHICH THE BONDS SHALL BE AUTHORIZED TO BE ISSUED,
36 SUBJECT ONLY TO ANY AGREEMENTS WITH THE HOLDERS OF OUTSTANDING BONDS
37 PLEDGING ANY PARTICULAR MONEYS, EARNINGS OR REVENUES.

38 2. THE AUTHORITY IS AUTHORIZED TO OBTAIN FROM ANY DEPARTMENT OR AGENCY
39 OF THE UNITED STATES OF AMERICA OR THE STATE OR ANY NONGOVERNMENTAL
40 INSURER OR FINANCIAL INSTITUTION ANY INSURANCE, GUARANTY OR OTHER CREDIT
41 SUPPORT DEVICE, TO THE EXTENT NOW OR HEREAFTER AVAILABLE, AS TO, OR FOR
42 THE PAYMENT OR REPAYMENT OF INTEREST OR PRINCIPAL, OR BOTH, OR ANY PART
43 THEREOF, ON ANY BONDS ISSUED BY THE AUTHORITY AND TO ENTER INTO ANY
44 AGREEMENT OR CONTRACT WITH RESPECT TO ANY SUCH INSURANCE OR GUARANTY,
45 EXCEPT TO THE EXTENT THAT THE SAME WOULD IN ANY WAY IMPAIR OR INTERFERE
46 WITH THE ABILITY OF THE AUTHORITY TO PERFORM AND FULFILL THE TERMS OF
47 ANY AGREEMENT MADE WITH THE HOLDERS OF OUTSTANDING BONDS OF THE AUTHORI-
48 TY.

49 3. THE BONDS SHALL BE AUTHORIZED BY RESOLUTION OF THE AUTHORITY AND
50 SHALL BEAR SUCH DATE OR DATES, MATURE AT SUCH TIME OR TIMES, EXCEPT THAT
51 BONDS AND ANY RENEWAL THEREOF SHALL MATURE WITHIN FORTY YEARS OF THE
52 DATE OF THEIR ORIGINAL ISSUANCE AND NOTES AND ANY RENEWAL THEREOF SHALL
53 MATURE WITHIN FIVE YEARS OF THE DATE OF THEIR ORIGINAL ISSUANCE, BEAR
54 INTEREST AT SUCH RATE OR RATES PER ANNUM PAYABLE AT SUCH TIMES, BE IN
55 SUCH DENOMINATIONS, BE IN SUCH FORM, CARRY SUCH REGISTRATION PRIVILEGES,
56 BE EXECUTED IN SUCH MANNER, BE PAYABLE IN SUCH MEDIUM OF PAYMENT AT SUCH

1 PLACE OR PLACES AND BE SUBJECT TO SUCH TERMS AND CONDITIONS, AS SUCH
2 RESOLUTION OR RESOLUTIONS MAY PROVIDE. SUCH BONDS OF THE AUTHORITY MAY
3 BE SOLD AT PUBLIC OR PRIVATE SALE FOR SUCH PRICE OR PRICES AS THE
4 AUTHORITY SHALL DETERMINE, PROVIDED THAT NO ISSUE OF BONDS MAY BE SOLD
5 AT PRIVATE SALE UNLESS THE TERMS OF SUCH SALE SHALL HAVE BEEN APPROVED
6 IN WRITING BY (A) THE COMPTROLLER, WHERE SUCH SALE IS NOT TO SUCH COMP-
7 TROLLER, OR (B) THE DIRECTOR OF THE BUDGET, WHERE SUCH SALE IS TO SUCH
8 COMPTROLLER. THE FOREGOING PROVISIONS SHALL BE APPLICABLE TO BONDS
9 ISSUED BY THE AUTHORITY NOTWITHSTANDING THE PROVISIONS OF ANY OTHER
10 GENERAL, SPECIAL OR LOCAL LAW TO THE CONTRARY.

11 4. ANY RESOLUTION OR RESOLUTIONS OF THE AUTHORITY AUTHORIZING ANY
12 BONDS OR ANY ISSUE OF BONDS MAY CONTAIN PROVISIONS, WHICH MAY BE A PART
13 OF THE CONTRACT WITH THE HOLDERS OF THE BONDS THEREBY AUTHORIZED, AS TO:

14 (A) PLEDGING ALL OR ANY PART OF THE REVENUES OF THE AUTHORITY, TOGETH-
15 ER WITH ANY OTHER MONEYS, SECURITIES, CONTRACTS OR PROPERTY OF THE
16 AUTHORITY TO SECURE THE PAYMENT OF THE BONDS OR OF ANY ISSUE OF THE
17 BONDS, SUBJECT TO SUCH AGREEMENTS WITH BONDHOLDERS AS MAY THEN EXIST;

18 (B) THE RATES, RENTALS, FEES AND OTHER CHARGES TO BE FIXED AND
19 COLLECTED AND THE AMOUNTS TO BE RAISED IN EACH YEAR THEREBY, AND THE USE
20 AND DISPOSITION OF THE EARNINGS AND OTHER REVENUES;

21 (C) THE SETTING ASIDE OF RESERVES AND THE CREATION OF SINKING FUNDS
22 AND THE REGULATION AND DISPOSITION THEREOF;

23 (D) LIMITATIONS ON THE RIGHT OF THE AUTHORITY TO RESTRICT AND REGULATE
24 THE USE OF THE PROPERTIES IN CONNECTION WITH WHICH SUCH BONDS ARE
25 ISSUED;

26 (E) LIMITATIONS IN THE PURPOSES TO WHICH THE PROCEEDS OF SALE OF ANY
27 ISSUE OF BONDS MAY BE APPLIED AND PLEDGING SUCH PROCEEDS TO SECURE THE
28 PAYMENT OF THE BONDS OR ANY ISSUE OF THE BONDS;

29 (F) LIMITATIONS ON THE ISSUANCE OF ADDITIONAL BONDS, THE TERMS UPON
30 WHICH ADDITIONAL BONDS MAY BE ISSUED AND SECURED AND THE REFUNDING OF
31 OUTSTANDING OR OTHER BONDS;

32 (G) THE PROCEDURE, IF ANY, BY WHICH THE TERMS OF ANY CONTRACT WITH
33 BONDHOLDERS MAY BE AMENDED OR ABROGATED, INCLUDING THE PROPORTION OF
34 BONDHOLDERS WHICH MUST CONSENT THERETO AND THE MANNER IN WHICH SUCH
35 CONSENT MAY BE GIVEN;

36 (H) THE CREATION OF SPECIAL FUNDS INTO WHICH ANY REVENUES OR OTHER
37 MONEYS OF THE AUTHORITY MAY BE DEPOSITED;

38 (I) THE TERMS AND PROVISIONS OF ANY MORTGAGE OR TRUST DEED OR INDEN-
39 TURE SECURING THE BONDS OR UNDER WHICH BONDS MAY BE ISSUED;

40 (J) VESTING IN A TRUSTEE OR TRUSTEES SUCH PROPERTIES, RIGHTS, POWERS
41 AND DUTIES IN TRUST AS THE AUTHORITY MAY DETERMINE, WHICH MAY INCLUDE
42 ANY OR ALL OF THE RIGHTS, POWERS AND DUTIES OF THE TRUSTEE APPOINTED BY
43 THE BONDHOLDERS PURSUANT TO SECTION TWELVE HUNDRED FORTY-ONE OF THIS
44 TITLE, AND LIMITING OR ABROGATING THE RIGHT OF THE BONDHOLDERS TO
45 APPOINT A TRUSTEE UNDER SUCH SECTION OR LIMITING THE RIGHTS, DUTIES AND
46 POWERS OF SUCH TRUSTEE;

47 (K) DEFINING THE ACTS OR OMISSIONS TO ACT WHICH MAY CONSTITUTE A
48 DEFAULT IN THE OBLIGATIONS AND DUTIES OF THE AUTHORITY TO THE BONDHOLD-
49 ERS AND PROVIDING FOR THE RIGHTS AND REMEDIES OF THE BONDHOLDERS IN THE
50 EVENT OF SUCH DEFAULT, INCLUDING AS A MATTER OF RIGHT THE APPOINTMENT OF
51 A RECEIVER, PROVIDED, HOWEVER, THAT SUCH RIGHTS AND REMEDIES SHALL NOT

54 (L) LIMITATIONS ON THE POWER OF THE AUTHORITY TO SELL OR OTHERWISE
55 DISPOSE OF ITS PROPERTIES OR ANY PART THEREOF;

1 (M) LIMITATIONS ON THE AMOUNT OF MONEYS OR REVENUES TO BE EXPENDED FOR
2 OPERATING, ADMINISTRATIVE OR OTHER EXPENSES OF THE AUTHORITY;

3 (N) THE PAYMENT OF THE PROCEEDS OF BONDS, REVENUES AND OTHER MONEYS TO
4 A TRUSTEE OR OTHER DEPOSITARY, AND FOR THE METHOD OF DISBURSEMENT THERE-
5 OF WITH SUCH SAFEGUARDS AND RESTRICTIONS AS THE AUTHORITY MAY DETERMINE;
6 AND

7 (O) ANY OTHER MATTERS, OF LIKE OR DIFFERENT CHARACTER, WHICH MAY IN
8 ANY WAY AFFECT THE SECURITY OR PROTECTION OF THE BONDS OR THE RIGHTS AND
9 REMEDIES OF BONDHOLDERS.

10 5. IN ADDITION TO THE POWERS HEREIN CONFERRED UPON THE AUTHORITY TO
11 SECURE ITS BONDS, THE AUTHORITY SHALL HAVE POWER IN CONNECTION WITH THE
12 ISSUANCE OF BONDS TO ENTER INTO SUCH AGREEMENTS AS THE AUTHORITY MAY
13 DEEM NECESSARY, CONVENIENT OR DESIRABLE CONCERNING THE USE OR DISPOSI-
14 TION OF ITS REVENUES OR OTHER MONEYS OR PROPERTY, INCLUDING THE MORTGAG-
15 ING OF ANY OF ITS PROPERTIES AND THE ENTRUSTING, PLEDGING OR CREATION OF
16 ANY OTHER SECURITY INTEREST IN ANY SUCH REVENUES, MONEYS OR PROPERTIES

19 MENTS. THE AUTHORITY SHALL HAVE POWER TO ENTER INTO AMENDMENTS OF ANY
20 SUCH AGREEMENTS WITHIN THE POWERS GRANTED TO THE AUTHORITY BY THIS TITLE
21 AND TO PERFORM SUCH AGREEMENTS. THE PROVISIONS OF ANY SUCH AGREEMENTS
22 MAY BE MADE A PART OF THE CONTRACT WITH THE HOLDERS OF BONDS OF THE
23 AUTHORITY.

24 6. ANY PROVISION OF THE UNIFORM COMMERCIAL CODE TO THE CONTRARY
25 NOTWITHSTANDING, ANY PLEDGE OF OR OTHER SECURITY INTEREST IN REVENUES,
26 MONEYS, ACCOUNTS, CONTRACT RIGHTS, GENERAL INTANGIBLES OR OTHER PERSONAL
27 PROPERTY MADE OR CREATED BY THE AUTHORITY SHALL BE VALID, BINDING AND
28 PERFECTED FROM THE TIME WHEN SUCH PLEDGE IS MADE OR OTHER SECURITY
29 INTEREST ATTACHES WITHOUT ANY PHYSICAL DELIVERY OF THE COLLATERAL OR
30 FURTHER ACT, AND THE LIEN OF ANY SUCH PLEDGE OR OTHER SECURITY INTEREST
31 SHALL BE VALID, BINDING AND PERFECTED AGAINST ALL PARTIES HAVING CLAIMS
32 OF ANY KIND IN TORT, CONTRACT OR OTHERWISE AGAINST THE AUTHORITY IRRE-
33 SPECTIVE OF WHETHER OR NOT SUCH PARTIES HAVE NOTICE THEREOF. NEITHER THE
34 RESOLUTION NOR ANY OTHER INSTRUMENT BY WHICH SUCH PLEDGE OR SECURITY
35 INTEREST IS CREATED NOR ANY FINANCING STATEMENT RELATING THERETO NEED BE
36 RECORDED OR FILED.

37 7. WHETHER OR NOT THE BONDS OF THE AUTHORITY ARE OF SUCH FORM AND
38 CHARACTER AS TO BE NEGOTIABLE INSTRUMENTS UNDER THE TERMS OF THE UNIFORM
39 COMMERCIAL CODE, THE BONDS ARE HEREBY MADE NEGOTIABLE INSTRUMENTS WITHIN
40 THE MEANING OF AND FOR ALL PURPOSES OF THE UNIFORM COMMERCIAL CODE,
41 SUBJECT ONLY TO THE PROVISIONS OF THE BONDS FOR REGISTRATION.

42 8. NEITHER THE MEMBERS NOR OFFICERS OF THE AUTHORITY, NOR ANY PERSON
43 EXECUTING THE BONDS SHALL BE LIABLE PERSONALLY ON THE BONDS OR BE
44 SUBJECT TO ANY PERSONAL LIABILITY OR ACCOUNTABILITY BY REASON OF THE
45 ISSUANCE THEREOF.

46 9. THE AUTHORITY, SUBJECT TO SUCH AGREEMENTS WITH BONDHOLDERS AS THEN
47 MAY EXIST, SHALL HAVE POWER OUT OF ANY FUNDS AVAILABLE THEREFOR TO
48 PURCHASE BONDS OF THE AUTHORITY, WHICH SHALL THEREUPON BE CANCELLED.

49 10. THE AUTHORITY SHALL HAVE POWER AND IS HEREBY AUTHORIZED TO ISSUE
50 NEGOTIABLE BOND ANTICIPATION NOTES IN CONFORMITY WITH APPLICABLE
51 PROVISIONS OF THE UNIFORM COMMERCIAL CODE AND MAY RENEW THE SAME FROM
52 TIME TO TIME BUT THE MAXIMUM MATURITY OF ANY SUCH NOTE, INCLUDING
53 RENEWALS THEREOF, SHALL NOT EXCEED FIVE YEARS FROM THE DATE OF ISSUE OF
54 SUCH ORIGINAL NOTE. SUCH NOTES SHALL BE PAID FROM ANY MONEYS OF THE
55 AUTHORITY AVAILABLE THEREFOR AND NOT OTHERWISE PLEDGED OR FROM THE
56 PROCEEDS OF SALE OF THE BONDS OF THE AUTHORITY IN ANTICIPATION OF WHICH

1 THEY WERE ISSUED. THE NOTES SHALL BE ISSUED IN THE SAME MANNER AS THE
2 BONDS AND SUCH NOTES AND THE RESOLUTION OR RESOLUTIONS AUTHORIZING THE
3 SAME MAY CONTAIN ANY PROVISIONS, CONDITIONS OR LIMITATIONS WHICH THE
4 BONDS OR A BOND RESOLUTION OF THE AUTHORITY MAY CONTAIN. SUCH NOTES MAY
5 BE SOLD AT PUBLIC OR PRIVATE SALE FOR SUCH PRICE OR PRICES AS THE
6 AUTHORITY SHALL DETERMINE, PROVIDED THAT NO ISSUE OF NOTES MAY BE SOLD
7 AT PRIVATE SALE UNLESS THE TERMS OF SUCH SALE SHALL HAVE BEEN APPROVED
8 IN WRITING BY (A) THE COMPTROLLER, WHERE SUCH SALE IS NOT TO SUCH COMP-
9 TROLLER, OR (B) THE DIRECTOR OF THE BUDGET, WHERE SUCH SALE IS TO SUCH
10 COMPTROLLER.

11 S 1241. REMEDIES OF BONDHOLDERS. 1. IN THE EVENT THAT THE AUTHORITY
12 SHALL DEFAULT IN THE PAYMENT OF PRINCIPAL OF OR INTEREST ON ANY ISSUE OF
13 THE BONDS AFTER THE SAME SHALL BECOME DUE, WHETHER AT MATURITY OR UPON
14 CALL FOR REDEMPTION, AND SUCH DEFAULT SHALL CONTINUE FOR A PERIOD OF
15 THIRTY DAYS, OR IN THE EVENT THAT THE AUTHORITY SHALL FAIL OR REFUSE TO
16 COMPLY WITH THE PROVISIONS OF THIS TITLE, OR SHALL DEFAULT IN ANY AGREE-
17 MENT MADE WITH THE HOLDERS OF ANY ISSUE OF THE BONDS, THE HOLDERS OF
18 TWENTY-FIVE PER CENTUM IN AGGREGATE PRINCIPAL AMOUNT OF THE BONDS OF
19 SUCH ISSUE THEN OUTSTANDING, BY INSTRUMENT OR INSTRUMENTS FILED IN THE
20 OFFICE OF THE CLERK OF THE COUNTY OF ALBANY AND PROVED OR ACKNOWLEDGED
21 IN THE SAME MANNER AS A DEED TO BE RECORDED, MAY APPOINT A TRUSTEE TO
22 REPRESENT THE HOLDERS OF SUCH BONDS FOR THE PURPOSES HEREIN PROVIDED.

23 2. SUCH TRUSTEE MAY, AND UPON WRITTEN REQUEST OF THE HOLDERS OF TWEN-
24 TY-FIVE PER CENTUM IN PRINCIPAL AMOUNT OF SUCH BONDS THEN OUTSTANDING
25 SHALL, IN HIS, HER OR ITS OWN NAME:

26 (A) BY ACTION OR PROCEEDING IN ACCORDANCE WITH THE CIVIL PRACTICE LAW
27 AND RULES, ENFORCE ALL RIGHTS OF THE BONDHOLDERS AND REQUIRE THE AUTHOR-
28 ITY TO CARRY OUT ANY AGREEMENTS WITH THE HOLDERS OF SUCH BONDS AND TO
29 PERFORM ITS DUTIES UNDER THIS TITLE;

30 (B) BRING AN ACTION OR PROCEEDING UPON SUCH BONDS;

31 (C) BY ACTION OR PROCEEDING, REQUIRE THE AUTHORITY TO ACCOUNT AS IF IT
32 WERE THE TRUSTEE OF AN EXPRESS TRUST FOR THE HOLDERS OF SUCH BONDS;

33 (D) BY ACTION OR PROCEEDING IN EQUITY, ENJOIN ANY ACTS OR THINGS WHICH
34 MAY BE UNLAWFUL OR IN VIOLATION OF THE RIGHTS OF THE HOLDERS OF SUCH
35 BONDS;

36 (E) DECLARE ALL SUCH BONDS DUE AND PAYABLE, AND IF ALL DEFAULTS SHALL
37 BE MADE GOOD THEN WITH THE CONSENT OF THE HOLDERS OF TWENTY-FIVE PER
38 CENTUM OF THE PRINCIPAL AMOUNT OF SUCH BONDS THEN OUTSTANDING, ANNUL
39 SUCH DECLARATION AND ITS CONSEQUENCES.

40 3. THE SUPREME COURT SHALL HAVE JURISDICTION OF ANY ACTION OR PROCEED-
41 ING BY THE TRUSTEE ON BEHALF OF BONDHOLDERS. THE VENUE OF ANY SUCH
42 ACTION OR PROCEEDING SHALL BE LAID IN THE COUNTY.

43 4. BEFORE DECLARING THE PRINCIPAL OF BONDS DUE AND PAYABLE, THE TRUS-
44 TEE SHALL FIRST GIVE THIRTY DAYS' NOTICE IN WRITING TO THE AUTHORITY.

47 RIGHT TO THE APPOINTMENT OF A RECEIVER OF ANY PART OR PARTS OF THE PROP-
48 erties THE REVENUES OF WHICH ARE PLEDGED FOR THE SECURITY OF THE BONDS
49 OF SUCH ISSUE AND SUCH RECEIVER MAY ENTER AND TAKE POSSESSION OF SUCH
50 PART OR PARTS OF THE PROPERTIES AND SUBJECT TO ANY PLEDGE OR AGREEMENT
51 WITH BONDHOLDERS SHALL TAKE POSSESSION OF SUCH PART OR PARTS OF SUCH
52 PROPERTIES AND PROCEED WITH ANY CONSTRUCTION THEREON OR THE ACQUISITION
53 OF ANY PROPERTY, REAL OR PERSONAL IN CONNECTION THEREWITH WHICH THE
54 AUTHORITY IS UNDER OBLIGATION TO DO, AND TO OPERATE, MAINTAIN AND RECON-
55 STRUCT SUCH PART OR PARTS OF THE PROPERTIES AND COLLECT AND RECEIVE ALL
56 REVENUES THEREAFTER ARISING THEREFROM SUBJECT TO ANY PLEDGE THEREOF OR

1 AGREEMENT WITH BONDHOLDERS RELATING THERETO AND PERFORM THE PUBLIC
2 DUTIES AND CARRY OUT THE AGREEMENTS AND OBLIGATIONS OF THE AUTHORITY
3 UNDER THE DIRECTION OF THE COURT. IN ANY SUIT, ACTION OR PROCEEDING BY
4 THE TRUSTEE THE FEES, COUNSEL FEES AND EXPENSES OF THE TRUSTEE AND OF
5 THE RECEIVER, IF ANY, SHALL CONSTITUTE TAXABLE DISBURSEMENTS AND ALL
6 COSTS AND DISBURSEMENTS ALLOWED BY THE COURT SHALL BE A FIRST CHARGE ON

8 6. SUCH TRUSTEES SHALL IN ADDITION TO THE FOREGOING HAVE AND POSSESS

27 DISCHARGED.

28 S 1244. BONDS LEGAL INVESTMENTS FOR FIDUCIARIES. THE BONDS ARE HEREBY
29 MADE SECURITIES IN WHICH ALL PUBLIC OFFICERS AND BODIES OF THIS STATE
30 AND ALL MUNICIPALITIES AND MUNICIPAL SUBDIVISIONS, ALL INSURANCE COMPA-
31 NIES AND ASSOCIATIONS AND OTHER PERSONS CARRYING ON AN INSURANCE BUSI-
32 NESS, ALL BANKS, BANKERS, TRUST COMPANIES, SAVINGS BANKS AND SAVINGS
33 ASSOCIATIONS, INCLUDING SAVINGS AND LOAN ASSOCIATIONS, BUILDING AND LOAN
34 ASSOCIATIONS, INVESTMENT COMPANIES AND OTHER PERSONS CARRYING ON A BANK-
35 ING BUSINESS, AND ADMINISTRATORS, GUARDIANS, EXECUTORS, TRUSTEES AND

37 HEREAFTER BE AUTHORIZED TO INVEST IN BONDS OR OTHER OBLIGATIONS OF THE

39 CONTROL OR BELONGING TO THEM. THE BONDS ARE ALSO HEREBY MADE SECURITIES

41 AND BODIES OF THIS STATE AND ALL MUNICIPALITIES AND MUNICIPAL SUBDIVI-

44 S 1252. AUDIT. THE ACCOUNTS OF THE AUTHORITY SHALL BE SUBJECT TO THE

46 S 1253. ACTIONS AGAINST AUTHORITY. 1. IN ANY ACTION FOUNDED UPON TORT
47 A NOTICE OF CLAIM SHALL BE REQUIRED AS A CONDITION PRECEDENT TO THE
48 COMMENCEMENT OF AN ACTION OR SPECIAL PROCEEDING AGAINST THE AUTHORITY OR
49 ANY OFFICER, APPOINTEE, AGENT OR EMPLOYEE THEREOF, AND THE PROVISIONS OF

5 INEFFECTIVE IN WHOLE OR IN PART, IN ITS TERMS OR IN ITS OPERATION, TO
