AN ACT to amend the public health law, in relation to health-related legal services programs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public health law is amended by adding a new section  
2 22 to read as follows:  
3 S 22. HEALTH-RELATED LEGAL SERVICES PROGRAM. 1. AS USED IN THIS  
4 SECTION, "HEALTH-RELATED LEGAL SERVICES PROGRAM" MEANS A PROGRAM THAT IS  
5 A COLLABORATION BETWEEN HEALTH CARE SERVICE PROVIDERS AND LEGAL SERVICES  
6 PROGRAMS TO PROVIDE ON SITE LEGAL SERVICES WITHOUT CHARGE TO ASSIST, ON  
7 A VOLUNTARY BASIS, INCOME ELIGIBLE PATIENTS AND THEIR FAMILIES TO  
8 RESOLVE LEGAL MATTERS OR NEEDS THAT HAVE AN IMPACT ON PATIENT HEALTH OR  
9 ARE CREATED OR AGGRAVATED BY A PATIENT'S HEALTH. FOR THE PURPOSE OF THIS  
10 SECTION, LEGAL MATTERS MAY INCLUDE, BUT SHALL NOT BE LIMITED TO:  
11 (A) HOUSING, INCLUDING UTILITIES;  
12 (B) PUBLIC OR PRIVATE HEALTH INSURANCE COVERAGE;  
13 (C) EMPLOYMENT AND ELIGIBILITY FOR EMPLOYMENT BENEFITS;  
14 (D) GOVERNMENT BENEFITS;  
15 (E) IMMIGRATION;  
16 (F) FAMILY LAW, INCLUDING, BUT NOT LIMITED TO, DOMESTIC VIOLENCE,  
17 GUARDIANSHIP, CUSTODY, AND CHILD SUPPORT;  
18 (G) ADVANCE PLANNING, INCLUDING, BUT NOT LIMITED TO, WILLS, HEALTH  
19 CARE PROXIES, POWERS OF ATTORNEY AND PERMANENCY PLANNING;  
20 (H) SPECIAL EDUCATION; AND  
21 (I) DEBTOR AND CREDITOR ISSUES.  
22 2. THE DEPARTMENT MAY DESIGNATE HEALTH-RELATED LEGAL SERVICES PROGRAMS  
23 THAT COMPLY WITH STANDARDS AND GUIDELINES ESTABLISHED FOR SUCH PROGRAMS.  
24 THE DEPARTMENT SHALL WORK WITH LEGAL SERVICES ORGANIZATIONS, COMMUNITY  
25 HEALTH ADVOCACY ORGANIZATIONS, HOSPITALS, DIAGNOSTIC AND TREATMENT

1 CENTERS AND OTHER PRIMARY AND SPECIALTY HEALTH CARE PROVIDERS, TO ESTAB-  
2 LISH STANDARDS AND GUIDELINES FOR HEALTH-RELATED LEGAL SERVICES PROGRAMS  
3 THAT ARE DESIGNATED UNDER THIS SECTION.

4 3. A HEALTH-RELATED LEGAL SERVICES PROGRAM DESIGNATED UNDER THIS  
5 SECTION SHALL BE A NOT-FOR-PROFIT ENTITY OPERATED BY OR AFFILIATED WITH  
6 ONE OR MORE LEGAL SERVICES ORGANIZATIONS, LAW SCHOOLS, SOCIAL SERVICES  
7 ORGANIZATIONS, OR HEALTH CARE PROVIDERS, AND IT SHALL COMPLY WITH THE  
8 STANDARDS, GUIDELINES AND REGULATIONS UNDER THIS SECTION, AND HAVE  
9 DEMONSTRATED ABILITY AND EXPERIENCE TO PROVIDE HIGH QUALITY HEALTH-RE-  
10 LATED LEGAL SERVICES MEETING THE NEEDS OF THE POPULATION TO BE SERVED.

11 S 2. This act shall take effect immediately.
