AN ACT to amend the penal law, in relation to designating promoting prostitution in the first degree, compelling prostitution and sex trafficking as class B violent felony offenses and the prostitution of minors

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (a) of subdivision 1 of section 70.02 of the penal law, as amended by chapter 320 of the laws of 2006, is amended to read as follows:

firearm in the first degree as defined in section 265.13, aggravated assault upon a police officer or a peace officer as defined in section 120.11, gang assault in the first degree as defined in section 120.07, intimidating a victim or witness in the first degree as defined in section 215.17, hindering prosecution of terrorism in the first degree as defined in section 490.35, criminal possession of a chemical weapon or biological weapon in the second degree as defined in section 490.40, and criminal use of a chemical weapon or biological weapon in the third degree as defined in section 490.47.

- S 2. Section 230.30 of the penal law, as amended by chapter 627 of the laws of 1978, is amended to read as follows:
- 12 S 230.30 Promoting prostitution in the second degree.
  - A person is guilty of promoting prostitution in the second degree when he OR SHE knowingly[:
  - 1. Advances] ADVANCES prostitution by compelling a person by force or intimidation to engage in prostitution, or profits from such coercive conduct by another[; or
- 18 2. Advances or profits from prostitution of a person less than sixteen 19 years old].
  - Promoting prostitution in the second degree is a class C felony.
  - S 3. Section 230.32 of the penal law, as added by chapter 627 of the laws of 1978, is amended to read as follows:
- 23 S 230.32 Promoting prostitution in the first degree.
  24 A person is guilty of promoting prostitution in t
  - A person is guilty of promoting prostitution in the first degree when he OR SHE knowingly advances or profits from prostitution of a person less than [eleven] SIXTEEN years old.
    - Promoting prostitution in the first degree is a class B felony.
- 28 S 4. This act shall take effect on the first of November next succeed-29 ing the date on which it shall have become a law and shall apply to 30 offenses committed on or after such date.
