AN ACT to amend the penal law, in relation to crimes against a delivery person

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The penal law is amended by adding a new section 120.65 to 2 read as follows:
 - S 120.65 CRIMES AGAINST A DELIVERY PERSON.

- 1. A PERSON COMMITS A CRIME AGAINST A DELIVERY PERSON WHEN HE OR SHE COMMITS A SPECIFIED OFFENSE AND EITHER:
- (A) INTENTIONALLY SELECTS THE PERSON AGAINST WHOM THE OFFENSE IS COMMITTED OR IS INTENDED TO BE COMMITTED IN WHOLE OR IN SUBSTANTIAL PART BECAUSE OF SUCH PERSON'S STATUS AS A DELIVERY PERSON; OR
- (B) INTENTIONALLY LURES SUCH DELIVERY PERSON INTO THE LOCATION WHERE THE SPECIFIED OFFENSE WAS COMMITTED.
- 2. A "SPECIFIED OFFENSE" IS AN OFFENSE DEFINED BY ANY OF THE FOLLOWING 11 PROVISIONS OF THIS CHAPTER: ASSAULT IN THE THIRD DEGREE, ASSAULT IN THE 12 13 SECOND DEGREE, ASSAULT IN THE FIRST DEGREE, MENACING IN THE FIRST 14 DEGREE, MENACING IN THE SECOND DEGREE, MENACING IN THE THIRD DEGREE, 15 RECKLESS ENDANGERMENT IN THE FIRST DEGREE, RECKLESS ENDANGERMENT IN THE SECOND DEGREE, MANSLAUGHTER IN THE SECOND DEGREE, MANSLAUGHTER IN 16 17 FIRST DEGREE, MURDER IN THE SECOND DEGREE, ROBBERY IN THE THIRD DEGREE, ROBBERY IN THE SECOND DEGREE, ROBBERY IN THE FIRST DEGREE, GANG ASSAULT 18 19 FIRST DEGREE, GANG ASSAULT IN THE SECOND DEGREE, OR ANY ATTEMPT 20 OR CONSPIRACY TO COMMIT ANY OF THE FOREGOING OFFENSES.
 - 3. FOR PURPOSES OF SENTENCING:
- (A) WHEN A PERSON IS CONVICTED OF A CRIME AGAINST A DELIVERY PERSON PURSUANT TO THIS SECTION AND THE SPECIFIED OFFENSE IS A MISDEMEANOR OR A CLASS C, D OR E FELONY, THE CRIME AGAINST A DELIVERY PERSON SHALL BE DEEMED TO BE ONE CATEGORY HIGHER THAN THE SPECIFIED OFFENSE THE DEFEND-26 ANT COMMITTED, OR ONE CATEGORY HIGHER THAN THE OFFENSE LEVEL APPLICABLE

TO THE DEFENDANT'S CONVICTION FOR AN ATTEMPT OR CONSPIRACY TO COMMIT A SPECIFIED OFFENSE, WHICHEVER IS APPLICABLE.

- (B) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, WHEN A PERSON IS CONVICTED OF A CRIME AGAINST A DELIVERY PERSON PURSUANT TO THIS SECTION AND THE SPECIFIED OFFENSE IS A CLASS B FELONY:
- (I) THE MAXIMUM TERM OF THE INDETERMINATE SENTENCE MUST BE AT LEAST FIVE YEARS IF THE DEFENDANT IS SENTENCED PURSUANT TO SECTION 70.00 OF THIS CHAPTER;
- (II) THE TERM OF THE DETERMINATE SENTENCE MUST BE AT LEAST SEVEN YEARS IF THE DEFENDANT IS SENTENCED PURSUANT TO SECTION 70.02 OF THIS CHAPTER;
- 11 (III) THE TERM OF THE DETERMINATE SENTENCE MUST BE AT LEAST ELEVEN 12 YEARS IF THE DEFENDANT IS SENTENCED PURSUANT TO SECTION 70.04 OF THIS 13 CHAPTER;
- 14 (IV) THE MAXIMUM TERM OF THE INDETERMINATE SENTENCE MUST BE AT LEAST 15 THREE YEARS IF THE DEFENDANT IS SENTENCED PURSUANT TO SECTION 70.05 OF 16 THIS CHAPTER; AND
 - (V) THE MAXIMUM TERM OF THE INDETERMINATE SENTENCE OR THE TERM OF THE DETERMINATE SENTENCE MUST BE AT LEAST NINE YEARS IF THE DEFENDANT IS SENTENCED PURSUANT TO SECTION 70.06 OF THIS CHAPTER.
 - (C) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, WHEN A PERSON IS CONVICTED OF A CRIME AGAINST A DELIVERY PERSON PURSUANT TO THIS SECTION AND THE SPECIFIED OFFENSE IS A CLASS A-I FELONY, THE MINIMUM PERIOD OF THE INDETERMINATE SENTENCE SHALL BE NOT LESS THAN NINETEEN YEARS.
- 24 S 2. This act shall take effect on the one hundred eightieth day after 25 it shall have become a law.
