AN ACT to amend the education law, in relation to authorizing school districts to establish reserve funds for the payment of the costs and expenses of programs of special education

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Section 3651 of the education law is amended by adding two new subdivisions 1-c and 3-b to read as follows:
- 1-C. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION ONE OF ANY SCHOOL DISTRICT MAY ESTABLISH A RESERVE FUND FOR THE SECTION, PAYMENTS OF THE COSTS AND EXPENSES OF PROVIDING PROGRAMS OF EDUCATION PURSUANT TO ARTICLE EIGHTY-NINE OF THIS CHAPTER, WITHOUT 7 APPROVAL BY THE QUALIFIED VOTERS OF THE DISTRICT, PROVIDED, HOWEVER, 8 THE TOTAL OF THE MONIES HELD IN SUCH RESERVE FUND SHALL NOT EXCEED THAT AMOUNT WHICH MIGHT REASONABLY BE DEEMED NECESSARY 9 TO MEET IPATED COSTS AND EXPENSES OF PROVIDING PROGRAMS OF SPECIAL EDUCATION FOR 10 WHICH THE STATE HAS NOT PROVIDED FINANCIAL ASSISTANCE. ANY MONIES DEPOS-11 ITED TO SUCH RESERVE FUND WHICH ARE NOT EXPENDED FOR THE PAYMENT OF THE 12 13 COSTS AND EXPENSES OF PROVIDING PROGRAMS OF SPECIAL EDUCATION DURING THE SCHOOL YEAR AND/OR WHICH WILL NOT REASONABLY BE REQUIRED TO PAY ANY SUCH 14 COSTS AND EXPENSES SHALL BE RETURNED TO THE GENERAL FUND. 15
- 3-B. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION THREE OF THIS SECTION, ANY SCHOOL DISTRICT WHICH ESTABLISHES A RESERVE FUND IN ACCORD-18 ANCE WITH SUBDIVISION ONE-C OF THIS SECTION MAY MAKE EXPENDITURES FROM SUCH FUND FOR THE PURPOSES SPECIFIED IN SUCH SUBDIVISION WITHOUT AUTHOR-
- 20 IZATION OF THE VOTERS.
- 21 S 2. This act shall take effect immediately.
