AN ACT to amend the general business law, in relation to the purchase of second-hand precious metals

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The general business law is amended by adding a new section 2 391-s to read as follows:

3 391-S. SECOND-HAND PRECIOUS METALS; RECORDS. 1. DEFINITIONS. S AS 4 USED IN THIS SECTION:

5 (A) "DEALER" SHALL MEAN ANY PERSON WHO, IN THE REGULAR COURSE OF BUSI-6 NESS, DEALS IN THE PURCHASE OF SECOND-HAND ARTICLES OR THINGS COMPRISED 7 OF GOLD, SILVER OR PLATINUM FOR THE PURPOSE OF RESALE, MELTING OR REFIN-8 ING, AND SHALL INCLUDE COLLATERAL LOAN BROKERS.

9 "SELLER" SHALL MEAN ANY PERSON WHO SELLS ANY SECOND-HAND ARTICLE (B) 10 OR THING COMPRISED OF GOLD, SILVER OR PLATINUM.

11 2. NO DEALER SHALL TAKE POSSESSION OF AND PROVIDE CONSIDERATION FOR ANY SECOND-HAND ITEM COMPRISED OF GOLD, SILVER OR PLATINUM FROM A SELLER 12 WITHOUT CONFIRMING THE IDENTITY OF SUCH SELLER UPON PRESENTATION OF TWO 13 FORMS OF IDENTIFICATION. THE DEALER SHALL MAINTAIN A RECORD OF EACH 14 ITEM COMPRISED OF GOLD, SILVER OR PLATINUM HE OR SHE TAKES 15 SECOND-HAND POSSESSION OF, AND SUCH RECORD SHALL INCLUDE A COPY OF THE 16 FORMS OF IDENTIFICATION PRESENTED BY THE SELLER AND A TELEPHONE NUMBER AND 17 ADDRESS AT WHICH THE SELLER MAY BE CONTACTED. ALL SUCH RECORDS SHALL BE 18 19 MAINTAINED BY THE DEALER FOR A PERIOD OF NOT LESS THAN TWO YEARS, AND 20 SHALL BE MADE AVAILABLE FOR INSPECTION DURING NORMAL BUSINESS HOURS.

21 3. UPON TAKING POSSESSION OF ANY SECOND-HAND ITEM COMPRISED OF GOLD, 22 SILVER OR PLATINUM, A DEALER SHALL RETAIN POSSESSION OF SUCH ITEM FOR A PERIOD OF NOT LESS THAN SEVENTY-TWO HOURS. 23

S 2. This act shall take effect on the sixtieth day after it 24 shall 25 have become a law.
