AN ACT to amend the public health law, in relation to requiring the use of network providers for evaluations or services under the early intervention program, state aid reimbursement to municipalities for respite services, and service coordination; to repeal subdivision 7 of section 2551 and subdivision 4 of section 2557 of the public health law, relating to administering early intervention services; to amend the public health law, in relation to requiring that each municipality be responsible for providing early intervention services; to amend the public health law, in relation to removing the authorization of the commissioner of health to collect data from counties on early intervention programs for the purpose of improving efficiency, cost effectiveness and quality; to amend the public health law, in relation to requiring health maintenance organizations to include coverage for otherwise covered services that are part of an early intervention program; to amend the insurance law, in relation to payment for early intervention services; to amend the education law, in relation to special education services and programs for preschool children with handicapping conditions; and to repeal subdivision 18 of section 4403 of the education law, relating to the power of the education department to approve the provision of early intervention services (Part A); to amend the public authorities law, in relation to funding and operations of the Roswell Park Cancer Institute (Part B); to amend the public health law, in relation to establishment of an electronic death registration system (Part C); to amend the public health law, in

of part H of chapter 59 of the laws of 2011, relating to types of appropriations exempt from certain reductions, in relation to certain payments with regard to local governments; to amend section 1 of part C of chapter 58 of the laws of 2005, relating to authorizing reimbursements for expenditures made by or on behalf of social services districts for medical assistance for needy persons and the administration thereof, in relation to Medicaid reimbursement; and to repeal certain provisions of the public health law, the social services law and the elder law relating thereto (Part D); to amend the public authorities law and the public officers law, in relation to the establishment of the New York Health Benefit Exchange (Part E); to amend chapter 58 of the laws of 2005 authorizing reimbursements for expenditures made by or on behalf of social services districts for medical assistance for needy persons and the administration thereof, in relation to an administrative cap on such program; to amend chapter 59 of the laws of 2011, amending the public health law and other laws relating to general hospital reimbursement for annual rates, in relation to the cap on local Medicaid expenditures; and to amend the social services law, in relation to the department assumption of program administration for medical assistance (Part F); to amend the public health law, in relation to regulations for computing hospital inpatient rates and to amend chapter 58 of the laws of 2005 relating to the preferred drug program, in relation to the effectiveness thereof (Part G); to amend chapter 57 of the laws of 2006, relating to establishing a cost of living adjustment for designated human services programs, in relation to foregoing such adjustment during the 2012-2013 state fiscal year; and in relation to directing limits on state reimbursement for executive compensation and administrative costs (Part H); in relation to contracts by the office for people with developmental disabilities made under section 1115 of the federal social security act (Part I); to amend the mental hygiene law, the public health law, the general municipal law, the education law, the social services law, and the surrogate's court procedure act, in relation to the office for people with developmental disabilities and the creation of developmental disabilities regional offices and state operations offices (Part J); to amend chapter 723 of the laws of 1989 amending the mental hygiene law and other laws relating to comprehensive psychiatric emergency programs, in relation to extending the repeal of certain provisions thereof (Part K); to permit the commissioners of the department of health, the office of mental health, the office of alcoholism and substance abuse services and the office for people with developmental disabilities the regulatory flexibility to more efficiently and effectively integrate health and behavioral health services (Part L); to permit the office of mental health and the state education department to enter into an agreement for purposes of providing education programming for patients residing in hospitals operated by the office of mental health who are between the ages of five and twenty-one; and providing for the repeal of such provisions upon expiration thereof (Part M); to amend the mental hygiene law and the public health law, in relation to the statewide comprehensive services plan for people with mental disabilities and in relation to the local planning process; and to repeal certain provisions of the mental hygiene law relating thereto (Part N); to amend the mental hygiene law, in relation to the closure and the reduction in size of certain facilities serving persons with mental illness (Part O); to amend the mental hygiene law, in relation to amending procedures under

the sex offender management and treatment act, and to amend the penal law, in relation to providing criminal penalties for certain violations of orders of commitment and strict and intensive supervision and treatment (Part P); to amend the criminal procedure law, in relation to providing for outpatient capacity restoration of felony defendants, or restoration at psychiatric units of jails or article 28 hospitals (Part Q); to amend chapter 111 of the laws of 2010 relating to the recovery of exempt income by the office of mental health for community residences and family-based treatment programs, in relation to the effectiveness thereof (Part R); and to amend the public health law, in relation to consolidating the excess medical malpractice liability coverage pool; and to repeal section 18 of chapter 266 of the laws of 1986, amending the civil practice law and rules and other laws relating to medical and dental malpractice, relating thereto (Part S)

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act enacts into law major components of legislation
2 which are necessary to implement the state fiscal plan for the 2012-2013
3 state fiscal year. Each component is wholly contained within a Part
4 identified as Parts A through S. The effective date for each particular
5 provision contained within such Part is set forth in the last section of
6 such Part. Any provision in any section contained within a Part, including
7 the effective date of the Part, which makes a reference to a section
8 "of this act", when used in connection with that particular component,
9 shall be deemed to mean and refer to the corresponding section of the
10 Part in which it is found. Section three of this act sets forth the
11 general effective date of this act.

12 PART A

13 Section 1. Paragraph (a) of subdivision 2 of section 2544 of the
14 public health law, as added by chapter 428 of the laws of 1992, is
15 amended and a new paragraph (c) is added to read as follows:

16 (a) [The] SUBJECT TO THE PROVISIONS OF SECTION TWENTY-FIVE HUNDRED
17 FORTY-FIVE-A OF THIS TITLE, THE parent may select an evaluator from the
18 list of approved evaluators as described in section twenty-five hundred
19 forty-two of this title to conduct the evaluation. The parent or evaluator
20 shall immediately notify the early intervention official of such
21 selection. The evaluator may begin the evaluation no sooner than four
22 working days after such notification, unless otherwise approved by the
23 initial service coordinator.

24 (C) IF, IN CONSULTATION WITH THE EVALUATOR, THE SERVICE COORDINATOR
25 IDENTIFIES A CHILD THAT IS POTENTIALLY ELIGIBLE FOR PROGRAMS OR SERVICES
26 OFFERED BY OR UNDER THE AUSPICES OF THE OFFICE FOR PEOPLE WITH DEVELOPMENTAL
27 DISABILITIES, THE SERVICE COORDINATOR SHALL, WITH PARENT CONSENT,
28 NOTIFY THE OFFICE FOR PEOPLE WITH DEVELOPMENTAL DISABILITIES' REGIONAL
29 DEVELOPMENTAL DISABILITIES SERVICES OFFICE OF THE POTENTIAL ELIGIBILITY
30 OF SUCH CHILD FOR SAID PROGRAMS OR SERVICES.

31 S 2. Subdivision 1, the opening paragraph of subdivision 2 and subdivision
32 7 of section 2545 of the public health law, as added by chapter
33 428 of the laws of 1992, are amended to read as follows:

1 1. If the evaluator determines that the infant or toddler is an eligi-
2 ble child, the early intervention official shall convene a meeting, at a
3 time and place convenient to the parent, consisting of the parent, such
4 official, the evaluator, A REPRESENTATIVE FROM THE CHILD'S INSURER OR
5 HEALTH MAINTENANCE ORGANIZATION, WHICH SHALL INCLUDE THE MEDICAL ASSIST-
6 ANCE PROGRAM OR THE CHILD HEALTH INSURANCE PROGRAM ESTABLISHED IN TITLE
7 ONE-A OF THIS ARTICLE, OR ANY OTHER GOVERNMENTAL THIRD PARTY PAYOR, IF
8 THE CHILD HAS COVERAGE THROUGH AN INSURER OR HEALTH MAINTENANCE ORGAN-
9 IZATION AND THE REPRESENTATIVE IS AVAILABLE TO ATTEND THE MEETING ON THE
10 DATE AND TIME CHOSEN BY THE EARLY INTERVENTION OFFICIAL, the initial
11 service coordinator and any other persons who the parent or the initial
12 service coordinator, with the parent's consent, invite, provided that
13 such meeting shall be held no later than forty-five days from the date
14 that the early intervention official was first contacted regarding the
15 child, except under exceptional circumstances prescribed by the commis-
16 sioner. The early intervention official, at or prior to the time of
17 scheduling the meeting, shall inform the parent of the right to invite
18 any person to the meeting. IF THE REPRESENTATIVE FROM THE CHILD'S
19 INSURER OR HEALTH MAINTENANCE ORGANIZATION IS NOT AVAILABLE TO ATTEND
20 THE MEETING IN PERSON ON THE DATE AND TIME CHOSEN BY THE EARLY INTER-
21 VENTION OFFICIAL, ARRANGEMENTS MAY BE MADE FOR THE REPRESENTATIVE'S
22 INVOLVEMENT IN THE MEETING BY PARTICIPATION IN A TELEPHONE CONFERENCE
23 CALL OR BY OTHER MEANS.

24 The early intervention official, A REPRESENTATIVE FROM THE CHILD'S
25 INSURER OR HEALTH MAINTENANCE ORGANIZATION, WHICH SHALL INCLUDE THE
26 MEDICAL ASSISTANCE PROGRAM OR THE CHILD HEALTH INSURANCE PROGRAM ESTAB-
27 LISHED IN TITLE ONE-A OF THIS ARTICLE, OR ANY OTHER GOVERNMENTAL THIRD
28 PARTY PAYOR, IF THE CHILD HAS COVERAGE THROUGH AN INSURER OR HEALTH
29 MAINTENANCE ORGANIZATION AND THE REPRESENTATIVE IS AVAILABLE TO ATTEND
30 THE MEETING ON THE DATE AND TIME CHOSEN BY THE EARLY INTERVENTION OFFI-
31 CIAL, initial service coordinator, parent and evaluator shall develop an
32 IFSP for an eligible child whose parents request services. The IFSP
33 shall be in writing and shall include, but not be limited to:

34 7. The IFSP shall be reviewed at six month intervals and shall be
35 evaluated annually by the early intervention official, A REPRESENTATIVE
36 FROM THE CHILD'S INSURER OR HEALTH MAINTENANCE ORGANIZATION, WHICH SHALL
37 INCLUDE THE MEDICAL ASSISTANCE PROGRAM OR THE CHILD HEALTH INSURANCE
38 PROGRAM ESTABLISHED IN TITLE ONE-A OF THIS ARTICLE, OR ANY OTHER GOVERN-
39 MENTAL THIRD PARTY PAYOR, IF THE CHILD HAS COVERAGE THROUGH AN INSURER
40 OR HEALTH MAINTENANCE ORGANIZATION AND THE REPRESENTATIVE IS AVAILABLE
41 TO PARTICIPATE IN THE REVIEW OR ATTEND ON THE DATE AND TIME CHOSEN BY
42 THE EARLY INTERVENTION OFFICIAL, THE service coordinator, the parent and
43 providers of services to the eligible child. Upon request of a parent,
44 the plan may be reviewed by such persons at more frequent intervals. IF
45 THE REPRESENTATIVE FROM THE CHILD'S INSURER OR HEALTH MAINTENANCE ORGAN-
46 IZATION IS NOT AVAILABLE TO PARTICIPATE IN THE REVIEW OR ATTEND IN
47 PERSON ON THE DATE AND TIME CHOSEN BY THE EARLY INTERVENTION OFFICIAL,
48 ARRANGEMENTS MAY BE MADE FOR THE REPRESENTATIVE'S INVOLVEMENT BY PARTIC-
49 IPATION IN A TELEPHONE CONFERENCE CALL OR BY OTHER MEANS.

50 S 2-a. Section 2545 of the public health law is amended by adding a
51 new subdivision 10 to read as follows:

52 10. THE SERVICE COORDINATOR SHALL ENSURE THAT THE IFSP, INCLUDING ANY
53 AMENDMENTS THERETO, IS IMPLEMENTED IN A TIMELY MANNER BUT NOT LATER THAN
54 THIRTY DAYS AFTER THE PROJECTED DATES FOR INITIATION OF THE SERVICES AS
55 SET FORTH IN THE PLAN.

1 S 3. The public health law is amended by adding a new section 2545-a
2 to read as follows:

3 S 2545-A. USE OF NETWORK PROVIDERS. FOR CHILDREN REFERRED TO THE
4 EARLY INTERVENTION PROGRAM ON OR AFTER JANUARY FIRST, TWO THOUSAND THIR-
5 TEEN, IF A CHILD HAS COVERAGE UNDER AN INSURANCE POLICY, PLAN OR
6 CONTRACT, INCLUDING COVERAGE AVAILABLE UNDER THE MEDICAL ASSISTANCE
7 PROGRAM OR THE CHILD HEALTH INSURANCE PROGRAM ESTABLISHED IN TITLE ONE-A
8 OF THIS ARTICLE OR UNDER ANY OTHER GOVERNMENTAL THIRD PARTY PAYOR, AND
9 THE INSURANCE POLICY, PLAN OR CONTRACT PROVIDES COVERAGE FOR EVALUATIONS
10 OR SERVICES THAT MAY BE RENDERED TO THE CHILD UNDER THE EARLY INTER-
11 VENTION PROGRAM, THE SERVICE COORDINATOR, OR, IN ACCORDANCE WITH SECTION
12 TWENTY-FIVE HUNDRED FORTY-FOUR OF THIS TITLE, THE PARENT, WITH RESPECT
13 TO EVALUATIONS, SHALL SELECT A PROVIDER APPROVED BY THE DEPARTMENT AND
14 WITHIN THE INSURER'S OR HEALTH MAINTENANCE ORGANIZATION'S NETWORK, IF
15 APPLICABLE, FOR THE PROVISION OF SUCH EVALUATION OR SERVICES, PROVIDED
16 HOWEVER THAT THIS SUBDIVISION SHALL NOT APPLY UNDER THE FOLLOWING CONDI-
17 TIONS:

18 1. THERE IS NO PROVIDER IN THE INSURER'S OR HEALTH MAINTENANCE ORGAN-
19 IZATION'S NETWORK THAT IS AVAILABLE OR APPROPRIATE TO RECEIVE THE REFER-
20 RAL AND TO CONDUCT THE EVALUATION OR TO BEGIN PROVIDING SERVICES IN A
21 TIMELY MANNER IN ACCORDANCE WITH THE CHILD'S IFSP;

22 2. INSURANCE OR HEALTH PLAN BENEFITS HAVE BEEN EXHAUSTED; OR

23 3. THE CHILD HAS A DEMONSTRATED NEED, AS DETERMINED BY THE INSURER OR
24 HEALTH MAINTENANCE ORGANIZATION, IF APPLICABLE, FOR AN EVALUATION OR
25 SERVICE RENDERED BY A PROVIDER WHO DOES NOT HOLD AN AGREEMENT WITH THE
26 CHILD'S INSURER OR HEALTH MAINTENANCE ORGANIZATION FOR THE PROVISION OF
27 SUCH EVALUATION OR SERVICE.

28 S 4. Subdivision 2 of section 2547 of the public health law, as
29 amended by chapter 231 of the laws of 1993, is amended to read as
30 follows:

31 2. In addition to respite services provided pursuant to subdivision
32 one of this section and subject to the amounts appropriated therefor,
33 the state shall reimburse the municipality IN ACCORDANCE WITH THE
34 PERCENTAGE OF STATE AID REIMBURSEMENT FOR APPROVED COSTS AS SET FORTH IN
35 SUBDIVISION TWO OF SECTION TWENTY-FIVE HUNDRED FIFTY-SEVEN OF THIS
36 TITLE, for [fifty percent of] the costs of respite services provided to
37 eligible children and their families with the approval of the early
38 intervention official.

39 S 5. Section 2548 of the public health law, as amended by section 20
40 of part H of chapter 686 of the laws of 2003, is amended to read as
41 follows:

42 S 2548. Transition plan. To the extent that a toddler with a disabili-
43 ty is thought to be eligible for services pursuant to section forty-four
44 hundred ten of the education law, the [early intervention official]
45 SERVICE COORDINATOR shall notify in writing the committee on preschool
46 special education of the local school district in which an eligible
47 child resides of the potential transition of such child and, with
48 parental consent, arrange for a conference among the service coordina-
49 tor, the parent and the chairperson of the preschool committee on
50 special education or his or her designee at least ninety days before
51 such child would be eligible for services under section forty-four
52 hundred ten of the education law to review the child's program options
53 and to establish a transition plan, if appropriate. If a parent does not
54 consent to a conference with the service coordinator and the chairperson
55 of the preschool committee on special education or his or her designee
56 to determine whether the child should be referred for services under

1 section forty-four hundred ten of the education law, and the child is
2 not determined to be eligible by the committee on preschool special
3 education for such services prior to the child's third birthday, the
4 child's eligibility for early intervention program services shall end at
5 the child's third birthday.

6 S 6. Subdivision 2 of section 2550 of the public health law, as
7 amended by section 5 of part B3 of chapter 62 of the laws of 2003, is
8 amended to read as follows:

9 2. In meeting the requirements of subdivision one of this section, the
10 lead agency shall adopt and use proper methods of administering the
11 early intervention program, including:

12 (a) establishing standards for evaluators, service coordinators and
13 providers of early intervention services;

14 (b) approving, and periodically re-approving evaluators, service coor-
15 dinators and providers of early intervention services who meet depart-
16 ment standards; PROVIDED HOWEVER THAT THE DEPARTMENT MAY REQUIRE THAT
17 APPROVED EVALUATORS, SERVICE COORDINATORS AND PROVIDERS OF EARLY INTER-
18 VENTION SERVICES ENTER INTO AGREEMENTS WITH THE DEPARTMENT IN ORDER TO
19 CONDUCT EVALUATIONS OR RENDER SERVICE COORDINATION OR EARLY INTERVENTION
20 SERVICES IN THE EARLY INTERVENTION PROGRAM. SUCH AGREEMENTS SHALL SET
21 FORTH THE TERMS AND CONDITIONS OF PARTICIPATION IN THE PROGRAM. IF THE
22 DEPARTMENT REQUIRES THAT SUCH PROVIDERS ENTER INTO AGREEMENTS WITH THE
23 DEPARTMENT FOR PARTICIPATION IN THE PROGRAM, "APPROVAL" OR "APPROVED" AS
24 USED IN THIS TITLE SHALL MEAN A PROVIDER WHO IS APPROVED BY THE DEPART-
25 MENT IN ACCORDANCE WITH DEPARTMENT REGULATIONS AND HAS ENTERED INTO AN
26 AGREEMENT WITH THE DEPARTMENT FOR THE PROVISION OF EVALUATIONS, SERVICE
27 COORDINATION OR EARLY INTERVENTION SERVICES.

28 A LESS-THAN-ARMS-LENGTH RELATIONSHIP SHALL NOT EXIST BETWEEN THE
29 SERVICE COORDINATOR, EVALUATOR AND THE PROVIDER AUTHORIZED TO DELIVER
30 EARLY INTERVENTION SERVICES TO THE CHILD, UNLESS APPROVAL OF THE LEAD
31 AGENCY, IN CONSULTATION WITH THE EARLY INTERVENTION OFFICIAL, IS
32 OBTAINED. PROVIDED FURTHER THAT, UNLESS AUTHORIZED BY THE LEAD AGENCY,
33 IN CONSULTATION WITH THE EARLY INTERVENTION OFFICIAL, UPON A FINDING
34 THAT IT HAS BEEN DEMONSTRATED THAT AN APPROVED PROVIDER IS THE ONLY
35 APPROPRIATE PROVIDER AVAILABLE TO RENDER THE SERVICES RECOMMENDED FOR
36 SUCH CHILD, THE SERVICE COORDINATOR, THE EVALUATOR SELECTED BY THE
37 PARENT AND THE PROVIDER RECOMMENDED TO DELIVER SERVICES TO SUCH CHILD,
38 AND ANY AGENCY UNDER WHICH SUCH SERVICE COORDINATOR, EVALUATOR OR
39 PROVIDER IS EMPLOYED BY OR UNDER CONTRACT WITH, SHALL NOT BE THE SAME
40 ENTITY.

41 ALL APPROVED EVALUATORS AND PROVIDERS OF EARLY INTERVENTION SERVICES,
42 HEREINAFTER COLLECTIVELY REFERRED TO AS "PROVIDER" OR "PROVIDERS" FOR
43 PURPOSES OF THIS SUBPARAGRAPH, SHALL ESTABLISH AND MAINTAIN CONTRACTS OR
44 AGREEMENTS WITH A SUFFICIENT NUMBER OF INSURERS OR HEALTH MAINTENANCE
45 ORGANIZATIONS, INCLUDING THE MEDICAL ASSISTANCE PROGRAM OR THE CHILD
46 HEALTH INSURANCE PROGRAM ESTABLISHED UNDER TITLE ONE-A OF THIS ARTICLE,
47 AS DETERMINED NECESSARY BY THE COMMISSIONER TO MEET INSURER OR HEALTH
48 MAINTENANCE ORGANIZATION NETWORK ADEQUACY; PROVIDED, HOWEVER, THAT THE
49 DEPARTMENT MAY, IN ITS DISCRETION, APPROVE A PROVIDER WHO DOES NOT HAVE
50 A CONTRACT OR AGREEMENT WITH ONE OR MORE INSURERS OR HEALTH MAINTENANCE
51 ORGANIZATIONS IF THE PROVIDER RENDERS A SERVICE THAT MEETS A UNIQUE NEED

55 HOLDS AN AGREEMENT OR CONTRACT. A PROVIDER'S APPROVAL WITH THE DEPART-
56 MENT TO DELIVER EVALUATIONS OR EARLY INTERVENTION SERVICES SHALL TERMI-

1 NATE IF THE PROVIDER FAILS TO PROVIDE SUCH INFORMATION OR DOCUMENTATION
2 ACCEPTABLE TO THE DEPARTMENT OF ITS CONTRACTS OR AGREEMENTS WITH INSUR-
3 ERS OR HEALTH MAINTENANCE ORGANIZATIONS AS REQUESTED BY THE DEPARTMENT;

4 (c) [compiling and disseminating to the municipalities lists of
5 approved evaluators, service coordinators and providers of early inter-
6 vention services;

7 (d)] monitoring of agencies, institutions and organizations under this
8 title and agencies, institutions and organizations providing early
9 intervention services which are under the jurisdiction of a state early
10 intervention service agency;

11 [(e)] (D) enforcing any obligations imposed on those agencies under
12 this title or Part H of the federal individuals with disabilities educa-
13 tion act and its regulations;

14 [(f)] (E) providing training and technical assistance to those agen-
15 cies, institutions and organizations, including initial and ongoing
16 training and technical assistance to municipalities to help enable them
17 to identify, locate and evaluate eligible children, develop IFSPs,
18 ensure the provision of appropriate early intervention services, promote
19 the development of new services, where there is a demonstrated need for
20 such services and afford procedural safeguards to infants and toddlers

25 shall provide municipalities with the results of any review of early

PROVIDERS SHALL NOT DISCONTINUE OR DELAY SERVICES TO ELIGIBLE CHILDREN PENDING PAYMENT OF THE CLAIM OR DETERMINATIONS OF ANY APPEAL DENIALS.

(c) Payments made for early intervention services under an insurance policy or health benefit plan, INCLUDING PAYMENTS MADE BY THE MEDICAL ASSISTANCE PROGRAM OR THE CHILD HEALTH INSURANCE PROGRAM ESTABLISHED UNDER TITLE ONE-A OF THIS ARTICLE OR OTHER GOVERNMENTAL THIRD PARTY PAYOR, which are provided as part of an IFSP pursuant to section twenty-five hundred forty-five of this title shall not be applied by the insurer or plan administrator against any maximum lifetime or annual limits specified in the policy or health benefits plan, pursuant to section eleven of the chapter of the laws of nineteen hundred ninety-two which added this title.

[(d) A municipality, or its designee, shall be subrogated, to the extent of the expenditures by such municipality for early intervention services furnished to persons eligible for benefits under this title, to any rights such person may have or be entitled to from third party reimbursement. The right of subrogation does not attach to benefits paid or provided under any health insurance policy or health benefits plan prior to receipt of written notice of the exercise of subrogation rights by the insurer or plan administrator providing such benefits.]

"COVERED HEALTH CARE SERVICES" SHALL ALSO INCLUDE EARLY INTERVENTION SERVICES PROVIDED PURSUANT TO TITLE TWO-A OF THIS ARTICLE UP TO THE SCOPE AND LEVEL OF COVERAGE FOR THE SAME SERVICES PROVIDED PURSUANT TO THIS SUBDIVISION, AS DEFINED BY THE COMMISSIONER. "Covered health care services" shall not include drugs, procedures and supplies for the treatment of erectile dysfunction when provided to, or prescribed for use by, a person who is required to register as a sex offender pursuant to article six-C of the correction law, provided that any denial of coverage of such drugs, procedures or supplies shall provide the patient with the means of obtaining additional information concerning both the denial and the means of challenging such denial.

S 4148. ELECTRONIC DEATH REGISTRATION SYSTEM. 1. LEGISLATIVE FINDINGS. THE LEGISLATURE FINDS THAT IT IS NECESSARY TO UPDATE AND MODERNIZE THE STATE'S SYSTEM OF FILING AND MAINTAINING INFORMATION AND DOCUMENTS RELATED TO THE REGISTRATION OF DEATH. AN ELECTRONIC DEATH REGISTRATION SYSTEM WILL PROMOTE ACCURACY AND PROVIDE FOR MORE TIMELY TRANSMISSION OF DOCUMENTATION, PROMOTING EFFICIENCY IN THE OPERATIONS OF THE DEPARTMENT, WHICH OVERSEES THE DEATH REGISTRATION FILING PROCESS; LOCAL REGISTRARS, WHICH ACCEPT AND FILE CERTIFICATES OF DEATH AND ISSUE BURIAL AND REMOVAL PERMITS; HEALTH CARE INSTITUTIONS AND PRACTITIONERS, CORONERS AND MEDICAL EXAMINERS, WHICH PREPARE CERTIFICATES OF DEATH; AND LICENSED FUNERAL DIRECTORS AND UNDERTAKERS, WHO REQUIRE PROMPT ACCESS TO CERTIFICATES OF DEATH TO CONDUCT BURIALS AND FUNERALS IN A TIMELY FASHION. LICENSED FUNERAL DIRECTORS AND UNDERTAKERS HAVE EXPRESSED THEIR INTEREST IN PARTNERING WITH THE DEPARTMENT TO SUPPORT THE ESTABLISHMENT AND MAINTENANCE OF SUCH SYSTEM THROUGH A CONTRIBUTION, TENDERED FOR EACH BURIAL AND REMOVAL PERMIT ISSUED TO A LICENSED FUNERAL DIRECTOR OR UNDERTAKER, IN THE AMOUNT OF TWENTY DOLLARS.

2. THE DEPARTMENT IS HEREBY AUTHORIZED AND DIRECTED TO DESIGN, IMPLEMENT AND MAINTAIN AN ELECTRONIC DEATH REGISTRATION SYSTEM FOR COLLECTING, STORING, RECORDING, TRANSMITTING, AMENDING, CORRECTING AND AUTHENTICATING INFORMATION, AS NECESSARY AND APPROPRIATE TO COMPLETE A DEATH REGISTRATION, AND TO GENERATE SUCH DOCUMENTS AS DETERMINED BY THE DEPARTMENT IN RELATION TO A DEATH OCCURRING IN THIS STATE. THE CONTRIBUTION REFERENCED IN SUBDIVISION ONE OF THIS SECTION SHALL BE COLLECTED FOR EACH BURIAL OR REMOVAL PERMIT ISSUED ON OR AFTER THE EFFECTIVE DATE OF THIS SECTION FROM THE LICENSED FUNERAL DIRECTOR OR UNDERTAKER TO WHOM SUCH PERMIT IS ISSUED, IN THE MANNER SPECIFIED BY THE DEPARTMENT AND SHALL BE USED SOLELY FOR THE PURPOSE SET FORTH IN SUBDIVISION 1 OF THIS SECTION.

3. COMMENCING ON JANUARY FIRST, TWO THOUSAND FOURTEEN, OR AS SOON THEREAFTER AS THE COMMISSIONER REASONABLY DETERMINES IS FEASIBLE IN LIGHT OF THE INTENT OF THIS SECTION, THE DEPARTMENT SHALL REQUIRE THAT DEATHS OCCURRING WITHIN THIS STATE MUST BE REGISTERED USING THE ELECTRONIC DEATH REGISTRATION SYSTEM ESTABLISHED IN THIS SECTION. ELECTRONIC DEATH REGISTRATION MAY BE PHASED IN, AS DETERMINED BY THE COMMISSIONER, FOR DEATHS OCCURRING IN THE STATE UNTIL THE ELECTRONIC DEATH REGISTRATION SYSTEM IS FULLY IMPLEMENTED IN THE STATE.

4. COMMENCING ON JANUARY FIRST, TWO THOUSAND FOURTEEN, OR ON SUCH DATE DETERMINED BY THE COMMISSIONER PURSUANT TO SUBDIVISION 3 OF THIS

SECTION, ALL PERSONS REQUIRED TO REGISTER A DEATH OR FILE A CERTIFICATE OF DEATH UNDER THIS ARTICLE, AND SUCH OTHERS AS MAY BE AUTHORIZED BY THE COMMISSIONER, SHALL HAVE ACCESS TO THE ELECTRONIC DEATH REGISTRATION SYSTEM FOR THE PURPOSE OF ENTERING INFORMATION REQUIRED TO EXECUTE, COMPLETE AND FILE A CERTIFICATE OF DEATH OR TO RETRIEVE SUCH INFORMATION OR GENERATE DOCUMENTATION FROM THE ELECTRONIC DEATH REGISTRATION SYSTEM. THE CONFIDENTIALITY PROVISIONS IN SECTION FORTY-ONE HUNDRED FORTY-SEVEN OF THIS TITLE SHALL APPLY TO INFORMATION MAINTAINED IN THIS SYSTEM.

5. NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND FOURTEEN, OR ON SUCH DATE DETERMINED BY THE COMMISSIONER PURSUANT TO SUBDIVISION 3 OF THIS SECTION, ANY REQUIREMENT OF THIS TITLE FOR A SIGNATURE OF ANY PERSON SHALL BE DEEMED SATISFIED BY THE USE BY SUCH PERSON OF DIGITAL SIGNATURE PROVIDED SUCH PERSON IS AUTHORIZED IN ACCORDANCE WITH THIS SECTION TO USE THE ELECTRONIC DEATH REGISTRATION SYSTEM.

S 2. Subdivision 1 of section 4100-a of the public health law, as amended by chapter 644 of the laws of 1988, is amended and a new subdivision 5 is added to read as follows:

1. The term "certified copy" means a photographic reproduction in the form of a photocopy or a microfilm print of the original certificate OR ELECTRONICALLY PRODUCED PRINT OF THE ORIGINAL CERTIFICATE, COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND FOURTEEN, and certified by the commissioner, his designated representative, a local registrar [or his deputy], DEPUTY REGISTRAR OR SUB-REGISTRAR as a true copy thereof.

13 2. AMOUNTS PROVIDED PURSUANT TO THIS SECTION SHALL BE USED ONLY TO

15 ACTIVITIES TO HELP ENSURE A STABLE SYSTEM OF SUPPORTIVE HOUSING FOR

17 3. THE COMMISSIONER IS AUTHORIZED AND EMPOWERED TO MAKE INSPECTIONS

37 RESULTING FROM SUBDIVISION FOUR OF THIS SECTION. WITHIN ANY FISCAL YEAR

39 (D) "COMPETENT ORAL INTERPRETATION" MEANS ORAL COMMUNICATION IN WHICH
40 A PERSON ACTING AS AN INTERPRETER COMPREHENDS A SPOKEN MESSAGE AND
41 RE-EXPRESSES THAT MESSAGE ACCURATELY IN ANOTHER LANGUAGE, UTILIZING ALL
42 NECESSARY PHARMACEUTICAL AND HEALTH-RELATED TERMINOLOGY, SO AS TO ENABLE
43 AN LEP INDIVIDUAL TO RECEIVE ALL NECESSARY INFORMATION IN THE LEP INDI-

45 (E) "PHARMACY PRIMARY LANGUAGES" SHALL MEAN THE TOP SEVEN LANGUAGES
46 SPOKEN BY LEP INDIVIDUALS IN THIS STATE AS DETERMINED BIENNIALY BY THE
47 STATE BOARD OF PHARMACY BASED ON DATA FROM THE MOST RECENT AMERICAN
48 COMMUNITY SURVEY FROM THE UNITED STATES CENSUS BUREAU AND OTHER RELEVANT

"PRIMARY CARE SERVICE CORPS PRACTITIONER" MEANS A PHYSICIAN ASSISTANT, NURSE PRACTITIONER, NURSE MIDWIFE, GENERAL OR PEDODONTIC DENTIST, DENTAL HYGIENIST, CLINICAL PSYCHOLOGIST, LICENSED CLINICAL SOCIAL WORKER, PSYCHIATRIC NURSE PRACTITIONER, LICENSED MARRIAGE AND FAMILY THERAPIST, OR A LICENSED MENTAL HEALTH COUNSELOR, WHO IS LICENSED, REGISTERED, OR CERTIFIED TO PRACTICE IN NEW YORK STATE AND WHO PROVIDES COORDINATED PRIMARY CARE SERVICES, INCLUDING, BUT NOT LIMITED TO, ORAL HEALTH AND MENTAL HEALTH SERVICES.

3. "PHYSICIAN ASSISTANT" MEANS A PERSON WHO HAS BEEN REGISTERED AS SUCH PURSUANT TO ARTICLE ONE HUNDRED THIRTY-ONE-B OF THE EDUCATION LAW.

4. "NURSE PRACTITIONER" MEANS A PERSON WHO HAS BEEN CERTIFIED AS SUCH PURSUANT TO SECTION SIXTY-NINE HUNDRED TEN OF THE EDUCATION LAW.

5. "NURSE MIDWIFE" MEANS A PERSON WHO HAS BEEN LICENSED AS SUCH PURSUANT TO SECTION SIXTY-NINE HUNDRED FIFTY-FIVE OF THE EDUCATION LAW.

6. "PSYCHOLOGIST" MEANS A PERSON WHO HAS BEEN LICENSED AS SUCH PURSUANT TO SECTION SEVENTY-SIX HUNDRED THREE OF THE EDUCATION LAW.

7. "LICENSED CLINICAL SOCIAL WORKER" MEANS A PERSON WHO HAS BEEN LICENSED AS SUCH PURSUANT TO SECTION SEVENTY-SEVEN HUNDRED TWO OF THE EDUCATION LAW.

1 8. "PSYCHIATRIC NURSE PRACTITIONER" MEANS A NURSE PRACTITIONER WHO, BY
2 REASON OF TRAINING AND EXPERIENCE, PROVIDES A FULL SPECTRUM OF PSYCHIAT-
3 RIC CARE, ASSESSING, DIAGNOSING, AND MANAGING THE PREVENTION AND TREAT-
4 MENT OF PSYCHIATRIC DISORDERS AND MENTAL HEALTH PROBLEMS.

5 9. "LICENSED MARRIAGE AND FAMILY THERAPIST" MEANS A PERSON WHO HAS

15 12. "DENTAL HYGIENIST" MEANS A PERSON WHO IS LICENSED TO PRACTICE
16 DENTAL HYGIENE PURSUANT TO SECTION SIXTY-SIX HUNDRED NINE OF THE EDUCA-

19 1. THE COMMISSIONER IS AUTHORIZED, WITHIN AMOUNTS AVAILABLE THEREFOR, TO
20 MAKE LOAN REPAYMENT AWARDS TO ELIGIBLE PRIMARY CARE SERVICE CORPS PRAC-
21 TITIONERS WHO AGREE TO PRACTICE FULL-TIME IN AN UNDERSERVED AREA IN NEW
22 YORK STATE, IN AMOUNTS TO BE DETERMINED BY THE COMMISSIONER, BUT NOT TO
23 EXCEED THIRTY-TWO THOUSAND DOLLARS PER YEAR FOR ANY YEAR IN WHICH SUCH
24 PRACTITIONERS PROVIDE FULL-TIME ELIGIBLE OBLIGATED SERVICE.

25 2. LOAN REPAYMENT AWARDS MADE TO A PRIMARY CARE SERVICE CORPS PRACTI-
26 TIONER PURSUANT TO SUBDIVISION ONE OF THIS SECTION SHALL NOT EXCEED THE
27 TOTAL QUALIFYING OUTSTANDING DEBT OF THE PRACTITIONER FROM STUDENT LOANS
28 TO COVER TUITION AND OTHER RELATED EDUCATIONAL EXPENSES, MADE BY OR
29 GUARANTEED BY THE FEDERAL OR STATE GOVERNMENT, OR MADE BY A LENDING OR
30 EDUCATIONAL INSTITUTION APPROVED UNDER TITLE IV OF THE FEDERAL HIGHER
31 EDUCATION ACT. LOAN REPAYMENT AWARDS SHALL BE USED SOLELY TO REPAY SUCH
32 OUTSTANDING DEBT.

33 3. IN THE EVENT THAT ANY COMMITMENT PURSUANT TO THE AGREEMENT REFER-
34 ENCED IN SUBDIVISION ONE OF THIS SECTION IS NOT FULFILLED, THE RECIPIENT
35 SHALL BE RESPONSIBLE FOR REPAYMENT IN AMOUNTS WHICH SHALL BE CALCULATED
36 IN ACCORDANCE WITH THE FORMULA SET FORTH IN SUBDIVISION (B) OF SECTION
37 TWO HUNDRED FIFTY-FOUR-O OF TITLE FORTY-TWO OF THE UNITED STATES CODE,
38 AS AMENDED.

39 4. THE COMMISSIONER IS AUTHORIZED TO APPLY ANY FUNDS AVAILABLE FOR
40 PURPOSES OF SUBDIVISION ONE OF THIS SECTION FOR USE AS MATCHING FUNDS
41 FOR ANY AVAILABLE FEDERAL GRANTS FOR THE PURPOSE OF ASSISTING STATES IN
42 OPERATING LOAN REPAYMENT PROGRAMS.

43 5. THE COMMISSIONER MAY POSTPONE, CHANGE OR WAIVE THE SERVICE OBLI-
44 GATION AND REPAYMENTS AMOUNTS SET FORTH IN SUBDIVISIONS ONE AND THREE OF
45 THIS SECTION, RESPECTIVELY, IN INDIVIDUAL CIRCUMSTANCES WHERE THERE IS
46 COMPELLING NEED OR HARDSHIP.

47 6. IN ORDER TO BE ELIGIBLE TO RECEIVE A LOAN REPAYMENT AWARD UNDER
48 THIS SECTION, A PRIMARY CARE SERVICE CORPS PRACTITIONER MUST MEET SITE
49 AND SERVICE ELIGIBILITY CRITERIA AS DETERMINED BY THE COMMISSIONER.

50 7. THE COMMISSIONER SHALL PROMULGATE REGULATIONS NECESSARY TO EFFECTU-
51 ATE THE PROVISIONS AND PURPOSES OF THIS ARTICLE.

52 S 24. Paragraph (a) of subdivision 4 of section 2801-a of the public
53 health law, as amended by section 57 of part A of chapter 58 of the laws
54 of 2010, is amended to read as follows:

55 (a) Any change in the person who is the operator of a hospital shall
56 be approved by the public health and health planning council in accord-

1 ance with the provisions of subdivisions two and three of this section.
2 NO CHANGE IN THE DIRECTORS OF A NOT-FOR-PROFIT CORPORATION THAT IS THE
3 OPERATOR OF A HOSPITAL SHALL BE EFFECTIVE UNLESS, AT LEAST ONE HUNDRED
4 TWENTY DAYS PRIOR TO THE INTENDED EFFECTIVE DATE THEREOF, THE CORPO-
5 RATION FULLY COMPLETES AND FILES WITH THE DEPARTMENT NOTICE ON A FORM,
6 TO BE DEVELOPED BY THE DEPARTMENT, WHICH SHALL DISCLOSE SUCH INFORMATION
7 AS MAY REASONABLY BE NECESSARY FOR THE DEPARTMENT TO DETERMINE WHETHER
8 IT SHOULD BAR THE CHANGE IN DIRECTORS. Notwithstanding any inconsistent
9 provision of this paragraph, any change by a natural person who is the
10 operator of a hospital seeking to transfer part of his or her interest
11 in such hospital to another person or persons so as to create a partner-
12 ship shall be approved in accordance with the provisions of paragraph
13 (b) of this subdivision.

14 S 25. Section 2806 of the public health law is amended by adding a new
15 subdivision 2-a to read as follows:

16 2-A. (A) THE COMMISSIONER MAY TEMPORARILY SUSPEND OR LIMIT AN OPERAT-
17 ING CERTIFICATE OF A NOT-FOR-PROFIT CORPORATION WITHOUT A HEARING UPON:
18 (I) THE COMMENCEMENT BY THE DEPARTMENT OF AN ACTION TO REVOKE, SUSPEND,
19 LIMIT OR ANNUL THE OPERATING CERTIFICATE PURSUANT TO PARAGRAPH (A) OF
20 SUBDIVISION ONE OF THIS SECTION DUE TO REPEATED VIOLATIONS OF THIS ARTI-
21 CLE OR RULES AND REGULATIONS PROMULGATED THEREUNDER; (II) THE INDICTMENT
22 ON FELONY CHARGES OF ANY MEMBER OF THE CORPORATION'S BOARD OF DIRECTORS
23 OR (III) NOTICE FROM THE ATTORNEY GENERAL OF AN ACTION TO REMOVE ANY
24 MEMBER OF THE CORPORATION'S BOARD OF DIRECTORS PURSUANT TO PARAGRAPH (D)
25 OF SECTION SEVEN HUNDRED SIX OF THE NOT-FOR-PROFIT CORPORATION LAW. SUCH
26 SUSPENSION OR LIMITATION OF THE OPERATING CERTIFICATE SHALL REMAIN
27 EFFECTIVE UNTIL THE RESOLUTION OF THE CRIMINAL ACTION THAT IS THE
28 SUBJECT OF THE INDICTMENT OR UNTIL THE RESOLUTION OF THE ACTION OF THE
29 ATTORNEY GENERAL, AS APPLICABLE.

30 (B) IN THE EVENT ONE OR MORE MEMBERS OF A BOARD OF DIRECTORS OF A
31 NOT-FOR-PROFIT CORPORATION ARE THE SUBJECT OF AN ACTION TO LIMIT AN
32 OPERATING CERTIFICATE PURSUANT TO PARAGRAPH (A) OF SUBDIVISION ONE OF
33 THIS SECTION, HAVE BEEN INDICTED ON FELONY CHARGES, OR ARE THE SUBJECT
34 OF AN ACTION FOR REMOVAL BY THE ATTORNEY GENERAL AS DESCRIBED IN PARA-
35 GRAPH (A) OF THIS SUBDIVISION, THE COMMISSIONER MAY, IN ADDITION TO HIS
36 OR HER OTHER POWERS, LIMIT THE EXISTING OPERATING CERTIFICATE OF SUCH
37 CORPORATION SO THAT IT SHALL APPLY ONLY TO THE REMAINING MEMBERS OF THE
38 BOARD OF DIRECTORS PROVIDED THAT: (I) EVERY SUCH PERSON SUBJECT TO AN
39 ACTION TO LIMIT THE OPERATING CERTIFICATE PURSUANT TO PARAGRAPH (A) OF
40 SUBDIVISION ONE OF THIS SECTION, EVERY SUCH INDICTED PERSON, OR EVERY
41 SUCH PERSON SUBJECT TO AN ACTION FOR REMOVAL SHALL IMMEDIATELY AND
42 COMPLETELY CEASE AND WITHDRAW FROM PARTICIPATION, IN ANY CAPACITY, IN
43 THE MANAGEMENT, GOVERNANCE OR OPERATION OF THE HOSPITAL; AND (II) THE
44 COMMISSIONER HAS FOUND THAT THE REMAINING MEMBERS OF THE BOARD OF DIREC-
45 TORS ARE OF SUCH CHARACTER, EXPERIENCE, COMPETENCE AND STANDING SO AS TO
46 GIVE REASONABLE ASSURANCE OF THEIR ABILITY TO CONDUCT THE AFFAIRS OF THE
47 CORPORATION IN ITS BEST INTERESTS AND IN THE PUBLIC INTEREST. IF THE
48 CONDITIONS SET FORTH IN SUBPARAGRAPHS (I) AND (II) OF THIS PARAGRAPH ARE
49 NOT MET, OR IF THE LIMITATION OF THE OPERATING CERTIFICATE UNDER THIS
50 PARAGRAPH RESULTS IN A BOARD OF DIRECTORS OF LESS THAN THREE MEMBERS,
51 THE COMMISSIONER SHALL TEMPORARILY SUSPEND THE OPERATING CERTIFICATE
52 PURSUANT TO PARAGRAPH (A) OF THIS SUBDIVISION.

53 (C) NOTWITHSTANDING PARAGRAPHS (A) AND (B) OF THIS SUBDIVISION, WHERE
54 THE COMMISSIONER HAS FOUND THAT THE SUSPENSION OF A HOSPITAL OPERATING
55 CERTIFICATE PURSUANT TO THIS SECTION WOULD JEOPARDIZE EXISTING OR
56 CONTINUED ACCESS TO NECESSARY SERVICES WITHIN THE COMMUNITY, THE COMMIS-

SIONER MAY APPOINT TEMPORARY MEMBERS OF THE BOARD OF DIRECTORS TO OPERATE AND MANAGE THE HOSPITAL UNDER THE EXISTING OPERATING CERTIFICATE, UNTIL THE RESOLUTION OF THE CRIMINAL ACTION, ATTORNEY GENERAL ACTION OR ACTION BY THE DEPARTMENT DESCRIBED IN PARAGRAPH (A) OF THIS SUBDIVISION, AS APPLICABLE.

S 26. Paragraphs (a) and (b) of subdivision 5 of section 2806 of the public health law, paragraph (a) as amended by section 20 of part LL of chapter 56 of the laws of 2010 and paragraph (b) as amended by chapter 607 of the laws of 1981, are amended to read as follows:

(a) Except as provided in paragraphs (b) and (d) of this subdivision, anything contained in this section or in a certificate of relief from disabilities or a certificate of good conduct issued pursuant to article twenty-three of the correction law to the contrary notwithstanding, a hospital operating certificate of a hospital under control of a controlling person as defined in paragraph (a) of subdivision twelve of section twenty-eight hundred one-a of this article, or under control of any other entity, shall be revoked upon a finding by the department that such controlling person or any individual, member of a partnership, MEMBER OF A LIMITED LIABILITY COMPANY, MEMBER OF A BOARD OF DIRECTORS, or shareholder of a corporation to whom or to which an operating certificate has been issued, has been convicted of a class A, B or C felony, or a felony related in any way to any activity or program subject to the regulations, supervision, or administration of the department or of the office of temporary and disability assistance or in violation of the public officers law in a court of competent jurisdiction in the state, or of a crime outside the state which, if committed within the state, would have been a class A, B or C felony or a felony related in any way to any activity or program subject to the regulations, supervision, or administration of the department or of the office of temporary and disability assistance or in violation of the public officers law.

(b) In the event one or more members of a partnership, MEMBER OF A LIMITED LIABILITY COMPANY, MEMBER OF A BOARD OF DIRECTORS, or shareholders of a corporation shall have been convicted of a felony as described in paragraph (a) of this subdivision, the commissioner shall, in addition to his other powers, limit the existing operating certificate of such partnership or corporation so that it shall apply only to the remaining partner, MEMBER OF A LIMITED LIABILITY COMPANY, MEMBER OF A BOARD OF DIRECTORS, or shareholders, as the case may be, provided that every such convicted person immediately and completely ceases and withdraws from participation, IN ANY CAPACITY, in the management and operation of the hospital, and further provided that an application for approval of change of ownership, CHANGE OF BOARD MEMBERSHIP, or transfer of stock is filed without delay in accordance with the pertinent provisions of section twenty-eight hundred one-a of this [chapter] ARTICLE.

S 27. The public health law is amended by adding a new section 2806-a to read as follows:

S 2806-A. TEMPORARY OPERATOR. 1. FOR THE PURPOSES OF THIS SECTION: (A) THE TERM "ADULT CARE FACILITY" SHALL MEAN AN ADULT HOME OR ENRICHED HOUSING PROGRAM LICENSED PURSUANT TO ARTICLE SEVEN OF THE SOCIAL SERVICES LAW OR AN ASSISTED LIVING RESIDENCE LICENSED PURSUANT TO ARTICLE FORTY-SIX-B OF THIS CHAPTER; (B) THE TERM "ESTABLISHED OPERATOR" SHALL MEAN THE OPERATOR OF AN ADULT CARE FACILITY, A GENERAL HOSPITAL OR A DIAGNOSTIC AND TREATMENT CENTER THAT HAS BEEN ESTABLISHED AND ISSUED AN OPERATING CERTIFICATE AS SUCH PURSUANT TO THIS ARTICLE; (C) THE TERM "FACILITY" SHALL MEAN (I) A GENERAL HOSPITAL OR A DIAGNOSTIC AND TREAT-

MENT CENTER THAT HAS BEEN ISSUED AN OPERATING CERTIFICATE AS SUCH PURSU-
ANT TO THIS ARTICLE; OR (II) AN ADULT CARE FACILITY; AND (D) THE TERM
"TEMPORARY OPERATOR" SHALL MEAN ANY PERSON OR ENTITY THAT:

(I) AGREES TO OPERATE A FACILITY ON A TEMPORARY BASIS IN THE BEST
INTERESTS OF ITS RESIDENTS OR PATIENTS AND THE COMMUNITY SERVED BY THE
FACILITY; AND

(II) HAS DEMONSTRATED THAT HE OR SHE HAS THE CHARACTER, COMPETENCE AND
FINANCIAL ABILITY TO OPERATE THE FACILITY IN COMPLIANCE WITH APPLICABLE
STANDARDS.

2. (A) WHEN A STATEMENT OF DEFICIENCIES HAS BEEN ISSUED BY THE DEPART-
MENT AND UPON A DETERMINATION BY THE COMMISSIONER THAT THERE EXIST
SIGNIFICANT MANAGEMENT FAILURES, INCLUDING BUT NOT LIMITED TO ADMINIS-
TRATIVE, OPERATIONAL OR CLINICAL DEFICIENCIES OR FINANCIAL INSTABILITY,
IN A FACILITY THAT (I) SERIOUSLY ENDANGER THE LIFE, HEALTH OR SAFETY OF
RESIDENTS OR PATIENTS OR (II) JEOPARDIZE EXISTING OR CONTINUED ACCESS TO
NECESSARY SERVICES WITHIN THE COMMUNITY, HE OR SHE SHALL APPOINT A
TEMPORARY OPERATOR TO ASSUME SOLE CONTROL OVER AND SOLE RESPONSIBILITY
FOR THE OPERATIONS OF THAT FACILITY. THE APPOINTMENT OF A TEMPORARY
OPERATOR SHALL BE IN ADDITION TO ANY OTHER REMEDIES PROVIDED BY LAW.

(B) THE ESTABLISHED OPERATOR OF A FACILITY MAY AT ANY TIME REQUEST THE
COMMISSIONER TO APPOINT A TEMPORARY OPERATOR. UPON RECEIVING SUCH A
REQUEST, THE COMMISSIONER MAY, IF HE OR SHE DETERMINES THAT SUCH AN
ACTION IS NECESSARY TO RESTORE OR MAINTAIN THE PROVISION OF QUALITY CARE
TO THE RESIDENTS OR PATIENTS, ENTER INTO AN AGREEMENT WITH THE ESTAB-
LISHED OPERATOR FOR THE APPOINTMENT OF A TEMPORARY OPERATOR TO ASSUME
SOLE CONTROL OVER AND SOLE RESPONSIBILITY FOR THE OPERATIONS OF THAT
FACILITY.

3. A TEMPORARY OPERATOR APPOINTED PURSUANT TO THIS SECTION SHALL USE
HIS OR HER BEST EFFORTS TO CORRECT OR ELIMINATE ANY DEFICIENCIES,
MANAGEMENT FAILURES OR FINANCIAL INSTABILITY IN THE FACILITY AND TO
PROMOTE THE QUALITY AND ACCESSIBILITY OF HEALTH CARE SERVICES IN THE
COMMUNITY SERVED BY THE FACILITY. SUCH CORRECTION OR ELIMINATION OF
DEFICIENCIES, MANAGEMENT FAILURES OR FINANCIAL INSTABILITY SHALL NOT
INCLUDE MAJOR ALTERATIONS OF THE PHYSICAL STRUCTURE OF THE FACILITY.
DURING THE TERM OF HIS OR HER APPOINTMENT, THE TEMPORARY OPERATOR SHALL
HAVE THE AUTHORITY TO DIRECT THE MANAGEMENT OF THE FACILITY IN ALL
ASPECTS OF OPERATION AND SHALL BE AFFORDED FULL ACCESS TO THE ACCOUNTS
AND RECORDS OF THE FACILITY. THE TEMPORARY OPERATOR SHALL, DURING THIS
PERIOD, OPERATE THE FACILITY IN SUCH A MANNER AS TO PROMOTE SAFETY AND
TO PROMOTE THE QUALITY AND ACCESSIBILITY OF HEALTH CARE SERVICES OR
RESIDENTIAL CARE IN THE COMMUNITY SERVED BY THE FACILITY. THE TEMPORARY
OPERATOR SHALL HAVE THE POWER TO LET CONTRACTS THEREFOR OR INCUR
EXPENSES ON BEHALF OF THE FACILITY, PROVIDED THAT WHERE INDIVIDUAL ITEMS
OF REPAIRS, IMPROVEMENTS OR SUPPLIES EXCEED TEN THOUSAND DOLLARS, THE
TEMPORARY OPERATOR SHALL OBTAIN PRICE QUOTATIONS FROM AT LEAST THREE
REPUTABLE SOURCES. THE TEMPORARY OPERATOR SHALL NOT BE REQUIRED TO FILE
ANY BOND. NO SECURITY INTEREST IN ANY REAL OR PERSONAL PROPERTY COMPRIS-
ING THE FACILITY OR CONTAINED WITHIN THE FACILITY, OR IN ANY FIXTURE OF
THE FACILITY, SHALL BE IMPAIRED OR DIMINISHED IN PRIORITY BY THE TEMPO-
RARY OPERATOR. NEITHER THE TEMPORARY OPERATOR NOR THE DEPARTMENT SHALL
ENGAGE IN ANY ACTIVITY THAT CONSTITUTES A CONFISCATION OF PROPERTY WITH-
OUT THE PAYMENT OF FAIR COMPENSATION.

4. THE TEMPORARY OPERATOR SHALL BE ENTITLED TO A REASONABLE FEE, AS
DETERMINED BY THE COMMISSIONER, AND NECESSARY EXPENSES INCURRED DURING
HIS OR HER PERFORMANCE AS TEMPORARY OPERATOR, TO BE PAID FROM THE REVEN-
UE OF THE FACILITY. THE TEMPORARY OPERATOR SHALL COLLECT INCOMING

PAYMENTS FROM ALL SOURCES AND APPLY THEM FIRST TO THE REASONABLE FEE AND TO COSTS INCURRED IN THE PERFORMANCE OF HIS OR HER FUNCTIONS AS TEMPORARY OPERATOR. THE TEMPORARY OPERATOR SHALL BE LIABLE ONLY IN HIS OR HER CAPACITY AS TEMPORARY OPERATOR FOR INJURY TO PERSON AND PROPERTY BY REASON OF CONDITIONS OF THE FACILITY IN A CASE WHERE AN ESTABLISHED OPERATOR WOULD HAVE BEEN LIABLE; HE OR SHE SHALL NOT HAVE ANY LIABILITY IN HIS OR HER PERSONAL CAPACITY, EXCEPT FOR GROSS NEGLIGENCE AND INTENTIONAL ACTS.

5. (A) THE INITIAL TERM OF THE APPOINTMENT OF THE TEMPORARY OPERATOR SHALL NOT EXCEED ONE HUNDRED EIGHTY DAYS. AFTER ONE HUNDRED EIGHTY DAYS, IF THE COMMISSIONER DETERMINES THAT TERMINATION OF THE TEMPORARY OPERATOR WOULD CAUSE SIGNIFICANT DETERIORATION OF THE QUALITY OF, OR ACCESS TO, HEALTH CARE OR RESIDENTIAL CARE IN THE COMMUNITY OR THAT REAPPOINTMENT IS NECESSARY TO CORRECT THE DEFICIENCIES, MANAGEMENT FAILURE OR FINANCIAL INSTABILITY THAT REQUIRED THE APPOINTMENT OF THE TEMPORARY OPERATOR, THE COMMISSIONER MAY AUTHORIZE UP TO TWO ADDITIONAL NINETY DAY TERMS. WITHIN FOURTEEN DAYS PRIOR TO THE TERMINATION OF EACH TERM OF THE APPOINTMENT OF THE TEMPORARY OPERATOR, THE TEMPORARY OPERATOR SHALL SUBMIT TO THE COMMISSIONER AND TO THE ESTABLISHED OPERATOR A REPORT DESCRIBING THE ACTIONS TAKEN DURING THE APPOINTMENT TO ADDRESS SUCH DEFICIENCIES, MANAGEMENT FAILURES AND/OR FINANCIAL INSTABILITY. THE REPORT SHALL REFLECT BEST EFFORTS TO PRODUCE A FULL AND COMPLETE ACCOUNTING.

(B) UPON THE COMPLETION OF THE TWO NINETY DAY TERMS REFERENCED IN PARAGRAPH (A) OF THIS SUBDIVISION, IF THE COMMISSIONER DETERMINES THAT TERMINATION OF THE TEMPORARY OPERATOR WOULD CAUSE SIGNIFICANT DETERIORATION OF THE QUALITY OF, OR ACCESS TO, HEALTH CARE OR RESIDENTIAL CARE IN THE COMMUNITY OR THAT REAPPOINTMENT IS NECESSARY TO CONTINUE THE CORRECTION OF THE DEFICIENCIES, MANAGEMENT FAILURE OR FINANCIAL INSTABILITY THAT REQUIRED THE APPOINTMENT OF THE TEMPORARY OPERATOR, THE COMMISSIONER MAY REAPPOINT THE TEMPORARY OPERATOR FOR ADDITIONAL NINETY DAY TERMS, PROVIDED THAT THE COMMISSIONER SHALL PROVIDE FOR NOTICE AND THE OPPORTUNITY FOR A HEARING AS SET FORTH IN SUBDIVISION SIX OF THIS SECTION.

(C) THE TERM OF THE INITIAL APPOINTMENT AND OF ANY SUBSEQUENT REAPPOINTMENT MAY BE TERMINATED PRIOR TO THE EXPIRATION OF THE DESIGNATED TERM, IF THE ESTABLISHED OPERATOR AND THE COMMISSIONER AGREE ON A PLAN OF CORRECTION AND THE IMPLEMENTATION OF SUCH PLAN.

6. THE COMMISSIONER SHALL, UPON MAKING A DETERMINATION TO APPOINT A TEMPORARY OPERATOR PURSUANT TO PARAGRAPH (A) OF SUBDIVISION TWO OF THIS SECTION OR REAPPOINT A TEMPORARY OPERATOR FOR THE FIRST ADDITIONAL NINETY DAY TERM PURSUANT TO PARAGRAPH (A) OF SUBDIVISION FIVE OF THIS SECTION, CAUSE THE ESTABLISHED OPERATOR OF THE FACILITY TO BE NOTIFIED OF THE DETERMINATION BY REGISTERED OR CERTIFIED MAIL ADDRESSED TO THE PRINCIPAL OFFICE OF THE ESTABLISHED OPERATOR. UPON RECEIPT OF SUCH NOTIFICATION AT THE PRINCIPAL OFFICE OF THE ESTABLISHED OPERATOR AND BEFORE THE EXPIRATION OF TEN DAYS THEREAFTER, THE ESTABLISHED OPERATOR MAY REQUEST AN ADMINISTRATIVE HEARING ON THE DETERMINATION TO BEGIN NO LATER THAN SIXTY DAYS FROM THE DATE OF THE APPOINTMENT OR REAPPOINTMENT OF THE TEMPORARY OPERATOR. ANY SUCH HEARING SHALL BE STRICTLY LIMITED TO THE ISSUE OF WHETHER

1 THE DETERMINATION OF THE COMMISSIONER WHICH RESULTED IN THE APPOINTMENT
2 OR REAPPOINTMENT IS SUPPORTED BY SUBSTANTIAL EVIDENCE.

12 OR ANY OTHER PERSON FOR THE PAYMENT OF MORTGAGES OR LIENS.

31 S 3980. STATEMENT OF POLICY AND PURPOSES. THE PURPOSE OF THIS ARTICLE

33 CONFORMANCE WITH THE FEDERAL PATIENT PROTECTION AND AFFORDABLE CARE ACT,

6 CILIATION ACT OF 2010, PUBLIC LAW 111-152, AND ANY REGULATIONS OR GUID-

8 6. "HEALTH PLAN" MEANS A POLICY, CONTRACT OR CERTIFICATE, OFFERED OR
9 ISSUED BY AN INSURER TO PROVIDE, DELIVER, ARRANGE FOR, PAY FOR OR REIM-
10 BURSE ANY OF THE COSTS OF HEALTH CARE SERVICES. HEALTH PLAN SHALL NOT

22 DENTAL TO OTHER INSURANCE BENEFITS;

23 (H) LIMITED SCOPE DENTAL OR VISION BENEFITS, BENEFITS FOR LONG-TERM
24 CARE INSURANCE, NURSING HOME INSURANCE, HOME CARE INSURANCE, OR ANY
25 COMBINATION THEREOF, OR SUCH OTHER SIMILAR, LIMITED BENEFITS HEALTH
26 INSURANCE AS SPECIFIED IN FEDERAL REGULATIONS, IF THE BENEFITS ARE
27 PROVIDED UNDER A SEPARATE POLICY, CERTIFICATE OR CONTRACT OF INSURANCE
28 OR ARE OTHERWISE NOT AN INTEGRAL PART OF THE PLAN;

29 (I) COVERAGE ONLY FOR A SPECIFIED DISEASE OR ILLNESS, HOSPITAL INDEM-
30 NITY, OR OTHER FIXED INDEMNITY COVERAGE;

31 (J) MEDICARE SUPPLEMENTAL INSURANCE AS DEFINED IN SECTION 1882(G)(1)
32 OF THE FEDERAL SOCIAL SECURITY ACT, COVERAGE SUPPLEMENTAL TO THE COVER-
33 AGE PROVIDED UNDER CHAPTER 55 OF TITLE 10 OF THE UNITED STATES CODE, OR
34 SIMILAR SUPPLEMENTAL COVERAGE PROVIDED UNDER A GROUP HEALTH PLAN IF IT
35 IS OFFERED AS A SEPARATE POLICY, CERTIFICATE OR CONTRACT OF INSURANCE;
36 OR

37 (K) THE MEDICAL INDEMNITY FUND ESTABLISHED PURSUANT TO TITLE FOUR OF
38 ARTICLE TWENTY-NINE-D OF THE PUBLIC HEALTH LAW.

39 7. "INSURER" MEANS AN INSURANCE COMPANY SUBJECT TO ARTICLE THIRTY-TWO
40 OR FORTY-THREE OF THE INSURANCE LAW, OR A HEALTH MAINTENANCE ORGANIZA-
41 TION CERTIFIED PURSUANT TO ARTICLE FORTY-FOUR OF THE PUBLIC HEALTH LAW
42 THAT CONTRACTS OR OFFERS TO CONTRACT TO PROVIDE, DELIVER, ARRANGE, PAY
43 OR REIMBURSE ANY OF THE COSTS OF HEALTH CARE SERVICES.

44 8. "QUALIFIED DENTAL PLAN" MEANS A LIMITED SCOPE DENTAL PLAN THAT IS
45 ISSUED BY AN INSURER AND CERTIFIED IN ACCORDANCE WITH SECTION
46 THIRTY-NINE HUNDRED EIGHTY-FIVE OF THIS ARTICLE.

47 9. "QUALIFIED EMPLOYER" MEANS A SMALL EMPLOYER THAT ELECTS TO MAKE ITS
48 FULL-TIME EMPLOYEES ELIGIBLE FOR ONE OR MORE QUALIFIED HEALTH PLANS
49 THROUGH THE EXCHANGE.

50 10. "QUALIFIED HEALTH PLAN" MEANS A HEALTH PLAN THAT IS ISSUED BY AN
51 INSURER AND CERTIFIED IN ACCORDANCE WITH SECTION THIRTY-NINE HUNDRED
52 EIGHTY-FIVE OF THIS ARTICLE.

53 11. "QUALIFIED INDIVIDUAL" MEANS AN INDIVIDUAL, INCLUDING A MINOR,

3 CERATION PENDING THE DISPOSITION OF CHARGES; AND

4 (D) IS, AND IS REASONABLY EXPECTED TO BE, FOR THE ENTIRE PERIOD FOR
5 WHICH ENROLLMENT IS SOUGHT, A CITIZEN OR NATIONAL OF THE UNITED STATES
6 OR AN ALIEN LAWFULLY PRESENT IN THE UNITED STATES.

7 12. "SECRETARY" MEANS THE SECRETARY OF THE UNITED STATES DEPARTMENT OF
8 HEALTH AND HUMAN SERVICES.

9 13. "SHOP" MEANS THE SMALL BUSINESS HEALTH OPTIONS PROGRAM DESIGNED TO
10 ASSIST QUALIFIED EMPLOYERS IN THIS STATE IN FACILITATING THE ENROLLMENT
11 OF THEIR EMPLOYEES IN QUALIFIED HEALTH PLANS OFFERED IN THE GROUP MARKET
12 IN THIS STATE.

13 14. "SMALL EMPLOYER" MEANS, FOR PLAN YEARS PRIOR TO JANUARY FIRST, TWO
14 THOUSAND SIXTEEN, AN EMPLOYER THAT EMPLOYED AN AVERAGE OF AT LEAST ONE
15 BUT NOT MORE THAN FIFTY EMPLOYEES ON BUSINESS DAYS DURING THE PRECEDING
16 CALENDAR YEAR. FOR PLAN YEARS BEGINNING ON AND AFTER JANUARY FIRST, TWO
17 THOUSAND SIXTEEN, SMALL EMPLOYER MEANS AN EMPLOYER THAT EMPLOYED AN
18 AVERAGE OF AT LEAST ONE BUT NOT MORE THAN ONE HUNDRED EMPLOYEES ON BUSI-
19 NESS DAYS DURING THE PRECEDING CALENDAR YEAR. FOR PURPOSES OF THE DEFINI-
20 TION OF SMALL EMPLOYER:

21 (A) ALL PERSONS TREATED AS A SINGLE EMPLOYER UNDER SUBSECTION (B),
22 (C), (M) OR (O) OF SECTION 414 OF THE INTERNAL REVENUE CODE OF 1986
23 SHALL BE TREATED AS A SINGLE EMPLOYER;

24 (B) AN EMPLOYER AND ANY PREDECESSOR EMPLOYER SHALL BE TREATED AS A
25 SINGLE EMPLOYER;

26 (C) ALL EMPLOYEES SHALL BE COUNTED, INCLUDING PART-TIME EMPLOYEES AND
27 EMPLOYEES WHO ARE NOT ELIGIBLE FOR COVERAGE THROUGH THE EMPLOYER;

28 (D) IF AN EMPLOYER WAS NOT IN EXISTENCE THROUGHOUT THE PRECEDING
29 CALENDAR YEAR, THEN THE DETERMINATION OF WHETHER THAT EMPLOYER IS A
30 SMALL EMPLOYER SHALL BE BASED UPON THE AVERAGE NUMBER OF EMPLOYEES THAT
31 THE EMPLOYER REASONABLY EXPECTS TO EMPLOY ON BUSINESS DAYS IN THE
32 CURRENT CALENDAR YEAR;

33 (E) IF A QUALIFIED EMPLOYER THAT MAKES ENROLLMENT IN QUALIFIED HEALTH
34 PLANS AVAILABLE TO ITS EMPLOYEES THROUGH THE EXCHANGE CEASES TO BE A
35 SMALL EMPLOYER BY REASON OF AN INCREASE IN THE NUMBER OF ITS EMPLOYEES,
36 THEN THE EMPLOYER SHALL CONTINUE TO BE TREATED AS A QUALIFIED EMPLOYER
37 FOR PURPOSES OF THIS ARTICLE FOR THE PERIOD BEGINNING WITH THE INCREASE

40 (F) NOTWITHSTANDING PARAGRAPHS (A) THROUGH (E) OF THIS SUBDIVISION, AN
41 EMPLOYER ALSO SHALL BE CONSIDERED A SMALL EMPLOYER IF THE COVERAGE IT
42 OFFERS WOULD BE CONSIDERED SMALL GROUP COVERAGE UNDER THE INSURANCE LAW
43 AND REGULATIONS PROMULGATED THEREUNDER PROVIDED THAT IT IS NOT OTHERWISE
44 PROHIBITED UNDER THE FEDERAL ACT.

45 15. "SMALL GROUP MARKET" MEANS THE HEALTH INSURANCE MARKET UNDER WHICH
46 INDIVIDUALS RECEIVE HEALTH INSURANCE COVERAGE ON BEHALF OF THEMSELVES
47 AND THEIR DEPENDENTS THROUGH A GROUP HEALTH PLAN MAINTAINED BY A SMALL

49 16. "SUPERINTENDENT" MEANS THE SUPERINTENDENT OF FINANCIAL SERVICES.

50 S 3982. ESTABLISHMENT OF THE NEW YORK HEALTH BENEFIT EXCHANGE. 1.
51 THERE IS HEREBY CREATED A PUBLIC BENEFIT CORPORATION TO BE KNOWN AS THE

18 (VI) PURCHASING HEALTH PLAN COVERAGE.

19 (C) RECOMMENDATIONS AND APPOINTMENTS SHALL TAKE INTO CONSIDERATION THE
20 EXPERTISE OF OTHER DIRECTORS RECOMMENDED AND APPOINTED PURSUANT TO THIS
21 SUBDIVISION, SO THAT THE BOARD COMPOSITION REFLECTS A DIVERSITY OF EXPE-
22 RIENCE AND COMPLIES WITH ANY REGULATIONS ISSUED BY THE SECRETARY PURSU-
23 ANT TO THE FEDERAL ACT.

24 (D) RECOMMENDATIONS BY THE TEMPORARY PRESIDENT OF THE SENATE AND THE
25 SPEAKER OF THE ASSEMBLY SHALL BE MADE WITHIN THIRTY DAYS OF THE EFFEC-

44 6. THE DIRECTORS SHALL NOT RECEIVE ANY COMPENSATION FOR THEIR SERVICES
45 AS DIRECTORS.

46 7. (A) EACH DIRECTOR SHALL HAVE THE RESPONSIBILITY AND DUTY TO MEET
47 THE REQUIREMENTS OF THIS ARTICLE, THE FEDERAL ACT, AND ALL APPLICABLE
48 STATE AND FEDERAL LAWS AND REGULATIONS TO SERVE THE PUBLIC INTEREST OF
49 THE INDIVIDUALS AND SMALL BUSINESSES SEEKING HEALTH CARE COVERAGE
50 THROUGH THE EXCHANGE, CONSISTENT WITH SECTION TWENTY-EIGHT HUNDRED TWEN-

20 AND OTHERWISE DEAL IN AND WITH, REAL OR PERSONAL PROPERTY, OR ANY INTER-
21 EST THEREIN, WHEREVER SITUATED;

22 4. TO SELL, CONVEY, LEASE, EXCHANGE, TRANSFER OR OTHERWISE DISPOSE OF,
23 OR MORTGAGE OR PLEDGE, OR CREATE A SECURITY INTEREST IN, ALL OR ANY OF
24 ITS PROPERTY, OR ANY INTEREST THEREIN, WHEREVER SITUATED;

25 5. TO MAKE CONTRACTS, GIVE GUARANTEES AND INCUR LIABILITIES, AND
26 BORROW MONEY; PROVIDED, HOWEVER, THAT THE EXCHANGE SHALL NOT ISSUE
27 BONDS;

28 6. TO INVEST AND REINVEST ITS FUNDS, AND TAKE AND HOLD REAL AND
29 PERSONAL PROPERTY AS SECURITY FOR THE PAYMENT OF FUNDS SO LOANED OR
30 INVESTED;

31 7. TO MAKE AND ALTER BY-LAWS FOR ITS ORGANIZATION AND MANAGEMENT;

32 8. TO MAKE AND ALTER RULES AND REGULATIONS AS NECESSARY TO IMPLEMENT
33 THE PROVISIONS OF THIS ARTICLE, SUBJECT TO THE PROVISIONS OF THE STATE
34 ADMINISTRATIVE PROCEDURE ACT;

35 9. TO HIRE EMPLOYEES, CONSISTENT WITH SECTION THIRTY-NINE HUNDRED
36 NINETY OF THIS ARTICLE;

37 10. TO DESIGNATE THE DEPOSITORIES OF ITS MONEY;

38 11. TO ESTABLISH ITS FISCAL YEAR;

39 12. TO INSURE OR OTHERWISE PROVIDE FOR THE INSURANCE OF THE EXCHANGE'S
40 PROPERTY OR OPERATIONS AND AGAINST SUCH OTHER RISKS AS THE EXCHANGE MAY
41 DEEM ADVISABLE;

42 13. TO RECEIVE AND SPEND MONEY FOR ANY OF ITS CORPORATE PURPOSES IN
43 ACCORDANCE WITH THIS ARTICLE; AND

44 14. TO APPLY FOR, ACCEPT THE AWARD OF, AND SPEND ANY AVAILABLE GRANT
45 MONEY.

46 S 3984. FUNCTIONS OF THE EXCHANGE. THE EXCHANGE SHALL:

47 1. (A) MAKE AVAILABLE QUALIFIED HEALTH PLANS TO QUALIFIED INDIVIDUALS

55 NOT BECOME EFFECTIVE PRIOR TO SUCH DATE, EITHER SEPARATELY OR IN
56 CONJUNCTION WITH A QUALIFIED HEALTH PLAN, IF SUCH PLAN PROVIDES PEDIA-

TRIC DENTAL BENEFITS MEETING THE REQUIREMENTS OF SECTION 1302(B)(1)(J) OF THE FEDERAL ACT;

ASSIGN A RATING TO EACH QUALIFIED HEALTH PLAN OFFERED THROUGH THE EXCHANGE IN ACCORDANCE WITH THE CRITERIA DEVELOPED BY THE SECRETARY PURSUANT TO SECTION 1311(C)(3) OF THE FEDERAL ACT, AND DETERMINE EACH QUALIFIED HEALTH PLAN'S LEVEL OF COVERAGE IN ACCORDANCE WITH REGULATIONS ISSUED BY THE SECRETARY PURSUANT TO SECTION 1302(D)(2)(A) OF THE FEDERAL ACT;

3. UTILIZE A STANDARDIZED FORMAT FOR PRESENTING HEALTH BENEFIT OPTIONS IN THE EXCHANGE, INCLUDING THE USE OF THE UNIFORM OUTLINE OF COVERAGE ESTABLISHED UNDER SECTION 2715 OF THE FEDERAL PUBLIC HEALTH SERVICE ACT;

4. 9. MAINTAIN AN INTERNET WEBSITE THROUGH WHICH ENROLLEES AND PROSPECTIVE ENROLLEES OF QUALIFIED HEALTH PLANS MAY OBTAIN STANDARDIZED COMPARATIVE INFORMATION ON SUCH PLANS AND PUBLIC HEALTH PROGRAMS;

10. ESTABLISH AND MAKE AVAILABLE BY ELECTRONIC MEANS A CALCULATOR TO DETERMINE THE ACTUAL COST OF COVERAGE AFTER THE APPLICATION OF ANY PREMIUM TAX CREDIT UNDER SECTION 36B OF THE INTERNAL REVENUE CODE OF 1986 AND ANY COST-SHARING REDUCTION UNDER SECTION 1402 OF THE FEDERAL ACT;

11. ESTABLISH A PROGRAM UNDER WHICH THE EXCHANGE AWARDS GRANTS TO ENTITIES TO SERVE AS NAVIGATORS, IN ACCORDANCE WITH SECTION 1311(I) OF THE FEDERAL ACT AND REGULATIONS ADOPTED THEREUNDER;

33 21. SUBMIT INFORMATION PROVIDED BY EXCHANGE APPLICANTS FOR VERIFICA-
34 TION AS REQUIRED BY SECTION 1411(C) OF THE FEDERAL ACT;

35 22. ESTABLISH RULES AND REGULATIONS, PURSUANT TO SUBDIVISION EIGHT OF
36 SECTION THIRTY-NINE HUNDRED EIGHTY-THREE OF THIS ARTICLE, THAT DO NOT
37 CONFLICT WITH OR PREVENT THE APPLICATION OF REGULATIONS PROMULGATED BY

48 (A) SUBMIT A JUSTIFICATION FOR ANY PREMIUM INCREASE TO THE EXCHANGE

9 SECRETARY AND THE SUPERINTENDENT, ACCURATE AND TIMELY DISCLOSURE OF:

10 (A) CLAIMS PAYMENT POLICIES AND PRACTICES;

11 (B) PERIODIC FINANCIAL DISCLOSURES;

12 (C) DATA ON ENROLLMENT AND DISENROLLMENT;

13 (D) DATA ON THE NUMBER OF CLAIMS THAT ARE DENIED;

14 (E) DATA ON RATING PRACTICES;

15 (F) INFORMATION ON COST-SHARING AND PAYMENTS WITH RESPECT TO ANY OUT-
16 OF-NETWORK COVERAGE;

17 (G) INFORMATION ON ENROLLEE AND PARTICIPANT RIGHTS UNDER TITLE I OF
18 THE FEDERAL ACT; AND

19 (H) OTHER INFORMATION AS DETERMINED APPROPRIATE BY THE SECRETARY;

20 (II) THE INFORMATION SHALL BE PROVIDED IN PLAIN LANGUAGE, AS THAT TERM
21 IS DEFINED IN SECTION 1311(E)(3)(B) OF THE FEDERAL ACT, AND IN GUIDANCE
22 JOINTLY ISSUED THEREUNDER BY THE SECRETARY AND THE FEDERAL SECRETARY OF
23 LABOR; AND

24 (C) PROVIDE TO INDIVIDUALS, IN A TIMELY MANNER UPON THE REQUEST OF THE
25 INDIVIDUAL, THE AMOUNT OF COST-SHARING, INCLUDING DEDUCTIBLES, COPAY-
26 MENTS, AND COINSURANCE, UNDER THE INDIVIDUAL'S HEALTH PLAN OR COVERAGE

52 S 3986. REGIONAL ADVISORY COMMITTEES. 1. THERE ARE HEREBY CREATED THE

8 3. TERMS SHALL BE THREE YEARS. MEMBERS SHALL SERVE UNTIL THEIR

10 4. VACANCIES SHALL BE FILLED IN THE SAME MANNER AS ORIGINAL APPOINT-

12 TERM TO WHICH THEY ARE APPOINTED.

13 5. RECOMMENDATIONS BY THE TEMPORARY PRESIDENT OF THE SENATE AND THE
14 SPEAKER OF THE ASSEMBLY SHALL BE MADE WITHIN SIXTY DAYS OF THE EFFECTIVE
15 DATE OF THIS ARTICLE OR THE OCCURRENCE OF A VACANCY, OR WITHIN SIXTY
16 DAYS PRIOR TO THE EXPIRATION OF A TERM.

17 6. THE MEMBERS OF EACH REGIONAL ADVISORY COMMITTEE SHALL INCLUDE:

18 (A) REPRESENTATIVES FROM THE FOLLOWING CATEGORIES, BUT NOT MORE THAN
19 TWO FROM ANY SINGLE CATEGORY:

20 (I) HEALTH PLAN CONSUMER ADVOCATES;

21 (II) SMALL BUSINESS CONSUMER REPRESENTATIVES;

22 (III) HEALTH CARE PROVIDER REPRESENTATIVES;

23 (IV) REPRESENTATIVES OF THE HEALTH INSURANCE INDUSTRY;

24 (B) REPRESENTATIVES FROM THE FOLLOWING CATEGORIES, BUT NOT MORE THAN
25 ONE FROM EITHER CATEGORY:

26 (I) LICENSED INSURANCE PRODUCERS; AND

27 (II) REPRESENTATIVES OF LABOR ORGANIZATIONS.

28 7. THE BOARD SHALL SELECT THE CHAIR OF EACH REGIONAL ADVISORY COMMIT-
29 TEE FROM AMONG THE MEMBERS OF SUCH COMMITTEE. THE BOARD SHALL ADOPT
30 RULES FOR THE GOVERNANCE OF THE REGIONAL ADVISORY COMMITTEES AND EACH
31 REGIONAL ADVISORY COMMITTEE SHALL MEET AT LEAST ONCE EACH QUARTER AND AT
32 SUCH OTHER TIMES AS DETERMINED BY THE BOARD TO BE NECESSARY.

33 8. MEMBERS OF THE REGIONAL ADVISORY COMMITTEES SHALL SERVE WITHOUT
34 COMPENSATION.

35 9. THE REGIONAL ADVISORY COMMITTEES SHALL MAKE FINDINGS AND RECOMMEN-
36 DATIONS REGARDING REGIONAL VARIATIONS IN THE OPERATION OF THE EXCHANGE,
37 WHICH SHALL BE SUBMITTED TO THE BOARD OF DIRECTORS, POSTED ON THE
38 WEBSITE OF THE EXCHANGE, AND CONSIDERED BY THE BOARD IN A REASONABLY
39 TIMELY FASHION. SUCH FINDINGS AND RECOMMENDATIONS SHALL BE MADE ON AN
40 ANNUAL BASIS, ON A DATE DETERMINED BY THE BOARD, AND AT SUCH OTHER TIMES
41 AS THE BOARD OR ANY REGIONAL ADVISORY COMMITTEE DEEMS APPROPRIATE.

42 S 3987. FUNDING OF THE EXCHANGE. 1. THE EXCHANGE SHALL BE FINANCIALLY
43 SELF-SUFFICIENT BY JANUARY FIRST, TWO THOUSAND FIFTEEN.

44 2. THE EXCHANGE SHALL CONDUCT OR CAUSE TO BE CONDUCTED A STUDY OF, AND
45 SHALL REPORT ITS RECOMMENDATIONS UPON, THE OPTIONS TO GENERATE FUNDING
46 FOR THE ONGOING OPERATION OF THE EXCHANGE, AS PROVIDED FOR IN SUBDIVI-
47 SION EIGHT OF SECTION THIRTY-NINE HUNDRED EIGHTY-EIGHT OF THIS ARTICLE
48 AND SUBJECT TO THE PROVISIONS OF SUBDIVISIONS FOURTEEN AND FIFTEEN OF
49 SUCH SECTION.

50 3. THE EXCHANGE SHALL PUBLISH ON ITS INTERNET WEBSITE THE FEES AND
51 ANY OTHER PAYMENTS REQUIRED BY THE EXCHANGE, AND THE ADMINISTRATIVE
52 COSTS OF THE EXCHANGE, TO EDUCATE CONSUMERS ON SUCH COSTS AND THE AMOUNT
53 OF MONIES LOST TO WASTE, FRAUD AND ABUSE.

54 4. THE EXCHANGE SHALL NOT UTILIZE ANY FUNDS INTENDED FOR THE ADMINIS-
55 TRATIVE AND OPERATIONAL EXPENSES OF THE EXCHANGE FOR STAFF RETREATS,
56 PROMOTIONAL GIVEAWAYS, EXCESSIVE EXECUTIVE COMPENSATION, OR PROMOTION OF

FEDERAL OR STATE LEGISLATIVE AND REGULATORY MODIFICATIONS PURSUANT TO SECTION 1411(C) OF THE FEDERAL ACT.

5. THE MONEYS OF THE EXCHANGE SHALL, EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, BE DEPOSITED IN A GENERAL ACCOUNT CALLED THE NEW YORK HEALTH BENEFIT EXCHANGE ACCOUNT AND SUCH OTHER ACCOUNTS AS THE EXCHANGE MAY DEEM NECESSARY, PURSUANT TO RESOLUTION OF THE BOARD, FOR THE TRANSACTION OF ITS BUSINESS AND SHALL BE PAID OUT AS AUTHORIZED BY THE CHAIR OF THE BOARD OR BY SUCH OTHER PERSON OR PERSONS AS THE CHAIR MAY DESIGNATE.

6. NO FUNDS OF THE EXCHANGE SHALL BE TRANSFERRED TO THE GENERAL FUND OR ANY SPECIAL REVENUE FUND OR SHALL BE USED FOR ANY PURPOSE OTHER THAN THE PURPOSES SET FORTH IN THIS ARTICLE. NO FUNDS SHALL BE TRANSFERRED FROM THE GENERAL FUND OR ANY SPECIAL REVENUE FUND TO THE EXCHANGE WITHOUT AN APPROPRIATION.

7. THE ACCOUNTS OF THE EXCHANGE SHALL BE SUBJECT TO SUPERVISION OF THE COMPTROLLER AND SUCH ACCOUNTS SHALL INCLUDE RECEIPTS, EXPENDITURES, CONTRACTS AND OTHER MATTERS WHICH PERTAIN TO THE FISCAL SOUNDNESS OF THE EXCHANGE.

NOTWITHSTANDING ANY LAW TO THE CONTRARY, AND IN ACCORDANCE WITH SECTION FOUR OF THE STATE FINANCE LAW, UPON REQUEST OF THE DIRECTOR OF THE BUDGET, IN CONSULTATION WITH THE COMMISSIONER, THE SUPERINTENDENT AND THE CHAIR OF THE BOARD, THE COMPTROLLER IS HEREBY AUTHORIZED AND DIRECTED TO SUBALLOCATE OR TRANSFER SPECIAL REVENUE FEDERAL FUNDS APPROPRIATED TO THE DEPARTMENT OF HEALTH FOR PLANNING AND IMPLEMENTING VARIOUS HEALTHCARE AND INSURANCE REFORM INITIATIVES AUTHORIZED BY FEDERAL LEGISLATION, INCLUDING, BUT NOT LIMITED TO, THE PATIENT PROTECTION AND AFFORDABLE CARE ACT (P.L. 111-148) AND THE HEALTH CARE AND EDUCATION RECONCILIATION ACT OF 2010 (P.L. 111-152) TO THE NEW YORK STATE HEALTH BENEFIT EXCHANGE. MONEYS SUBALLOCATED OR TRANSFERRED PURSUANT TO THIS SECTION SHALL BE PAID OUT OF THE FUND UPON AUDIT AND WARRANT OF THE STATE COMPTROLLER ON VOUCHERS CERTIFIED OR APPROVED BY THE EXCHANGE.

S 3988. STUDIES AND RECOMMENDATIONS. 1. S 3989. TAX EXEMPTION AND TAX CONTRACT BY THE STATE. 1. IT IS HEREBY DETERMINED THAT THE CREATION OF THE EXCHANGE AND THE FULFILLMENT OF ITS CORPORATE PURPOSES IS IN ALL RESPECTS FOR THE BENEFIT OF THE PEOPLE OF THIS STATE AND IS A PUBLIC PURPOSE. 26 MANNER AND CONSISTENT WITH THOSE EMPLOYEES DESCRIBED IN SUBDIVISION SIX
27 OF THIS SECTION.

28 3. ANY PUBLIC OFFICER OR EMPLOYEE OF A STATE DEPARTMENT, AGENCY OR
29 COMMISSION MAY BE TRANSFERRED TO THE EXCHANGE WITHOUT EXAMINATION AND
30 WITHOUT LOSS OF ANY CIVIL SERVICE STATUS OR RIGHTS TO A COMPARABLE
31 OFFICE, POSITION OR EMPLOYMENT WITH THE EXCHANGE; PROVIDED, HOWEVER, NO
32 SUCH TRANSFER MAY BE MADE WITHOUT THE CONSENT OF THE HEAD OF THE DEPART-
33 MENT, AGENCY OR COMMISSION. TRANSFERS SHALL BE MADE PURSUANT TO SUBDI-
34 VISION TWO OF SECTION SEVENTY OF THE CIVIL SERVICE LAW.

35 4. THE SALARY OR COMPENSATION OF ANY SUCH OFFICER OR EMPLOYEE, AFTER
36 SUCH TRANSFER, SHALL BE PAID BY THE EXCHANGE.

37 5. ANY OFFICER OR EMPLOYEE TRANSFERRED TO THE EXCHANGE PURSUANT TO
38 THIS SECTION, WHO ARE MEMBERS OF OR BENEFIT UNDER ANY EXISTING PENSION
39 OR RETIREMENT FUND OR SYSTEM, SHALL CONTINUE TO HAVE ALL RIGHTS, PRIVI-
40 LEGES, OBLIGATIONS AND STATUS WITH RESPECT TO SUCH FUND OR SYSTEM AS ARE
41 NOW PRESCRIBED BY LAW, BUT DURING THE PERIOD OF THEIR EMPLOYMENT BY THE
42 EXCHANGE, ALL CONTRIBUTIONS TO SUCH FUNDS OR SYSTEMS TO BE PAID BY THE
43 EMPLOYER ON ACCOUNT OF SUCH OFFICERS OR EMPLOYEES SHALL BE PAID BY THE
44 EXCHANGE.

45 6. A TRANSFERRED EMPLOYEE SHALL REMAIN IN THE SAME COLLECTIVE BARGAIN-
46 ING UNIT AS WAS THE CASE PRIOR TO HIS OR HER TRANSFER; SUCCESSOR EMPLOY-
47 EES TO THE POSITIONS HELD BY SUCH TRANSFERRED EMPLOYEES SHALL, CONSIST-
48 ENT WITH THE PROVISIONS OF ARTICLE FOURTEEN OF THE CIVIL SERVICE LAW, BE
49 INCLUDED IN THE SAME UNIT AS THEIR PREDECESSORS. EMPLOYEES SERVING IN
50 POSITIONS IN NEWLY CREATED TITLES SHALL BE ASSIGNED TO THE SAME COLLEC-

S 3991. LIMITATION OF LIABILITY; INDEMNIFICATION. THE PROVISIONS OF SECTIONS SEVENTEEN AND NINETEEN OF THE PUBLIC OFFICERS LAW SHALL BE APPLICABLE TO EXCHANGE EMPLOYEES, AS SUCH TERM IS DEFINED IN SECTIONS SEVENTEEN AND NINETEEN OF THE PUBLIC OFFICERS LAW; PROVIDED, HOWEVER, THAT NOTHING CONTAINED WITHIN THIS SECTION SHALL BE DEEMED TO PERMIT THE EXCHANGE TO EXTEND THE PROVISIONS OF SECTIONS SEVENTEEN AND NINETEEN OF THE PUBLIC OFFICERS LAW UPON ANY INDEPENDENT CONTRACTOR.

S 3992. CONTINGENCY FOR FEDERAL FUNDING. THE IMPLEMENTATION OF THE PROVISIONS OF THIS ARTICLE SHALL BE CONTINGENT, AS DETERMINED BY THE DIRECTOR OF THE BUDGET, ON THE AVAILABILITY OF SUFFICIENT FEDERAL FINANCIAL SUPPORT FOR THE PLANNING AND IMPLEMENTATION OF HEALTH CARE AND INSURANCE REFORM INITIATIVES AUTHORIZED BY FEDERAL LEGISLATION TO ESTABLISH AND IMPLEMENT THE HEALTH BENEFIT EXCHANGE.

S 3993. CONSTRUCTION. NOTHING IN THIS ARTICLE, AND NO ACTION TAKEN BY THE EXCHANGE PURSUANT HERETO, SHALL BE CONSTRUED TO:

1. PREEMPT OR SUPERSEDE THE AUTHORITY OF THE SUPERINTENDENT OR THE COMMISSIONER; OR

2. EXEMPT INSURERS, INSURANCE PRODUCERS OR QUALIFIED HEALTH PLANS FROM THE PUBLIC HEALTH LAW OR THE INSURANCE LAW AND REGULATIONS PROMULGATED THEREUNDER.

(A) THE LEGISLATURE FINDS THAT TO ENSURE THE MEDICAL ASSISTANCE PROGRAM CONTINUES TO FUNCTION IN AN EFFICIENT MANNER TO MAKE HIGH QUALITY MEDICAL CARE, SERVICES, AND SUPPLIES AVAILABLE TO ELIGIBLE PERSONS, AND TO ACHIEVE TIMELY COMPLIANCE WITH THE REQUIREMENTS OF THE PATIENT PROTECTION AND AFFORDABLE CARE ACT RELATED TO THE EXPANSION OF THE MEDICAL ASSISTANCE PROGRAM AND THE CREATION OF A HEALTH CARE EXCHANGE, IT IS NECESSARY TO CONVERT THE PROGRAM OF MEDICAL ASSISTANCE FROM ONE PRIMARILY ADMINISTERED BY SOCIAL SERVICES DISTRICTS, UNDER THE SUPERVISION OF THE DEPARTMENT OF HEALTH ("DEPARTMENT"), TO ONE ADMINISTERED BY THE DEPARTMENT, WITH SUCH ASSISTANCE FROM SOCIAL SERVICES DISTRICTS AS THE COMMISSIONER OF HEALTH ("COMMISSIONER") MAY DETERMINE NECESSARY, AND THAT SUCH CONVERSION SHOULD BE COMPLETED BY APRIL FIRST, TWO THOUSAND EIGHTEEN. RECOGNIZING THE COMPLEXITY AND DIFFICULTY OF COMPLETING THIS CONVERSION WITHIN SUCH TIME FRAME, IT IS THE INTENT OF THE LEGISLATURE TO GRANT THE COMMISSIONER BROAD AUTHORITY AND FLEXIBILITY TO TAKE ACTIONS NECESSARY TO ACHIEVE THIS GOAL, AS DETERMINED BY THE COMMISSIONER, AND TO HAVE THE PROVISIONS OF THIS SECTION CONSTRUED IN LIGHT OF THE AUTHORITY AND FLEXIBILITY SO GRANTED. THE ADMINISTRATION OF THE PROGRAM BY THE DEPARTMENT MAY BE ACCOMPLISHED THROUGH THE USE OF DEPARTMENT STAFF, CONTRACTED ENTITIES, OR SOME COMBINATION THEREOF, AS DETERMINED ADVISABLE BY THE COMMISSIONER TO ACHIEVE THE GOALS OF THIS SECTION, SUBJECT TO THE LIMITATIONS PRESCRIBED HEREIN. THE COMMISSIONER WILL CONSULT WITH SOCIAL SERVICES DISTRICTS IN FORMULATING THE OPTIMAL PLAN FOR IMPLEMENTING THIS CONVERSION.

(B) THE LEGISLATURE FURTHER FINDS THAT THE CONTINUED, UNINTERRUPTED, ADEQUATE AND EFFICIENT OPERATION OF FUNCTIONS RELATED TO MEDICAL ASSISTANCE ELIGIBILITY AND COVERED BENEFITS IS NECESSARY FOR THE GENERAL WELFARE OF THE PEOPLE OF THE STATE; THAT SUCH OPERATION INVOLVES AND REQUIRES PERSONNEL WITH TRAINING, PRACTICAL EXPERIENCE AND KNOWLEDGE IN MEDICAL ASSISTANCE ELIGIBILITY AND COVERED BENEFITS; AND THAT REQUIRING COMPETITIVE EXAMINATION FOR APPOINTMENT OF PERSONS CURRENTLY PERFORMING SUCH FUNCTIONS IN COUNTIES IN THE STATE TO POSITIONS IN THE CLASSIFIED SERVICE OF THE STATE UPON THE ASSUMPTION OF SUCH FUNCTIONS BY THE DEPARTMENT WOULD IRREPARABLY DISRUPT, DELAY AND IMPEDE OPERATIONS AND INTERRUPT THE CONTINUANCE AND PERFORMANCE OF IMPORTANT SERVICES.

2. NOTWITHSTANDING THE PROVISIONS OF TITLE TWO OF ARTICLE THREE OF THIS CHAPTER OR OF SECTION THREE HUNDRED SIXTY-FIVE OF THIS TITLE OR OF ANY OTHER LAW TO THE CONTRARY, THE COMMISSIONER IS AUTHORIZED TO TAKE ANY AND ALL ACTIONS NECESSARY TO TRANSFER RESPONSIBILITY FOR THE ADMINISTRATION OF THE MEDICAL ASSISTANCE PROGRAM FROM SOCIAL SERVICES DISTRICTS TO THE DEPARTMENT.

1 3. FOR PURPOSES OF THIS SECTION, ADMINISTRATION OF THE MEDICAL ASSIST-
2 ANCE PROGRAM INCLUDES PROCESSING APPLICATIONS FOR BENEFITS AND SERVICES
3 AVAILABLE UNDER THIS TITLE AND TITLE ELEVEN-D OF THIS ARTICLE, MAKING
4 DETERMINATIONS OF INITIAL AND ONGOING ELIGIBILITY FOR SUCH BENEFITS AND
5 SERVICES AND MAKING COVERAGE DETERMINATIONS WITH RESPECT TO BENEFITS AND
6 SERVICES REQUIRING PRIOR AUTHORIZATION, NOTIFYING APPLICANTS AND RECIPI-
7 ENTS OF THESE DETERMINATIONS AND OF THEIR RIGHTS AND RESPONSIBILITIES,
8 AUTHORIZING BENEFITS AND SERVICES FOR PERSONS FOUND ELIGIBLE, EXERCISING
9 SUBROGATION RIGHTS WITH RESPECT TO AMOUNTS RECEIVED FROM INSURANCE
10 CARRIERS OR OTHER LIABLE THIRD PARTIES, IMPOSING LIENS AND PURSUING
11 RECOVERIES, AND ANY OTHER TASKS AND FUNCTIONS IDENTIFIED BY THE COMMIS-
12 SIONER.

13 4. NOTWITHSTANDING THE PROVISIONS OF THE CIVIL SERVICE LAW OR ANY
14 PROVISIONS TO THE CONTRARY CONTAINED IN ANY GENERAL, SPECIAL, OR LOCAL
15 LAWS, ALL LAWFUL APPOINTEES OF A COUNTY PERFORMING FUNCTIONS RELATED TO
16 MEDICAL ASSISTANCE ELIGIBILITY AND COVERED BENEFITS AS OF THE EFFECTIVE
17 DATE OF THIS SECTION WILL BE ELIGIBLE TO TRANSFER TO APPROPRIATE POSI-
18 TIONS IN THE DEPARTMENT OF HEALTH CLASSIFIED TO PERFORM SUCH FUNCTIONS
19 WITHOUT FURTHER EXAMINATION OR QUALIFICATION AND, UPON SUCH TRANSFER,
20 WILL HAVE ALL THE RIGHTS AND PRIVILEGES OF THE JURISDICTIONAL CLASSI-
21 FICATION TO WHICH SUCH POSITIONS MAY BE ALLOCATED IN THE CLASSIFIED
22 SERVICE OF THE STATE.

23 5. SUBJECT TO THE PROVISIONS OF SUBDIVISIONS SIX AND SEVEN OF THIS
24 SECTION, THE COMMISSIONER MAY CONTRACT WITH ONE OR MORE ENTITIES,
25 INCLUDING UNITS OF LOCAL GOVERNMENT, FOR THE PURPOSE OF EXERCISING HIS
26 OR HER AUTHORITY UNDER THIS SECTION. SUCH ENTITIES MAY BE CONTRACTED TO
27 PERFORM ALL OR A PORTION OF THE FUNCTIONS DESCRIBED IN SUBDIVISION THREE
28 OF THIS SECTION, AND MAY PERFORM SUCH FUNCTIONS WITH RESPECT TO THE
29 ENTIRE STATE OR WITH RESPECT TO A SPECIFIC REGION OR REGIONS, AS DETER-
30 MINED BY THE COMMISSIONER. IN NO EVENT, HOWEVER, SHALL THE DEPARTMENT,
31 BY MEANS OF SUCH A CONTRACT, DELEGATE ITS AUTHORITY TO EXERCISE ADMINIS-
32 TRATIVE DISCRETION IN THE ADMINISTRATION OR SUPERVISION OF THE STATE
33 PLAN FOR MEDICAL ASSISTANCE SUBMITTED PURSUANT TO SECTION THREE HUNDRED
34 SIXTY-THREE-A OF THIS TITLE, OR TO ISSUE POLICIES, RULES, AND REGU-
35 LATIONS ON PROGRAM MATTERS, NOR MAY ANY CONTRACTED ENTITY BE GIVEN THE
36 AUTHORITY TO CHANGE OR DISAPPROVE ANY ADMINISTRATIVE DECISION OF THE
37 DEPARTMENT, OR OTHERWISE SUBSTITUTE THE ENTITY'S JUDGMENT FOR THAT OF
38 THE DEPARTMENT WITH RESPECT TO THE APPLICATION OF POLICIES, RULES, AND
39 REGULATIONS ISSUED BY THE DEPARTMENT.

40 6. NOTWITHSTANDING ANY INCONSISTENT PROVISION OF SECTIONS ONE HUNDRED
41 TWELVE AND ONE HUNDRED SIXTY-THREE OF THE STATE FINANCE LAW, OR SECTIONS
42 ONE HUNDRED FORTY-TWO AND ONE HUNDRED FORTY-THREE OF THE ECONOMIC DEVEL-
43 OPMENT LAW, OR ANY OTHER CONTRARY PROVISION OF LAW, THE COMMISSIONER IS
44 AUTHORIZED TO AMEND THE TERMS OF EXISTING CONTRACTS, INCLUDING A
45 CONTRACT ENTERED INTO PURSUANT TO SUBDIVISION TWENTY-FOUR OF SECTION TWO
46 HUNDRED SIX OF THE PUBLIC HEALTH LAW, AS ADDED BY SECTION THIRTY-NINE OF
47 PART C OF CHAPTER FIFTY-EIGHT OF THE LAWS OF TWO THOUSAND EIGHT, WITHOUT
48 A COMPETITIVE BID OR REQUEST FOR PROPOSAL PROCESS, UPON A DETERMINATION
49 THAT THE EXISTING CONTRACTOR IS QUALIFIED TO PROVIDE ASSISTANCE WITH ONE
50 OR MORE FUNCTIONS RELATED TO THE ADMINISTRATION OF THE MEDICAL ASSIST-
51 ANCE PROGRAM OR TO ACHIEVING THE GOALS OF THIS SECTION.

52 7. NOTWITHSTANDING ANY INCONSISTENT PROVISION OF SECTIONS ONE HUNDRED
53 TWELVE AND ONE HUNDRED SIXTY-THREE OF THE STATE FINANCE LAW, OR SECTIONS
54 ONE HUNDRED FORTY-TWO AND ONE HUNDRED FORTY-THREE OF THE ECONOMIC DEVEL-
55 OPMENT LAW, OR ANY OTHER CONTRARY PROVISION OF LAW, THE COMMISSIONER IS
56 AUTHORIZED TO ENTER INTO A CONTRACT OR CONTRACTS UNDER THIS SUBDIVISION

1 WITHOUT A COMPETITIVE BID OR REQUEST FOR PROPOSAL PROCESS, PROVIDED,
2 HOWEVER, THAT WITH RESPECT TO A CONTRACT WITH AN ENTITY OTHER THAN A
3 LOCAL UNIT OF GOVERNMENT:

4 (A) THE DEPARTMENT SHALL POST ON ITS WEBSITE, FOR A PERIOD OF NO LESS
5 THAN THIRTY DAYS:

6 (I) A DESCRIPTION OF THE PROPOSED SERVICES TO BE PROVIDED PURSUANT TO
7 THE CONTRACT OR CONTRACTS;

8 (II) THE CRITERIA FOR SELECTION OF A CONTRACTOR OR CONTRACTORS;

9 (III) THE PERIOD OF TIME DURING WHICH A PROSPECTIVE CONTRACTOR MAY
10 SEEK SELECTION, WHICH SHALL BE NO LESS THAN THIRTY DAYS AFTER SUCH
11 INFORMATION IS FIRST POSTED ON THE WEBSITE; AND

12 (IV) THE MANNER BY WHICH A PROSPECTIVE CONTRACTOR MAY SEEK SUCH
13 SELECTION, WHICH MAY INCLUDE SUBMISSION BY ELECTRONIC MEANS;

14 (B) ALL REASONABLE AND RESPONSIVE SUBMISSIONS THAT ARE RECEIVED FROM
15 PROSPECTIVE CONTRACTORS IN TIMELY FASHION SHALL BE REVIEWED BY THE
16 COMMISSIONER; AND

17 (C) THE COMMISSIONER SHALL SELECT SUCH CONTRACTOR OR CONTRACTORS THAT,
18 IN HIS OR HER DISCRETION, ARE BEST SUITED TO SERVE THE PURPOSES OF THIS
19 SECTION.

20 8. THE COMMISSIONER SHALL PROMULGATE SUCH REGULATIONS AS MAY BE NECES-
21 SARY TO CARRY OUT THE PROVISIONS OF THIS SECTION, WHICH REGULATIONS MAY
22 BE PROMULGATED ON AN EMERGENCY BASIS. IN ADDITION, THE COMMISSIONER
23 SHALL MAKE ANY AMENDMENTS TO THE STATE PLAN FOR MEDICAL ASSISTANCE, OR
24 DEVELOP AND SUBMIT AN APPLICATION FOR ANY WAIVER OR APPROVAL UNDER THE

3 S 10. Severability clause. If any clause, sentence, paragraph, subdi-
4 vision, section or part of this act shall be adjudged by any court of
5 competent jurisdiction to be invalid, such judgment shall not affect,

(PPRs) and provide for rate adjustments or payment disallowances related to PPRs and other potentially preventable negative outcomes (PPNOs), which shall be calculated in accordance with methodologies as determined by the commissioner, provided, however, that such methodologies shall be based on a comparison of the actual and risk adjusted expected number of PPRs and other PPNOs in a given hospital and with benchmarks established by the commissioner and provided further that such rate adjustments or payment disallowances shall result in an aggregate reduction in Medicaid payments of no less than thirty-five million dollars for the period July first, two thousand ten through March thirty-first, two thousand eleven and no less than fifty-one million dollars for [the period] ANNUAL PERIODS BEGINNING April first, two thousand eleven through March thirty-first, two thousand [twelve] THIRTEEN, provided further that such aggregate reductions shall be offset by Medicaid payment reductions occurring as a result of decreased PPRs during the period July first, two thousand ten through March thirty-first, two thousand eleven and the period April first, two thousand eleven through March thirty-first, two thousand [twelve] THIRTEEN and as a result of decreased PPNOs during the period April first, two thousand eleven through March thirty-first, two thousand [twelve] THIRTEEN; and provided further that for the period July first, two thousand ten through March thirty-first, two thousand [twelve] THIRTEEN, such rate adjustments or payment disallowances shall not apply to behavioral health PPRs; or to readmissions that occur on or after fifteen days following an initial admission. By no later than July first, two thousand eleven the commissioner shall enter into consultations with representatives of the health care facilities subject to this section regarding potential prospective revisions to applicable methodologies and benchmarks set forth in regulations issued pursuant to this subparagraph;

S 3. This act shall take effect immediately and shall be deemed to have been in full force and effect on and after April 1, 2012.

PART H

Section 1. Section 4 of part C of chapter 57 of the laws of 2006, relating to establishing a cost of living adjustment for designated human services programs, as amended by section 2 of part F of chapter 59 of the laws of 2011, is amended to read as follows:

S 4. This act shall take effect immediately and shall be deemed to have been in full force and effect on and after April 1, 2006; provided section one of this act shall expire and be deemed repealed April 1, [2015] 2012; provided, further, that sections two and three of this act shall expire and be deemed repealed December 31, 2009.

S 2. Notwithstanding any other provision of law to the contrary, effective April 1, 2013 and annually thereafter, state agencies including, but not limited to, the office for people with developmental disabilities, office of mental health, office of alcoholism and substance abuse services, office of children and family services, office of temporary and disability assistance, department of health, office for the aging, division of criminal justice services, office of victim services, and state education department that operate, license, certify, or fund providers of services shall develop and calculate annual adjustments to established payments to providers of such services, based on factors to be determined by the commissioner of the agency. Such adjustments shall be based on performance metrics to be developed by the commissioners of such agencies which shall include, but not be limited to the following

1 to the extent practicable: the actual costs of providing such services,
2 the percentages of administrative costs, the determination and levels of
3 executive compensation, and such other criteria as such commissioners
4 may determine. Such annual adjustments shall be subject to any necessary
5 federal approvals and restrictions. The amount of any annual adjustment
6 and the metrics used to determine such adjustment shall be subject to
7 the review and approval of the director of the budget.

8 S 3. Notwithstanding any other provision of law to the contrary,
9 commencing on April 1, 2012, the commissioner or director of each state

45 Section 1. Notwithstanding any inconsistent provision of sections one
46 hundred twelve and one hundred sixty-three of the state finance law, or
47 section one hundred forty-two of the economic development law, or any
48 other law to the contrary, the commissioner of developmental disabili-
49 ties, pursuant to a pilot program established in accordance with an
50 application made under section 1115 of the federal social security act,
51 42 U.S.C. 1315, is authorized to enter into a contract or contracts
52 without a competitive bid or request for proposal process, with the
53 approval of the director of the budget, provided, however, that:

(a) the office for people with developmental disabilities shall post on its website, for a period of not less than thirty days, a pilot application, and the following information:

(i) a description of the proposed services to be provided pursuant to the pilot program;

(ii) the procedure for application to participate in the pilot program and criteria for selection of an applicant to participate in the pilot program;

(iii) the period of time during which an applicant may seek selection, which shall be no less than thirty days after such information is first posted on the website; and

(iv) the manner by which an applicant may seek such selection, which may include submission by electronic means;

(b) all reasonable and responsive submissions that are received from applicants in a timely fashion shall be reviewed by the commissioner; and

(c) the commissioner of developmental disabilities shall select such applicant or applicants that, in the commissioner's discretion, have demonstrated the ability to effectively, efficiently, and economically provide services pursuant to the pilot program; have the requisite expertise and financial resources; have demonstrated that their directors, sponsors, members, managers, partners or operators have the requisite character, competence and standing in the community, and are best suited to serve the purposes of this section.

13 without prior notice and may report on conditions to the governor, to
14 the commissioner and to the chairman of the state commission on quality

17 tee of members shall inspect [the] SUCH facility once every three months
18 without prior notice. A report on conditions may be submitted to the

32 failed to visit and inspect [the] A facility at least twice a year shall

34 by the governor within forty-five days after the end of the calendar
35 year. The board shall have the power to investigate all charges against
36 the STATE OPERATIONS director and all cases of alleged patient abuse or
37 mistreatment made against any employee and shall have the power to
38 interview patients and employees of the [facility] FACILITIES in pursuit
39 of such investigations. In conducting such an investigation, the board
40 shall have the power, in accordance with the civil practice law and
41 rules, to subpoena witnesses, compel their testimony, administer oaths
42 to witnesses, examine witnesses under oath, and require the production

44 a member may include in the report or separately at any time any matter
45 pertaining to the management and affairs of [the facility] SUCH FACILI-
46 TIES and may make recommendations to the governor, to the commissioner
47 and to the chairman of the state commission on quality of care [for the
48 mentally disabled] AND ADVOCACY FOR PERSONS WITH DISABILITIES. Each
49 board member shall enter in a book, kept at each SUCH facility for that
50 purpose, the date of each visit.

53 the board of] STATE OPERATIONS REGION in which such member or members

After any such visits or inspections, a report containing findings and recommendations may be submitted to the governor, to the commissioner or to the state commission on quality of care [for the mentally disabled] AND ADVOCACY FOR PERSONS WITH DISABILITIES.

(2) Any member or members of the board may visit and inspect a community residence operated by the office for people with developmental disabilities, which is within the catchment area of the [school on the board of] STATE OPERATIONS REGION IN which such member or members serve. Such member or members shall be granted access to such facility and to all books, records and data pertaining to such facility deemed necessary for carrying out the purposes of such visit and inspection. Information, books, records or data which are confidential as provided by law shall be kept confidential and any limitations on the release thereof imposed by law upon the party furnishing the information, books, records or data shall apply to such member or members of the board. After any such visits or inspection, a report containing findings and recommendations shall be submitted promptly to the commissioner and to the chairman of the state commission on quality of care and advocacy for persons with disabilities.

(j) Once each year, each board shall make an independent assessment of conditions at [the facility] SUCH FACILITIES and shall submit a report on the assessment and recommendations to the governor, to the commissioner and to the chairman of the state commission on quality of care [for the mentally disabled] AND ADVOCACY FOR PERSONS WITH DISABILITIES.

(k) The commissioner shall notify the board of visitors of a [school] FACILITY under his OR HER jurisdiction of the proposed appointment of a STATE OPERATIONS director [to such facility] or the proposed transfer of a STATE OPERATIONS director [from such facility], with a request that the board report an expression of its opinion of the appointment or transfer and, if it objects thereto, the reasons for such objection.

(l) The commissioner shall appoint representatives of the office [department] to serve as liaison between the office and the boards of visitors. At least once each year the commissioner shall meet with the boards collectively. The commissioner, or his OR HER designee, shall meet quarterly with representatives of boards of visitors.

(m) Members of the boards of visitors shall be considered officers of the office for people with developmental disabilities for the purposes of sections seventy-three, to the extent provided therein, and seventy-four of the public officers law relating to business or professional activities by state officers and employees and the code of ethics.

The chairman of the commission on quality of care [for the mentally disabled] AND ADVOCACY FOR PERSONS WITH DISABILITIES shall notify the governor and the appointed member of any such member's failure to attend such a training program. A member who has failed to attend such a training program scheduled for such member shall be considered to have vacated his office unless otherwise ordered by the governor within forty-five days after the notice.

26 Section 1. Legislative findings. It is the finding of the legislature
27 that the integration and coordination of physical and behavioral health
28 services results in an improvement in the quality of services being
29 provided to recipients, with a resultant improvement in outcomes and
30 reduction in the costs of care. It is the further finding of the legis-
31 lature that the reduction or elimination of redundant or unnecessary
32 licensing and oversight requirements and procedures will facilitate the
33 provision of integrated and coordinated care and result in a more effi-
34 cient use of governmental resources.

35 S 2. (a) Notwithstanding any law, rule or regulation to the contrary,
36 two or more of the commissioners of the department of health, the office
37 of mental health, the office of alcoholism and substance abuse services
38 or the office for people with developmental disabilities are jointly
39 authorized to establish operating, reporting and construction require-
40 ments, as well as joint survey requirements and procedures for entities
41 that:

42 (1) can demonstrate experience and competence in the delivery of
43 health, mental health, alcohol and substance abuse services and/or
44 services to persons with developmental disabilities and the capacity to
45 offer the integrated delivery of such services at locations as may be
46 approved by two or more of the respective commissioners; and

47 (2) meet the standards that may be established by the respective
48 commissioners for the provision of such services; provided, however,
49 that an entity meeting the standards established pursuant to this
50 section shall not be required to be an integrated service provider
51 pursuant to subdivision 7 of section 365-1 of the social services law.

1 (b) In establishing one or more sets of joint requirements or proce-
2 dures for entities described in this section, the commissioners of the
3 department of health, the office of mental health, the office of alco-
4 holism and substance abuse services, and/or the office for people with
5 developmental disabilities are authorized to waive any regulatory
6 requirements, or to determine that compliance with another commission-
7 er's regulatory requirements shall be deemed to meet the regulatory
8 requirements of his or her agency, as may be necessary or desirable to
9 avoid duplication of requirements and/or to permit the integrated deliv-
10 ery of health and behavioral health services in an efficient and effec-

PART M

19 Section 1. Legislative findings. It is the finding of the legislature
20 that patients hospitalized in facilities operated by the office of
21 mental health who are between the ages of five and twenty-one are enti-
22 tled to receive an education comparable to that which they would other-
23 wise be entitled to receive in their local school districts pursuant to
24 the education law and the regulations of the commissioner of education.

25 S 2. (a) Notwithstanding any other provision of law to the contrary,
26 the office of mental health shall be authorized to enter into an agree-
27 ment with the state education department for the purposes of providing
28 education programming and services for patients residing in hospitals
29 operated by the office of mental health who are between the ages of five
30 and twenty-one, that is comparable to that which they would otherwise be
31 entitled to receive in their local school districts pursuant to the
32 education law and the regulations of the commissioner. The commissioner
33 of education shall be authorized to require local school districts,
34 including the school district located in a city with a million persons
35 or more, and/or boards of cooperative educational services to provide
36 such comparable educational programming and services, provided, however,
37 the commissioner of mental health shall be authorized to contract
38 directly with local school districts, including the school district
39 located in a city with a million persons or more, and/or boards of coop-
40 erative educational services to provide such comparable educational
41 programming and services. Such comparable education programming and
42 services for such children shall be authorized to be provided, in the
43 2012-2013 and 2013-2014 and 2014-2015 school years within a city with a
44 population of a million persons or more, and in the 2013-2014 and 2014-
45 2015 school year in the rest of the state, in accordance with implemen-
46 tation standards issued by the commissioner of education, and in accord-
47 ance with a plan for educational services jointly approved by the
48 commissioners of education and mental health.

49 (b) The commissioner of education, or pursuant to contract the commis-
50 sioner of mental health, shall reimburse districts and boards of cooper-
51 ative educational services for unreimbursed, approved expenses for the
52 cost of such programming and services for such children pursuant to this
53 section, as may be determined through a reimbursement methodology devel-

oped by the commissioner of education and approved by the director of the budget.

(c) The commissioner of mental health, with the approval of the director of the budget, shall be authorized to transfer funding to the commissioner of education for the provision of educational programming and services to patients residing in hospitals operated by the office of mental health who are between the ages of five and twenty-one.

S 3. The commissioners of education and mental health shall jointly submit to the governor and to the temporary president of the senate and the speaker of the assembly a report by February 1, 2015, which shall state whether additional actions should be taken to ensure that children who are patients residing in hospitals operated by the office of mental health receive education programming and services that are comparable to that which they would otherwise be entitled to receive in their local school districts pursuant to education law and the regulations of the commissioner. Such commissioners shall also recommend whether this act should be amended and whether it should be made permanent.

S 4. This act shall take effect July 1, 2012 and shall expire June 30, 2015 when upon such date the provisions of this act shall be deemed repealed.

PART N

Section 1. Section 1.03 of the mental hygiene law is amended by adding two new subdivisions 56 and 57 to read as follows:

56. "SUBSTANCE USE DISORDER" MEANS THE MISUSE, DEPENDENCE, OR ADDICTION TO ALCOHOL AND/OR LEGAL OR ILLEGAL DRUGS LEADING TO EFFECTS THAT ARE DETRIMENTAL TO THE INDIVIDUAL'S PHYSICAL AND MENTAL HEALTH, OR THE WELFARE OF OTHERS AND SHALL INCLUDE ALCOHOLISM, ALCOHOL ABUSE, SUBSTANCE ABUSE, SUBSTANCE DEPENDENCE, CHEMICAL ABUSE, AND/OR CHEMICAL DEPENDENCE.

57. "SUBSTANCE USE DISORDER SERVICES" SHALL MEAN AND INCLUDE EXAMINATION, EVALUATION, DIAGNOSIS, CARE, TREATMENT, REHABILITATION, OR TRAINING OF PERSONS WITH SUBSTANCE USE DISORDERS AND THEIR FAMILIES OR SIGNIFICANT OTHERS.

S 2. The mental hygiene law is amended by adding a new section 5.06 to read as follows:

S 5.06 BEHAVIORAL HEALTH SERVICES ADVISORY COUNCIL.

(A) THERE IS HEREBY CREATED WITHIN THE DEPARTMENT A BEHAVIORAL HEALTH SERVICES ADVISORY COUNCIL, THE PURPOSE OF WHICH SHALL BE TO ADVISE THE OFFICES OF MENTAL HEALTH AND ALCOHOLISM AND SUBSTANCE ABUSE SERVICES ON MATTERS RELATING TO THE PROVISION OF BEHAVIORAL HEALTH SERVICES; ISSUES OF JOINT CONCERN TO THE OFFICES, INCLUDING THE INTEGRATION OF VARIOUS BEHAVIORAL HEALTH SERVICES AND THE INTEGRATION OF BEHAVIORAL HEALTH SERVICES WITH HEALTH SERVICES; AND ISSUES RELATED TO THE DELIVERY OF BEHAVIORAL HEALTH SERVICES THAT ARE RESPONSIVE TO LOCAL, STATE AND FEDERAL CONCERNS. THE COUNCIL SHALL CONSIST OF THE COMMISSIONER OF MENTAL HEALTH AND THE COMMISSIONER OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES WHO SHALL NOT HAVE THE RIGHT TO VOTE, THE CHAIR OF THE CONFERENCE OF LOCAL MENTAL HYGIENE DIRECTORS OR HIS OR HER DESIGNEE, AND TWENTY-EIGHT MEMBERS APPOINTED BY THE GOVERNOR. MEMBERS SHALL BE APPOINTED ONLY IF THEY HAVE PROFESSIONAL KNOWLEDGE IN THE CARE OF PERSONS RECEIVING BEHAVIORAL HEALTH SERVICES, OR AN ACTIVE INTEREST IN THE BEHAVIORAL HEALTH SERVICES SYSTEM.

(B) THE GOVERNOR SHALL DESIGNATE ONE OF THE MEMBERS OF THE COUNCIL AS CHAIR. AT LEAST ONE-HALF OF THE MEMBERS OF THE COUNCIL SHALL NOT BE

1 PROVIDERS OF BEHAVIORAL HEALTH SERVICES. MEMBERSHIP SHALL REFLECT A
2 BALANCED REPRESENTATION OF PERSONS WITH INTERESTS IN MENTAL HEALTH AND
3 SUBSTANCE USE DISORDER SERVICES AND SHALL INCLUDE:

4 (1) AT LEAST FIVE CURRENT OR FORMER CONSUMERS OF BEHAVIORAL HEALTH
5 SERVICES;

6 (2) AT LEAST THREE INDIVIDUALS WHO ARE PARENTS OR RELATIVES OF CURRENT
7 OR FORMER CONSUMERS OF BEHAVIORAL HEALTH SERVICES;

8 (3) AT LEAST THREE MEMBERS WHO ARE NOT PROVIDERS OF BEHAVIORAL HEALTH
9 SERVICES AND WHO REPRESENT NON-GOVERNMENTAL ORGANIZATIONS, SUCH AS NOT-
10 FOR-PROFIT ENTITIES REPRESENTING HEALTH OR BEHAVIORAL HEALTH CARE
11 EMPLOYEES, OR OTHER ORGANIZATIONS CONCERNED WITH THE PROVISION OF BEHAV-
12 IORAL HEALTH SERVICES;

13 (4) AT LEAST FIVE REPRESENTATIVES OF PROVIDERS OF SERVICES TO PERSONS
14 WITH MENTAL ILLNESS AND AT LEAST FIVE REPRESENTATIVES OF PROVIDERS OF
15 SERVICES TO PERSONS WITH SUBSTANCE USE DISORDERS, AT LEAST TWO OF WHOM
16 SHALL BE PHYSICIANS;

17 (5) ONE MEMBER APPOINTED ON THE RECOMMENDATION OF THE DIRECTOR OF THE
18 DIVISION OF VETERANS' AFFAIRS;

19 (6) ONE MEMBER APPOINTED ON THE RECOMMENDATION OF THE ADJUTANT GENERAL
20 OF THE DIVISION OF MILITARY AND NAVAL AFFAIRS;

21 (7) AT LEAST THREE REPRESENTATIVES OF LOCAL GOVERNMENTS OR OTHER STATE
22 AND LOCAL AGENCIES CONCERNED WITH THE PROVISION OF BEHAVIORAL HEALTH
23 SERVICES; AND

24 (8) AT LEAST TWO MEMBERS WHO ARE ALSO MEMBERS OF THE PUBLIC HEALTH AND
25 HEALTH PLANNING COUNCIL PURSUANT TO SECTION TWO HUNDRED TWENTY OF THE
26 PUBLIC HEALTH LAW.

27 (C) MEMBERS SHALL BE APPOINTED FOR TERMS OF THREE YEARS PROVIDED,
28 HOWEVER, THAT OF THE MEMBERS FIRST APPOINTED, ONE-THIRD SHALL BE
29 APPOINTED FOR ONE YEAR TERMS AND ONE-THIRD SHALL BE APPOINTED FOR TWO
30 YEAR TERMS. VACANCIES SHALL BE FILLED IN THE SAME MANNER AS ORIGINAL
31 APPOINTMENTS FOR THE REMAINDER OF ANY UNEXPIRED TERM. NO PERSON SHALL BE
32 AN APPOINTED MEMBER OF THE COUNCIL FOR MORE THAN SIX YEARS IN ANY PERIOD
33 OF TWELVE CONSECUTIVE YEARS.

34 (D) THE COUNCIL SHALL MEET AT LEAST FOUR TIMES IN EACH FULL CALENDAR
35 YEAR. THE COUNCIL SHALL MEET AT THE REQUEST OF ITS CHAIR OR EITHER
36 COMMISSIONER.

37 (E) THE COUNCIL SHALL ESTABLISH SUCH COMMITTEES AS IT DEEMS NECESSARY
38 TO ADDRESS THE SERVICE NEEDS OF SPECIAL POPULATIONS AND TO ADDRESS
39 PARTICULAR SUBJECTS OF IMPORTANCE IN THE DEVELOPMENT AND MANAGEMENT OF
40 BEHAVIORAL HEALTH SERVICES.

41 (F) THE COUNCIL MAY CONSIDER ANY MATTER RELATING TO THE IMPROVEMENT OF
42 BEHAVIORAL HEALTH SERVICES IN THE STATE AND SHALL ADVISE THE COMMISSION-
43 ERS ON ANY SUCH MATTER, INCLUDING, BUT NOT LIMITED TO:

44 (1) CARE AND SERVICES TO PERSONS WITH BEHAVIORAL HEALTH DISORDERS,
45 INCLUDING SPECIAL AND UNDERSERVED POPULATIONS AS DETERMINED BY THE
46 COMMISSIONER;

47 (2) FINANCING BEHAVIORAL HEALTH SERVICES;

48 (3) INTEGRATION OF BEHAVIORAL HEALTH SERVICES WITH HEALTH SERVICES;

49 (4) CARE AND SERVICES FOR PERSONS WITH CO-OCCURRING DISORDERS OR
50 MULTIPLE DISABILITIES;

51 (5) PREVENTION OF BEHAVIORAL HEALTH DISORDERS; AND

52 (6) IMPROVEMENT OF CARE IN STATE OPERATED OR COMMUNITY BASED PROGRAMS,
53 RECRUITMENT, EDUCATION AND TRAINING OF QUALIFIED DIRECT CARE PERSONNEL,
54 AND PROTECTION OF THE INTERESTS OF EMPLOYEES AFFECTED BY ADJUSTMENTS IN
55 THE BEHAVIORAL HEALTH SERVICE SYSTEM.

1 (G) THE COUNCIL SHALL, IN COOPERATION WITH THE COMMISSIONERS, ESTAB-
2 LISH STATEWIDE GOALS AND OBJECTIVES FOR SERVICES TO PERSONS WITH BEHAV-
3 IORAL HEALTH DISORDERS, PURSUANT TO SECTION 5.07 OF THIS ARTICLE.

4 (H) (1) THE COUNCIL SHALL REVIEW THE PORTION OF THE STATEWIDE PLAN TO
5 BE DEVELOPED AND UPDATED ANNUALLY BY THE COMMISSIONERS PURSUANT TO
6 SECTION 5.07 OF THIS ARTICLE AND REPORT ITS RECOMMENDATIONS THEREON TO
7 THE COMMISSIONERS.

8 (2) THE COUNCIL SHALL REVIEW ANY MENTAL HEALTH OR SUBSTANCE USE COMPO-
9 NENT OF STATEWIDE HEALTH PLANS DEVELOPED IN ACCORDANCE WITH ANY APPLICA-
10 BLE FEDERAL LAW AND SHALL REPORT ITS RECOMMENDATIONS THEREON TO THE
11 COMMISSIONERS.

12 (I) THE COUNCIL SHALL REVIEW APPLICATIONS FILED IN ACCORDANCE WITH:

13 (1) SECTION 31.22 OF THIS CHAPTER FOR APPROVAL OF INCORPORATION OR
14 ESTABLISHMENT OF A FACILITY, AND SECTION 31.23 OF THIS CHAPTER FOR
15 APPROVAL OF THE CONSTRUCTION OF A FACILITY FOR WHICH APPROVAL FROM THE
16 COMMISSIONER OF MENTAL HEALTH IS REQUIRED; AND

17 (2) SECTION 32.29 OR 32.31 OF THIS CHAPTER FOR APPROVAL OF INCORPO-
18 RATION OR ESTABLISHMENT OR CONSTRUCTION OF A FACILITY FOR WHICH APPROVAL
19 TO OPERATE IS REQUIRED FROM THE COMMISSIONER OF ALCOHOLISM AND SUBSTANCE
20 ABUSE SERVICES PURSUANT TO ARTICLE THIRTY-TWO OF THIS CHAPTER, AND AS
21 OTHERWISE REQUESTED BY SUCH COMMISSIONER;

22 (J) AT LEAST SIXTY DAYS PRIOR TO THE COMMISSIONERS' FINAL APPROVAL OF
23 RULES AND REGULATIONS UNDER THEIR RESPECTIVE JURISDICTION, OTHER THAN
24 EMERGENCY RULES AND REGULATIONS AND REGULATIONS PROMULGATED PURSUANT TO
25 SECTION 43.01 OF THIS CHAPTER, THE COMMISSIONERS SHALL SUBMIT SUCH
26 PROPOSED RULES AND REGULATIONS TO THE COUNCIL FOR ITS REVIEW. THE COUN-
27 CIL SHALL REVIEW ALL PROPOSED RULES AND REGULATIONS AND REPORT ITS
28 RECOMMENDATIONS THEREON TO THE COMMISSIONERS WITHIN SIXTY DAYS. THE
29 COMMISSIONER HAVING STATUTORY JURISDICTION OVER THE PROPOSED RULE OR
30 REGULATION SHALL NOT ACT IN A MANNER INCONSISTENT WITH THE RECOMMENDA-
31 TIONS OF THE COUNCIL WITHOUT FIRST APPEARING BEFORE THE COUNCIL TO
32 REPORT THE REASONS THEREFOR. THE COUNCIL, UPON A MAJORITY VOTE OF ITS
33 MEMBERS, MAY REQUIRE THAT AN ALTERNATIVE APPROACH TO THE PROPOSED RULES
34 AND REGULATIONS BE PUBLISHED WITH THE NOTICE OF THE PROPOSED RULES AND
35 REGULATIONS PURSUANT TO SECTION TWO HUNDRED TWO OF THE STATE ADMINISTRA-
36 TIVE PROCEDURE ACT. WHEN AN ALTERNATIVE APPROACH IS PUBLISHED PURSUANT
37 TO THIS SECTION, THE COMMISSIONER HAVING STATUTORY JURISDICTION OF THE
38 SUBJECT PROPOSED RULE OR REGULATION SHALL STATE THE REASONS FOR NOT
39 SELECTING SUCH ALTERNATIVE APPROACH.

40 (K) THE COUNCIL, BY A MAJORITY VOTE OF ITS MEMBERS, MAY PROPOSE RULES
41 AND REGULATIONS ON ANY MATTER WITHIN THE REGULATORY JURISDICTION OF THE
42 OFFICES OF MENTAL HEALTH OR ALCOHOLISM AND SUBSTANCE ABUSE SERVICES,
43 OTHER THAN ESTABLISHMENT OF FEE SCHEDULES PURSUANT TO SECTION 43.01 OF
44 THIS CHAPTER, AND FORWARD SUCH PROPOSED RULES AND REGULATIONS TO BOTH
45 COMMISSIONERS FOR REVIEW AND CONSIDERATION, PROVIDED, HOWEVER, THAT ONLY
46 THE APPROVAL OF THE COMMISSIONER WITH STATUTORY JURISDICTION OF THE
47 PROPOSED RULE OR REGULATION SHALL BE REQUIRED. PRIOR TO SUCH COMMISSION-
48 ER'S FINAL APPROVAL AND PROMULGATION OF SUCH PROPOSED RULES AND REGU-
49 LATIONS, IF SUCH RULES AND REGULATIONS ARE MODIFIED IN ANY RESPECT, THEY
50 SHALL BE SUBMITTED TO THE COUNCIL PURSUANT TO SUBDIVISION (J) OF THIS
51 SECTION. IF SUCH COMMISSIONER DETERMINES NOT TO PROMULGATE SUCH PROPOSED
52 RULES AND REGULATIONS, THE COMMISSIONER SHALL APPEAR BEFORE THE COUNCIL
53 TO REPORT THE REASONS THEREFOR.

54 (L) THE MEMBERS OF THE COUNCIL SHALL RECEIVE NO COMPENSATION FOR THEIR
55 SERVICES BUT SHALL BE REIMBURSED FOR EXPENSES ACTUALLY AND NECESSARILY
56 INCURRED IN THE PERFORMANCE OF THEIR DUTIES.

(M) THE COMMISSIONERS, UPON REQUEST OF THE COUNCIL, SHALL DESIGNATE ONE OR MORE OFFICERS OR EMPLOYEES FROM EITHER OR BOTH OFFICES TO PROVIDE ADMINISTRATIVE SUPPORT SERVICES TO THE COUNCIL, AND MAY ASSIGN FROM TIME TO TIME SUCH OTHER EMPLOYEES AS THE COUNCIL MAY REQUEST.

(N) NO CIVIL ACTION SHALL BE BROUGHT IN ANY COURT AGAINST ANY MEMBER OF THE BEHAVIORAL HEALTH SERVICES ADVISORY COUNCIL FOR ANY ACT DONE, FAILURE TO ACT, OR STATEMENT OR OPINION MADE, WHILE DISCHARGING HIS OR HER DUTIES AS A MEMBER OF THE COUNCIL, WITHOUT LEAVE FROM A JUSTICE OF THE SUPREME COURT, FIRST HAD AND OBTAINED. IN ANY EVENT SUCH MEMBER SHALL NOT BE LIABLE FOR DAMAGES IN ANY SUCH ACTION IF HE OR SHE SHALL HAVE ACTED IN GOOD FAITH, WITH REASONABLE CARE AND UPON PROBABLE CAUSE. MEMBERS OF THE COUNCIL SHALL BE CONSIDERED PUBLIC OFFICERS FOR THE PURPOSES OF SECTION SEVENTEEN OF THE PUBLIC OFFICERS LAW.

(O) THE COUNCIL MAY ESTABLISH SUCH COMMITTEES AS IT DEEMS NECESSARY.

(P) THE COUNCIL MAY ESTABLISH WRITTEN BYLAWS.

(Q) FOR PURPOSES OF THIS SECTION, "BEHAVIORAL HEALTH SERVICES" SHALL MEAN EXAMINATION, DIAGNOSIS, CARE, TREATMENT, REHABILITATION, OR TRAINING FOR PERSONS WITH MENTAL ILLNESS AND/OR FOR PERSONS WITH SUBSTANCE USE OR COMPULSIVE GAMBLING DISORDERS.

S 3. a. be measurable in terms of attainment AND FOCUSED ON OUTCOMES FOR THOSE BEING SERVED;

b. be DEVELOPED IN COLLABORATION WITH, AND communicated to, providers of services, department facilities, consumers and consumer representatives, and other appropriate state and local governmental agencies;

c. [require that all state and local public and private services for persons with mental disabilities be organized, staffed and financed to best meet the needs of all persons with mental disabilities whether receiving in-patient or non in-patient services;

d.] reflect the partnership between state and local governmental units; and

1 [e.] D. emphasize [that gaps in services be filled and that services
2 are provided to persons with mental disabilities] THE NEED TO INTEGRATE
3 BEHAVIORAL HEALTH AND HEALTH SERVICES.

4 (2) Such advisory councils shall [establish, review, augment or delete
5 from such goals and objectives, as appropriate,] ACCOMPLISH THEIR DUTIES
6 by means of a [continuing annual goal-setting] process which is:

7 a. open, visible and accessible to the public; and

8 b. consistent with the statewide AND FEDERALLY MANDATED planning,
9 appropriation and evaluation processes and activities for services to
10 [the mentally disabled] PERSONS WITH MENTAL DISABILITIES.

11 (3) The advisory councils are hereby empowered to hold public hearings
12 and meetings to enable them to accomplish their duties.

13 Statewide comprehensive plan for services to [the mentally disabled]

15 (1) The office of mental health, the office for people with develop-
16 mental disabilities and the office of alcoholism and substance abuse
17 services shall [each] formulate a statewide comprehensive [five-year]
18 plan for the provision of all state and local services for persons with
19 mental illness [and], developmental disabilities, [and] AND/OR those
20 [suffering from alcoholism and] WITH substance [abuse, respectively] USE
21 OR COMPULSIVE GAMBLING DISORDERS. [Each] THE STATEWIDE COMPREHENSIVE

40 GOALS;

41 [e. define the authority and responsibility for state and local
42 participation in the delivery of services] D. IDENTIFY SERVICES AND
43 SUPPORTS, WHICH MAY INCLUDE PROGRAMS RUN OR LED BY PEERS, THAT ARE
44 DESIGNED TO PROMOTE THE HEALTH AND WELLNESS OF PERSONS WITH MENTAL
45 ILLNESS, DEVELOPMENTAL DISABILITIES, AND/OR SUBSTANCE USE OR COMPULSIVE
46 GAMBLING DISORDERS;

47 [f. propose programs to achieve the goals, which programs may include
48 direct services, development of multi-purpose facilities, contracts for
49 services, and innovative financial and organizational relationships with
50 public and private providers;

51 g. identify services and programs that assist the informal caregiver
52 to care for the mentally disabled; make recommendations to enhance the
53 ability of the informal caregiver to continue providing care; and devel-
54 op strategies for creating informal caregivers for clients in the commu-
55 nity who do not have a system in place;

1 h. analyze] E. PROVIDE ANALYSIS OF current and anticipated utilization
2 of state and local, and public and private facilities [and], programs,
3 SERVICES, AND/OR SUPPORTS;

4 [i.] F. encourage and promote PERSON-CENTERED, CULTURALLY AND LINGUIS-
5 TICALLY COMPETENT community-based programs, SERVICES, AND/OR SUPPORTS
6 which reflect the partnership between state and local governmental
7 units; and

8 [j.] G. include progress reports on the implementation of both short-
9 term and long-term recommendations of the children's plan required
10 pursuant to section four hundred eighty-three-f of the social services
11 law.

12 (3) The commissioners of each of the offices shall be responsible for
13 the development of such statewide [five-year] plan for services within
14 the jurisdiction of their respective offices and after giving due notice
15 shall conduct one or more public hearings on such plan. The BEHAVIORAL
16 HEALTH SERVICES advisory council [of each office] AND THE ADVISORY COUN-
17 CIL ON DEVELOPMENTAL DISABILITIES shall review the statewide [five year]
18 COMPREHENSIVE plan developed by such office OR OFFICES and report its
19 recommendations thereon to such commissioner OR COMMISSIONERS. Each

(3) Such plan shall further specify for each project whether the project is to be a residential or nonresidential facility, a state or voluntary operated facility, and, the number of clients, by source of clients, proposed to utilize the facility. The information on the source of the client shall include but not be limited to identification of clients currently living independently, or at home with families, or with caretakers, clients defined by their respective agencies as special populations, or clients currently residing in an institutional setting under the jurisdiction of the offices of the department.

(4) The advisory council of the appropriate office shall review such plan and report its recommendation to the commissioner for inclusion, provided, however, that the mental health services council shall forward its comments on the capital plan of the office of mental health to the mental health planning council which shall forward such recommendations after review to the commissioner of mental health. The commissioner shall submit his or her plan with the formal recommendations of the advisory council of his or her office and any subsequent appropriate modifications to the governor no later than the first day of October of each year or concurrent with the annual submission of estimates and information required by section one of article seven of the constitution in order that such plans shall be considered with the estimates of the offices for the preparation of the executive budget of the state of New York for the next succeeding state fiscal year. The commissioners shall also submit such plans to the chairmen of the senate finance committee and the assembly ways and means committee.

(5) Each statewide three year capital plan for facilities shall be evaluated and revised annually to encompass the fiscal year then in progress and the next ensuing two fiscal years to ensure responsiveness to the changing needs and goals of the department, and to reflect the development of new information and project completion.]

S 4. Section 7.05 of the mental hygiene law is REPEALED.

S 5. Subdivision (c) of section 13.05 of the mental hygiene law, as amended by chapter 37 of the laws of 2011, is amended to read as follows:

(c) The developmental disabilities advisory council shall have no executive, administrative or appointive duties. It shall, in cooperation with the commissioner of developmental disabilities, [establish] PROVIDE RECOMMENDATIONS FOR statewide PRIORITIES AND goals [and objectives] for services for individuals with developmental disabilities and shall advise the commissioner on matters related to development and implementation of the [OPWDD's triennial state developmental disabilities] STATEWIDE comprehensive plan as required under [paragraph two of subdivision (b) of] section 5.07 of this chapter. 7 (c) A local services plan shall be developed, in accordance with the
8 regulations of the commissioner or commissioners of the office or
9 offices of the department having jurisdiction of the services by the
10 local governmental unit or units which shall direct and administer a
11 local comprehensive planning process for its geographic area, consistent
12 with statewide goals and objectives established pursuant to section 5.07
13 of this chapter. The planning process shall involve the directors of any
14 department facilities, directors of hospital based mental health
15 services, directors of community mental health centers, THE DIRECTOR OF
16 THE LOCAL OFFICE FOR THE AGING OR HIS OR HER REPRESENTATIVE, consumers,
17 consumer groups, voluntary agencies, other providers of services, and
18 local correctional facilities and other local criminal justice agencies.
19 The local governmental unit, or units, shall determine the proposed
20 local services plan to be submitted for approval. If any provider of

14 transitional placement programs, provided that the commissioner provide
15 at least 30 days notice of such reductions to the temporary president of
16 the senate and the speaker of the assembly and simultaneously post such
17 notice upon its public website. In assessing which significant service
18 reductions to undertake, the commissioner shall consider data related to
19 inpatient census, indicating nonutilization or under utilization of
20 beds, and the efficient operation of facilities.

21 (b) At least sixty days prior to the anticipated closure, consol-
22 idation or merger of any hospitals named in subdivision (b) of section
23 7.17 of the mental hygiene law, the commissioner of mental health shall
24 provide notice of such closure, consolidation or merger to the temporary
25 president of the senate, and speaker of the assembly, the chief execu-
26 tive officer of the county in which the facility is located, and shall
27 post such notice upon its public website. The commissioner shall be
28 authorized to conduct any and all preparatory actions which may be
29 required to effectuate such closures during such sixty day period. In
30 assessing which of such hospitals to close, the commissioner shall
31 consider the following factors: (1) the size, scope and type of services
32 provided by the hospital; (2) the relative quality of the care and
33 treatment provided by the hospital, as may be informed by internal or
34 external quality or accreditation reviews; (3) the current and antic-
35 ipated long-term need for the types of services provided by the facility
36 within its catchment area, which may include, but not be limited to,
37 services for adults or children, or other specialized services, such as
38 forensic services; (4) the availability of staff sufficient to address
39 the current and anticipated long term service needs; (5) the long term
40 capital investment required to ensure that the facility meets relevant
41 state and federal regulatory and capital construction requirements, and
42 national accreditation standards; (6) the proximity of the facility to
43 other facilities with space that could accommodate anticipated need, the
44 relative cost of any necessary renovations of such space, the relative
45 potential operating efficiency of such facilities, and the size, scope

48 mental health services available in the facility catchment area and the

S 3. Severability clause. If any clause, sentence, paragraph, subdivision, section or part of this act shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part thereof directly involved in the controversy in which such judgment shall have been rendered. It is hereby declared to be the intent of the legislature that this act would have been enacted even if such invalid provisions had not been included herein.

Personnel from these same agencies may provide security services, provided that such staff are adequately trained in security methods and so equipped as to minimize the risk or danger of escape. THE COMMISSIONER SHALL HAVE THE DISCRETION TO ENTER INTO AGREEMENTS FOR THE PROVISION OF CARE AND TREATMENT TO PERSONS HELD AT A SECURE TREATMENT FACILITY PURSUANT TO THIS ARTICLE, OR FOR THE PROVISION OF APPROPRIATE SECURITY SERVICES, BY INDIVIDUALS WHO ARE NOT PERSONNEL OF SUCH AGENCIES.

S 2. Subdivision (k) of section 10.06 of the mental hygiene law, as amended by section 118-c of subpart B of part C of chapter 62 of the laws of 2011, is amended to read as follows:

(k) At the conclusion of the hearing, the court shall determine whether there is probable cause to believe that the respondent is a sex offender requiring civil management. If the court determines that probable cause has not been established, the court shall issue an order dismissing the petition, and the respondent's release shall be in accordance with other applicable provisions of law. If the court determines that probable cause has been established: (i) the court shall order that the respondent be committed to a secure treatment facility designated by the commissioner for care, treatment and control upon his or her release, provided, however, that a respondent who otherwise would be required to be transferred to a secure treatment facility [may,] SHALL REMAIN IN THE CUSTODY OF THE DEPARTMENT OF CORRECTIONS AND COMMUNITY SUPERVISION PENDING THE OUTCOME OF THE PROCEEDINGS UNDER THIS ARTICLE UNTIL HE OR SHE HAS REACHED THE MAXIMUM EXPIRATION OF HIS OR HER SENTENCE OR HAS BEEN APPROVED FOR RELEASE TO PAROLE SUPERVISION BY THE STATE BOARD OF PAROLE, PROVIDED, FURTHER THAT A RESPONDENT MAY, upon a written consent signed by the respondent and his or her counsel, consent to remain in the custody of the department of corrections and community

1 supervision pending the outcome of the proceedings under this article,
2 and that such consent may be revoked in writing at any time; (ii) the
3 court shall set a date for trial in accordance with subdivision (a) of
4 section 10.07 of this article; and (iii) the respondent shall not be
5 released pending the completion of such trial.

6 S 3. Subdivision (f) of section 10.07 of the mental hygiene law, as
7 added by chapter 7 of the laws of 2007, is amended to read as follows:

8 (f) If the jury, or the court if a jury trial is waived, determines
9 that the respondent is a detained sex offender who suffers from a mental
10 abnormality, then the court shall consider whether the respondent is a
11 dangerous sex offender requiring confinement or a sex offender requiring
12 strict and intensive supervision. The parties may offer additional

21 for care, treatment, and control until such time as he or she no longer
22 requires confinement. FAILURE OF A DANGEROUS SEX OFFENDER REQUIRING
23 CONFINEMENT TO MEANINGFULLY PARTICIPATE IN TREATMENT IN A SECURE TREAT-
24 MENT FACILITY SHALL CONSTITUTE A VIOLATION OF THE ORDER OF CONFINEMENT.
25 If the court does not find that the respondent is a dangerous sex offen-
26 der requiring confinement, then the court shall make a finding of dispo-
27 sition that the respondent is a sex offender requiring strict and inten-
28 sive supervision, and the respondent shall be subject to a regimen of
29 strict and intensive supervision and treatment in accordance with
30 section 10.11 of this article. In making a finding of disposition, the
31 court shall consider the conditions that would be imposed upon the
32 respondent if subject to a regimen of strict and intensive supervision,
33 and all available information about the prospects for the respondent's
34 possible re-entry into the community.

41 SUAL SYSTEM, AS THAT TERM IS DEFINED IN SUBDIVISION ONE OF SECTION
42 182.10 OF THE CRIMINAL PROCEDURE LAW, FOR PURPOSES OF A COURT APPEARANCE
43 OR FOR GIVING TESTIMONY. IT SHALL CONSTITUTE GOOD CAUSE THAT A WITNESS
44 IS CURRENTLY EMPLOYED BY THE STATE AT A SECURE TREATMENT FACILITY OR
45 ANOTHER WORK LOCATION, UNLESS THERE ARE COMPELLING CIRCUMSTANCES REQUIR-
46 ING THE WITNESS'S PERSONAL PRESENCE AT THE COURT PROCEEDING. FOR
47 PURPOSES OF THIS SUBDIVISION, AN "ELECTRONIC APPEARANCE" MEANS AN
48 APPEARANCE AT WHICH A PARTICIPANT IS NOT PRESENT IN THE COURT, BUT IN
49 WHICH: (I) ALL OF THE PARTICIPANTS ARE ABLE TO SEE AND HEAR THE SIMUL-
50 TANEOUS REPRODUCTIONS OF THE VOICES AND IMAGES OF THE JUDGE, COUNSEL,
51 RESPONDENT OR ANY OTHER APPROPRIATE PARTICIPANT, AND (II) COUNSEL IS

56 RESPONDENT OR WITNESS HAD MADE A PERSONAL APPEARANCE. NOTHING IN THIS

1 SUBDIVISION SHALL BE CONSTRUED TO PROHIBIT THE RESPONDENT OR ANY WITNESS
2 FROM MAKING AN ELECTRONIC APPEARANCE IN THE COURT AT A TRIAL CONDUCTED
3 PURSUANT TO SECTION 10.07 OF THIS ARTICLE BY MEANS OF AN INDEPENDENT
4 AUDIO-VISUAL SYSTEM, UPON GOOD CAUSE SHOWN AND CONSENT OF THE PARTIES.

5 S 5. The section heading and subdivisions (a), (b), (c), (d), and (f)
6 of section 10.09 of the mental hygiene law, as added by chapter 7 of the
7 laws of 2007, are amended to read as follows:

8 [Annual] BIENNIAL examinations and petitions for discharge.

9 (a) The commissioner shall provide the respondent and counsel for
10 respondent with [an annual] A BIENNIAL written notice of the right to
11 petition the court for discharge. The notice shall contain a form for
12 the waiver of the right to petition for discharge.

13 (b) The commissioner shall also assure that each respondent committed
14 under this article shall have an examination for evaluation of his or
15 her mental condition made at least once every [year] TWO YEARS by a
16 psychiatric examiner who shall report to the commissioner his or her
17 written findings as to whether the respondent is currently a dangerous
18 sex offender requiring confinement. At such time, the respondent also
19 shall have the right to be evaluated by an independent psychiatric exam-
20 iner. If the respondent is financially unable to obtain an examiner,
21 the court shall appoint an examiner of the respondent's choice to be

33 (d) The court shall hold an evidentiary hearing as to retention of the
34 respondent within forty-five days if it appears from one of the [annual]

36 (i) that the respondent has petitioned, or has not affirmatively waived
37 the right to petition, for discharge, or (ii) that even if the respond-
38 ent has waived the right to petition, and the commissioner has deter-

50 an evidentiary hearing be held, or may deny an evidentiary hearing and
51 deny the petition upon a finding that the petition is frivolous or does
52 not provide sufficient basis for reexamination prior to the next [annu-
53 al] BIENNIAL review. If the court orders an evidentiary hearing under
54 this subdivision, the attorney general shall have the burden of proof as
55 to whether the respondent is currently a dangerous sex offender requir-
56 ing confinement.

14 (c) An order for a regimen of strict and intensive supervision and
15 treatment places the person in the custody and control of the department
16 of corrections and community supervision. A person ordered to undergo a
17 regimen of strict and intensive supervision and treatment pursuant to
18 this article is subject to lawful conditions set by the court and the
19 department of corrections and community supervision. A VIOLATION OF A
20 CONDITION OF THE REGIMEN OF STRICT AND INTENSIVE SUPERVISION AND TREAT-
21 MENT FOR A PERSON UNDER COMMUNITY SUPERVISION, AS DEFINED IN SUBDIVISION
22 THREE OF SECTION TWO HUNDRED FIFTY-NINE OF THE EXECUTIVE LAW, MAY BE THE
23 BASIS FOR REVOCATION OF PAROLE PURSUANT TO SECTION TWO HUNDRED
24 FIFTY-NINE-I OF THE EXECUTIVE LAW. A PERSON WHO INTENTIONALLY VIOLATES A

26 AND TREATMENT SHALL BE GUILTY OF A CLASS E FELONY.

27 S 8. Section 120.05 of the penal law is amended by adding a new subdi-

29 13. HAVING BEEN FOUND TO BE A SEX OFFENDER REQUIRING CIVIL MANAGEMENT

52 Section 1. Section 1 of part D of chapter 111 of the laws of 2010
53 relating to the recovery of exempt income by the office of mental health

for community residences and family-based treatment programs is amended to read as follows:

Section 1. The office of mental health is authorized to recover funding from community residences and family-based treatment providers licensed by the office of mental health, consistent with contractual obligations of such providers, and notwithstanding any other inconsistent provision of law to the contrary, in an amount equal to 50 percent of the income received by such providers which exceeds the fixed amount of annual Medicaid revenue limitations, as established by the commissioner of mental health. Recovery of such excess income shall be for the following fiscal periods: for programs in counties located outside of the city of New York, the applicable fiscal periods shall be January 1, 2003 through December 31, 2009 AND JANUARY 1, 2011 THROUGH DECEMBER 31, 2013; and for programs located within the city of New York, the applicable fiscal periods shall be July 1, 2003 through June 30, 2010 AND JULY 1, 2011 THROUGH JUNE 30, 2013.

S 2. This act shall take effect immediately.

Section 1. Section 18 of chapter 266 of the laws of 1986, amending the civil practice law and rules and other laws relating to medical and dental malpractice, is REPEALED.

S 2. Any rules or regulations promulgated by the superintendent of insurance or the commissioner of health pursuant to the provisions of section 18 of chapter 266 of the laws of 1986 shall survive such repeal, and shall be applicable to the excess medical malpractice liability coverage pool and related provisions as created by section three of this act.

The repeal of section 18 of chapter 266 of the laws of 1986 as effectuated by section one of this act shall not affect the rights or obligations of any physician, dentist, insurer or general hospital related to excess or equivalent excess coverage purchased pursuant to the provisions of section 18 of chapter 266 of the laws of 1986 that were in effect prior to the date this act takes effect; nor shall the repeal of section 18 of chapter 266 of the laws of 1986 as effectuated by section one of this act affect the rights or obligations of any claimant against excess or equivalent excess coverage that was purchased pursuant to the provisions of section 18 of chapter 266 of the laws of 1986 that were in effect prior to the date this act takes effect.

S 3. The public health law is amended by adding a new section 23 to read as follows:

S 23. EXCESS MEDICAL MALPRACTICE LIABILITY COVERAGE POOL. 1. THE HOSPITAL EXCESS LIABILITY POOL ESTABLISHED BY SUBDIVISION FIVE OF SECTION EIGHTEEN OF CHAPTER TWO HUNDRED SIXTY-SIX OF THE LAWS OF NINETEEN HUNDRED EIGHTY-SIX, AS AMENDED BY CHAPTER TWO HUNDRED FIFTY-SIX OF THE LAWS OF NINETEEN HUNDRED NINETY-THREE SHALL BE CONTINUED AND IS HEREBY RENAMED THE "EXCESS MEDICAL MALPRACTICE LIABILITY COVERAGE POOL." THE EXCESS MEDICAL MALPRACTICE LIABILITY COVERAGE POOL SHALL BE OVERSEEN BY THE SUPERINTENDENT OF FINANCIAL SERVICES AND THE COMMISSIONER, AND SHALL CONSIST OF FUNDS CURRENTLY IN OR OWED TO THE EXCESS LIABILITY POOL AS OF THE EFFECTIVE DATE OF THIS SECTION, AND FUNDS APPROPRIATED FOR THE PURPOSES OF THE EXCESS MEDICAL MALPRACTICE LIABILITY COVERAGE POOL.

2. NOTWITHSTANDING ANY INCONSISTENT PROVISION OF SECTIONS ONE HUNDRED TWELVE AND ONE HUNDRED SIXTY-THREE OF THE STATE FINANCE LAW, OR SECTIONS ONE HUNDRED FORTY-TWO AND ONE HUNDRED FORTY-THREE OF THE ECONOMIC DEVEL-

OPMENT LAW, OR ANY OTHER CONTRARY PROVISION OF LAW, THE SUPERINTENDENT OF FINANCIAL SERVICES MAY ENTER INTO A CONTRACT OR CONTRACTS UNDER THIS SUBDIVISION WITHOUT A COMPETITIVE BID OR REQUEST FOR PROPOSAL PROCESS, PROVIDED, HOWEVER, THAT:

(A) THE DEPARTMENT OF FINANCIAL SERVICES SHALL POST ON ITS WEBSITE, FOR A PERIOD OF NO LESS THAN THIRTY DAYS:

(I) A DESCRIPTION OF THE PROPOSED SERVICES TO BE PROVIDED PURSUANT TO THE CONTRACT OR CONTRACTS;

(II) THE CRITERIA FOR SELECTION OF A CONTRACTOR OR CONTRACTORS;

(III) THE PERIOD OF TIME DURING WHICH A PROSPECTIVE CONTRACTOR MAY SEEK SELECTION, WHICH SHALL BE NO LESS THAN THIRTY DAYS AFTER SUCH INFORMATION IS FIRST POSTED ON THE WEBSITE; AND

(IV) THE MANNER BY WHICH A PROSPECTIVE CONTRACTOR MAY SEEK SUCH SELECTION, WHICH MAY INCLUDE SUBMISSION BY ELECTRONIC MEANS;

(B) ALL REASONABLE AND RESPONSIVE SUBMISSIONS THAT ARE RECEIVED FROM PROSPECTIVE CONTRACTORS IN TIMELY FASHION SHALL BE REVIEWED BY THE SUPERINTENDENT OF FINANCIAL SERVICES; AND

(C) THE SUPERINTENDENT OF FINANCIAL SERVICES SHALL SELECT SUCH CONTRACTOR OR CONTRACTORS THAT, IN THE SUPERINTENDENT OF FINANCIAL SERVICES' DISCRETION, ARE BEST SUITED TO SERVE THE PURPOSES OF THIS SUBDIVISION.

3. (A) THE SUPERINTENDENT OF FINANCIAL SERVICES AND THE COMMISSIONER OR THEIR DESIGNEES SHALL, FROM FUNDS AVAILABLE IN THE EXCESS MEDICAL MALPRACTICE LIABILITY COVERAGE POOL CREATED PURSUANT TO SUBDIVISION ONE OF THIS SECTION, PURCHASE A POLICY OR POLICIES FOR EXCESS INSURANCE COVERAGE, OR FOR EQUIVALENT EXCESS COVERAGE, FOR MEDICAL OR DENTAL MALPRACTICE OCCURRENCES BETWEEN THE FIRST OF JULY OF A GIVEN YEAR AND ENDING THE THIRTIETH OF JUNE OF THE NEXT SUCCEEDING YEAR, OR TO REIMBURSE A GENERAL HOSPITAL WHERE THE HOSPITAL PURCHASES EQUIVALENT EXCESS COVERAGE FOR MEDICAL OR DENTAL MALPRACTICE OCCURRENCES BETWEEN THE FIRST OF JULY IN A GIVEN YEAR AND ENDING THE THIRTIETH OF JUNE IN THE SUCCEEDING YEAR FOR ELIGIBLE PHYSICIANS OR DENTISTS AS CERTIFIED BY A GENERAL HOSPITAL LICENSED PURSUANT TO ARTICLE TWENTY-EIGHT OF THIS CHAPTER FOR EACH SUCH PERIOD OR PERIODS.

(B) SUCH POLICIES MAY BE PURCHASED PURSUANT TO SECTION FIVE THOUSAND FIVE HUNDRED TWO OF THE INSURANCE LAW, OR FROM AN INSURER, DULY LICENSED IN THIS STATE TO WRITE PERSONAL INJURY LIABILITY INSURANCE AND ACTUALLY WRITING MEDICAL MALPRACTICE INSURANCE IN THIS STATE.

(C) NO SINGLE INSURER SHALL WRITE MORE THAN FIFTY PERCENT OF THE TOTAL EXCESS PREMIUM FOR A GIVEN POLICY YEAR, UNLESS UPON REQUEST BY THE INSURER, THE SUPERINTENDENT OF FINANCIAL SERVICES IN WRITING DETERMINED THAT EXCEEDING SUCH LIMIT WOULD NOT BE HARMFUL TO THE POLICYHOLDER AND THE PEOPLE OF THE STATE.

4. (A) FOR THE PURPOSES OF THIS SECTION, "ELIGIBLE PHYSICIAN OR DENTIST" SHALL A MEAN A PHYSICIAN OR DENTIST, EXCLUDING A FACULTY PRACTICE PHYSICIAN OR DENTIST, WHO:

(I) IS PRIMARILY ENGAGED IN THE PRIVATE PRACTICE OF MEDICINE, OR IS AN EMPLOYEE OF AN ELIGIBLE HOSPITAL;

(II) HAS PROFESSIONAL PRIVILEGES IN THE GENERAL HOSPITAL THAT IS CERTIFYING THE PHYSICIAN'S OR DENTIST'S ELIGIBILITY;

(III) IS PROVIDING EMERGENCY MEDICAL OR DENTAL SERVICES, INCLUDING EMERGENCY MEDICAL SCREENING EXAMINATIONS, TREATMENT FOR EMERGENCY MEDICAL CONDITIONS, INCLUDING LABOR AND DELIVERY, OR TREATMENT FOR EMERGENCY DENTAL CONDITIONS TO PERSONS IN NEED OF SUCH TREATMENT AT THE GENERAL HOSPITAL THAT IS CERTIFYING THEIR ELIGIBILITY; AND

(IV) (1) HAS IN FORCE COVERAGE UNDER AN INDIVIDUAL POLICY OR GROUP POLICY WRITTEN IN ACCORDANCE WITH THE PROVISIONS OF THE INSURANCE LAW, PAID FOR SOLELY BY SUCH PHYSICIAN OR DENTIST OR HIS OR HER PRIVATE PRACTICE, FROM AN INSURER LICENSED IN THIS STATE TO WRITE PERSONAL INJURY LIABILITY INSURANCE, OF PRIMARY MALPRACTICE INSURANCE COVERAGE IN AMOUNTS OF NO LESS THAN ONE MILLION THREE HUNDRED THOUSAND DOLLARS FOR EACH CLAIMANT AND THREE MILLION NINE HUNDRED THOUSAND DOLLARS FOR ALL CLAIMANTS UNDER THAT POLICY AND COVERING THE SAME TIME PERIOD AS THE EXCESS INSURANCE COVERAGE;

(2) IN THE CASE OF AN EMPLOYEE OF AN ELIGIBLE HOSPITAL, HAS IN FORCE AN INDIVIDUAL POLICY OR GROUP POLICY WRITTEN IN ACCORDANCE WITH THE PROVISIONS OF THE INSURANCE LAW, PARTIALLY OR FULLY PURCHASED BY AN ELIGIBLE HOSPITAL, FROM AN INSURER LICENSED IN THIS STATE TO WRITE PERSONAL INJURY LIABILITY INSURANCE, OF PRIMARY MALPRACTICE INSURANCE COVERAGE IN AMOUNTS OF NO LESS THAN ONE MILLION THREE HUNDRED THOUSAND DOLLARS FOR EACH CLAIMANT AND THREE MILLION NINE HUNDRED THOUSAND DOLLARS FOR ALL CLAIMANTS UNDER THAT POLICY AND COVERING THE SAME TIME PERIOD AS THE EXCESS INSURANCE COVERAGE; OR

(3) IS ENDORSED AS AN ADDITIONAL INSURED UNDER A VOLUNTARY ATTENDING PHYSICIAN ("CHANNELING") PROGRAM PREVIOUSLY PERMITTED BY THE SUPERINTENDENT OF INSURANCE AND COVERING THE SAME TIME PERIOD AS THE EQUIVALENT EXCESS COVERAGE.

(B) THE EXCESS COVERAGE OR EQUIVALENT EXCESS COVERAGE SHALL, WHEN COMBINED WITH THE PHYSICIAN'S OR DENTIST'S PRIMARY MALPRACTICE INSURANCE COVERAGE OR COVERAGE PROVIDED THROUGH A VOLUNTARY ATTENDING PHYSICIAN ("CHANNELING") PROGRAM PREVIOUSLY PERMITTED BY THE SUPERINTENDENT OF INSURANCE, TOTAL AN AGGREGATE LEVEL OF COVERAGE OF TWO MILLION THREE HUNDRED THOUSAND DOLLARS FOR EACH CLAIMANT AND SIX MILLION NINE HUNDRED THOUSAND DOLLARS FOR ALL CLAIMANTS WITH RESPECT TO OCCURRENCES DURING THE POLICY PERIOD.

(C) THE EQUIVALENT EXCESS COVERAGE SHALL PROVIDE FOR PAYMENT ONLY AFTER COVERAGE AVAILABLE THROUGH THE VOLUNTARY ATTENDING PHYSICIAN ("CHANNELING") PROGRAM HAS BEEN EXHAUSTED DURING THE POLICY PERIOD.

(D) IN THE EVENT THAT AN ELIGIBLE PHYSICIAN OR DENTIST HAS PROFESSIONAL PRIVILEGES IN MORE THAN ONE GENERAL HOSPITAL, THE CERTIFICATION OF THE PHYSICIAN'S OR DENTIST'S ELIGIBILITY SHALL BE PROVIDED BY THE GENERAL HOSPITAL DESIGNATED BY SUCH PHYSICIAN OR DENTIST AS THE GENERAL HOSPITAL WITH WHICH THE PHYSICIAN OR DENTIST IS PRIMARILY AFFILIATED, AS MAY BE DEFINED PURSUANT TO REGULATIONS PROMULGATED BY THE COMMISSIONER.

5. FOR THE PURPOSES OF THIS SECTION THE TERM "ELIGIBLE HOSPITAL" SHALL MEAN A GENERAL HOSPITAL THAT HAS BEEN DETERMINED BY THE COMMISSIONER IN CONSULTATION WITH THE SUPERINTENDENT OF FINANCIAL SERVICES TO:

(A) HAVE ADEQUATELY DEMONSTRATED THAT HIGH COSTS FOR, OR LACK OF AVAILABILITY OF, MEDICAL MALPRACTICE LIABILITY COVERAGE HAVE IMPAIRED THE HOSPITAL'S ABILITY TO ATTRACT AND RETAIN PHYSICIANS AND DENTISTS PRACTICING IN FIELDS FOR WHICH THERE IS HIGH DEMAND BASED ON THE RATIO OF PATIENT VOLUME TO AVAILABLE PHYSICIANS; AND

(B) BE A VITAL ACCESS PROVIDER; AND

(C) HAVE ADEQUATELY DEMONSTRATED THAT THE GENERAL HOSPITAL IS IN FINANCIAL DISTRESS.

6. FOR THE PURPOSES OF THIS SECTION "EQUIVALENT EXCESS COVERAGE" SHALL MEAN A POLICY OR POLICIES OF INSURANCE FOR A PHYSICIAN OR DENTIST INSURED UNDER A VOLUNTARY ATTENDING PHYSICIAN ("CHANNELING") PROGRAM PREVIOUSLY PERMITTED BY THE SUPERINTENDENT OF INSURANCE INSURING A PHYSICIAN OR DENTIST AGAINST MEDICAL OR DENTAL MALPRACTICE WITH AN AGGREGATE LEVEL OF COVERAGE PROVIDING NOT LESS THAN TWO MILLION THREE

1 HUNDRED THOUSAND DOLLARS FOR EACH CLAIMANT AND SIX MILLION NINE HUNDRED
2 THOUSAND DOLLARS FOR ALL CLAIMANTS DURING THE POLICY PERIOD. SUCH COVER-
3 AGE LIMITS SHALL BE REDUCED BY PAYMENTS MADE ON BEHALF OF SUCH PHYSICIAN
4 OR DENTIST UNDER A HOSPITAL PROFESSIONAL LIABILITY POLICY WRITTEN PURSU-
5 ANT TO A VOLUNTARY ATTENDING PHYSICIAN ("CHANNELING") PROGRAM PREVIOUSLY
6 PERMITTED BY THE SUPERINTENDENT OF INSURANCE, IN AN AMOUNT NOT TO EXCEED
7 TWO MILLION THREE HUNDRED THOUSAND DOLLARS FOR EACH CLAIMANT AND SIX
8 MILLION NINE HUNDRED THOUSAND DOLLARS FOR ALL CLAIMANTS DURING SUCH
9 POLICY PERIOD FOR EACH SUCH PHYSICIAN OR DENTIST.

10 7. FOR THE PURPOSES OF THIS SECTION, A PHYSICIAN OR DENTIST IN THE
11 "PRIVATE PRACTICE OF MEDICINE" SHALL MEAN A PHYSICIAN OR DENTIST WHO
12 RECEIVES THE LARGEST PERCENTAGE OF HIS OR HER INCOME DERIVED FROM THE
13 PROVISION OF MEDICAL SERVICES, FROM BILLS:

14 (A) ISSUED DIRECTLY BY THE PHYSICIAN OR DENTIST;

15 (B) ISSUED DIRECTLY BY A CORPORATION, ORGANIZED FOR THE PURPOSE OF
16 PROVIDING MEDICAL OR DENTAL CARE, THAT IS NOT OWNED BY, AND IS NOT A
17 SUBSIDIARY OF, A GENERAL HOSPITAL, OR ISSUED BY A VENDOR CONTRACTED BY
18 THAT CORPORATION FOR THE PURPOSES OF BILLING, FOR SERVICES RENDERED BY
19 THE PHYSICIAN OR DENTIST; OR

20 (C) ISSUED BY A GENERAL HOSPITAL FOR SERVICES RENDERED BY A PHYSICIAN
21 OR DENTIST WHO HAS IN FORCE AN INDIVIDUAL MEDICAL MALPRACTICE INSURANCE
22 POLICY THAT IS PURCHASED SOLELY BY THE PHYSICIAN OR DENTIST OR AN ORGAN-
23 IZATION DESCRIBED IN PARAGRAPH (B) OF THIS SUBDIVISION, FROM AN INSURER
24 LICENSED IN THIS STATE TO WRITE PERSONAL INJURY LIABILITY INSURANCE, OF
25 PRIMARY MEDICAL MALPRACTICE INSURANCE COVERAGE IN AMOUNTS OF NO LESS
26 THAN ONE MILLION THREE HUNDRED THOUSAND DOLLARS FOR EACH CLAIMANT AND
27 THREE MILLION NINE HUNDRED THOUSAND DOLLARS FOR ALL CLAIMANTS.

28 8. (A) TO THE EXTENT FUNDS AVAILABLE TO THE EXCESS MEDICAL MALPRACTICE
29 LIABILITY COVERAGE POOL PURSUANT TO SUBDIVISION ONE OF THIS SECTION ARE
30 INSUFFICIENT TO MEET THE COSTS OF EXCESS INSURANCE COVERAGE OR EQUIV-
31 ALENT EXCESS COVERAGE FOR COVERAGE PERIODS DURING THE PERIOD BETWEEN
32 JULY FIRST OF A GIVEN YEAR AND JUNE THIRTIETH OF THE NEXT SUCCEEDING
33 YEAR, BEGINNING JULY FIRST, TWO THOUSAND TWELVE AND ENDING JUNE THIRTI-

36 FOR SUCH PERIOD SHALL BE RESPONSIBLE FOR PAYMENT TO THE PROVIDER OF
37 EXCESS INSURANCE COVERAGE OR EQUIVALENT EXCESS COVERAGE OF AN ALLOCABLE
38 SHARE OF SUCH INSUFFICIENCY, BASED ON THE RATIO OF THE TOTAL COST OF
39 SUCH COVERAGE FOR SUCH PHYSICIAN OR DENTIST TO THE SUM OF THE TOTAL COST
40 OF SUCH COVERAGE FOR ALL PHYSICIANS OR DENTISTS APPLIED TO SUCH INSUFFI-

42 (B) EACH PROVIDER OF EXCESS INSURANCE COVERAGE OR EQUIVALENT EXCESS
43 COVERAGE COVERING THE PERIOD BETWEEN JULY FIRST OF A GIVEN YEAR AND JUNE
44 THIRTIETH OF THE NEXT SUCCEEDING YEAR, BEGINNING JULY FIRST, TWO THOU-
45 SAND TWELVE AND ENDING JUNE THIRTIETH, TWO THOUSAND FOURTEEN SHALL NOTI-

50 GRAPH (A) OF THIS SUBDIVISION. SUCH AMOUNT SHALL BE DUE FROM SUCH PHYSI-
51 CIAN OR DENTIST TO SUCH PROVIDER OF EXCESS INSURANCE COVERAGE OR EQUIV-
52 ALENT EXCESS COVERAGE IN A TIME AND MANNER DETERMINED BY THE
53 SUPERINTENDENT OF FINANCIAL SERVICES.

54 (C) IF A PHYSICIAN OR DENTIST LIABLE FOR PAYMENT OF A PORTION OF THE

14 COMMISSIONER OR THEIR DESIGNEE OF EACH PHYSICIAN AND DENTIST ELIGIBLE

38 SECTION SHALL BE WRITTEN UPON AND GIVE EFFECT TO THE CHOICE OF AN INSUR-
39 ER BY THE PHYSICIAN OR DENTIST, PROVIDED, HOWEVER, THAT SUCH CHOICE
40 SHALL BE MADE AMONG INSURERS WRITING EXCESS COVERAGE POLICIES IN ACCORD-

48 9. ANY INSURER ISSUING POLICIES OF EXCESS OR EQUIVALENT EXCESS COVER-
49 AGE IN ACCORDANCE WITH SUBDIVISION ONE OF THIS SECTION MAY, NOTWITH-
50 STANDING ANY PROVISIONS OF THE INSURANCE LAW, RETURN TO THE STATE, IN
51 WHOLE OR IN PART, THE MONEYS REIMBURSED BY THE STATE IN ACCORDANCE WITH
52 THIS SECTION FOR SPECIFIED POLICY PERIODS, UPON A CERTIFICATION TO THE
53 INSURER BY THE SUPERINTENDENT OF FINANCIAL SERVICES THAT THERE IS A
54 REASONABLE LIKELIHOOD ON AN ACTUARIAL BASIS THAT THE MONEYS RETURNED
55 WILL NOT BE NEEDED TO PAY FOR THE EXPECTED LIABILITIES INCURRED BY THE
56 INSURER FOR SUCH POLICY PERIODS.

1 10. THE SUPERINTENDENT OF FINANCIAL SERVICES AND THE COMMISSIONER MAY
2 ADOPT AND MAY AMEND SUCH REGULATIONS AS ARE NECESSARY TO EFFECTUATE THE
3 PROVISIONS OF THIS SECTION.

4 S 4. This act shall take effect immediately.

5 S 2. Severability clause. If any clause, sentence, paragraph, subdivi-
6 sion, section or part of this act shall be adjudged by any court of
7 competent jurisdiction to be invalid, such judgment shall not affect,
8 impair, or invalidate the remainder thereof, but shall be confined in
9 its operation to the clause, sentence, paragraph, subdivision, section
10 or part thereof directly involved in the controversy in which such judg-
11 ment shall have been rendered. It is hereby declared to be the intent of
12 the legislature that this act would have been enacted even if such
13 invalid provisions had not been included herein.

14 S 3. This act shall take effect immediately provided, however, that
15 the applicable effective date of Parts A through S of this act shall be
16 as specifically set forth in the last section of such Parts.
