AN ACT to amend the environmental conservation law, in relation to
establishing the natural gas production contamination response and
compensation program; and to amend the state finance law, in relation
to creating the New York natural gas production contamination damage
recovery and remediation fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Article 23 of the environmental conservation law is amended
2 by adding a new title 29 to read as follows:

16 S 23-2901. LEGISLATIVE INTENT.

17 THE LEGISLATURE FINDS AND DECLARES THAT NEW YORK'S LANDS AND WATERS
18 CONSTITUTE A UNIQUE AND DELICATELY BALANCED RESOURCE; THAT THE
19 PROTECTION AND PRESERVATION OF THESE LANDS AND WATERS PROMOTES THE
20 HEALTH, SAFETY AND WELFARE OF THE PEOPLE OF THIS STATE; THAT THE STATE
21 IS THE TRUSTEE, FOR THE BENEFIT OF ITS CITIZENS, OF ALL NATURAL
22 RESOURCES WITHIN ITS JURISDICTION; AND THAT CONTAMINATION FROM INCIDENTS
23 OR ACCIDENTS THAT RESULT FROM NATURAL GAS PRODUCTION POSE A THREAT TO
24 THE ECONOMY AND ENVIRONMENT OF THIS STATE. THE LEGISLATURE INTENDS BY

1 THE PASSAGE OF THIS TITLE TO EXERCISE THE POWERS OF THIS STATE TO
2 PROVIDE STRICT LIABILITY FOR DAMAGE SUSTAINED WITHIN THIS STATE AS A
3 RESULT OF CONTAMINATION CAUSED BY NATURAL GAS PRODUCTION, REQUIRE PROMPT
4 CLEANUP AND DECONTAMINATION OF ANY AFFECTED REAL OR PERSONAL PROPERTY,
5 AND ESTABLISH A FUND FOR THE PAYMENT OF REMEDIATION COSTS OF CONTAM-
6 INATION AND TIMELY AND ADEQUATE COMPENSATION TO ANY PERSONS DAMAGED BY
7 SUCH CONTAMINATION.

8 S 23-2902. PURPOSES.

9 IT IS THE PURPOSE OF THIS TITLE TO ENSURE A CLEAN ENVIRONMENT AND
10 HEALTHY ECONOMY FOR THE STATE BY PROVIDING FOR THE REMEDIATION OF ANY
11 CONTAMINATION ASSOCIATED WITH NATURAL GAS PRODUCTION WHICH MAY RESULT IN
12 DAMAGE TO LANDS, WATERS OR NATURAL RESOURCES OF THE STATE BY AUTHORIZING
13 THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION TO RESPOND QUICKLY TO SUCH
14 CONTAMINATION AND EFFECT PROMPT CLEANUP AND DECONTAMINATION OF SUCH
15 CONTAMINATION, GIVING FIRST PRIORITY TO PROTECTING PUBLIC HEALTH AND
16 MINIMIZING ENVIRONMENTAL DAMAGE, AND BY PROVIDING FOR STRICT LIABILITY
17 FOR DAMAGE SUSTAINED WITHIN THE STATE AS A RESULT OF SUCH CONTAMINATION.
18 S 23-2903. DEFINITIONS.

19 FOR THE PURPOSES OF THIS TITLE, UNLESS THE CONTEXT CLEARLY INDICATES
20 OTHERWISE, THE FOLLOWING TERMS SHALL HAVE THE FOLLOWING MEANINGS:

21 1. "ADMINISTRATOR" MEANS THE CHIEF EXECUTIVE, WITHIN THE DEPARTMENT OF
22 AUDIT AND CONTROL, OF THE NEW YORK NATURAL GAS PRODUCTION CONTAMINATION
23 DAMAGE RECOVERY AND REMEDIATION FUND ESTABLISHED IN SECTION NINETY-TWO-T
24 OF THE STATE FINANCE LAW;

25 2. "CLAIM" MEANS, FOR PURPOSES OF PART THREE OF THIS TITLE, ANY CLAIM
26 OF THE FUND OR ANY CLAIM BY AN INJURED PERSON WHO IS NOT RESPONSIBLE FOR
27 THE CONTAMINATION SEEKING COMPENSATION FOR CLEANUP AND DECONTAMINATION
28 COSTS INCURRED OR DAMAGES SUSTAINED AS A RESULT OF CONTAMINATION THAT
29 RESULTS FROM NATURAL GAS PRODUCTION;

30 3. "CLEANUP AND DECONTAMINATION" MEANS ACTIVITIES UNDERTAKEN TO PERMA-
31 NENTLY ELIMINATE, REMOVE, ABATE, CONTROL OR MONITOR HEALTH AND/OR ENVI-
32 RONMENTAL HAZARDS OR POTENTIAL HAZARDS IN CONNECTION WITH NATURAL GAS
33 PRODUCTION;

34 4. "CLEANUP AND DECONTAMINATION COSTS" MEANS ALL COSTS ASSOCIATED WITH
35 THE CLEANUP AND DECONTAMINATION OF CONTAMINATION INCLUDING RELOCATION
36 COSTS PURSUANT TO SECTION 23-2907 OF THIS TITLE INCURRED BY THE STATE OR
37 ITS POLITICAL SUBDIVISIONS OR THEIR AGENTS OR ANY PERSON WITH APPROVAL
38 OF THE DEPARTMENT;

39 5. "CONTAMINATION" MEANS ANY DAMAGE TO ANY PROPERTY OR THE ENVIRON-
40 MENT, INCLUDING, BUT NOT LIMITED TO, A PUBLIC OR PRIVATE WATER SUPPLY,
41 ANY THREAT TO PUBLIC HEALTH, OR ANY HAZARDOUS CONDITION THAT PREVENTS
42 THE USE OF PROPERTY OR THAT REQUIRES RELOCATION OF PEOPLE OR PROPERTY TO
43 PREVENT HARM RESULTING FROM NATURAL GAS PRODUCTION, OR THE RELEASE OF
44 ANY SUBSTANCE USED IN OR ASSOCIATED WITH PROCESSES RELATED TO NATURAL
45 GAS PRODUCTION, INCLUDING, BUT NOT LIMITED TO, THE DEVELOPMENT OF
46 NATURAL GAS WELLS; ACTIVITIES ASSOCIATED WITH DRILLING, STIMULATING,
47 COMPLETING, OR OPERATING A NATURAL GAS WELL; ACTIVITIES ASSOCIATED WITH
48 THE CONSTRUCTION OR OPERATION OF FACILITIES FOR THE COLLECTION AND/OR
49 PROCESSING OF NATURAL GAS OR FOR THE TRANSMISSION OF NATURAL GAS FROM
50 GAS WELLS TO CONSUMERS OF NATURAL GAS; AND THE TRANSPORTATION OF MATERI-
51 ALS ASSOCIATED WITH A NATURAL GAS WELL SITE OR NATURAL GAS PRODUCTION;

52 6. "ENVIRONMENT" MEANS ANY WATER INCLUDING, BUT NOT LIMITED TO, A
53 STREAM, POND, LAKE, RIVER, WATER COURSE, AQUIFER, WETLAND OR RESERVOIR,
54 ANY LAND INCLUDING, BUT NOT LIMITED TO, A LAND SURFACE OR SUBSURFACE,
55 AIR, FISH, WILDLIFE, BIOTA AND ALL OTHER NATURAL RESOURCES;

1 7. "FUND" MEANS THE NEW YORK NATURAL GAS PRODUCTION CONTAMINATION
 2 DAMAGE RECOVERY AND REMEDIATION FUND ESTABLISHED BY SECTION NINETY-TWO-T
 3 OF THE STATE FINANCE LAW;

4 8. "NATURAL GAS PRODUCTION" OR "GAS PRODUCTION" MEANS ALL ACTIVITIES
 5 ASSOCIATED WITH THE EXPLORATION AND PRODUCTION OF NATURAL GAS, INCLUD-
 6 ING, BUT NOT LIMITED TO, (A) DEVELOPMENT OF NATURAL GAS WELLS; (B)
 7 ACTIVITIES ASSOCIATED WITH DRILLING, STIMULATING, COMPLETING, OR OPERAT-
 8 ING A NATURAL GAS WELL; (C) ACTIVITIES ASSOCIATED WITH THE CONSTRUCTION
 9 OR OPERATION OF FACILITIES FOR THE COLLECTION AND TRANSMISSION OF
 10 NATURAL GAS FROM GAS WELLS TO CONSUMERS OF NATURAL GAS; AND (D) THE
 11 TRANSPORTATION OF MATERIALS ASSOCIATED WITH A NATURAL GAS WELL SITE OR
 12 NATURAL GAS PRODUCTION WHETHER OR NOT SUCH GAS IS RE-INJECTED INTO THE
 13 SUBSURFACE OF THE EARTH, FROM A GEOLOGICAL FORMATION AND THE TRANSPORTA-
 14 TION OF SUCH NATURAL GAS TO ANOTHER LOCATION;

15 9. "OWNER" OR "OPERATOR" MEANS WITH RESPECT TO NATURAL GAS PRODUCTION
 16 ANY PERSON OWNING OR OPERATING BY LEASE, CONTRACT OR OTHER FORM OF
 17 AGREEMENT ANY NATURAL GAS PRODUCTION SITES, FACILITIES, EQUIPMENT, OR
 18 DEVELOPMENT RIGHTS; WITH RESPECT TO ABANDONED OR DERELICT SITES, FACILI-
 19 TIES, EQUIPMENT, OR DEVELOPMENT RIGHTS, THE PERSON WHO OWNED OR OPERATED
 20 SUCH SITES, FACILITIES, EQUIPMENT OR DEVELOPMENT RIGHTS IMMEDIATELY
 21 PRIOR TO SUCH ABANDONMENT, OR THE OWNER, OR OPERATOR AT THE TIME OF
 22 CONTAMINATION;

23 10. "PERSON" MEANS PUBLIC OR PRIVATE CORPORATIONS, COMPANIES, ASSOCI-
 24 ATIONS, SOCIETIES, FIRMS, PARTNERSHIPS, JOINT STOCK COMPANIES, INDIVID-
 25 UALS, THE UNITED STATES, THE STATE OF NEW YORK AND ANY OF ITS POLITICAL
 26 SUBDIVISIONS OR AGENTS.

45 S 23-2905. CLEANUP AND DECONTAMINATION OF CONTAMINATION CAUSED BY
 46 NATURAL GAS PRODUCTION.

47 1. THE COMMISSIONER SHALL PROMULGATE REGULATIONS GOVERNING THE CLEANUP
 48 AND DECONTAMINATION OF ANY CONTAMINATION RESULTING FROM NATURAL GAS
 49 PRODUCTION.

50 2. NO PERSON SHALL SUPERVISE, AID OR PARTICIPATE IN ANY CLEANUP OR
 51 DECONTAMINATION METHOD WHICH IS INCONSISTENT WITH ANY RULE OR REGULATION
 52 PROMULGATED PURSUANT TO THIS SECTION.

53 S 23-2906. NOTIFICATION BY PERSONS RESPONSIBLE FOR CONTAMINATION.

54 ANY PERSON RESPONSIBLE FOR CAUSING CONTAMINATION SHALL IMMEDIATELY
 55 NOTIFY THE DEPARTMENT PURSUANT TO RULES AND REGULATIONS ESTABLISHED BY
 56 THE DEPARTMENT, BUT IN NO CASE LATER THAN TWO HOURS AFTER THE CONTAM-

1 INATION. FAILURE TO SO NOTIFY SHALL MAKE SUCH PERSON LIABLE PURSUANT TO
2 THE PENALTY PROVISIONS OF SECTION 23-2932 OF THIS TITLE.

3 S 23-2907. CLEANUP AND DECONTAMINATION OF PROHIBITED CONTAMINATIONS.

4 1. ANY PERSON CAUSING CONTAMINATION PROHIBITED BY SECTION 23-2904 OF
5 THIS PART SHALL IMMEDIATELY UNDERTAKE TO CONTAIN SUCH CONTAMINATION.
6 NOTWITHSTANDING THE ABOVE REQUIREMENT, THE DEPARTMENT, PURSUANT TO REGU-
7 LATIONS PROMULGATED FOR SUCH PURPOSE, MAY UNDERTAKE THE DECONTAMINATION
8 OF SUCH CONTAMINATION AND MAY RETAIN AGENTS AND CONTRACTORS WHO SHALL
9 OPERATE UNDER THE DIRECTION OF SUCH DEPARTMENT FOR SUCH PURPOSE.

10 2. (A) UPON THE OCCURRENCE OF CONTAMINATION RESULTING FROM NATURAL GAS
11 PRODUCTION, PURSUANT TO REGULATIONS PROMULGATED FOR SUCH PURPOSE, THE
12 DEPARTMENT SHALL RESPOND PROMPTLY AND PROCEED TO CLEANUP AND REMOVE THE
13 CONTAMINATION IN ACCORDANCE WITH ENVIRONMENTAL PRIORITIES OR MAY, AT ITS
14 DISCRETION, DIRECT THE PERSON RESPONSIBLE FOR SUCH CONTAMINATION TO
15 PROMPTLY CLEANUP AND REMOVE THE CONTAMINATION. THE DEPARTMENT SHALL BE
16 RESPONSIBLE FOR CLEANUP AND DECONTAMINATION OR, AS THE CASE MAY BE, FOR
17 RETAINING AGENTS AND CONTRACTORS WHO SHALL OPERATE UNDER THE DIRECTION
18 OF THAT DEPARTMENT FOR SUCH PURPOSES. IMPLEMENTATION OF CLEANUP AND
19 DECONTAMINATION PROCEDURES OF EACH CONTAMINATION SHALL BE CONDUCTED IN
20 ACCORDANCE WITH ENVIRONMENTAL PRIORITIES AND PROCEDURES ESTABLISHED BY
21 THE DEPARTMENT.

22 (B) SECTION EIGHT OF THE COURT OF CLAIMS ACT OR ANY OTHER PROVISION OF
23 LAW TO THE CONTRARY NOTWITHSTANDING, THE STATE SHALL BE IMMUNE FROM
24 LIABILITY AND ACTION WITH RESPECT TO ANY ACT OR OMISSION DONE IN THE
25 DISCHARGE OF THE DEPARTMENT'S RESPONSIBILITY PURSUANT TO THIS TITLE;
26 PROVIDED, HOWEVER, THAT THIS SUBDIVISION SHALL NOT LIMIT ANY LIABILITY
27 WHICH MAY OTHERWISE EXIST FOR UNLAWFUL, WILLFUL OR MALICIOUS ACTS OR
28 OMISSIONS ON THE PART OF THE STATE, STATE AGENCIES, OR THEIR OFFICERS,
29 EMPLOYEES OR AGENTS OR FOR CONTAMINATION IN VIOLATION OF SECTION 23-2904
30 OF THIS PART.

31 3. ANY UNEXPLAINED CONTAMINATION CAUSED BY NATURAL GAS PRODUCTION
32 WITHIN STATE JURISDICTION OR CONTAMINATION CAUSED BY NATURAL GAS
33 PRODUCTION OCCURRING BEYOND STATE JURISDICTION THAT FOR ANY REASON PENE-
34 TRATES WITHIN STATE JURISDICTION SHALL BE REMOVED BY OR UNDER THE DIREC-
35 TION OF THE DEPARTMENT. EXCEPT FOR THOSE EXPENSES INCURRED BY THE PARTY
36 CAUSING SUCH CONTAMINATION, ANY EXPENSES INCURRED IN THE DECONTAMINATION
37 OF CONTAMINATION SHALL BE PAID PROMPTLY FROM THE NEW YORK NATURAL GAS
38 PRODUCTION CONTAMINATION DAMAGE RECOVERY AND REMEDIATION FUND PURSUANT
39 TO SECTION NINETY-TWO-T OF THE STATE FINANCE LAW AND ANY REIMBURSEMENTS
40 DUE SUCH FUND SHALL BE COLLECTED IN ACCORDANCE WITH THE PROVISIONS OF
41 SUCH SECTION.

42 4. CLEANUP AND DECONTAMINATION OF CONTAMINATION AND ACTIONS TO MINI-
43 MIZE DAMAGE FROM SUCH CONTAMINATION SHALL BE, TO THE GREATEST EXTENT
44 POSSIBLE, PERMANENT REMEDIES TO THE CONTAMINATION, IN ACCORDANCE WITH
45 APPLICABLE FEDERAL AND STATE ENVIRONMENTAL LAWS, RULES AND REGULATIONS.

46 5. THE DEPARTMENT, IN CONSULTATION WITH THE STATE COMPTROLLER AND THE
47 ATTORNEY GENERAL, SHALL DEVELOP A STANDARD CONTRACT FORM TO BE USED WHEN
48 CONTRACTING SERVICES FOR THE CLEANUP AND DECONTAMINATION OF A CONTAM-
49 INATION.

50 6. WHENEVER THE DEPARTMENT ACTS TO REMOVE CONTAMINATION OR CONTRACTS
51 TO SECURE PROSPECTIVE DECONTAMINATION SERVICES, THE DEPARTMENT IS
52 AUTHORIZED TO DRAW UPON THE MONEY AVAILABLE IN THE FUND, PAID OUT ON THE
53 AUDIT AND WARRANT OF THE COMPTROLLER. SUCH MONEYS SHALL BE USED TO PAY
54 PROMPTLY FOR ALL CLEANUP AND DECONTAMINATION COSTS INCURRED BY THE
55 DEPARTMENT. WHENEVER THE DEPARTMENT ACTS TO REMOVE CONTAMINATION OR
56 CONTRACTS TO SECURE PROSPECTIVE DECONTAMINATION SERVICES TO ADDRESS

1 CONTAMINATION THAT IS ASSOCIATED WITH AN OWNER OR OPERATOR, IT SHALL
2 FIRST DRAW ON THE BOND OR OTHER FINANCIAL SECURITY REQUIRED BY PARAGRAPH
3 (C) OF SUBDIVISION THREE OF SECTION 23-2915 OF THIS TITLE PAID OUT ON
4 THE AUDIT AND WARRANT OF THE COMPTROLLER. IF SUCH BOND OR FINANCIAL
5 SECURITY IS INSUFFICIENT TO FULLY DISCHARGE CLEANUP AND DECONTAMINATION
6 COSTS, THE DEPARTMENT IS AUTHORIZED TO DRAW ON MONEY AVAILABLE IN THE
7 FUND, PAID OUT ON THE AUDIT AND WARRANT OF THE STATE COMPTROLLER.

8 7. (A) NOTHING IN THIS SECTION IS INTENDED TO PRECLUDE CLEANUP AND
9 DECONTAMINATION BY ANY PERSON THREATENED BY SUCH CONTAMINATION, WHO, AS
10 SOON AS IS REASONABLY POSSIBLE, COORDINATES AND OBTAINS APPROVAL FOR
11 SUCH ACTIONS WITH ONGOING STATE OR FEDERAL OPERATIONS AND APPROPRIATE
12 STATE AND FEDERAL AUTHORITIES. NOTWITHSTANDING ANY OTHER PROVISION OF
13 LAW TO THE CONTRARY, THE LIABILITY OF ANY CONTRACTOR FOR SUCH PERSON,
14 WHERE SUCH PERSON OBTAINS APPROVAL FROM APPROPRIATE STATE AND FEDERAL
15 AUTHORITIES FOR SUCH CLEANUP AND DECONTAMINATION, AND THE LIABILITY OF
16 ANY PERSON PROVIDING SERVICES RELATED TO THE CLEANUP OR DECONTAMINATION
17 OF CONTAMINATION, UNDER CONTRACT WITH THE DEPARTMENT, FOR ANY INJURY TO
18 A PERSON OR PROPERTY CAUSED BY OR RELATED TO SUCH SERVICES SHALL BE
19 LIMITED TO ACTS OR OMISSIONS OF THE PERSON DURING THE COURSE OF PERFORM-
20 ING SUCH SERVICES WHICH ARE SHOWN TO HAVE BEEN THE RESULT OF NEGLIGENCE,
21 GROSS NEGLIGENCE OR RECKLESS, WANTON OR INTENTIONAL MISCONDUCT. NOTWITH-
22 STANDING ANY OTHER PROVISIONS OF LAW, WHEN (I) A VERDICT OR DECISION IN
23 AN ACTION OR CLAIM FOR INJURY TO A PERSON OR PROPERTY CAUSED BY OR
24 RELATED TO SUCH SERVICES IS DETERMINED IN FAVOR OF A CLAIMANT IN AN
25 ACTION INVOLVING A PERSON PERFORMING SUCH SERVICES AND ANY OTHER PERSON
26 OR PERSONS JOINTLY LIABLE, AND (II) THE LIABILITY OF THE PERSON PERFORM-
27 ING SUCH SERVICES IS FOUND TO BE FIFTY PERCENT OR LESS OF THE TOTAL
28 LIABILITY ASSIGNED TO ALL PERSONS LIABLE, AND (III) THE LIABILITY OF THE
29 PERSON PERFORMING SUCH SERVICES IS NOT BASED ON A FINDING OF RECKLESS
30 DISREGARD FOR THE SAFETY OF OTHERS, OR INTENTIONAL MISCONDUCT, THEN THE
31 LIABILITY OF THE PERSON PERFORMING SUCH SERVICES TO THE CLAIMANT FOR
32 LOSS RELATING TO INJURY TO PROPERTY AND FOR NON-ECONOMIC LOSS RELATING
33 TO INJURY TO A PERSON SHALL NOT EXCEED THE EQUITABLE SHARE OF THE PERSON
34 PERFORMING SUCH SERVICES DETERMINED IN ACCORDANCE WITH THE RELATIVE
35 CULPABILITY OF EACH PERSON CAUSING OR CONTRIBUTING TO THE TOTAL LIABIL-
36 ITY FOR SUCH LOSSES; PROVIDED, HOWEVER, THAT THE CULPABLE CONDUCT OF ANY
37 PERSON NOT A PARTY TO THE ACTION SHALL NOT BE CONSIDERED IN DETERMINING
38 ANY EQUITABLE SHARE HEREIN IF THE CLAIMANT PROVES THAT WITH DUE DILI-
39 GENCE THE CLAIMANT WAS UNABLE TO OBTAIN JURISDICTION OVER SUCH PERSON IN
40 SAID ACTION. AS USED IN THIS SECTION, THE TERM "NON-ECONOMIC LOSS"
41 INCLUDES, BUT IS NOT LIMITED TO, PAIN AND SUFFERING, MENTAL ANGUISH,

52 NO PERSON WHO GRATUITOUSLY RENDERS ASSISTANCE IN CONTAINING OR REMOVING

15 BY THIS PARAGRAPH TO PAY PROMPTLY FOR CLEANUP AND DECONTAMINATION COSTS

26 AND IN LIGHT OF ALL RELEVANT FACTS AND CIRCUMSTANCES; AND

27 (B) TOOK PRECAUTIONS AGAINST THE ACTS OR OMISSIONS OF ANY SUCH THIRD
28 PARTY AND THE CONSEQUENCES OF THOSE ACTS OR OMISSIONS. THESE DEFENSES
29 SHALL NOT APPLY TO A PERSON RESPONSIBLE WHO REFUSES OR FAILS TO (I)
30 REPORT THE CONTAMINATION, OR (II) PROVIDE ALL REASONABLE COOPERATION AND

39 (C) NOTHING SET FORTH IN THIS SUBDIVISION SHALL BE CONSTRUED TO HOLD A
40 LENDER LIABLE TO THE STATE AS A PERSON RESPONSIBLE FOR THE CONTAMINATION
41 CAUSED BY NATURAL GAS PRODUCTION AT A SITE IN THE EVENT: (I) SUCH LEND-
42 ER, WITHOUT PARTICIPATING IN THE MANAGEMENT OF SUCH SITE, HOLDS INDICIA
43 OF OWNERSHIP PRIMARILY TO PROTECT THE LENDER'S SECURITY INTEREST IN THE
44 SITE, OR (II) SUCH LENDER DID NOT PARTICIPATE IN THE MANAGEMENT OF SUCH

46 (1) FORECLOSES ON SUCH SITE; AND

47 (2) AFTER FORECLOSURE, SELLS, RE-LEASES (IN THE CASE OF A LEASE
48 FINANCE TRANSACTION), OR LIQUIDATES SUCH SITE, MAINTAINS BUSINESS ACTIV-
49 ITIES, WINDS UP OPERATIONS, OR TAKES ANY OTHER MEASURE TO PRESERVE,
50 PROTECT OR PREPARE SUCH SITE FOR SALE OR DISPOSITION; PROVIDED HOWEVER,
51 THAT SUCH LENDER SHALL TAKE ACTIONS TO SELL, RE-LEASE (IN THE CASE OF A
52 LEASE FINANCE TRANSACTION), OR OTHERWISE DIVEST ITSELF OF SUCH SITE AT
53 THE EARLIEST PRACTICABLE, COMMERCIALY REASONABLE TIME, ON COMMERCIALY
54 REASONABLE TERMS, TAKING INTO ACCOUNT MARKET CONDITIONS AND LEGAL AND
55 REGULATORY REQUIREMENTS.

1 (D) THIS EXEMPTION SHALL NOT APPLY TO ANY LENDER THAT HAS CAUSED OR
2 CONTRIBUTED TO THE CONTAMINATION CAUSED BY NATURAL GAS PRODUCTION FROM
3 OR AT THE SITE.

4 THE TERMS "PARTICIPATING IN MANAGEMENT," "FORECLOSURE," "LENDER" AND

8 5. ANY CLAIM BY ANY INJURED PERSON FOR THE COSTS OF CLEANUP AND DECON-
9 TAMINATION AND DIRECT AND INDIRECT DAMAGES BASED ON THE STRICT LIABILITY
10 IMPOSED BY THIS SECTION MAY BE BROUGHT DIRECTLY AGAINST THE PERSON WHO
11 HAS CAUSED CONTAMINATION, PROVIDED, HOWEVER, THAT DAMAGES RECOVERABLE BY
12 ANY INJURED PERSON IN SUCH A DIRECT CLAIM BASED ON THE STRICT LIABILITY
13 IMPOSED BY THIS SECTION SHALL BE LIMITED TO THE DAMAGES AUTHORIZED BY
14 THIS SECTION.

15 S 23-2916. ENVIRONMENTAL LIEN.

16 1. THE FUND SHALL HAVE A LIEN FOR THE COSTS INCURRED BY THE FUND FOR
17 THE CLEANUP AND DECONTAMINATION OF CONTAMINATION AND FOR THE PAYMENT OF
18 CLAIMS FOR DIRECT AND INDIRECT DAMAGES AS A RESULT OF CONTAMINATION UPON
19 REAL PROPERTY LOCATED WITHIN THE STATE:

20 (A) OWNED BY A PERSON LIABLE TO THE FUND FOR SUCH COSTS UNDER SECTION
21 23-2915 OF THIS PART AT THE TIME A NOTICE OF ENVIRONMENTAL LIEN IS
22 FILED; AND

23 (B) UPON WHICH THE CONTAMINATION OCCURRED.

24 2. AN ENVIRONMENTAL LIEN SHALL ATTACH WHEN:

25 (A) CLEANUP AND DECONTAMINATION COSTS AND DAMAGE COSTS ARE INCURRED BY
26 THE FUND;

27 (B) THE PERSON REFERRED TO IN SUBDIVISION ONE OF THIS SECTION FAILS TO
28 PAY SUCH COSTS WITHIN NINETY DAYS AFTER A WRITTEN DEMAND THEREFOR BY THE
29 ADMINISTRATOR IS MAILED BY CERTIFIED OR REGISTERED MAIL, RETURN RECEIPT
30 REQUESTED; AND

31 (C) A NOTICE OF ENVIRONMENTAL LIEN IS FILED AS PROVIDED IN SECTION
32 23-2918 OF THIS PART; PROVIDED, HOWEVER, THAT A COPY OF THE NOTICE OF
33 ENVIRONMENTAL LIEN IS SERVED UPON THE OWNER OF THE REAL PROPERTY SUBJECT
34 TO THE ENVIRONMENTAL LIEN WITHIN THIRTY DAYS OF SUCH FILING IN ACCORD-
35 ANCE WITH THE PROVISIONS OF SECTION ELEVEN OF THE LIEN LAW.

36 3. AN ENVIRONMENTAL LIEN SHALL CONTINUE AGAINST THE REAL PROPERTY
37 UNTIL:

38 (A) THE CLAIM OR JUDGMENT AGAINST THE PERSON REFERRED TO IN SUBDIVI-
39 SION ONE OF THIS SECTION FOR CLEANUP AND DECONTAMINATION COSTS AND
40 DAMAGE COSTS IS SATISFIED OR BECOMES UNENFORCEABLE;

41 (B) THE LIEN IS RELEASED BY THE ADMINISTRATOR PURSUANT TO THIS SUBDI-
42 VISION;

43 (C) THE LIEN IS DISCHARGED BY PAYMENT OF MONEYS INTO COURT; OR

44 (D) THE LIEN IS OTHERWISE VACATED BY COURT ORDER.

45 UPON THE OCCURRENCE OF ANY OF THE FOREGOING, EXCEPT WHERE THE LIEN IS
46 VACATED BY COURT ORDER, THE ADMINISTRATOR SHALL EXECUTE THE RELEASE OF
47 AN ENVIRONMENTAL LIEN AND FILE THE RELEASE AS PROVIDED IN SECTION
48 23-2918 OF THIS PART. THE ADMINISTRATOR MAY RELEASE AN ENVIRONMENTAL
49 LIEN WHERE:

50 (I) A LEGALLY ENFORCEABLE AGREEMENT SATISFACTORY TO THE ADMINISTRATOR
51 HAS BEEN EXECUTED RELATING TO CLEANUP AND DECONTAMINATION COSTS AND
52 DAMAGE COSTS OR REIMBURSING THE FUND FOR CLEANUP AND DECONTAMINATION
53 COSTS AND DAMAGE COSTS; OR

54 (II) THE ATTACHMENT OR ENFORCEMENT OF THE ENVIRONMENTAL LIEN IS DETER-
55 MINED BY THE ADMINISTRATOR NOT TO BE IN THE PUBLIC INTEREST.

1 4. AN ENVIRONMENTAL LIEN IS SUBJECT TO THE RIGHTS OF ANY OTHER PERSON,
2 INCLUDING AN OWNER, PURCHASER, HOLDER OF A MORTGAGE OR SECURITY INTER-
3 EST, OR JUDGMENT LIEN CREDITOR, WHOSE INTEREST IS PERFECTED BEFORE A
4 LIEN NOTICE HAS BEEN FILED AS PROVIDED IN SECTION 23-2918 OF THIS PART.
5 S 23-2917. ENVIRONMENTAL LIEN NOTICE; CONTENTS.

6 A NOTICE OF ENVIRONMENTAL LIEN MUST STATE:

7 1. THAT THE LIENOR IS THE NEW YORK NATURAL GAS PRODUCTION CONTAM-
8 INATION DAMAGE RECOVERY AND REMEDIATION FUND;

9 2. THE NAME OF THE RECORD OWNER OF THE REAL PROPERTY ON WHICH THE
10 ENVIRONMENTAL LIEN HAS ATTACHED;

11 3. THE REAL PROPERTY SUBJECT TO THE LIEN, WITH A DESCRIPTION THEREOF
12 SUFFICIENT FOR IDENTIFICATION;

13 4. THAT THE REAL PROPERTY DESCRIBED IN THE NOTICE IS THE PROPERTY UPON
14 WHICH CONTAMINATION OCCURRED AND THAT CLEANUP AND DECONTAMINATION COSTS
15 AND DAMAGE COSTS HAVE BEEN INCURRED BY THE LIENOR AS A RESULT OF SUCH
16 CONTAMINATION;

17 5. THAT THE OWNER IS POTENTIALLY LIABLE FOR CLEANUP AND DECONTAM-
18 INATION COSTS AND DAMAGE COSTS PURSUANT TO SECTION 23-2915 OF THIS PART;
19 AND

20 6. THAT AN ENVIRONMENTAL LIEN HAS ATTACHED TO THE DESCRIBED REAL PROP-
21 ERTY.

22 S 23-2918. FILING OF NOTICE OF ENVIRONMENTAL LIEN; FILING OF RELEASE.

23 1. A NOTICE OF ENVIRONMENTAL LIEN SHALL BE FILED WITHIN SIX YEARS FROM
24 THE TIME A DISBURSEMENT IS MADE BY THE FUND FOR CLEANUP AND DECONTAM-
25 INATION COSTS AND DAMAGE COSTS INCURRED BY THE FUND IN THE CLERK'S
26 OFFICE OF THE COUNTY WHERE THE PROPERTY IS SITUATED. IF SUCH PROPERTY IS

38 VACATED OR RELEASED, AS PRESCRIBED IN ARTICLE THREE OF THE LIEN LAW;
39 PROVIDED, HOWEVER, THAT NOTHING IN THIS ARTICLE OR IN ARTICLE THREE OF
40 THE LIEN LAW SHALL AFFECT THE RIGHT OF THE FUND TO BRING AN ACTION TO

44 AMOUNTS RECEIVED BY THE ADMINISTRATOR TO SATISFY ALL OR PART OF AN
45 ENVIRONMENTAL LIEN SHALL BE DEPOSITED IN THE STATE TREASURY AND CREDITED
46 TO THE NATURAL GAS PRODUCTION DAMAGE RECOVERY AND REMEDIATION FUND.

48 CLAIMS SHALL BE FILED WITH THE ADMINISTRATOR NOT LATER THAN THREE

5 THE ADMINISTRATOR SHALL ATTEMPT TO PROMOTE AND ARRANGE A SETTLEMENT
6 BETWEEN THE CLAIMANT AND THE PERSON RESPONSIBLE FOR THE CONTAMINATION.
7 IF THE SOURCE OF THE CONTAMINATION CAN BE DETERMINED AND LIABILITY IS
8 CONCEDED, THE CLAIMANT AND THE ALLEGED PERSON RESPONSIBLE FOR THE
9 CONTAMINATION MAY AGREE TO A SETTLEMENT WHICH SHALL BE FINAL AND BINDING
10 UPON THE PARTIES AND WHICH WILL WAIVE ALL RECOURSE AGAINST THE FUND.

11 S 23-2923. SETTLEMENTS WHEN SOURCE OF CONTAMINATION IS UNKNOWN.

12 IF THE SOURCE OF THE CONTAMINATION IS UNKNOWN OR CANNOT BE DETERMINED,
13 THE CLAIMANT AND THE ADMINISTRATOR SHALL ATTEMPT TO ARRANGE A SETTLEMENT
14 OF ANY CLAIM AGAINST THE FUND. THE ADMINISTRATOR IS AUTHORIZED TO ENTER
15 AND CERTIFY PAYMENT OF SUCH SETTLEMENT SUBJECT TO SUCH PROOF AND PROCE-
16 DURES CONTAINED IN REGULATIONS PROMULGATED BY THE ADMINISTRATOR.

17 S 23-2924. HEARINGS FOR PERSONS ON CLAIMS FILED WITH THE ADMINISTRATOR.

18 1. THE ADMINISTRATOR SHALL GRANT A HEARING WHEN PERSONS ALLEGED TO BE
19 RESPONSIBLE FOR THE CONTAMINATION CONTEST THE VALIDITY OR AMOUNT OF
20 DAMAGE CLAIMS OR CLAIMS FOR CLEANUP AND DECONTAMINATION COSTS PRESENTED
21 BY INJURED PERSONS TO THE FUND FOR PAYMENT OR WHEN INJURED PERSONS WHO
22 HAVE FILED A CLAIM AGAINST THE FUND CONTEST THE VALIDITY OR AMOUNT OF
23 THE SETTLEMENT PROPOSED BY THE ADMINISTRATOR.

24 2. ONE HEARING MAY BE GRANTED TO HEAR AND DETERMINE ALL CLAIMS ARISING
25 FROM OR RELATED TO A COMMON CONTAMINATION.

26 3. THE BURDEN OF PROOF WITH RESPECT TO THE VALIDITY OR AMOUNT OF
27 DAMAGE CLAIMS OR CLAIMS FOR CLEANUP AND DECONTAMINATION COSTS SHALL BE
28 UPON THE PERSONS CONTESTING SUCH CLAIMS OR THE CLAIMANTS CONTESTING THE
29 SETTLEMENT PROPOSED BY THE ADMINISTRATOR.

30 4. AT LEAST TWENTY DAYS NOTICE OF SUCH HEARING SHALL BE GIVEN BY THE
31 ADMINISTRATOR TO THE CLAIMANTS AND, IF KNOWN, THE ALLEGED PERSON RESPON-
32 SIBLE FOR THE CONTAMINATION.

33 5. UPON THE RETURN DAY OF SUCH NOTICE THE PERSON SO NOTIFIED SHALL
34 FILE WITH THE ADMINISTRATOR A STATEMENT SETTING FORTH THE POSITION OF
35 THE PERSON SO NOTIFIED. PERTINENT AND RELEVANT TESTIMONY OF WITNESSES
36 SHALL BE RECEIVED IN SUPPORT OF OR OPPOSITION TO SUCH STATEMENT. THE
37 CLAIMANTS OR ALLEGED PERSONS RESPONSIBLE FOR THE CONTAMINATION MAY
38 APPEAR IN PERSON OR BY ATTORNEY, PRESENT WITNESSES, SUBMIT EVIDENCE AND
39 BE GIVEN FULL OPPORTUNITY TO BE HEARD.

40 6. THE ADMINISTRATOR SHALL HAVE THE POWER TO ORDER TESTIMONY UNDER
41 OATH AND MAY SUBPOENA ATTENDANCE AND TESTIMONY OF WITNESSES AND THE
42 PRODUCTION OF SUCH DOCUMENTARY MATERIALS PERTINENT TO THE ISSUES
43 PRESENTED AT THE HEARING. EACH PERSON APPEARING AT THE HEARING MAY BE
44 REPRESENTED BY COUNSEL.

45 7. WITHIN SIXTY CALENDAR DAYS FROM THE CLOSE OF SUCH HEARING AND AFTER
46 DUE CONSIDERATION OF THE WRITTEN AND ORAL STATEMENTS AND TESTIMONY AND
47 ARGUMENTS FILED PURSUANT TO THIS SECTION, OR ON DEFAULT IN APPEARANCE ON
48 SAID RETURN DAY, THE ADMINISTRATOR SHALL MAKE HIS FINAL DETERMINATION ON
49 THE VALIDITY OR AMOUNT OF THE DAMAGE CLAIMS OR CLAIMS FOR CLEANUP AND
50 DECONTAMINATION COSTS FILED BY THE INJURED PERSONS. THE ADMINISTRATOR
51 SHALL NOTIFY THE CLAIMANT AND, IF KNOWN, THE ALLEGED PERSON RESPONSIBLE

53 8. DETERMINATIONS MADE BY THE ADMINISTRATOR AFTER SUCH HEARING SHALL

55 PURSUANT TO THE PROVISIONS OF ARTICLE SEVENTY-EIGHT OF THE CIVIL PRAC-

22 THE PERSON RESPONSIBLE FOR THE CONTAMINATION OR OTHER RESPONSIBLE PARTY
23 AND ANY PENALTY ARISING UNDER THIS TITLE.

24 S 23-2926. AWARDS EXCEEDING CURRENT BALANCE.

25 IN THE EVENT THAT THE TOTAL AWARDS FOR A SPECIFIC OCCURRENCE EXCEED
26 THE CURRENT BALANCE OF THE FUND, THE IMMEDIATE AWARD SHALL BE PAID ON A
27 PRORATED BASIS, AND ALL CLAIMANTS PAID ON A PRORATED BASIS SHALL BE PAID

34 ANY CLAIMS FOR COSTS OF CLEANUP AND DECONTAMINATION, CIVIL PENALTIES
35 OR DAMAGES BY THE STATE AND ANY CLAIM FOR DAMAGES BY ANY INJURED PERSON,
36 MAY BE BROUGHT DIRECTLY AGAINST THE BOND, THE INSURER, OR ANY OTHER
37 PERSON PROVIDING EVIDENCE OF FINANCIAL RESPONSIBILITY.

38 S 23-2928. APPLICATION OF TITLE.

39 FOR PURPOSES OF CLEANUP AND DECONTAMINATION OF ANY PUBLIC OR PRIVATE
40 GROUND WATER SUPPLY SYSTEM CONTAMINATED BY ANY CONTAMINATION OCCURRING
41 EITHER BEFORE OR AFTER THE EFFECTIVE DATE OF THIS TITLE, ALL RELEVANT
42 PROVISIONS OF THIS TITLE SHALL APPLY.

21 OF THE PEOPLE OF THIS STATE, SHALL BE LIBERALLY CONSTRUED TO AFFECT ITS
22 PURPOSES.

23 S 23-2935. REPORTS.

24 THE COMMISSIONER AND THE ADMINISTRATOR SHALL MAKE AN ANNUAL REPORT TO
25 THE LEGISLATURE AND THE GOVERNOR WHICH SHALL DESCRIBE THE QUANTITY AND
26 DEGREE OF CONTAMINATION CAUSED BY NATURAL GAS PRODUCTION, THE COSTS AND
27 DAMAGES PAID BY AND RECOVERED FOR THE FUND, AND THE ECONOMIC AND ENVI-
28 RONMENTAL IMPACT ON THE STATE AS A RESULT OF THE ADMINISTRATION OF THIS
29 TITLE.

30 S 23-2936. EFFECT OF FEDERAL LEGISLATION.

31 IF THE UNITED STATES CONGRESS ENACTS LEGISLATION PROVIDING COMPEN-
32 SATION IN THE EVENT OF CONTAMINATION CAUSED BY NATURAL GAS PRODUCTION,
33 THE COMMISSIONER SHALL DETERMINE TO WHAT DEGREE SUCH LEGISLATION
34 PROVIDES THE NEEDED PROTECTION FOR OUR CITIZENS, BUSINESSES AND ENVIRON-
35 MENT AND SHALL MAKE THE APPROPRIATE RECOMMENDATIONS TO THE LEGISLATURE
36 FOR AMENDMENTS TO THIS TITLE.

37 S 2. Section 23-1903 of the environmental conservation law is amended
38 by adding a new subdivision 3 to read as follows:

39 3. THE COMMISSIONER IS HEREBY AUTHORIZED TO ESTABLISH A SURCHARGE
40 PURSUANT TO REGULATION ON THE PERMIT FEES ON GAS WELLS, AUTHORIZED BY
41 SUBDIVISION ONE OF THIS SECTION, TO BE CREDITED TO THE NEW YORK NATURAL
42 GAS PRODUCTION CONTAMINATION DAMAGE RECOVERY AND REMEDIATION FUND ESTAB-
43 LISHED IN SECTION NINETY-TWO-T OF THE STATE FINANCE LAW. THE SURCHARGE
44 SHALL BE ESTABLISHED TO PROVIDE SUFFICIENT FUNDS TO MEET THE OBLIGATIONS
45 OF THE FUND.

46 S 3. The state finance law is amended by adding a new section 92-t to
47 read as follows:

48 S 92-T. NEW YORK NATURAL GAS PRODUCTION CONTAMINATION DAMAGE RECOVERY
49 AND REMEDIATION FUND. 1. THERE IS HEREBY ESTABLISHED IN THE JOINT
50 CUSTODY OF THE STATE COMPTROLLER AND THE COMMISSIONER OF TAXATION AND
51 FINANCE A SPECIAL FUND TO BE KNOWN AS THE "THE NEW YORK NATURAL GAS
52 PRODUCTION CONTAMINATION DAMAGE RECOVERY AND REMEDIATION FUND".

53 2. THE FUND SHALL CONSIST OF REVENUES COLLECTED BY THE DEPARTMENT OF
54 ENVIRONMENTAL CONSERVATION PURSUANT TO SUBDIVISION 3 OF SECTION 23-1903,
55 SECTION 23-2915, SECTION 23-2920, AND SECTION 23-2932 OF THE ENVIRON-

1 MENTAL CONSERVATION LAW AND ALL OTHER MONEYS APPROPRIATED, CREDITED OR
2 TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT TO LAW.

3 3. MONEYS IN THE FUND SHALL BE KEPT SEPARATE AND NOT COMMINGLED WITH
4 ANY OTHER MONEYS IN THE CUSTODY OF THE COMMISSIONER OF TAXATION AND
5 FINANCE AND THE STATE COMPTROLLER.

6 4. MONEYS OF THE FUND, FOLLOWING APPROPRIATION BY THE LEGISLATURE, MAY
7 BE EXPENDED FOR THE FOLLOWING PURPOSES:

8 (A) DAMAGES AS DEFINED IN SECTION 23-2915 OF THE ENVIRONMENTAL CONSER-
9 VATION LAW;

10 (B) RESEARCH ON THE PREVENTION AND THE EFFECTS OF CONTAMINATION FROM
11 NATURAL GAS PRODUCTION ON THE ENVIRONMENT AND ON THE DEVELOPMENT OF
12 IMPROVED CLEANUP AND DECONTAMINATION OPERATIONS; PROVIDED, HOWEVER, THAT
13 THE COST OF SUCH RESEARCH SHALL NOT EXCEED THE AMOUNT OF INTEREST WHICH
14 IS CREDITED TO THIS FUND;

15 (C) GENERAL ADMINISTRATION OF THE FUND, EQUIPMENT AND PERSONNEL COSTS
16 OF THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION, THE STATE COMPTROLLER
17 AND ANY OTHER STATE AGENCY RELATED TO THE ENFORCEMENT OF TITLE
18 TWENTY-NINE OF ARTICLE TWENTY-THREE OF THE ENVIRONMENTAL CONSERVATION
19 LAW;

20 (D) RESEARCH AND DEMONSTRATION PROGRAMS CONCERNING THE CAUSES AND
21 ABATEMENT OF CONTAMINATION FROM NATURAL GAS PRODUCTION; PROVIDED, HOWEV-
22 ER, THAT THE COST OF SUCH RESEARCH AND DEMONSTRATION PROGRAMS SHALL NOT
23 EXCEED THE AMOUNT OF INTEREST WHICH IS CREDITED TO THIS FUND.

24 5. THE COMPTROLLER MAY INVEST AND REINVEST ANY MONEYS IN SUCH FUND IN
25 OBLIGATIONS IN WHICH THE COMPTROLLER IS AUTHORIZED TO INVEST PURSUANT TO
26 THE PROVISIONS OF SECTION NINETY-EIGHT-A OF THE STATE FINANCE LAW. ANY
27 INCOME OR INTEREST DERIVED FROM SUCH INVESTMENT SHALL BE INCLUDED IN THE
28 FUND.

29 6. MONEYS, SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF
30 THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMPTROLLER
31 AND THE COMMISSIONER OF ENVIRONMENTAL CONSERVATION.

32 7. THE ADMINISTRATOR OF THE FUND, AS ESTABLISHED IN SECTION 23-2914 OF
33 THE ENVIRONMENTAL CONSERVATION LAW, SHALL RECOVER TO THE FUND MONEYS
34 DISBURSED FOR THE FOLLOWING PURPOSES:

35 A. COSTS INCURRED BY THE FUND IN THE CLEANUP AND DECONTAMINATION OF
36 CONTAMINATION WHEN THE PERSON RESPONSIBLE FOR CAUSING A CONTAMINATION
37 HAS FAILED TO PROMPTLY CLEAN UP AND REMOVE THE CONTAMINATION TO THE
38 SATISFACTION OF THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION;

39 B. COSTS INCURRED BY THE FUND IN THE PAYMENT OF CLAIMS FOR DIRECT AND
40 INDIRECT DAMAGES, AS DEFINED IN SECTION 23-2915 OF THE ENVIRONMENTAL
41 CONSERVATION LAW; AND

42 C. ALL PENALTIES ASSESSED PURSUANT TO TITLE TWENTY-NINE OF ARTICLE
43 TWENTY-THREE OF THE ENVIRONMENTAL CONSERVATION LAW.

44 S 4. Severability. If any clause, sentence, paragraph, section or part
45 of this act shall be adjudged by any court of competent jurisdiction to
46 be invalid, the judgment shall not affect, impair, or invalidate the
47 remainder thereof, but shall be confined in its operation to the clause,
48 sentence, paragraph, section or part thereof directly involved in the
49 controversy in which the judgment shall have been rendered.

50 S 5. This act shall take effect on the one hundred twentieth day after
51 it shall have become a law; provided, however, that effective immediate-
52 ly, the addition, amendment and/or repeal of any rule or regulation
53 necessary for the implementation of this act on its effective date is
54 authorized to be made and completed on or before such date.
