AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for hunting in Cayuga county; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907

49 paragraph pursuant to chapters 321 and 326 of the laws of 2011, as
50 amended, when upon such date the provisions of section two of this act
51 shall take effect;

53 section 11-0907 of the environmental conservation law made by section

1 two of this act shall be subject to the expiration and reversion of such
2 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as
3 amended when upon such date the provisions of section three of this act
4 shall take effect; and
5 c. the amendments to item (i) of paragraph a of subdivision 2 of
6 section 11-0907 of the environmental conservation law made by section
7 three of this act shall be subject to the expiration and reversion of
8 such paragraph pursuant to section 17 of chapter 483 of the laws of
9 2010, when upon such date the provisions of section four of this act
10 shall take effect.
