AN ACT creating the Grinnell public library district; and to amend chapter 672 of the laws of 1993 amending the public authorities law relating to the construction and financing for certain public libraries, in relation to providing for financing through the dormitory authority

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1.     Creation of library district. Notwithstanding the  
2 provisions of any general, special, or local law to the contrary, there  
3 is hereby created and established in the towns of Wappinger and Pough-  
4 keepsie, county of Dutchess, a public library district which shall  
5 consist of the entire village of Wappingers Falls, including both the  
6 portion located in the town of Wappinger and the portion located in the  
7 town of Poughkeepsie, hereinafter referred to as the village, and also  
8 including the town of Wappinger, hereinafter referred to as the town,  
9 except for those parcels in the town that are located in the Beacon City  
10 School District, and shall be known as the Grinnell public library  
11 district, hereinafter referred to as the district. The district will  
12 operate a public library to be known as the Grinnell public library.

13     S 2. Election. 1. The district herein described shall not come into  
14 existence unless and until it is approved with the initial budget in  
15 support thereof proposed by the board of trustees of the existing Grinnell library, and nine trustees are elected by a vote of the majority of  
16 the qualified voters voting in an election held, not later September 30,  
17 2013, pursuant to the following provisions:

19     Upon receipt of a petition signed by not less than twenty-five voters  
20 qualified to vote at a general election in the town, the board of trustees of the existing Grinnell library shall conduct an election at which  
21 the issues shall be:

23     (a) whether the public library district herein described with the  
24 initial budget in support thereof proposed by the board of trustees of  
25 the existing Grinnell library shall be created or not; and

26     (b) the election of nine trustees as provided by this act.

1 The board of trustees of the existing Grinnell library shall give  
2 notice of such election by publication of notice at least twice in one  
3 or more newspapers having a general circulation in the district to be  
4 served. The first publication of such notice shall be not less than  
5 thirteen days and not more than twenty days prior to the date of such  
6 election. In addition, the board of trustees of the existing Grinnell  
7 library shall cause copies of such notice to be posted conspicuously in  
8 three public places in the district at least thirteen days prior to the  
9 date of such election. Such notice shall specify the date and time when  
10 and the place where such election will be held and the issues to be  
11 decided at such election. The board of trustees of the existing Grinnell  
12 library shall designate a resident qualified voter of such district to  
13 act as chairperson of any election of such district and shall designate  
14 not less than two nor more than four resident qualified voters to act as  
15 election inspectors and ballot clerks at such election. No trustee of  
16 the existing Grinnell library shall serve as chairperson or as an  
17 election inspector or ballot clerk. The board of trustees of the exist-  
18 ing Grinnell library may adopt a resolution providing that such chair-  
19 person, election inspectors and ballot clerks shall be paid reasonable  
20 compensation for their respective services at such election. Every  
21 voter who is a resident of the district and otherwise qualified to vote  
22 at a general election in the town shall be qualified to vote at said  
23 election. The board of trustees of the existing Grinnell library may, to  
24 the extent authorized by law, authorize the use of absentee ballots for  
25 the election. After the polls have closed at such election, the election  
26 inspectors and the ballot clerks shall immediately canvass publicly the  
27 ballots cast and the chairperson of the election shall publicly announce  
28 the result. Within seventy-two hours thereafter, the chairperson,  
29 election inspectors and ballot clerks shall execute and file a certifi-  
30 cate of the result of the canvass with the board of trustees of the  
31 existing Grinnell library and the town and village clerks. If a majori-  
32 ty of the voters approve the formation of the district with the initial  
33 budget in support thereof proposed by the board of trustees of the  
34 existing Grinnell library, then the district shall come into existence  
35 on the terms and conditions set forth in this act.

36 2. In the event that the district is created, there shall be an annual  
37 election conducted by the board of trustees of the Grinnell public  
38 library district in accordance with the provisions of subdivision one of  
39 this section at a time to be set by the board of trustees of the  
40 district, at which election vacancies on the board of trustees shall be  
41 filled and at which any proposed budget which the board shall determine  
42 to submit to the voters pursuant to section four of this act shall be  
43 submitted to the voters.

44 3. Candidates for the office of member of the board of trustees of the  
45 Grinnell public library district shall be nominated by petition. No  
46 vacancy to be filled on the board of trustees shall be considered a  
47 separate, specific office. A separate petition shall be required to  
48 nominate each candidate for a vacancy on the board. Each petition shall  
49 be directed to the secretary of the board of trustees of the existing  
50 Grinnell library, shall be signed by at least twenty-five qualified  
51 voters of the district, shall state the residence of each signer, and  
52 shall state the name and residence of the candidate. In the event that  
53 any such nominees shall withdraw their candidacy prior to the election,  
54 such person shall not be considered a candidate unless a new petition  
55 nominating such person in the same manner and within the same time limi-  
56 tation applicable to other candidates is filed with the secretary of the

board of trustees of the existing Grinnell library. Each petition shall be filed with the secretary of the board of trustees of the existing Grinnell library, between the hours of 9:00 a.m. and 5:00 p.m., not later than the thirtieth day before the election at which the candidates nominated are to be elected. In the event that the new district is created, petitions nominating candidates for the board of trustees for all future elections shall be filed with the secretary of the Grinnell public library district.

S 3. Organization and structure. The Grinnell public library district shall be managed, operated, and controlled by a board of trustees consisting of nine members. The trustees shall take office at the first regular meeting of the board of trustees following their election. At the first regular meeting of the board of trustees of the district, the trustees shall determine when the terms of office of each member shall expire as follows: the trustees receiving the first, second, and third highest number of votes shall each serve for three years, the trustees receiving the fourth, fifth, and sixth highest number of votes shall each serve for two years, and the trustees receiving the seventh, eighth, and ninth highest number of votes shall each serve for one year. As vacancies occur due to expiration of terms of office, trustees shall be elected by the voters of the district at the election provided for by this act to serve three year terms, such terms to commence at the first regular meeting of the board of trustees of the district next following their election. All other vacancies caused by resignation, removal, death, or inability to serve shall be filled by appointment by the board of trustees of the district until the next election, at which time the vacancy shall be filled by election for the remaining portion of the term. At any election where one or more persons are to be elected for the unexpired portion of a term or terms, the candidate receiving the largest number of votes shall be entitled to the full three year term and the candidates receiving the next highest number of votes shall be entitled, in decreasing order of the respective numbers of votes, to the vacancy or vacancies, in decreasing order of the length of the unexpired portion or portions of a term or terms. Only qualified voters of the district shall be eligible for election to the board of trustees. The board of trustees at its first meeting after each annual election shall elect or appoint a president and vice-president, who shall be members of the board, and a secretary, treasurer, and such other officers as they deem necessary. If the board so determines, the offices of secretary and treasurer may be held by individuals who are not members of the board of trustees and, in that event, such officers may, if the board so determines, receive compensation as fixed by resolution of the board.

S 4. Finances. 1. The initial budget to support the district shall be determined by a vote of the voters of the district in the initial election as hereinafter provided for. All future budgets that increase or decrease to the district's proposed tax levy as compared to the tax levy in the preceding fiscal year's budget shall be submitted to the residents voting at the annual election of trustees pursuant to section two of this act. Funds voted for library purposes at the initial election and at all future elections shall be considered an annual appropriation therefor and shall be levied and collected yearly by the town for the district in the same manner and at the same time as other taxes in the town.

2. The board of trustees of the district shall annually file with the clerks of the town and village on or before the first day of November an estimate of the proposed budget including costs of library services to

1 be raised by levy for the library district in the fiscal year beginning  
2 on the first day of January of the next year. The town shall not make  
3 any change in the estimate of revenues or expenditures submitted by the  
4 board of the district in preparation of its preliminary budget.

5 3. The town board of the town shall levy a tax against all of the real  
6 property lying within the Grinnell public library district except the  
7 real property lying within the village, and the village board of the  
8 village shall levy a tax against the remainder of the real property  
9 lying within the Grinnell public library district, which together shall  
10 equal the amount to be raised by tax as approved by the voters of the  
11 Grinnell public library district. Such tax shall be levied by the town  
12 and village in proportion to the total combined full value of the real  
13 property lying within the town, excluding the parcels lying within the  
14 village and excluding the parcels lying within the Beacon City School  
15 District, and of the real property lying within the village. The town  
16 board and village board shall pay the full amount of the tax levy  
17 approved by the voters over to the treasurer of the Grinnell public  
18 library district pursuant to the schedule set forth in this section. The  
19 town board and village board shall each annually pay over to the treas-  
20 urer of the Grinnell public library district on or before the thirtieth  
21 day after their respective tax collection period ends, the full amount  
22 of the levy due from the parcels subject to their respective levy. If  
23 necessary to meet this schedule, the town board and village board may  
24 each issue tax anticipation notes pursuant to article II of the local  
25 finance law to obtain the necessary moneys therefor.

26 4. The town board of the town shall have the power to authorize, sell,  
27 and issue bonds, notes, and other evidences of indebtedness pursuant to  
28 the local finance law in order to permit the district to provide facili-  
29 ties or improved facilities for library purposes. Upon written request  
30 from the board of trustees of the Grinnell public library district,  
31 after approval by the qualified voters of such district, the town board  
32 shall authorize, sell, and issue such bonds, notes, or other evidences  
33 of indebtedness as are necessary to accomplish the improvements speci-  
34 fied in the notice. The proceeds of such bonds, notes, or other  
35 evidences of indebtedness shall be paid to the treasurer of the Grinnell  
36 public library district and maintained in a segregated account in  
37 accordance with section 165.00 of the local finance law and expended by  
38 the treasurer only on specific authorization by the board of trustees.

39 5. The board of trustees of the Grinnell public library district may  
40 accept on behalf of the district any absolute gift, devise, or bequest  
41 of real or personal property and such conditional gifts, devises, or  
42 bequests as it shall by resolution approve.

43 6. The treasurer of the Grinnell public library district shall be  
44 custodian of all funds of the district, including gifts and trust funds  
45 paid over to the trustees. The board of trustees may authorize the  
46 investment of funds in the custody of the treasurer in the same manner  
47 in which town funds may be invested. Proceeds of obligations received  
48 from the town may be invested in accordance with section 165.00 of the  
49 local finance law. The town and the village shall promptly pay over to  
50 the district all monies which belong to or are raised for the district.  
51 No monies shall be disbursed by the treasurer of the district except  
52 after audit by the board of trustees. The board of trustees of the Grin-  
53 nell public library district shall audit all claims and shall order the  
54 payment thereof, except as otherwise provided by this section. No such  
55 claims shall be audited or ordered paid by the trustees unless an item-  
56 ized voucher therefor shall be presented to the board of trustees for

1 audit and allowance. The provisions of this section shall not be appli-  
2 cable to payment of utility costs, claims of fixed salaries, and amounts  
3 which the district may be required to pay on account of retirement  
4 contributions for past or current services to officers and employees of  
5 the district. The treasurer shall keep such records in such manner as  
6 the board of trustees may require.

7 S 5. Charter, commencement of operations, and transfer of property and  
8 employees. The initially elected trustees of the Grinnell public library  
9 district shall, within ninety days from the date of approval of the  
10 district by the voters of the district, apply to the board of regents  
11 for a charter as a public library. Upon the granting of such a charter  
12 by the board of regents, title to all liabilities and assets, including  
13 all property, both real and personal, and both tangible and intangible,  
14 all trust and other funds, and all other obligations, now held by the  
15 existing Grinnell library shall be transferred to, vested in, and be  
16 acquired by the district established by this act. The above provisions  
17 for transfer to, vesting and acquisition of real and personal property,  
18 both tangible and intangible, and all trust and other funds, are effec-  
19 tuated by operation of law pursuant to the authority of this act, except  
20 that, for purposes of clarity of real property records, deeds of convey-  
21 ance shall be executed and filed for any parcels of real property. Upon  
22 the transfer of all such property, the existing Grinnell library shall  
23 be deemed dissolved. Upon the granting of such charter by the board of  
24 regents, all employees of the existing Grinnell library shall become  
25 employees of the district upon the same terms and conditions of employ-  
26 ment and at the same rate of pay as their previous employment by the  
27 existing Grinnell library.

28 S 6. Ad valorem levy. The several lots and parcels of land within the  
29 area of the district are hereby determined to be benefited by the  
30 library facilities and devices existing as of the effective date of this  
31 act, and the town and the village are hereby authorized to assess, levy,  
32 and collect the necessary expenses of operation, maintenance, and repair  
33 of such facilities and services and such capital improvements, including  
34 debt service on bonds, notes, or other evidences of indebtedness of the  
35 town and village issued for the purpose of the Grinnell public library  
36 district, as may be hereafter authorized pursuant to the provisions of  
37 this act from such lots and parcels of land in the same manner and at  
38 the same time as other town charges.

39 S 7. Education law. Except as otherwise provided by this act, the  
40 provisions of the education law relating to public libraries shall be  
41 applicable to the district established by this act.

42 S 8. The Grinnell public library district is deemed a special district  
43 which is separate and distinct from the town for all purposes, including  
44 but not limited to management, appropriations, and expenditures. Any tax  
45 levy for the district shall not be charged or imputed to the town, and  
46 shall instead be charged or imputed to the district, for purposes of any  
47 general or special laws enacted by the legislature.

48 S 9. Section 5 of chapter 672 of the laws of 1993, amending the public  
49 authorities law relating to the construction and financing of facilities  
50 for certain public libraries, as separately amended by chapter 533 of  
51 the laws of 2011 and chapter 23 of the laws of 2012, is amended to read  
52 as follows:

53 S 5. The following libraries shall be eligible public libraries for  
54 purposes of title 4 of article 8 of the public authorities law:

41 S 10. This act shall take effect immediately; provided that:

42 (a) subdivision 41 of section 5 of chapter 672 of the laws of 1993, as  
43 designated by section nine of this act shall take effect in accordance  
44 with the provisions of section 9 of chapter 23 of the laws of 2012; and

45 (b) subdivision 42 of section 5 of chapter 672 of the laws of 1993, as  
46 added by section nine of this act shall take effect on the same date as  
47 the Grinnell public library district shall come into existence pursuant  
48 to this act; provided that the trustees of the Grinnell public library  
49 district shall notify the legislative bill drafting commission upon the  
50 creation of such district pursuant to this act in order that the commis-  
51 sion may maintain an accurate and timely effective data base of the  
52 official text of the laws of the state of New York in furtherance of  
53 effectuating the provisions of section 44 of the legislative law and  
54 section 70-b of the public officers law.
