AN ACT to amend the transportation corporation law, in relation to the powers of gas and electric corporations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 11 of the transportation corporation law is 2 amended by adding a new subdivision 8 to read as follows:
 - 8. SUBDIVISIONS THREE, THREE-A AND THREE-B OF THIS SECTION SHALL NOT APPLY TO ANY ELECTRIC CORPORATION WHICH:
- 5 (A) SEEKS, THROUGH ITSELF, OR THROUGH ONE OR MORE AFFILIATED INTERESTS
 6 AS DEFINED IN PARAGRAPH (C) OF THIS SUBDIVISION, TO EITHER BUILD A TRAN7 SMISSION LINE OR TO EXPAND AN EXISTING TRANSMISSION LINE WHICH TRANS8 MISSION LINE ORIGINATES AT A LOCATION OUTSIDE OF THE TERRITORIAL LIMITS
 9 OF THE UNITED STATES OF AMERICA AND EXTENDS TO A LOCATION WITHIN THE
 10 STATE OF NEW YORK; OR
- (B) SEEKS, THROUGH ITSELF, OR THROUGH ONE OR MORE AFFILIATED INTERESTS 11 12 DEFINED PARAGRAPH (C) OF THIS SUBDIVISION, TO EITHER BUILD AN INELECTRIC GENERATING FACILITY, OR TO EXPAND AN EXISTING ELECTRIC GENERAT-13 ING FACILITY THAT IS LOCATED OUTSIDE OF THE TERRITORIAL LIMITS 14 OF THE UNITED STATES OF AMERICA TOGETHER WITH BUILDING OR OTHERWISE UTILIZING 15 AN EXISTING ELECTRICAL INTERCONNECTION TO A POINT LOCATED WITHIN 16 17 STATE OF NEW YORK.
- 18 (C) FOR THE PURPOSES OF THIS SUBDIVISION, THE FOLLOWING TERMS SHALL 19 HAVE THE FOLLOWING MEANINGS:
- 20 I. "AFFILIATED INTERESTS" SHALL INCLUDE BUT NOT BE LIMITED TO, ANY 21 PERSON WHICH DIRECTLY, INDIRECTLY, OR CONSTRUCTIVELY:
 - A. CONTROLS ANOTHER PERSON;

- B. IS CONTROLLED BY ANOTHER PERSON; OR
- 24 C. IS, ALONG WITH ANOTHER PERSON, UNDER THE CONTROL OF A COMMON 25 PARENT.

- II. "CONTROL" MEANS POSSESSION OF THE POWER TO DIRECT, OR CAUSE THE 1 2 DIRECTION OF, THE MANAGEMENT AND POLICIES OF ANOTHER PERSON.
- 3 III. "PERSON" MEANS ANY INDIVIDUAL, CORPORATION, PUBLIC BENEFIT CORPO-
- RATION, POLITICAL SUBDIVISION, SOVEREIGN OR TRIBAL NATION, GOVERNMENT AGENCY, MUNICIPALITY, PARTNERSHIP, CO-OPERATIVE ASSOCIATION, TRUST OR 5
- 6 ESTATE.
- 7 S 2. This act shall take effect immediately.
