AN ACT to amend the general obligations law, in relation to the liability of persons involved in equine activities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Legislative intent. The legislature hereby finds that 1 2 horseback riding is both a major recreational sport and a major industry 3 within the state of New York. The legislature further finds: (1) that 4 horseback riding, like many other sports, contains inherent risks 5 including, but not limited to, the risks of personal injury, death or property damage, which may be caused by the propensity of equines to 6 7 behave in ways that are not always controllable by the participant; the 8 unpredictability of an equine's reaction to such things as sounds, 9 sudden movements, and unfamiliar objects, persons or other animals; 10 surface or subsurface conditions; collisions with other equines or objects; and the potential of a participant to act in a negligent 11 manner; (2) that it is appropriate, as well as in the public interest, 12 establish certain duties and obligations of equine sponsors and 13 to 14 equine professionals relative to the safety of the horseback riding that it is also necessary and appropriate that the 15 public; and (3) 16 public become apprised of and understand the risks inherent in the sport of horseback riding so that they may make an informed decision of wheth-17 er or not to participate in horseback riding notwithstanding the risks. 18 19 Therefore, the purpose and intent of this act is to establish guidelines for the conduct of the participants, sponsors and professionals involved 20 21 in the sport of horseback riding; to educate the public as to the inher-22 ent risks in the sport of horseback riding so as to minimize the risk of 23 injury to persons engaged in the sport of horseback riding; to promote safety in the horseback riding industry; and to preserve the financial 24 25 sustainability of the equine sponsors and equine professionals engaged 26 in the horseback riding industry.

27 S 2. The general obligations law is amended by adding a new article 28 18-B to read as follows:

31	(D) RIDING, INSPECTING OR EVALUATING OF AN EQUINE BELONGING TO ANOTHER
32	BY A PURCHASER OR AGENT, WHETHER OR NOT THE OWNER HAS RECEIVED SOME
33	MONETARY CONSIDERATION OR OTHER THING OF VALUE FOR THE USE OF THE EQUINE
34	OR IS PERMITTING A PROSPECTIVE PURCHASER OF THE EQUINE TO RIDE, INSPECT

"INHERENT RISKS OF EQUINE ACTIVITIES" MEANS THOSE DANGERS OR CONDI-1 2 TIONS WHICH ARE AN INTEGRAL PART OF EQUINE ACTIVITIES, INCLUDING BUT NOT 3 LIMITED TO: 4 (A) THEPROPENSITY OF EQUINES TO BEHAVE IN WAYS THAT MAY RESULT IN 5 INJURY, HARM OR DEATH TO PERSONS ON OR AROUND THEM; 6 (B) THE UNPREDICTABILITY OF AN EQUINE'S REACTION TO SUCH THINGS AS 7 SOUNDS, SUDDEN MOVEMENT, AND UNFAMILIAR OBJECTS, PERSONS OR OTHER 8 ANIMALS; 9 (C) CERTAIN HAZARDS SUCH AS SURFACE AND SUBSURFACE CONDITIONS INCLUD-10 BUT NOT LIMITED TO, ROCKS, FOREST GROWTH, DEBRIS, BRANCHES, TREES, ING, ROOTS, STUMPS OR OTHER NATURAL OBJECTS; 11 12 (D) COLLISIONS WITH OTHER EOUINES OR OBJECTS; AND (E) THE POTENTIAL OF A PARTICIPANT TO ACT IN A NEGLIGENT MANNER 13 THAT 14 MAY CONTRIBUTE TO INJURY TO THE PARTICIPANT OR OTHERS, SUCH AS FAILING 15 TO MAINTAIN CONTROL OVER THE ANIMAL OR NOT ACTING WITHIN HIS OR HER ABILITY. 16 17 7. "PARTICIPANT" MEANS ANY PERSON, WHETHER AMATEUR OR PROFESSIONAL, WHO ENGAGES IN AN EOUINE ACTIVITY, WHETHER OR NOT A FEE IS 18 PAID TO 19 PARTICIPATE IN THE EQUINE ACTIVITY. 18-303. LIABILITY OF PERSONS INVOLVED IN EQUINE ACTIVITIES. 20 1. S NOTHING IN SECTION 18-304 OF THIS ARTICLE SHALL PREVENT OR LIMIT 21 THE 22 LIABILITY OF AN EQUINE ACTIVITY SPONSOR OR AN EQUINE PROFESSIONAL, IF 23 THE EQUINE ACTIVITY SPONSOR OR EQUINE PROFESSIONAL: (A) PROVIDED EQUIPMENT OR TACK, KNEW OR SHOULD HAVE 24 KNOWN THAT SUCH 25 EQUIPMENT OR TACK WAS FAULTY, AND THE EQUIPMENT OR TACK WAS FAULTY TO 26 THE EXTENT THAT IT CAUSED THE INJURY; 27 (B) PROVIDED THE EQUINE AND FAILED TO MAKE REASONABLE AND PRUDENT TO DETERMINE THE ABILITY OF THE PARTICIPANT TO ENGAGE SAFELY IN 28 EFFORTS 29 THE EOUINE ACTIVITY, AND DETERMINE THE ABILITY OF THE PARTICIPANT TΟ SAFELY MANAGE THE PARTICULAR EQUINE BASED ON THE PARTICIPANT'S REPRESEN-30 31 TATIONS OF HIS OR HER ABILITY; 32 OWNS, LEASES, RENTS, HAS AUTHORIZED USE OF OR IS OTHERWISE IN (C) LAWFUL POSSESSION AND CONTROL OF THE LAND OR FACILITIES UPON WHICH THE 33 PARTICIPANT SUSTAINED INJURIES BECAUSE OF A DANGEROUS LATENT CONDITION 34 WHICH WAS KNOWN OR SHOULD HAVE BEEN KNOWN TO THE EQUINE ACTIVITY SPONSOR 35 OR EQUINE PROFESSIONAL, AND FOR WHICH WARNING SIGNS, PURSUANT TO SECTION 36 37 18-305 OF THIS ARTICLE, HAVE NOT BEEN CONSPICUOUSLY POSTED; 38 (D) COMMITS AN ACT OF OMISSION THAT CONSTITUTES WILLFUL OR WANTON 39 DISREGARD FOR THE SAFETY OF THE PARTICIPANT, AND THAT ACT OF OMISSION 40 CAUSED THE INJURY; OR (E) INTENTIONALLY INJURES THE PARTICIPANT. 41 2. THIS SECTION SHALL NOT APPLY TO THE HORSE RACING ACTIVITY AUTHOR-42 43 PURSUANT TO ARTICLE TWO, THREE OR FOUR OF THE RACING, PARI-MUTUEL IZED 44 WAGERING AND BREEDING LAW. 45 S 18-304. LIMITATION OF LIABILITY. 1. EXCEPT AS PROVIDED IN SUBDIVI-SION TWO OF SECTION 18-303 OF THIS ARTICLE, AN EQUINE ACTIVITY SPONSOR, 46 47 AN EQUINE PROFESSIONAL OR ANY OTHER PERSON, WHICH SHALL INCLUDE A CORPO-48 RATION, LIMITED LIABILITY COMPANY OR PARTNERSHIP, SHALL NOT BE LIABLE 49 FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT RESULTING FROM THE INHER-RISKS OF EQUINE ACTIVITIES AND, EXCEPT AS PROVIDED IN SUBDIVISION 50 ENTTWO OF SECTION 18-303 OF THIS ARTICLE, NO PARTICIPANT NOR PARTICIPANT'S 51 REPRESENTATIVE SHALL MAKE ANY CLAIM AGAINST, MAINTAIN AN ACTION AGAINST, 52 OR RECOVER FROM AN EQUINE ACTIVITY SPONSOR, AN EQUINE PROFESSIONAL OR 53 54 ANY OTHER PERSON FOR INJURY, LOSS, DAMAGE OR DEATH OF THE PARTICIPANT RESULTING FROM ANY OF THE INHERENT RISKS OF EQUINE ACTIVITIES. 55

1 2. NOTHING IN THIS ARTICLE SHALL LIMIT THE APPLICATION OF THE 2 PROVISIONS OF SECTION 9-103 OF THIS CHAPTER.

3 S 18-305. POSTING AND NOTIFICATION. 1. EVERY EQUINE PROFESSIONAL 4 SHALL POST AND MAINTAIN SIGNS WHICH CONTAIN THE WARNING NOTICE SPECIFIED 5 IN SUBDIVISION TWO OF THIS SECTION. SUCH SIGNS SHALL BE PLACED IN A CLEARLY VISIBLE LOCATION IN THE PROXIMITY OF THE EQUINE ACTIVITY. THE 6 7 WARNING NOTICE SPECIFIED IN SUBDIVISION TWO OF THIS SECTION SHALL APPEAR ON THE SIGN IN BLACK LETTERS, WITH EACH LETTER TO BE A MINIMUM OF ONE 8 INCH IN HEIGHT. EVERY WRITTEN CONTRACT ENTERED INTO BY AN EQUINE PROFES-9 10 SIONAL FOR THE PROVISION OF PROFESSIONAL SERVICES, INSTRUCTION OR THE RENTAL OF EQUIPMENT OR TACK OR AN EQUINE TO A PARTICIPANT, WHETHER OR 11 NOT THE CONTRACT INVOLVES EQUINE ACTIVITIES ON OR OFF THE LOCATION OR 12 SITE OF THE EQUINE PROFESSIONAL'S BUSINESS, SHALL CONTAIN, IN CLEARLY 13 14 READABLE PRINT, THE WARNING NOTICE SPECIFIED IN SUBDIVISION TWO OF THIS 15 SECTION.

16 2. THE SIGNS AND CONTRACTS DESCRIBED IN SUBDIVISION ONE OF THIS 17 SECTION SHALL CONTAIN THE FOLLOWING WARNING NOTICE:

WARNING

19 UNDER NEW YORK LAW, AN EQUINE PROFESSIONAL OR EQUINE ACTIVITY SPONSOR 20 IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE 21 ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES, 22 PURSUANT TO SECTION 18-304 OF THE GENERAL OBLIGATIONS LAW.

23 S 3. This act shall take effect on the ninetieth day after it shall 24 have become a law.
