AN ACT to authorize the conveyance of certain real property in the city
of Poughkeepsie subject to section twenty of the general city law

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Notwithstanding any other provision of law, the city of
2 Poughkeepsie is hereby authorized to convey to 1687 Properties LLC, all
3 its rights, title and interest in the real property and improvements
4 thereon described as Parcel A in section two of this act, now owned by
5 the city of Poughkeepsie upon such terms and conditions as the parties
6 shall agree. The conveyances authorized by this act are subject to
7 section 20 of the general city law.

8 S 2. The property authorized by this act to be conveyed by the city of
9 Poughkeepsie to 1687 Properties LLC is generally described as a parcel
10 of real property with improvements thereon, consisting of approximately
11 2.717 acres, located at 83 North Water Street in the City of Poughkeep-
12 sie, County of Dutchess, and is bounded by the Hudson River on the west,
13 the Fallkill Creek on the South, North Water Street on the East and the
14 property line of Central Hudson Gas and Electric Corp. on the North, and
15 being more particularly described as Follows:

18 All that parcel of land situate in the City of Poughkeepsie, County of
19 Dutchess and State of New York, bounded and described as follows:

35 Beginning at a point on the assumed westerly line of North Water
36 Street at its intersection with the division line between lands now or
37 formerly of Adolfo's of Poughkeepsie, now or formerly Mid-Hudson Chil-
38 dren's Center Doc. 02-2004-4074 on the south and lands now or formerly
39 of Central Hudson Energy Group, Inc. on the north. Thence along said
40 division line North 73° 10' 58" West 6.43 feet. Thence through said
41 lands of Central Hudson Energy Group, Inc. (hereafter called Lot 2) the
42 following four (4) courses and distances: 1) North 33° 09' 00" West
43 39.94 feet, 2) North 55° 49' 36" West 159.95 feet, 3) North 48° 01' 30"
44 West 58.68 feet, 4) North 45° 28' 10" West 42.10 feet to its inter-

51 South 33° 09' 00" East 25.92 feet to its intersection with said line of
52 North Water Street. Thence along said line of North Water Street the

54 feet and 2) South 08° 25' 51" West 32.06 feet to the point of beginning.

1 Beginning at a point on the assumed westerly line of North Water
2 Street being distant the following four (4) courses and distances as
3 measured along said line of North Water Street from its intersection
4 with the division line between lands now or formerly of Mid Hudson Chil-
5 dren's Center Doc. 02-2004-4074 on the south and Lot 2, F.M. 11198 on
6 the north; 1) North $08^{\circ} 25' 51''$ East 32.06 feet, 2) North $44^{\circ} 58' 46''$
7 East 45.43 feet, 3) North $67^{\circ} 25' 17''$ East 46.96 feet, 4) North $26^{\circ} 55'$
8 $56''$ East 90.08 feet. Thence through said Lot 2 the following four (4)
9 courses and distances: 1) North $74^{\circ} 32' 00''$ West 109.86 feet, 2) South
10 $78^{\circ} 59' 00''$ West 86.29 feet, 3) South $83^{\circ} 09' 00''$ West 90.01 feet to the
11 northeasterly line of aforescribed Utility Easement No. 1, Thence
12 along the just mentioned line the following two (2) courses and
13 distances: 1) North $48^{\circ} 01' 30''$ West 32.72 feet, 2) North $45^{\circ} 28' 10''$
14 West 13.20 feet to its intersection with the lot line between Lot 1 F.M.
15 11198 on the north and said Lot 2 on the south. Thence along said lot

24 Beginning at a point on the assumed westerly line of North Water
25 Street being distant the following four (4) courses and distances are
26 measured along said line of North Water Street from its intersection
27 with the division line between lands now or formerly of Mid-Hudson Chil-
28 dren's Center Doc 02-2004-4074 on the south and Lot 2 F.M. 11198 on the
29 north: 1) North $08^{\circ} 25' 51''$ East 32.06 feet, 2) North $44^{\circ} 58' 46''$ East
30 45.43 feet, 3) North $67^{\circ} 25' 17''$ East 46.96 feet, 4) North $26^{\circ} 55' 56''$
31 East 94.46 feet. Thence through said Lot 2, North $10^{\circ} 50' 45''$ West
32 169.66 feet to its intersection with the lot line between Lot 1 F.M.
33 11198 on the north and said Lot 2 on the south (the last mentioned point
34 being an angle point on said lot line). Thence along said lot line, N
35 $50^{\circ} 31' 40''$ East 34.18 feet. Thence through said Lot 2, South $10^{\circ} 50'$
36 $45''$ East 147.33 feet to its intersection with said line of North Water
37 Street. Thence along said line of North Water Street, S $26^{\circ} 55' 56''$ West
38 48.97 feet to the point of beginning of this parcel.

39 Containing 4,755 Sq. Ft. = 0.109 Acre more or less.

40 S 3. This act shall take effect immediately.
