Introduced by M. of A. TEDISCO -- read once and referred to the Committee on Ways and Means

AN ACT to amend the tax law, the state finance law and the executive law, in relation to creating a veterans' outreach advisory board and authorizing a tax check-off for gifts to such board

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The tax law is amended by adding a new section 625-a to
2 read as follows:
3 S 625-A. GIFTS TO THE VETERANS' OUTREACH ADVISORY BOARD. EFFECTIVE
4 FOR ANY TAXABLE YEAR COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND
5 THIRTEEN, AN INDIVIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO
6 THE VETERANS' OUTREACH ADVISORY BOARD FOR FINANCIAL SUPPORT FOR VETER-
7 ANS' ORGANIZATIONS. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE DOLLAR
8 AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY SUCH INDI-
9 VIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE PERSONAL INCOME TAX
10 RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIBUTION. NOTWITHSTANDING
11 ANY OTHER PROVISION OF LAW ALL REVENUES COLLECTED PURSUANT TO THIS
12 SECTION SHALL BE CREDITED TO THE GIFTS TO VETERANS' OUTREACH ADVISORY
13 BOARD FUND AND USED ONLY FOR THOSE PURPOSES SET FORTH IN SECTION EIGHT-
14 Y-TWO OF THE STATE FINANCE LAW.
15 S 2. The state finance law is amended by adding a new section 82 to
16 read as follows:
17 S 82. GIFTS TO VETERANS' OUTREACH ADVISORY BOARD FUND. 1. THERE IS
18 HEREBY ESTABLISHED A GIFTS TO VETERANS' OUTREACH ADVISORY BOARD FUND.
19 2. SUCH FUND SHALL CONSIST OF ALL MONEYS RECEIVED BY THE DEPARTMENT OF
20 TAXATION AND FINANCE FROM GIFTS TO THE VETERANS' OUTREACH ADVISORY BOARD
21 PURSUANT TO SECTION SIX HUNDRED TWENTY-FIVE-A OF THE TAX LAW, AND ALL
22 OTHER MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM ANY
23 OTHER FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED HEREIN SHALL
24 PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS OR BEQUESTS FOR THE
25 PURPOSES OF THE FUND AS DEFINED IN THIS SECTION AND DEPOSITING THEM INTO
26 THE FUND ACCORDING TO LAW.

1 3. SUCH MONEYS, AFTER APPROPRIATION BY THE LEGISLATURE, SHALL BE
2 AVAILABLE TO THE VETERANS' OUTREACH ADVISORY BOARD TO CARRY OUT THE
3 PURPOSES SET FORTH IN SECTION THREE HUNDRED SIXTY-NINE OF THE EXECUTIVE
4 LAW, INCLUDING THE DISTRIBUTION OF COMPETITIVE GRANTS TO VETERANS'
5 ORGANIZATIONS WITHIN THIS STATE TO PROMOTE ACTIVITIES, PROGRAMS AND
6 PROJECTS OF SUCH ORGANIZATIONS.

7 4. MONIES SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF
8 THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE DIRECTOR OF
9 VETERANS' AFFAIRS.

10 S 3. The executive law is amended by adding a new section 369 to read
11 as follows:

12 S 369. VETERANS' OUTREACH ADVISORY BOARD. 1. THERE IS HEREBY ESTAB-
13 LISHED WITHIN THE DIVISION A VETERANS' OUTREACH ADVISORY BOARD. THE
14 MEMBERSHIP OF THE BOARD SHALL CONSIST OF ONE COUNTY VETERANS' AFFAIRS
15 DIRECTOR FROM EACH OF THE JUDICIAL DISTRICTS OF THE STATE AND THE DIREC-
16 TOR, WHO SHALL SERVE AS THE CHAIR OF SUCH BOARD. EACH COUNTY VETERANS'
17 AFFAIRS DIRECTOR SHALL BE CHOSEN FROM THE COUNTY VETERANS' AFFAIRS
18 DIRECTORS WITHIN THE JUDICIAL DISTRICT SERVED BY SUCH COUNTY DIRECTOR
19 AND SHALL SERVE FOR A TERM OF FOUR YEARS. VACANCIES IN OFFICE SHALL BE
20 FILLED IN THE SAME MANNER AS THE REGIONAL APPOINTMENT.

21 2. THE MEMBERS OF THE BOARD SHALL RECEIVE NO COMPENSATION FOR THEIR
22 SERVICES AS MEMBERS OF THE BOARD, BUT EACH OF THEM SHALL BE ALLOWED THE
23 NECESSARY AND ACTUAL EXPENSES WHICH HE OR SHE SHALL INCUR IN THE
24 PERFORMANCE OF HIS OR HER DUTIES UNDER THIS SECTION. THE DIVISION SHALL
25 PROVIDE STAFF AND SUPPORT NECESSARY FOR THE BOARD TO CARRY OUT ITS
26 DUTIES AND RESPONSIBILITIES.

27 3. THE BOARD SHALL MEET AT SUCH TIMES AS THE CHAIR MAY DIRECT. A
28 MAJORITY OF THE MEMBERS OF THE BOARD SHALL CONSTITUTE A QUORUM.

29 4. THE VETERANS' OUTREACH ADVISORY BOARD SHALL BE AUTHORIZED AND
30 EMPOWERED TO:

31 A. MAKE SUCH REASONABLE RULES AND REGULATIONS AS MAY BE NECESSARY FOR
32 THE PROPER OPERATION OF SUCH BOARD;

33 B. PROVIDE COMPETITIVE GRANTS TO VETERANS' ORGANIZATIONS WITHIN THIS
34 STATE TO PROMOTE ACTIVITIES, PROGRAMS AND PROJECTS OF SUCH ORGANIZATIONS
35 WHILE ALSO PROMOTING REGIONAL ECONOMIC DEVELOPMENT WITHIN THE STATE;

36 C. TO HAVE ALL OTHER POWERS WHICH MAY BE REASONABLY IMPLIED FROM THE
37 GRANTING OF EXPRESS POWERS BY THIS SECTION, TOGETHER WITH SUCH OTHER
38 POWERS AS MAY BE INCIDENT TO OR NECESSARY FOR THE CARRYING OUT THE
39 PURPOSES OF THIS SECTION; AND

40 D. REPORT TO THE GOVERNOR AND TO THE LEGISLATURE CONCERNING ITS ACTIV-
41 ITIES AT LEAST ONCE ANNUALLY.

42 S 4. This act shall take effect immediately.
