AN ACT to amend the penal law, in relation to assault on district attorneys and assistant district attorneys

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 120.05 of the penal law, as separately
2 amended by chapters 318 and 345 of the laws of 2010, is amended
3 to read as follows:

4 3. With intent to prevent a peace officer, a police officer, DISTRICT
5 ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse, licensed practical
6 nurse, sanitation enforcement agent, a firefighter, including a
7 firefighter acting as a paramedic or emergency medical technician administering
8 first aid in the course of performance of duty as such firefighter, an
9 emergency medical service paramedic or emergency medical service technician,
10 or medical or related personnel in a hospital emergency department, a city
11 marshal, a traffic enforcement officer or traffic enforcement agent, from
12 performing a lawful duty, by means including releasing or failing to control
13 an animal under circumstances evincing the actor's intent that the animal
14 obstruct the lawful activity of such peace officer, police officer, DISTRICT
15 ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse, licensed practical
16 nurse, sanitation enforcement agent, firefighter, paramedic, technician, city
17 marshal, traffic enforcement officer or traffic enforcement agent, he or she
18 causes physical injury to such peace officer, police officer, DISTRICT
19 ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse, licensed practical
20 nurse, sanitation enforcement agent, firefighter, paramedic, technician or
21 medical or related personnel in a hospital emergency department, city
22 marshal, traffic enforcement officer or traffic enforcement agent; or

1 11. With intent to cause physical injury to a train operator, ticket
2 inspector, conductor, signalperson, bus operator or station agent
3 employed by any transit agency, authority or company, public or private,
4 whose operation is authorized by New York state or any of its political
5 subdivisions, a city marshal, a traffic enforcement officer, traffic
6 enforcement agent, DISTRICT ATTORNEY, ASSISTANT DISTRICT ATTORNEY or
7 sanitation enforcement agent, registered nurse or licensed practical
8 nurse he or she causes physical injury to such train operator, ticket
9 inspector, conductor, signalperson, bus operator or station agent, city
10 marshal, traffic enforcement officer, traffic enforcement agent,
11 DISTRICT ATTORNEY, ASSISTANT DISTRICT ATTORNEY, registered nurse [or],
12 licensed practical nurse or sanitation enforcement agent, while such
13 employee is performing an assigned duty on, or directly related to, the
14 operation of a train or bus, or such city marshal, traffic enforcement
15 officer, traffic enforcement agent, DISTRICT ATTORNEY, ASSISTANT
16 DISTRICT ATTORNEY, registered nurse [or], licensed practical nurse or
17 sanitation enforcement agent is performing an assigned duty.
18 S 3. This act shall take effect on the one hundred eightieth day after
