Introduced by M. of A. PRETLOW, FARRELL, SCHIMMINGER, COLTON, MILLMAN, SCHIMEL -- read once and referred to the Committee on Ways and Means

AN ACT to amend the tax law, in relation to exempting low-emission and energy efficient vehicles from retail sales and compensating use taxes; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision (a) of section 1115 of the tax law is amended 2 by adding a new paragraph 44 to read as follows:
- 3 (44) LOW-EMISSION AND ENERGY EFFICIENT VEHICLES. FOR PURPOSES OF "LOW-EMISSION AND ENERGY EFFICIENT VEHICLE" SHALL MEAN A VEHICLE CERTIFIED BY THE ADMINISTRATOR OF THE UNITED STATES 5 ENVIRON-6 MENTAL PROTECTION AGENCY PURSUANT TO 23 U.S.C. S 166(F)(3). IF THE 7 ADMINISTRATOR OF THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY SO CERTIFIED ANY VEHICLE AS A LOW-EMISSION AND ENERGY EFFICIENT 8 VEHICLE, THEN, UNTIL SUCH CERTIFICATION OCCURS, "LOW-EMISSION AND ENERGY 9 10 EFFICIENT VEHICLE" SHALL MEAN ANY VEHICLE THAT HAS ACHIEVED AN AIR POLLUTION SCORE OF NINE OR BETTER AND A GREENHOUSE GAS SCORE OF NINE OR 11 12 BETTER ON THE GREEN VEHICLE GUIDE MAINTAINED BY THE UNITED STATES RONMENTAL PROTECTION AGENCY. THE DEPARTMENT SHALL POST ON ITS WEB SITE A 13 LIST OF LOW-EMISSION AND ENERGY EFFICIENT VEHICLES BY MAKE AND MODEL 14 15 YEAR AND SUCH OTHER SPECIFICATIONS AS MAY BE NECESSARY TOIDENTIFY A LOW-EMISSION AND ENERGY EFFICIENT VEHICLE, AND SHALL UPDATE SUCH LIST AS 16 17 NECESSARY TO PROVIDE A COMPLETE LIST OF LOW-EMISSION AND ENERGY EFFI-CIENT VEHICLES. 18
- 19 S 2. This act shall take effect on the first day of the sales tax 20 quarter that begins at least ninety days after the day on which it shall 21 have become a law and shall expire and be deemed repealed December 31, 22 2016.
