AN ACT to amend the election law, in relation to authorizing registration records of victims of a sexual offense to be kept confidential in certain cases

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 1 of section 5-508 of the election law is  
2 amended by adding a new paragraph (c) to read as follows:  
3     (C) "VICTIM OF A SEXUAL OFFENSE" MEANS ANY PERSON WHO IS A VICTIM OF  
4 ANY OFFENSE LISTED UNDER ARTICLE ONE HUNDRED THIRTY OF THE PENAL LAW.  
5     S 2. Section 5-508 of the election law is amended by adding a new  
6 subdivision 3 to read as follows:  
7     3. UPON APPLICATION MADE TO THE SUPREME COURT, IN THE COUNTY WHEREIN A  
8 VICTIM OF A SEXUAL OFFENSE IS REGISTERED PURSUANT TO THIS ARTICLE, THE  
9 COURT MAY ISSUE AN ORDER REQUIRING THAT ANY REGISTRATION RECORD KEPT OR  
10 MAINTAINED IN ACCORDANCE WITH THIS ARTICLE WITH RESPECT TO SUCH AN INDI-  
11 VIDUAL BE KEPT SEPARATE AND APART FROM OTHER REGISTRATION RECORDS AND  
12 NOT BE MADE AVAILABLE FOR INSPECTION OR COPYING BY THE PUBLIC OR ANY

4 S 3. This act shall take effect on the one hundred twentieth day after  
5 it shall have become a law. Effective immediately, the addition, amend-  
6 ment and/or repeal of any rule or regulation necessary for the implemen-  
7 tation of this act on its effective date is authorized to be made on or  
8 before such date.
