AN ACT to amend the alcoholic beverage control law, in relation to cooperative agreements by licensees to sell at retail for consumption off the premises

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 105 of the alcoholic beverage control law is 2 amended by adding a new subdivision 24 to read as follows:

- 3 24. COOPERATIVE AGREEMENTS BY LICENSEES TO SELL AT RETAIL FOR CONSUMP-THE PREMISES. FOR THE PURPOSES OF PURCHASING ONLY, ANY TWO OR 4 5 PERSONS LICENSED PURSUANT TO SECTIONS SIXTY-THREE 6 SEVENTY-NINE OF THIS CHAPTER MAY JOIN IN AN AGREEMENT TO MAKE JOINT 7 PURCHASES OF LIQUOR AND/OR WINE IN LARGER QUANTITIES THAN MIGHT OTHER-8 BE PURCHASED; PROVIDED, HOWEVER, THAT ALL SUCH ALCOHOLIC BEVERAGES 9 PURCHASED PURSUANT TO ANY SUCH AGREEMENT SHALL BE DISTRIBUTED OTHER THAN A LICENSEE WHO IS A PARTY TO SUCH AGREEMENT. A COOPERATIVE 10 AGREEMENT, AS AUTHORIZED UNDER THIS SUBDIVISION, SHALL BE VOID 11 WITHIN A CITY WITH A POPULATION OF ONE MILLION OR MORE, THE PREMISES 12 13 OPERATING UNDER SUCH COOPERATIVE AGREEMENT AUTHORIZED IN THIS LOCATED MORE THAN ONE MILE FROM ONE ANOTHER; (B) OUTSIDE OF A 14 SION ARE 15 CITY WITH A POPULATION OF ONE MILLION OR MORE, THE PREMISES OPERATING AUTHORIZED IN THIS SUBDIVISION ARE 16 UNDER SUCH COOPERATIVE AGREEMENT LOCATED MORE THAN FIFTY MILES FROM ONE 17 ANOTHER; OR (C) ANY PERSON LICENSED PURSUANT TO SECTIONS SIXTY-THREE AND/OR SEVENTY-NINE OF THIS 18 19 CHAPTER WHO CHOOSES TO PARTICIPATE IN SUCH COOPERATIVE AGREEMENT AND HAS
