AN ACT to amend the education law and the public health law, in relation to course work or training in early recognition of and intervention for eating disorders

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 6505-d 2 to read as follows:

6505-D. COURSE WORK OR TRAINING IN EARLY RECOGNITION OF AND INTER-VENTION FOR EATING DISORDERS. EVERY PHYSICIAN AND PHYSICIAN ASSISTANT PRACTICING IN THE STATE SHALL, ON OR BEFORE JULY FIRST, TWO THOUSAND THIRTEEN COMPLETE COURSE WORK OR TRAINING APPROVED BY THEEARLY RECOGNITION OF AND INTERVENTION FOR EATING DISOR-REGARDING THE DERS, IN CONSULTATION WITH THE DEPARTMENT OF HEALTH, WHICH SHALL CONSISTENT, AS FAR AS APPROPRIATE, WITH ANY STANDARDS OR BEST PRACTICES ESTABLISHED BY THE COMPREHENSIVE CARE CENTERS FOR EATING DISORDERS ESTABLISHED PURSUANT TO ARTICLE TWENTY-SEVEN-J OF THE PUBLIC HEALTH LAW. EACH SUCH PROFESSIONAL SHALL ATTEST TO THE DEPARTMENT AT THE TIME OF REGISTRATION COMMENCING WITH THE FIRST REGISTRATION AFTER JULY

PRESCRIBED BY THIS SECTION. THE ONE HOUR ONLINE COURSE SHALL CONSIST OF, LIMITED TO, INFORMATION REGARDING PHYSICAL, EMOTIONAL, AND BUT NOT BE 3 BEHAVIORAL INDICATORS OF EATING DISORDERS. THE DEPARTMENT SHALL PROVIDE EXEMPTION FROM THIS REQUIREMENT TO ANYONE WHO REOUESTS SUCH AN 5 EXEMPTION AND WHO CLEARLY DEMONSTRATES TO THE DEPARTMENT'S SATISFACTION THERE WOULD BE NO NEED FOR HIM OR HER TO COMPLETE SUCH COURSE 6 THAT (I) 7 WORK OR TRAINING BECAUSE OF THE NATURE OF HIS OR HER PRACTICE, (II) THAT HE OR SHE HAS COMPLETED COURSE WORK OR TRAINING DEEMED BY THE DEPARTMENT 8 TO BE EQUIVALENT TO THE COURSE WORK OR TRAINING APPROVED BY THE DEPART-9 10 MENT PURSUANT TO THIS SECTION OR (III) SOME OTHER GOOD CAUSE PREVENTS THEM FROM COMPLETING SUCH COURSE WORK OR TRAINING. 11

- S 2. Subdivision 1 of section 2805-k of the public health law is amended by adding a new paragraph (h) to read as follows:
- (H) DOCUMENTATION THAT THE PHYSICIAN HAS COMPLETED THE COURSE WORK OR TRAINING AS MANDATED BY SECTION SIX THOUSAND FIVE HUNDRED FIVE-D OF THE EDUCATION LAW. A HOSPITAL OR FACILITY SHALL NOT GRANT OR RENEW PROFESSIONAL PRIVILEGES OR ASSOCIATION TO A PHYSICIAN WHO HAS NOT COMPLETED SUCH COURSE WORK OR TRAINING.
- 19 S 3. This act shall take effect on the first of January next succeed-20 ing the date on which it shall have become a law; provided that the 21 commissioner of education is immediately authorized and directed to 22 promulgate, amend and/or repeal any rules and regulations necessary to 23 implement the provisions of this act on such effective date.
