AN ACT to amend the education law, in relation to authorizing boards of cooperative educational services to enter into contracts with public libraries for high-speed telecommunications services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph h of subdivision 4 of section 1950 of the educa-2 tion law is amended by adding a new subparagraph 10 to read as follows: 3 (10) TO ENTER INTO CONTRACTS WITH INDIVIDUAL PUBLIC LIBRARIES OR 4 PUBLIC LIBRARY SYSTEMS FOR THE PURPOSE OF PROVIDING HIGH-SPEED TELECOM-MUNICATIONS SERVICES INCLUDING, BUT NOT LIMITED TO, HIGH-SPEED 6 SERVICES. ANY SUCH PROPOSED CONTRACT SHALL BE SUBJECT TO THE REVIEW AND 7 APPROVAL OF THE COMMISSIONER, WHO MAY ONLY APPROVE SUCH PROPOSED 8 CONTRACT WHEN, IN SUCH COMMISSIONER'S OPINION, SUCH CONTRACT: 9 RESULT IN A MORE ECONOMICAL UTILIZATION OF EXISTING BOARD OF COOPERATIVE EDUCATIONAL SERVICES HIGH-SPEED TELECOMMUNICATIONS SERVICES OR RESOURCES 10 11 WOULD BEACHIEVED WERE SUCH CONTRACT NOT APPROVED; (B) WILL NOT 12 DISRUPT THE LEVEL OF SERVICES TO COMPONENT SCHOOL DISTRICTS; WILL RESULT MORE ECONOMICAL UTILIZATION OF 13 IN A EXISTING LIBRARY 14 RESOURCES.
