AN ACT to amend the public authorities law and the administrative code
of the city of New York, in relation to requiring the metropolitan
transportation authority to transfer any remaining money on an expired
pay-per-ride MetroCard to a new MetroCard, and enacting certain other
technical provisions

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1261 of the public authorities law is amended by
2 adding a new subdivision 11-a to read as follows:
3 11-A. "METROCARD" SHALL MEAN ANY CARD WHETHER PAY-PER-RIDE OR UNLIMIT-
4 ED RIDE, SOLD FOR TRAVEL ON THE NEW YORK CITY SUBWAY SYSTEM; NEW YORK
5 CITY TRANSIT BUSES, INCLUDING ROUTES OPERATED BY OTHER OPERATORS UNDER
6 CONTRACT TO THE METROPOLITAN TRANSPORTATION AUTHORITY (MTA); MTA BUS,
7 AND MTA LONG ISLAND BUS SYSTEMS; THE PATH SUBWAY SYSTEM; THE ROOSEVELT
8 ISLAND TRAM; AIRTRAIN JFK; AND WESTCHESTER COUNTY BEE-LINE BUS SYSTEM ON
9 WHICH THE CUSTOMER ELECTRONICALLY LOADS FARES WHETHER THE CARD IS SOLD
10 BY THE METROPOLITAN TRANSPORTATION AUTHORITY, ANY OF SUCH AUTHORITIES'
11 AUTHORIZED AGENTS, NEIGHBORHOOD MERCHANTS, OR PURCHASED THROUGH ANY
12 EMPLOYER TRANSIT PROGRAMS.
13 S 2. The public authorities law is amended by adding a new section
14 1266-j to read as follows:
15 S 1266-J. EXPIRED PAY-PER-RIDE METROCARDS WITH UNUSED BALANCES. THE
16 METROPOLITAN TRANSPORTATION AUTHORITY (MTA) SHALL BE REQUIRED TO TRANS-
17 FER ANY REMAINING MONEY ON AN EXPIRED PAY-PER-RIDE METROCARD TO A NEW
18 PAY-PER-RIDE METROCARD AS DEFINED UNDER SECTION TWELVE HUNDRED SIXTY-ONE

3 S 3. The administrative code of the city of New York is amended by
4 adding a new section 20-706-a to read as follows:
5 S 20-706-A EXPIRED PAY-PER-RIDE METROCARDS WITH UNUSED BALANCES. THE
6 METROPOLITAN TRANSPORTATION AUTHORITY (MTA) SHALL BE REQUIRED TO TRANS-
7 FER ANY REMAINING MONEY ON AN EXPIRED PAY-PER-RIDE METROCARD TO A NEW
8 CARD AT THE CUSTOMER'S REQUEST REGARDLESS OF THE AMOUNT OF TIME THAT HAS
9 LAPSED SINCE THE INITIAL EXPIRATION DATE OF THE CARD.
10 S 4. This act shall take effect immediately.
