AN ACT to amend the state finance law, in relation to the cost effectiveness of consultant contracts by state agencies

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 163 of the state finance law is amended by adding a 2 new subdivision 15 to read as follows:

ING THE CONTRACT.

A STATE AGENCY ENTERS INTO A CONSULTANT SERVICES. Α. BEFORE CONTRACT FOR CONSULTANT SERVICES WHICH IS ANTICIPATED TO COST MORE FIVE HUNDRED THOUSAND DOLLARS IN A TWELVE MONTH PERIOD THE STATE AGENCY SHALL CONDUCT A COST COMPARISON REVIEW TO DETERMINE WHETHER THE SERVICES TO BE PROVIDED BY THE CONSULTANT CAN BE PERFORMED AT EOUAL OR LOWER COST BY UTILIZING STATE EMPLOYEES, UNLESS THE CONTRACT MEETS ONE THE SET FORTH IN PARAGRAPH B OF THIS SUBDIVISION. AS EXCEPTIONS USED IN THIS SECTION, THE TERM "CONSULTANT SERVICES" SHALL MEAN ANY CONTRACT INTO BY A STATE AGENCY FOR ANALYSIS, EVALUATION, RESEARCH, TRAINING, DATA PROCESSING, COMPUTER PROGRAMMING, ENGINEERING, ARCHITEC-TURE, ENVIRONMENTAL, HEALTH SERVICES, MENTAL HEALTH SERVICES, ACCOUNT-ING, AUDITING, OR SIMILAR SERVICES, BUT SHALL NOT INCLUDE LEGAL SERVICES OR SERVICES IN CONNECTION WITH LITIGATION INCLUDING EXPERT WITNESSES AND SHALL NOT INCLUDE CONTRACTS FOR CONSTRUCTION OF PUBLIC WORKS. COMPARISON SHALL COMPARE THE ANTICIPATED COST OF CONSULTANT SERVICES WITH THE ANTICIPATED COST OF PROVIDING SIMILAR SERVICES BY STATE EMPLOY-EES INCLUDING THE COST OF SALARIES AND BENEFITS OF ANY ADDITIONAL EMPLOYEES THAT WOULD BE REQUIRED TO PERFORM THE SERVICES. THE ANTIC-IPATED COST OF CONSULTANT SERVICES SHALL INCLUDE ALL COSTS ASSOCIATED

- B. A COST COMPARISON SHALL NOT BE REQUIRED IF:
- (I) THE SERVICES ARE INCIDENTAL TO THE PURCHASE OF REAL OR PERSONAL PROPERTY; OR
- (II) THE CONTRACT IS NECESSARY IN ORDER TO AVOID A CONFLICT OF 5 EST ON THE PART OF THE AGENCY OR ITS EMPLOYEES; OR
  - THE SERVICES ARE OF SUCH A HIGHLY SPECIALIZED NATURE THAT IT IS NOT FEASIBLE TO UTILIZE STATE EMPLOYEES TO PERFORM THEM OR REOUIRE SPECIAL EQUIPMENT THAT IS NOT FEASIBLE FOR THE STATE TO PURCHASE OR LEASE; OR
- 10 (IV) THE SERVICES ARE OF SUCH AN URGENT NATURE THAT IT IS NOT FEASIBLE TO UTILIZE STATE EMPLOYEES; OR 11
- 12 (V) THE SERVICES ARE ANTICIPATED TO BE SHORT TERM AND ARE NOT LIKELY TO BE EXTENDED OR REPEATED AFTER THE CONTRACT IS COMPLETED. 13
- C. NOTHING IN THIS SECTION SHALL BE DEEMED TO AUTHORIZE A STATE AGENCY 15 TO ENTER INTO A CONTRACT WHICH IS OTHERWISE PROHIBITED BY LAW.
- ALL DOCUMENTS RELATED TO THE COST COMPARISON REQUIRED BY THIS 16 SUBDIVISION SHALL BE PUBLIC RECORDS SUBJECT TO DISCLOSURE PURSUANT TO 17 ARTICLE SIX OF THE PUBLIC OFFICERS LAW. 18
- 19 2. This act shall take effect on the ninetieth day after it shall have become a law; provided, however, that the amendments to section 163 20 21 of the state finance law made by section one of this act shall not affect the repeal of such section and shall be deemed to repeal there-23 with.
