AN ACT to amend the public health law, in relation to prohibiting smoking on waiting and platform areas of railroad stations operated by the metropolitan transportation authority or its subsidiaries

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1399-o of the public health law, as amended by  
2 chapter 13 of the laws of 2003, subdivision 13 as amended by chapter 154  
3 of the laws of 2008, is amended to read as follows:

4 S 1399-o. Smoking restrictions. 1. Smoking shall not be permitted and  
5 no person shall smoke in the following indoor areas:

6 [1.] A. places of employment;

7 [2.] B. bars;

8 [3.] C. food service establishments, except as provided in subdivision  
9 six of section thirteen hundred ninety-nine-q of this article;

1 [4.] D. enclosed indoor areas open to the public containing a swimming  
2 pool;

3 [5.] E. public means of mass transportation, including subways, under-  
4 ground subway stations, and when occupied by passengers, buses, vans,  
5 taxicabs and limousines;

6 [6.] F. ticketing, boarding and waiting areas in public transportation  
7 terminals;

8 [7.] G. youth centers and facilities for detention as defined in  
9 sections five hundred twenty-seven-a and five hundred three of the execu-  
10 tive law;

11 [8.] H. any facility that provides child care services as defined in  
12 section four hundred ten-p of the social services law, provided that  
13 such services provided in a private home are excluded from this subdivi-  
14 sion when children enrolled in such day care are not present;

15 [9.] I. child day care centers as defined in section three hundred  
16 ninety of the social services law and child day care centers licensed by  
17 the city of New York;

18 [10.] J. group homes for children as defined in section three hundred  
19 seventy-one of the social services law;

20 [11.] K. public institutions for children as defined in section three  
21 hundred seventy-one of the social services law;

22 [12.] L. residential treatment facilities for children and youth as  
23 defined in section 1.03 of the mental hygiene law;

24 [13.] M. all public and private colleges, universities and other  
25 educational and vocational institutions, including dormitories, resi-  
26 dence halls, and other group residential facilities that are owned or  
27 operated by such colleges, universities and other educational and voca-  
28 tional institutions, except that these restrictions shall not apply in  
29 any off-campus residential unit occupied by a person who is not enrolled  
30 as an undergraduate student in such college, university or other educa-  
31 tional or vocational institution;

32 [14.] N. general hospitals and residential health care facilities as  
33 defined in article twenty-eight of this chapter, and other health care  
34 facilities licensed by the state in which persons reside; provided,  
35 however, that the provisions of this subdivision shall not prohibit  
36 smoking by patients in separate enclosed rooms of residential health  
37 care facilities, adult care facilities established or certified under  
38 title two of article seven of the social services law, community mental  
39 health residences established under section 41.44 of the mental hygiene  
40 law, or facilities where day treatment programs are provided, which are  
41 designated as smoking rooms for patients of such facilities or programs;

42 [15.] O. commercial establishments used for the purpose of carrying on  
43 or exercising any trade, profession, vocation or charitable activity;

44 [16.] P. indoor arenas;

45 [17.] Q. zoos; and

46 [18.] R. bingo facilities.

47 2. SMOKING SHALL NOT BE PERMITTED AND NO PERSON SHALL SMOKE IN THE  
48 FOLLOWING OUTDOOR AREAS: TICKETING, BOARDING, WAITING OR PLATFORM AREAS  
49 OF RAILROAD STATIONS OPERATED BY THE METROPOLITAN TRANSPORTATION AUTHOR-  
50 ITY OR ITS SUBSIDIARIES.

51 S 2. This act shall take effect on the ninetieth day after it shall  
52 have become a law.
