AN ACT to amend the public health law, in relation to the creation of a reference list of businesses that provide locator technology designed to assist in the expedited location of individuals afflicted with Alzheimer's disease or dementia who become lost or disoriented, and requiring physicians to disclose the existence of such technology to persons afflicted with Alzheimer's disease or dementia and to maintain information regarding any technology utilized by such afflicted people

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public health law is amended by adding two new sections 2 2010 and 2011 to read as follows:

3 S 2010. ALZHEIMER'S AND DEMENTIA LOCATOR TECHNOLOGY INFORMATION. 1. 4 DEPARTMENT, IN CONJUNCTION WITH THE OFFICE FOR THE AGING, THE THE 5 DEPARTMENT OF SOCIAL SERVICES AND THE STATE POLICE, SHALL DEVELOP AND 6 MAINTAIN A COMPREHENSIVE LIST OF BUSINESSES AND OTHER ENTITIES THAT 7 MANUFACTURE, DISTRIBUTE OR OTHERWISE OFFER LOCATOR TECHNOLOGY OR 8 SERVICES DESIGNED TO ASSIST IN THE EXPEDITED LOCATION OF INDIVIDUALS 9 AFFLICTED WITH ALZHEIMER'S DISEASE OR DEMENTIA WHO BECOME LOST OR DISO-10 RIENTED. THE DEPARTMENT SHALL NOTIFY ALL PHYSICIANS LICENSED TO PRACTICE 11 THIS STATE OF THE EXISTENCE OF THE LIST AND SHALL MAKE THE LIST IN 12 AVAILABLE TO THE GENERAL PUBLIC THROUGH THE DEPARTMENT'S WEBSITE. THE 13 LIST SHALL BE UPDATED BY THE DEPARTMENT ON AT LEAST A SEMI-ANNUAL BASIS, AND MAY BE MAINTAINED ON OR CONNECTED TO THE WEBSITES OF OTHER STATE 14 OFFICES, INCLUDING THOSE MAINTAINED BY THE OFFICE FOR THE 15 AGING, THE 16 DEPARTMENT OF SOCIAL SERVICES, THE STATE POLICE AND THE DEPARTMENT OF 17 MENTAL HEALTH.

2. AS USED IN THIS SECTION "LOCATOR TECHNOLOGY" MEANS ANY 1 PRODUCT, SYSTEM USED TO ASSIST IN THE LOCATION AND IDENTIFICATION OF 2 PROGRAM OR 3 LOST OR DISORIENTED PERSONS, AND INCLUDES BUT IS NOT LIMITED TO, RADIO 4 WRIST TRANSMITTER TRACKING SYSTEMS, SOFTWARE PROGRAMS, DATA BASES, AND 5 PRODUCTS CONTAINING IDENTIFYING INFORMATION, INCLUDING NECKLACES OR 6 BRACELETS.

7 3. THE COMMISSIONER SHALL PROMULGATE SUCH RULES AND REGULATIONS AS HE 8 OR SHE DEEMS NECESSARY TO GIVE EFFECT TO THE PROVISIONS OF THIS SECTION.

S 2011. PHYSICIANS AND FACILITIES; DUTY TO ADVISE OF LOCATOR TECHNOLO-9 10 INFORMATION. 1. EFFECTIVE JANUARY FIRST, TWO THOUSAND TWELVE, EVERY GΥ PHYSICIAN DIAGNOSING OR TREATING A PERSON WITH ALZHEIMER'S DISEASE 11 OR OTHER DEMENTIA, AND EVERY FACILITY CARING FOR SUCH PERSON SHALL ADVISE 12 EACH AFFLICTED PERSON AND SUCH PERSON'S FAMILY AND CAREGIVERS OF 13 THE AVAILABILITY OF TECHNOLOGY DESIGNED TO ASSIST IN THE EXPEDITED LOCATION 14 15 OF INDIVIDUALS AFFLICTED WITH ALZHEIMER'S DISEASE OR DEMENTIA WHO BECOME LOST OR DISORIENTED, AND OF THE LOCATOR TECHNOLOGY LIST MAINTAINED BY 16 17 THE DEPARTMENT PURSUANT TO SECTION TWO THOUSAND TEN OF THIS ARTICLE.

PHYSICIAN DIAGNOSING OR TREATING A PERSON WITH ALZHEIMER'S 18 2. EACH 19 DISEASE, DEMENTIA OR TRAUMATIC BRAIN INJURY SHALL MAINTAIN IN THE AFFLICTED PERSON'S MEDICAL RECORDS INFORMATION PERTAINING TO ANY LOCATOR 20 21 TECHNOLOGY UTILIZED BY SUCH PERSON, INCLUDING THE NATURE AND TYPE OF THE 22 TECHNOLOGY, THE APPROXIMATE DATE THE TECHNOLOGY WAS ACQUIRED, THE MANUFACTURER'S NAME AND CONTACT INFORMATION, AND THE SERIAL NUMBER, 23 IF OF SUCH PRODUCT. NOTWITHSTANDING ANY PROVISION OF LAW TO THE 24 ANY. 25 CONTRARY, ALL SUCH INFORMATION SHALL BE IMMEDIATELY DISCLOSED BY THE STATE POLICE UPON REQUEST BY THE STATE POLICE IN THE 26 PHYSICIAN TO THE 27 EVENT THE AFFLICTED PERSON IS REPORTED TO THE POLICE AS BEING LOST OR 28 MISSING; SUCH DISCLOSURE SHALL NOT CONSTITUTE A VIOLATION OF ANY FEDERAL 29 OR STATE STATUTES REGARDING THE CONFIDENTIALITY OF PATIENT MEDICAL 30 INFORMATION.

S 2. This act shall take effect on the first of January next succeeding the date on which it shall have become a law, provided that the department of health is immediately authorized and directed to take such actions as are necessary to implement this act, including the promulgation of rules in accordance with the state administrative procedure act, on or before its effective date.
