Introduced by M. of A. CALHOUN -- read once and referred to the Committee on Insurance

AN ACT to amend the insurance law, the state finance law and the executive law, in relation to creating the innocent uncompensated motorist accident fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph 2 of subsection (e) of section 9110 of the insurance law, as added by section 2 of part T of chapter 56 of the laws of 2 2009, is renumbered paragraph 3 and a new paragraph 2 is added to read 3 as follows: 4

5 (2) EACH FISCAL YEAR, ONE-HALF PERCENT OF THE MONEYS COLLECTED SHALL 6 BE PAID TO THE INNOCENT UNCOMPENSATED MOTORIST ACCIDENT FUND ESTABLISHED 7 PURSUANT TO SECTION NINETY-SEVEN-KKKK OF THE STATE FINANCE LAW.

8 S 2. The state finance law is amended by adding a new section 97-kkkk 9 to read as follows:

10 S 97-KKKK. INNOCENT UNCOMPENSATED MOTORIST ACCIDENT FUND. 1. THERE IS 11 HEREBY ESTABLISHED IN THE JOINT CUSTODY OF THE STATE COMPTROLLER AND THE 12 COMMISSIONER OF TAXATION AND FINANCE A FUND TO BE KNOWN AS THE INNOCENT 13 UNCOMPENSATED MOTORIST ACCIDENT FUND. SUCH FUND SHALL CONSIST OF MONEYS 14 RECEIVED PURSUANT TO PARAGRAPH TWO OF SUBSECTION (E) OF SECTION NINE 15 THOUSAND ONE HUNDRED TEN OF THE INSURANCE LAW.

16 2. MONEYS OF THE FUND SHALL BE MADE AVAILABLE TO THE COMMISSIONER OF 17 MOTOR VEHICLES FOR THE PURPOSE OF COMPENSATING THE OWNER OF A MOTOR 18 VEHICLE INVOLVED IN AN ACCIDENT WHICH IS CAUSED BY PERSONS, TEAMS, MOTOR 19 VEHICLES, AND OTHER EQUIPMENT WHILE ACTUALLY ENGAGED IN WORK ON A HIGH- 20 WAY, NOTWITHSTANDING SUBDIVISION (B) OF SECTION ONE THOUSAND ONE HUNDRED 21 THREE OF THE VEHICLE AND TRAFFIC LAW.

22 S 3. Paragraph (a) of subdivision 2 of section 846-m of the executive 23 law, as amended by section 6 of part T of chapter 57 of the laws of 24 2000, is amended to read as follows:

1 (a) The moneys received by the fund shall be expended in a manner that
2 is consistent with the plan of operation, pursuant to appropriation,
3 only to reimburse costs incurred by provider agencies for pilot program
4 activities relating to the detection, prevention or reduction of motor
5 vehicle theft and motor vehicle insurance fraud; PROVIDED, HOWEVER, THAT
6 ON AND AFTER JANUARY 1, 2012, ONE-HALF PERCENT OF THE MONEYS RECEIVED BY
7 THE FUND SHALL BE TRANSFERRED AND DEPOSITED INTO THE INNOCENT UNCOMPEN-
8 SATED MOTORIST ACCIDENT FUND ESTABLISHED PURSUANT TO SECTION NINETY-SEV-
9 EN-KKKK OF THE STATE FINANCE LAW AND DISBURSED EXCLUSIVELY TO COMPENSATE
10 THE OWNER OF A MOTOR VEHICLE INVOLVED IN AN ACCIDENT WHICH IS CAUSED BY
11 PERSONS, TEAMS, MOTOR VEHICLES, AND OTHER EQUIPMENT WHILE ACTUALLY
12 ENGAGED IN WORK ON A HIGHWAY, NOTWITHSTANDING SUBDIVISION (B) OF SECTION
13 ONE THOUSAND ONE HUNDRED THREE OF THE VEHICLE AND TRAFFIC LAW.

14 S 4. This act shall take effect immediately.
