- AN ACT to amend the vehicle and traffic law, in relation to requiring the suspension of a driver's license for an accident caused by the failure to yield the right of way and death results

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 603-c to read as follows:

3 S 603-C. ACCIDENTS; SUSPENSION FOR FAILURE TO YIELD RIGHT OF WAY. 1. IN ADDITION TO THE REQUIREMENTS OF SECTIONS SIX HUNDRED THREE, 4 SIX 5 HUNDRED THREE-A AND SIX HUNDRED THREE-B OF THIS ARTICLE, THE COMMISSION-6 ER SHALL CAUSE TO BE SUSPENDED THE DRIVER'S LICENSE OF ANY OPERATOR OF A 7 MOTOR VEHICLE WHO IS CHARGED WITH A FAILURE TO YIELD THE RIGHT OF WAY TO ANOTHER OPERATOR IN VIOLATION OF ANY PROVISION OF ARTICLE TWENTY-SIX OF 8 9 THIS CHAPTER AND SUCH FAILURE TO YIELD THE RIGHT OF WAY IS THE CAUSE OF 10 AN ACCIDENT RESULTING IN THE DEATH OF ONE OR MORE PERSONS.

11 2. ANY SUSPENSION REOUIRED BY SUBDIVISION ONE OF THIS SECTION SHALL 12 REMAIN IN EFFECT UNTIL CERTIFICATION BY THE COMMISSIONER OF THE INVESTIGATIONS AND REPORTS REQUIRED BY SECTIONS SIX 13 COMPLETION OF THE 14 HUNDRED THREE, SIX HUNDRED THREE-A AND SIX HUNDRED THREE-B OF THIS ARTI-CLE, BUT FOR NO LONGER THAN SIXTY DAYS. THE COMMISSIONER SHALL 15 CERTIFY COMPLETION OF SUCH INVESTIGATIONS AND REPORTS IN A MANNER AND FORM 16 THE TO BE DETERMINED BY THE COMMISSIONER. ANY OPERATOR OF A MOTOR VEHICLE 17 LICENSE IS SUSPENDED PURSUANT TO THIS ARTICLE MAY APPLY TO THE 18 WHOSE COMMISSIONER FOR A RESTRICTED LICENSE WHEREBY SUCH OPERATOR MAY OPERATE 19 20 MOTOR VEHICLE ONLY FOR TRANSPORTATION TO HIS OR HER PLACE OF EMPLOY-А 21 MENT OR THE PLACE OF EMPLOYMENT OF HIS OR HER SPOUSE, TO ATTEND CLASSES 22 SCHOOL OR INSTITUTION OF HIGHER EDUCATION OR TO TRANSPORT HIS OR HER AT

4 3. THE COMMISSIONER IS HEREBY AUTHORIZED AND DIRECTED TO PROMULGATE 5 RULES AND REGULATIONS FOR THE PURPOSE OF CARRYING OUT THE PROVISIONS OF 6 THIS SECTION.

7 S 2. This act shall take effect on the ninetieth day after it shall 8 have become a law; provided that effective immediately, the addition,

- 9 amendment and/or repeal of any rule or regulation necessary for the
- 10 implementation of this act on its effective date is authorized and

11 directed to be made and completed on or before such effective date.
