AN ACT to amend the environmental conservation law, in relation to
allowing the use of rifles for deer hunting in the county of Chautau-
qua

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907

40 ments to item (i) of paragraph a of subdivision 2 of section 11-0907 of
41 the environmental conservation law made by section one of this act shall
42 be subject to the expiration and reversion of such paragraph pursuant to
43 section 13 of chapter 600 of the laws of 1993, as amended, when upon
44 such date the provisions of section two of this act shall take effect;
45 and provided, further, that the amendments to item (i) of paragraph a of
46 subdivision 2 of section 11-0907 of the environmental conservation law
47 made by section two of this act shall be subject to the expiration and
48 repeal of such paragraph pursuant to section 17 of chapter 483 of the
49 laws of 2010, as amended, when upon such date the provisions of section
50 three of this act shall take effect.
