AN ACT to amend the general business law, in relation to protecting consumers from price gouging and product tampering of gasoline

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 396-x of the general business law, as added by
2 chapter 616 of the laws of 1984, is amended to read as follows:
3 S 396-x. Gasoline stations; air pumps, SIGNAGE required. 1. Defi-
4 nition. As used in this section: "dealer" shall mean any person owning
5 or operating a premise or facility with four or more gas dispensing
6 nozzles for the retail sale of motor fuels for use in motor vehicles.
7 2. Any dealer must provide on the premises where motor fuel is sold at
8 retail for use in motor vehicles a functioning motor driven air compres-
9 sor capable of inflating automobile tires for use by customers during
10 hours in which such station is open for business.
11 3. FOR THE PURPOSE OF CONSUMER COMPLAINTS BASED ON (I) OVERCHARGING
12 FOR GASOLINE OR (II) PRODUCT TAMPERING OF GASOLINE, ALL DEALERS MUST
13 PROVIDE CLEAR AND CONSPICUOUS NOTICE OF CONSUMER COMPLAINT CONTACT
14 INFORMATION BY CAUSING SIGNS TO BE POSTED AT ALL SERVICE DESKS, GAS
15 DISPENSING AREAS, GAS PUMPS AND OTHER APPROPRIATE AREAS AS NECESSARY
16 WHICH SHALL CONTAIN INFORMATION, INCLUDING, BUT NOT LIMITED TO, A TELE-
17 PHONE NUMBER AND MAILING ADDRESS OF THE STATE CONSUMER PROTECTION BOARD.
18 4. Wilful failure to comply with the provisions of this section shall
19 subject a dealer to a civil penalty of up to twenty-five dollars for
20 each day such failure occurs. If the failure to comply results from the
