AN ACT to amend the elder law, in relation to making certain persons who are eligible for or receiving social security disability insurance benefits eligible for elderly pharmaceutical insurance coverage

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivisions 1 and 2 of section 242 of the elder law, paragraph (b) of subdivision 1 and paragraphs (a) and (b) of subdivision 2 as amended by section 14 of part B of chapter 57 of the laws of 2006, are amended to read as follows:

5 1. Persons eligible for comprehensive coverage under section two 6 hundred forty-seven of this title shall include:

7 (a) any unmarried resident who is at least sixty-five years of age, OR 8 ELIGIBLE FOR OR RECEIVING SOCIAL SECURITY DISABILITY INSURANCE (SSDI) BENEFITS, and whose income for the calendar year immediately preceding 9 the effective date of the annual coverage period beginning on or after 10 11 January first, two thousand five, is less than or equal to twenty thou-12 After the initial determination of eligibility, sand dollars. each 13 eligible individual must be redetermined eligible at least every twen-14 ty-four months; and

15 (b) any married resident who is at least sixty-five years of age, OR 16 ELIGIBLE FOR OR RECEIVING SOCIAL SECURITY DISABILITY INSURANCE (SSDI) BENEFITS, and whose income for the calendar year immediately preceding 17 18 the effective date of the annual coverage period when combined with the 19 income in the same calendar year of such married person's spouse beginning on or after January first, two thousand one, is less than or equal 20 to twenty-six thousand dollars. After the initial 21 determination of 22 eligibility, each eligible individual must be redetermined eligible at 23 least every twenty-four months.

1 2. Persons eligible for catastrophic coverage under section two 2 hundred forty-eight of this title shall include:

3 (a) any unmarried resident who is at least sixty-five years of age, OR 4 ELIGIBLE FOR OR RECEIVING SOCIAL SECURITY DISABILITY INSURANCE (SSDI) 5 BENEFITS, and whose income for the calendar year immediately preceding the effective date of the annual coverage period beginning on or after 6 January first, two thousand one, is more than twenty thousand and 7 less 8 than or equal to thirty-five thousand dollars. After the initial determination of eligibility, each eligible individual must be redetermined 9 10 eligible at least every twenty-four months; and

11 any married resident who is at least sixty-five years of age, OR (b) ELIGIBLE FOR OR RECEIVING SOCIAL SECURITY DISABILITY 12 INSURANCE (SSDI) BENEFITS, and whose income for the calendar year immediately preceding 13 the effective date of the annual coverage period when combined with 14 the 15 income in the same calendar year of such married person's spouse beginning on or after January first, two thousand one, is more than twenty-16 six thousand dollars and less than or equal to fifty thousand dollars. 17 After the initial determination of eligibility, each eligible individual 18 19 must be redetermined eligible at least every twenty-four months.

S 2. This act shall take effect immediately and shall apply to benefits paid on or after such effective date. Effective immediately the executive director of the elderly pharmaceutical insurance coverage panel may promulgate any rules and regulations necessary for the implementation of this act.
