AN ACT to amend the parks, recreation and historic preservation law, in relation to establishing the Nissequogue River state park

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The parks, recreation and historic preservation amended by adding a new section 13.32 to read as follows:

- S 13.32 NISSEQUOGUE RIVER STATE PARK. 1. THE COMMISSIONER SHALL DESIG-NATE, PURSUANT TO SECTION 13.03 OF THIS ARTICLE, THOSE PARCELS OF LAND SPECIFIED IN SUBDIVISION TWO OF THIS SECTION TO BE THE PART OF THE STATE PARK SYSTEM TO BE KNOWN AS THE "NISSEQUOGUE RIVER STATE PARK".
- 2. THE NISSEQUOGUE RIVER STATE PARK SHALL CONSTITUTE THOSE LANDS DEDI-CATED BY THE COMMISSIONER AS THE NISSEQUOGUE RIVER STATE PARK IN 1999, ADDITION TO APPROXIMATELY 365.68± ACRES MORE OR LESS OF STATE LANDS WITHIN THE FORMER KINGS PARK PSYCHIATRIC CENTER, INCLUDING TWO PARCELS AGGREGATING 4.2± ACRES MORE OR LESS LOCATED ADJACENT TO A CEMETERY THAT IS LOCATED ON THE WESTERN EXTREMITY OF THE 365.68± ACRE PARCEL.
