- AN ACT to amend the environmental conservation law, in relation to prohibiting the possession, sale, offer for sale, trade or distribution of shark fins

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 13-0338 of the environmental conservation law, as 2 added by chapter 231 of the laws of 1992, paragraph a of subdivision 1 3 as amended by chapter 308 of the laws of 1999 and subdivision 4 as 4 amended by chapter 428 of the laws of 2011, is amended to read as 5 follows:

6 S 13-0338. Sharks; finning prohibited.

7 1. For purposes of this section:

a. "Shark" means any species of the [order Squaliformes except species
in the suborder Batoidea, and] SUBCLASS ELASMOBRANCHII EXCEPT SPECIES IN
THE SUPER ORDER BATOIDEA;

b. "Finning" means the removal of a fin[, other than the caudal fin,] 1 2 from a shark and not retaining the remainder of the shark's carcass[.]; 3 AND 4 C. "SHARK FIN" MEANS THE RAW, DRIED OR OTHERWISE PROCESSED DETACHED 5 FIN INCLUDING THE TAIL. 6 2. No person shall engage in finning on the waters of the marine and 7 coastal district. [No person shall possess shark fins in the marine and coastal 8 3. district unless the proper proportion of species, number, and 9 size of 10 shark carcasses is also possessed. 11 4. The department may, until December thirty-first, two thousand thirteen, fix by regulation measures for the management of sharks, including 12 size limits, catch and possession limits, open and closed seasons, 13 closed areas, restrictions on the manner of taking and landing, require-14 15 ments for permits and eligibility therefor, recordkeeping requirements, requirements on the amount and type of fishing effort and gear, and 16 17 requirements relating to transportation, possession and sale, provided that such regulations are no less restrictive than requirements set 18 19 forth in this chapter and provided further that such regulations are 20 consistent with the compliance requirements of applicable fishery 21 management plans adopted by the Atlantic States Marine Fisheries Commis-22 sion and with applicable provisions of fishery management plans adopted pursuant to the Federal Fishery Conservation and Management Act (16 23 U.S.C. S1800 et seq.).] NO PERSON SHALL POSSESS, SELL, OFFER FOR SALE, 24 25 TRADE OR DISTRIBUTE A SHARK FIN PROVIDED; HOWEVER, THAT THIS PROHIBITION SHALL NOT APPLY TO ANY LEGALLY TAKEN SHARK FIN THAT MEETS THE FOLLOWING 26 27 CRITERIA: 28 A. WAS TAKEN FROM A SPINY DOGFISH (SQUALUS ACANTHIAS) OR A SMOOTH 29 DOGFISH (MUSTELUS CANIS) CAUGHT BY A LICENSED COMMERCIAL FISHERMAN; OR 30 TAKEN FROM A SHARK CAUGHT BY A RECREATIONAL FISHERMAN WHO HAS WAS в.
