AN ACT to amend the penal law, in relation to offenses relating to unauthorized recordings

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Subdivision 6 of section 275.00 of the penal law, as added by chapter 460 of the laws of 1990, is amended and a new subdivision 7 is added to read as follows:
- 6. "Recording" means an original phonograph record, disc, tape, audio or video cassette, wire, film, HARD DRIVE, FLASH DRIVE, MEMORY CARD OR OTHER DATA STORAGE DEVICE or any other medium on WHICH such sounds, images, or both sounds and images are or can be recorded or otherwise stored, or a copy or reproduction that duplicates in whole or in part the original.
- 7. "AGGREGATE WHOLESALE VALUE" MEANS THE AVERAGE WHOLESALE VALUE OF LAWFULLY MANUFACTURED AND AUTHORIZED RECORDINGS CORRESPONDING TO THE NUMBER OF NONCONFORMING RECORDINGS INVOLVED IN THE OFFENSE. PROOF OF THE SPECIFIC WHOLESALE VALUE OF EACH NONCONFORMING RECORDING SHALL NOT BE REOUIRED.
- 15 S 2. The penal law is amended by adding a new section 275.50 to read 16 as follows:
