AN ACT to amend the environmental conservation law, in relation to prohibiting coal tar in pavement products

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The environmental conservation law is amended by adding a 2 new section 37-0115 to read as follows:

3 S 37-0115. COAL TAR; PROHIBITED.

4 1. ON THE ONE HUNDRED TWENTIETH DAY AFTER THE EFFECTIVE DATE OF THIS 5 SECTION, A PERSON SHALL NOT SELL OR OFFER TO SELL AT WHOLESALE OR RETAIL 6 A PAVEMENT PRODUCT THAT IS LABELED AS CONTAINING COAL TAR.

2. ON THE ONE HUNDRED EIGHTIETH DAY AFTER THE EFFECTIVE DATE OF THIS
8 SECTION, A PERSON SHALL NOT APPLY A PAVEMENT PRODUCT THAT IS LABELED AS
9 CONTAINING COAL TAR ON A DRIVEWAY OR PARKING AREA.

10 3. A. THE DEPARTMENT MAY ISSUE A NOTICE OF CORRECTIVE ACTION TO ANY 11 PERSON IN VIOLATION OF SUBDIVISION ONE OR TWO OF THIS SECTION.

B. A MUNICIPAL CORPORATION, ACTING BY AND THROUGH ITS GOVERNING BODY, 12 LOCAL LAW, ORDINANCE OR RESOLUTION PROVIDING 13 MAY ENACT A FOR THE 14 ENFORCEMENT OF SUBDIVISIONS ONE AND TWO OF THIS SECTION AND SHALL BE 15 DEEMED TO HAVE CONCURRENT JURISDICTION WITH THE DEPARTMENT IN THE ENFORCEMENT OF SUCH PROVISIONS. 16

17 4. FOR PURPOSES OF THIS SECTION, THE FOLLOWING TERMS SHALL HAVE THE 18 FOLLOWING MEANINGS:

19 A. "COAL TAR" MEANS A LIQUID OF HIGH VISCOSITY WITH VARIABLE MIXTURES 20 OF PHENOLS, POLYCYCLIC AROMATIC HYDROCARBONS (PAHS), AND HETEROCYCLIC 21 COMPOUNDS.

22 B. "PAVEMENT PRODUCT" MEANS A MATERIAL THAT IS FOR USE ON AN ASPHALT 23 OR CONCRETE SURFACE, INCLUDING BUT NOT LIMITED TO SEALCOAT.

24 C. "PERSON" MEANS ANY INDIVIDUAL, FIRM, ASSOCIATION, PARTNERSHIP, 25 CORPORATION, ORGANIZATION, OR JOINT VENTURE.

26 S 2. This act shall take effect immediately.
