AN ACT to amend the real property tax law, in relation to the definition of income for purposes of the senior citizen rent increase exemptions (SCRIE) program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph c of subdivision 1 of section 467-b of the real property tax law, as amended by chapter 500 of the laws of 2001, is amended to read as follows:

c. "Income" means income from all sources after deduction of all income and social security taxes and includes social security and retirement benefits, supplemental security income and additional state payments, public assistance benefits, interest, dividends, net rental income, salary or earnings, and net income from self-employment, but shall not include gifts or inheritances, payments made to individuals because of their status as victims of Nazi persecution, as defined in P.L. 103-286, or increases in benefits accorded pursuant to the social security act or a public or private pension paid to any member of the household which increase, in any given year, does not exceed the consumer price index (all items United States city average) for such year which take effect after the date of eligibility of head of the household receiving benefits hereunder whether received by the head of the household or any other member of the household; PROVIDED HOWEVER THAT INCOME SHALL NOT INCLUDE INCOME FROM SOCIAL SECURITY BENEFITS OR SUPPLEMENTAL

SECURITY INCOME PAYMENTS IF THE GOVERNING BOARD OF THE MUNICIPALITY IN WHICH THE SENIOR CITIZEN RESIDES, AFTER PUBLIC HEARING, ADOPTS A LOCAL LAW, ORDINANCE, OR RESOLUTION ELECTING TO EXEMPT SUCH BENEFITS AND PAYMENTS;

- S 2. Paragraph f of subdivision 1 of section 467-c of the real property tax law, as amended by chapter 500 of the laws of 2001, is amended to read as follows:
- 8 "Income" means income received by the eligible head of the house-9 hold combined with the income of all other members of the household from 10 all sources after deduction of all income and social security taxes and includes without limitation, social security and retirement benefits, 11 supplemental security income and additional state payments, public assistance benefits, interest, dividends, net rental income, salary and 12 13 earnings, and net income from self employment, but shall not include 14 gifts or inheritances, payments made to individuals because of their 15 status as victims of Nazi persecution as defined in P.L. 103-286, nor 16 17 increases in benefits accorded pursuant to the social security act or a public or private pension paid to any member of the household which 18 increase, in any given year, does not exceed the consumer price index 19 20 (all items United States city average) for such year which take effect 21 after the eligibility date of an eligible head of the household receiv-22 ing benefits hereunder whether received by the eligible head of household or any other member of the household. When the eligible head 23 24 of the household has retired on or after the commencement of the taxable 25 making an application for a rent period and prior to the date of 26 increase exemption order/tax abatement certificate pursuant to this section, such person's income shall be adjusted by excluding salary or 27 28 earnings and projecting such person's retirement income over the entire taxable period. FOR PURPOSES OF DETERMINING INCOME PURSUANT 29 PARAGRAPH, INCOME SHALL NOT INCLUDE SOCIAL SECURITY BENEFITS AND SUPPLE-30 MENTAL SECURITY INCOME PAYMENTS IF THE GOVERNING BOARD OF THE LOCAL 31 32 MUNICIPALITY IN WHICH THE SENIOR CITIZEN RESIDES, AFTER PUBLIC HEARING, 33 ADOPTS A LOCAL LAW, ORDINANCE, OR RESOLUTION ELECTING TO 34 BENEFITS AND PAYMENTS.
- 35 S 3. This act shall take effect immediately; provided, however, that 36 the amendments to paragraph c of subdivision 1 of section 467-b of the 37 real property tax law, made by section one of this act, shall not affect 38 the expiration of such section and shall be deemed to expire therewith.
